

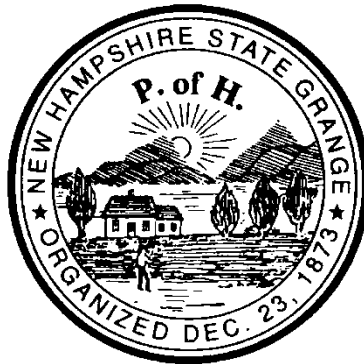

**JOURNAL OF PROCEEDINGS OF THE

Thursday, October 27, 2011

The New Hampshire State Grange Officers marched in to officially open the 138th Annual Session at 7:05 p.m.

State Master Jim Tetreault called the session to order with the Grange opening in the Sixth Degree.

Roll call of officers found Wilber Heath, Chairman of the Executive Committee and Richard Patten, State Historian absent. Wilber Heath arrived during a later recess.

The Grange was then lowered to the Fourth Degree.

Roll call of Granges found a quorum present.

State Master Jim Tetreault introduced Bruce Croucher, Priest Annalist, Assembly of Demeter and his wife, Sharon who is Lecturer of the NY State Grange. The Crouchers' were escorted to the Master's Station and each spoke briefly.

State Master Jim Tetreault called a brief recess to prepare for the Memorial Service.

The Grange was called back to order with the gates closed.

State Chaplain Matt Clark conducted the Memorial Service.

After the conclusion of the Memorial Service, State Treasurer Gail Turcotte was called upon to give her report.

Treasurer’s Annual Report

Worthy Master, Distinguished Guests, Associate State Officers, Members of the Pink Sash Family, Delegates, Brothers and Sisters:

I am pleased to bring you my fourth report as State Treasurer. I will not give you complete details of our finances, as those will be printed in the Journal. These are some highlights of our past year that I would like to share with you now.

Sherrill Bokousky and the members of her fundraising team have been very busy throughout the year and I would like to thank them for all their efforts. Fundraising remains an important goal for this administration but unfortunately we were not able to meet our income and expense guidelines as set forth in the budget approved last year. Legal counsel for ongoing matters plus advice from our accountants significantly increased both of those line items and we had to withdraw principal twice during the year to cover our operating expenses.

Anne and Marty Boisvert continue to manage our building in Hooksett and they perform as much maintenance work themselves as possible to help control costs. Thank you Anne and Marty for your efforts.

Our invested funds remain with Morgan Stanley Smith Barney and after our annual review with our financial advisor John Habig, Don Ross and I recommended to the Executive Committee that we continue with our present investment and spending policy. Our investment plan currently allocates 60 % to equities, 38% to fixed income and 2% to cash and equivalents with combined goals of growth and income.

We continue to carry the value of the State Grange Building at the purchase price of \$87,500.00. Our Account Receivable is at \$1,180.00 with one loan payment of \$100 received during the year. Thank you to Wicwas Lake for that loan payment.

A quick review of the special funds shows that the Treasurer of the Education Loan Fund for the second year in a row has paid the scholarships from their checking account by using the donations, interest paid, repayment of loans and memorial gifts received. This allowed us to reinvest the income earned on the investment account into principal.

The Randall Richardson Memorial Youth Fund has not received as many donations as in past years and travel and meal costs to attend National Session continue to rise. A special appeal is currently being made for assistance with this year's expenses. Additional donations are still being accepted from both individual members and from Granges. The NH State Grange Executive Committee also voted to authorize the withdrawal of principal to assist the youth to attend National Session in Tulsa, Oklahoma.

We opened a new Defunct Grange account when the former Starr King Grange hall in Jefferson was sold in late spring. The NH State Grange Executive Committee also agreed to hold and invest the Northeast Connection funds until National Session is held here in NH in 2013. These funds are now invested in an account with Morgan Stanley Smith Barney until needed.

Fiscal year 2010 is the third year that all Subordinate and Pomona Granges are required to file the 990-N report with the Internal Revenue Service. Filing this report is an annual requirement with each year's report due to the IRS by February 15. I do have some of the 2010 paper version 990-EZ forms available for those few Granges that are unable to file electronically. One change to the 990-N report this year is the amount of money earned. It has been raised from \$25,000 to \$50,000. So if your Grange has less than \$50,000 income you may file the 990-N report. The receipt you print upon completion of filing has also changed slightly.

I would like to thank Don Ross and Beth Merrill, finance committee members for assisting me during this past year. Don continues to attend meetings with our financial advisor and both Beth and Don offer advice whenever called upon.

A large thank you also to Carolyn Ross, State Secretary for continuing to handle her part of our shared financial duties in a timely and efficient manner. We have not paid any late fees or service charges in the past three years thanks to her efficiency. Carolyn continues to use discount coupons from Staples that result in significant savings to the NH State Grange.

SECRETARY'S ANNUAL REPORT

Worthy State Master, National Representatives, Bruce & Sharon Croucher, Associate State Officers, Committee Members, Delegates and Patrons:

I am happy to bring you my fourth annual report as State Secretary.

This past year we have had to close Jaffrey Grange #135 on November 1, 2010 and Contoocook Grange #216 on January 3, 2011. There are still more Granges out there that still need to consider on closing or consolidating with another Grange.

As of June 30, 2011 there are 11 Pomona Granges in the state with a total membership of 763, of which 251 are Golden Sheaf members. The largest Pomona is Merrimack County Pomona with 137 members.

As of June 30, 2011 there were 63 Subordinate Granges with a total membership of 1858, of which 482 are Golden Sheaf members. The largest Subordinate Grange is Wingold Grange with 78 members.

By authority of the National Grange, I have issued the following membership awards:

State Executive Committee Chairman Wilber Heath gave his report as Chairman of the Executive Committee.

Report of the Executive Committee

October 27, 2011

Worthy Master, National Representatives, Fellow State Officers, Delegates, Brothers and Sisters:

The State Executive Committee has been very busy this year. Our first meeting took place right after the installation where Wilber Heath was voted as Chairman and Beth Merrill as Secretary. We met again at Deputy School to clarify some important matters.

Our next meeting on January 29th was held at the NH State Grange building. We discussed two Granges whose halls we were attempting to sell. We also discussed two other Granges that were in court cases. We had two Granges that had been contacted concerning reports we had received and were unable to communicate with either one of these. We had one Grange that requested funds from their escrow account and after receiving additional information on the needs, we granted the funds. We also adopted the new accounting procedures for officers,

departments and contractors. Northeast Connection fund has been started and will be handled by NH. The reports of Master, Treasurer and Secretary were accepted.

Our next meeting took place on June 23rd again at the NH State Grange Building. Topics at this meeting included discussions on nine Granges. Some were consolidations with Hudson and Wattannick consolidating plus Ocean Side and Hampton Falls consolidating. We received notice that the Rebekahs, who have used our hall for many years had disbanded. When they vacate the premises, this will free up some additional storage space in the hall. We also discussed a new custodial agreement with Claire Gagne. She has been doing a great job and we hope she stays on. An agreement was signed with American Income Life where they will supply all of our members with one year accidental death policy. The executive committee created two new forms, one for use to request a loan and one to request Escrow funds from the principle. These are both available on the NH Grange web site. Background check forms were made available for those that work with the youth and distributed to the new members of the department. An offer from Amazon to put a link to their site on our homepage was presented and held over for additional research. Contract signed for the annual session at Town & Country in Gorham. A painted curtain that was removed from Starr King was presented to Wicwas Lake Grange.

Our next meeting was held August 12 at the NH State Grange building. Nine Granges were discussed with different issues that had come to our attention. We still have one Grange Hall that is on the market as we finally closed on Starr King Grange and deposited the income from that sale into a Defunct Grange account. Don Whittum, our attorney, had provided some changes be made to our guidelines for selling halls and these were put into a resolution to be presented at State Session. We had a lengthy discussion on an offer from Amazon and it was decided due to the fact that the income generated would be taxable, we declined the offer. A motion was made that the State Master appoint someone to write a policy on fundraising and that this be incorporated in a Policy Book for the Executive Committee. A contract for the 2012 annual session to be held at Ashworth-by-the Sea in Hampton was signed. Arthur Merrill was appointed as the second delegate for National Grange.

The next meeting was held October 7th, 2011 at the State Grange building. Money owed from White Mt Grange was received and this was deposited into a Defunct Grange account. Rhoda Davis and Vicki Hussman were elected as Trustees of the Trust Funds.

Our last meeting before State Session was held October 23rd following the 6th Degree rehearsal. We wrapped up a few items that had to be cleared before State Session. One important item was the winterizing of Contoocook Grange hall before cold weather sets in. We audited the books of the State Secretary, State Treasurer and the Education Loan, Northeast Connection and Trust Funds. Books of the departments will be audited at Deputies School in December.

Subordinate Granges continue to either close or consolidate.

This year's project – "Kiss the Pig" was able to draw in some money though not as much as the Plunge.

The State Grange Building in Hooksett continues to receive upgrades per orders from the Hooksett Fire Marshall. We have continued our contract with Orkin Pest Control to continue to eradicate the pests.

The State Grange currently has charge of selling one Grange Hall (Contoocook). Hannah West continues to do an excellent job as the Editor of the *Granite State Granger*. Hannah passes on numerous e-mails of importance to some members which enable those of us with electronic capabilities to know what's happening in the state. Linda Nielson has been sending notices to all our Grangers with Facebook access.

To our Worthy Master, Jim Tetreault, we thank you for leading us through this year. Jim is always on the go, visiting Granges throughout the state as well as travelling to the other Northeast States. It was exciting working next to Jim at the first of our Blueberry Pie days at the Big "E", with his cow hat. And I have enjoyed my monthly phone calls to Jim as we support each other in our tasks.

My biggest supporter has been my son Chris, who is there to get me back home after the late meetings we have had where I turn into a pumpkin after 9PM. I also bounce ideas and thoughts off of him as I prepare for each meeting and the challenges that come before us. To the rest of the committee, I thank you for the help you have each given me as we all struggle to get through each meeting and come to a final decision on each subject. Positive or negative, we make the decisions we have to make and try our best to represent the Good of the Order.

In closing, it has been a joy to serve this past year as the Chairman of the State Grange Executive Committee. As my predecessor has said in the past, The Executive Committee is comprised of members from all walks of life and is much diversified. However, we all work together as a team for the best interests of the Grange.

Meeting called to order at 7:43 p.m. and commenced with auditing books for the Publicist, Legislative, Youth, Lecturer, Family and Community accounts. Grange Services books unavailable for auditing at this meeting.

Meeting officially called to order at 8:31 p.m. Members present were Chairman, Wilber Heath; Members: Mark Collins, Donald Ross, Bob Haefner, Beth Merrill; Master, Jim Tetreault; Overseer, Chris Heath; Treasurer, Gail Turcotte; and Secretary, Carolyn Ross.

Minutes of October 24th meeting recorded by secretary, Hannah West were approved. It was noted that the original meeting date of November 26th was changed at the mini meeting on October 31st, hence this meeting on the 18th.

Minutes of October 31st meeting recorded by secretary, Beth Merrill were approved.

Don Ross reported that Starr King Grange hall is now listed at \$39,900. We're waiting to hear from an antique dealer if she is willing to make an offer of \$35,000.

Jaffrey Grange will be closed as of November 1, 2010. Jim will send letters to the members informing them that the Charter has been revoked and include their demit cards with the letter. We will have Mr. Whittum send a letter to the town of Jaffrey informing them of the Grange's trademark issue on the use of the name Jaffrey Grange Scholarship. If the town ignores or refuses to comply with our request to not use the name "Grange", then their case will be referred to the National Grange for further action.

Halloween is down to thirteen members and is in violation of Master/Secretary/Treasurer separation by-law requirement. The State Master will send a letter informing them of the new by-law change and our concern that their membership is at a critical level.

Pleasant Valley is in violation of M/S/T by-law requirement as well. The State Master will send a letter informing them of the new by-law change and address their current circumstance of not holding meetings.

Meriden Grange is in violation of M/S/T by-law requirement. The State Master will send a letter informing them of the new by-law change and our concern that their membership is at a critical level.

Brookline/Wilton owes dues for more than 12 quarters. Bob Haefner, as their Pomona Master will try to contact them in that capacity. Carolyn will send them a delinquent Grange letter. We will try to gather whatever information we can as to the status of their Grange prior to our next committee meeting, at which time further action will be decided upon.

The process of the White Mountain Grange closure had no update at this point. The State Secretary will be responsible for compiling a current list of members; once the six month time limit of White Mountain Grange demits have expired. The Northern NH Pomona Secretary will need to be informed as to which members have used their demits and should be kept on the Pomona roll book.

Contoocook – Jim and Arthur will be going to a meeting there on November 22nd to inform them of the policy to not close a Grange until they entertain a Growth Team and go through that process. He has also asked to have copies of financial records available at that time.

Wicwas Lake's new officers have been installed and their November fundraiser, a barn dance, was successful. Ida Hutchins and Dave Boynton have been assigned to monitor and guide them through the process of "becoming a Grange".

2013 National Grange Convention – Logo concept has been presented to the National Grange Communications Director for her design input.

Kiss the Pig – Mark made the motion and Carolyn seconded to not distribute any of the charity monies collected thus far until the pig is actually kissed. Motion carried unanimously, however it is noted that the Worthy Treasurer and Worthy Overseer, both non-voting members of the Executive Committee, expressed dissenting opinions during the discussion.

National and Regional Assessment fees – State Secretary and State Master will combine efforts in sending out individual bills to each Subordinate Grange for \$1.50 per member to cover both assessments. It will be the responsibility of each Grange to check with their Pomona Grange to see if/how the Pomona is handling the National Grange \$1 per member assessment.

State Grange Building fund is now depleted due to the recent payments made for the recent extermination of the carpenter ant infestation.

Investment opportunities for individual Granges – Don checked with Morgan Stanley Smith Barney to see if this would be possible and found that they accepted our many accounts only because they were accompanied by the "meat and potatoes" general fund. Then he went to Edward Jones and found that they would take on individual Granges under the umbrella of the State Grange. He was quoted an estimated 5-8% income potential. This still raises the

possibility of the State Treasurer being in charge of managing multiple accounts, something that this board was trying to avoid when we decided to invest with Morgan Stanley Smith Barney. Discussion will continue at the next meeting.

Resolution # 12 adopted at 2010 NH State Grange Session— Anytime the State Secretary receives a quarterly report which reduces the number of members reported, after the state has submitted its report and payment to National Grange, the State Secretary will send a letter and a bill to the Grange for the difference already paid to National Grange.

Master's Address Items of Concern —

Grange Services Committee will be asked to develop a member benefits brochure incorporating all the National and State Grange benefits.

Big "E" Banner –The membership committee will be assigned the task of creating a banner to be used in the Grange Day parade at Big "E".

Accounting Procedures -

As a result of the discussion at State Session regarding the budget we find that the State Grange has not been in compliance with record keeping requirements by IRS rules in regard to monies paid to Committees, Deputies and State Officers, namely Master, Secretary, and Treasurer.

Mark moved and Bob seconded to implement the accounting procedures as presented by Master Jim Tetreault. It was suggested that the committees and deputies sections be implemented immediately as the Deputy School meeting is quickly approaching. Motion carried unanimously.

State Session financial report — final credit card bills have not yet been received.

Area Meetings — Official representation will not be required of the Executive Committee, but if questions arise, whatever committee member that is present may be asked to answer.

Dates will be January 15th at Riverside Grange in Dalton, January 22nd in Rochester (tentative), and January 29th in Hooksett.

Resolutions at National Grange — E-membership passed its final vote this year and has already been implemented via the National Grange website.

NH resolutions to National Grange

Resolution #6 — a housekeeping by-law change regarding National Grange Executive Committee sashes was adopted.

Resolution #7 — asking to exempt office of Master from six year term limits was changed by the Grange Law Committee and instead asked to eliminate all term limits. The resolution was adopted, but is subject to a second vote at the 2011 Session before it will go into effect.

Resolutions #8 [Executive Committee 4.10.1(c) (1)], #10 (Sale of Grange Halls), and #16 (Labeling of Household Cleaners) were all withdrawn and resolution #9 (Master, Secretary, Treasurer) was declared a state issue and returned to the state.

Ruth Gray, past Master of Florida State Grange and past Pomona of the NH State Grange fell during the session and broke her arm.

Wayne Turcotte, newly retired, will achieve a life-long dream by residing in south Florida December through March/April. Gail has already done a trial run to make sure that the Treasurer's duties can be handled long distance, so no major problems are expected with this new seasonal living situation.

The next meeting will be January 29th in Hooksett following the Area Meeting, approximately 3:00 p.m.

Meeting moved into Executive Session at this time. Executive Session adjourned

Meeting was called to order at 3:09 p.m. with all members of the Executive Committee present except Treasurer, Gail Turcotte.

Bob moved and Jim seconded to approve minutes of November 18, 2010 meeting as presented. Motion carried.

Carolyn moved and Bob seconded to approve the minutes of the December 4, 2010 special Executive Session meeting. Motion carried.

Conflict of interest forms were signed and submitted by all that were present. The originals will be filed in the safe at the State Grange Building, with copies to go on file with the State Master, State Secretary and Chairman of the Executive Committee.

Contoocook Grange Hall Sale discussion – Contoocook Grange was closed on January 3, 2011 and the State Grange is now in control of the building. A contract was received from the realtor to the State Grange for her continued services. There was discussion of whether or not we should make a minimal investment to maximize the sale price. Jim will contact the realtor to see if someone can look at the hall and give estimates for repair of the furnace and how those repairs might reflect in the sale price.

Mark moved and Bob seconded that we sign the agreement with Cowan and Zellers Real Estate, LLC. Motion carried.

The two committee members who will be working on this sale are Bob Haefner and Jim Tetreault. Don moved and Mark seconded that Jim be authorized to have the electricity turned back on. Motion carried.

Starr King Grange Hall sale – No new activity. Mark suggested that the realtor be asked to send a letter to a prospective buyer rather than relying strictly on email communication.

Granite State Grange – A November 21st letter was sent to James Doggett by the State Master, but no reply has been received to date. Carolyn reported that they are caught up on their quarterlies.

Brookline/Wilton Grange –Bob Haefner's attempts to contact Barbara Collins had no results. Beth learned that a key member is dealing with a serious family health issue. Bob will follow some new leads in trying to make contact with this Grange.

Croydon Grange – Master needs to follow up with the National Grange and have them re-issue a third Charter, as the latest one had another error. As of January 16th, they have completed their incorporation with the Secretary of State's office and are working on obtaining their Employer Identifier/Tax Identifier number from the Department of the Treasury.

Pineconia Grange – An email poll of the Executive Committee was taken in December, the result of which granted Pineconia Grange's request to receive \$1500 from the principal of their escrow account. The final result of the email vote on December 21, 2010 was 6 in favor and 1 not voting.

As a result of discussion regarding this issue, it was decided that a form shall be designed for Granges to use when requesting funds, escrow or otherwise, from the State Grange. It's felt that our policy/bylaws stand for themselves, but that a supporting document will reinforce this Executive Committee's goal to preserve each Grange's escrow account, and whenever possible, to avoid the necessity of using the principal of any accounts of the State Grange. Mark Collins will work on designing the new form.

Treasurer's Report – Update on status of 990 IRS report- our accountants have completed the long form 990 and Gail will file as soon as she receives the copies. Gail has also filed the 990-N for our Department EIN/TID number. Note- our income tax preparation budget line is over the estimated amount due to our accountants having to use reports from three investment advisors to complete the form and by the additional time spent consulting and researching accounting procedures for the Deputies, Departments and State Officers and Custodian. Carolyn moved and Jim seconded to accept the report as presented. Motion carried.

Bonding – Mark moved and Jim seconded that we reinstate Wicwas Lake Grange's bonding. Motion carried.

Revised Accounting procedures – Mark moved and Don seconded that the independent contractor agreement, state officers accounting procedures, department directors accounting procedures, and Deputy State Masters accounting procedures as presented at this meeting be adopted. Motion carried.

Northeast Connection (NC) Funds – Once the check from CT State Grange is received, it will be deposited with Morgan Stanley Smith Barney per the Northeast Connection's instructions. The account will be under the NH State Grange's EIN/TID and will be governed by our investment policy as previously discussed at our EC meeting. Discussion of what the proper voucher procedure should be. Nothing conclusive was decided at this time.

National Session Assessment Collections – The State Master and State Secretary will continue working on this.

Trustee of Trust Funds – Omer Ahern, Jr. has resigned as a Trustee of the State Grange Trust. Jim moved and Bob seconded to elect Rhoda Davis as a Trustee. Motion carried. Jim will notify Sister Davis of her election.

Rebekahs – Jim moved, and Mark seconded that the State Secretary send a bill to the Rebekahs for storage June 2010 through December 31, 2011 payable by March 31, 2011. Motion carried. They will be asked to vacate the storage space if they do not settle their account.

Riverhill – Jim and Arthur are scheduling a meeting with them, possibly for next month. Jim moved and Mark seconded that Riverhill Grange and Wicwas Lake Grange be billed to pay the sum total of back dues that the New Hampshire State Grange has paid to National Grange on their behalf. Motion carried.

Obligation Ceremony Report Form – Creating this new form was discussed. The State Master will work with the State Secretary and General Deputy to see if a resolution can be made to the problem of Grange secretaries not properly reporting new members that were obligated into membership.

Halloween Grange – Chris will meet with Dianne Hoitt to work with them and help them get back on their feet. Master, Secretary, and Treasurer are the same person and they are down to 13 members.

Reports:

Members of the EC felt that the Master's Quarterly Report was worthwhile and should be continued for future meetings.

Beth moved and Mark seconded to accept Secretary's and Master's report. Motion carried. The reports are filed in the Executive Committee Secretary's file.

Hannah West questions whether or not we need to keep a phone line at the State Grange.

After some discussion it was agreed that having a phone is a nominal expense and should be kept for safety reasons, especially in regard to rental situations.

A member's request earlier in the day during the Area Meeting called for the Executive Committee to look into making it possible for Granges to pay their quarterly dues online. The discussion on this subject was a general feeling that the cost for the State Grange to provide this service would be too excessive for the few secretaries who might utilize it.

Moved into Executive Session.

Returned to regular session.

Next meeting will be April 21st at 7:15 p.m.

Don moved and Bob seconded that the meeting be adjourned. Motion carried. Meeting adjourned at 6:47 p.m.

State Grange Building:

There was also a question that since the Rebekah Lodge that provided them with refreshments at their meeting has closed, if they are in need of a new group to provide that service.

Agreement with Claire Gagne – Waiting for her sister to advise what is the best option for her financial situation before she signs the new Custodian Agreement form the Executive Committee has designed. It was noted that the Grange Building always looks great and is in good order since Claire took on the cleaning duties.

Obligation Ceremony Report Form – A form to help keep track of new members has been designed and will be turned over to the General Deputy for his comment.

Insurance Agreements

American Income Life– Wilber has signed the agreement for the company to offer a complimentary, one year accidental death policy for all our members.

Clark Insurance – Labels have been sent to their firm so that they can do a mailing to offer liability and regalia insurance to NH Granges.

1. All persons, except special guests, shall be registered. Nametags and programs shall be issued.
2. Admission to the meetings shall be by nametag and password only. Upon giving proper password, the meeting Deputy will provide a colored sticker for the name badge to eliminate the need for giving the password again at this Session. If you are not wearing your nametag, you will be refused admittance.
3. As a common courtesy to all members, cell phones are to be turned off, or set on vibrate.

WHEREAS, there are currently no provisions for sale, encumbrance or transfer of Grange Halls or Real Property under Article XIII Pomona Granges in the New Hampshire State Grange By-Laws, yet the same rules apply per the National Grange Digest; therefore be it

RESOLVED, that Article XIV, Section 9 of the New Hampshire State Grange By-Laws be re-named “Sale, Encumbrance or Transfer of Real Property”; and be it further

RESOLVED, that Article XIV, Section 9, Division 2 of the New Hampshire State Grange By-Laws be deleted; and be it further

RESOLVED, Article XIV, Section 9, Division 1 of the New Hampshire State Grange By-Laws be re-numbered to Article XIV, Section 9, Division 2, and insert “the Master and” after “petition”

in the first line and change “real estate” to “Real Property” at the end of the first sentence; and be it further

RESOLVED, that the New Hampshire State Grange By-Laws Article XIV, Section 9, be amended by adding a new Division 1:

Division 1. For the instructions/procedures for the sale, encumbrance or transfer of a Grange Hall or Real Property, go to Appendix F of the New Hampshire State Grange By-Laws which includes Chapter 4, Article XI, Sections 4.11.1 through 4.11.5 of the National Grange Digest and Article XIV, Section 9, Divisions 2 through 4 of the New Hampshire State Grange By-Laws inserted where appropriate”; and be it further

Resolution #4 - Submitted by Gilman Grange #1
Subject: Voting Protocol during State Session

WHEREAS, NH State Grange By-Laws Article XII, Division 4, state: "All elections in State, Pomona, Subordinate and Junior Granges shall be by ballot, and a majority of all legal votes cast shall be necessary for choice."; and

WHEREAS, the Subordinate and Pomona delegates represent the voting body at State Session; and

WHEREAS, the State Session Committees are made up of the delegates present; and

WHEREAS, State Session Committees currently meet during session (including when voting is taking place) to conduct committee business, preventing the committee members from participating in State Session voting; therefore be it

RESOLVED, that the NH State Grange By-Laws Article X, have a new Section created that states: "No Sessions Committee meetings will be held while voting is taking place at the Annual State Grange Session."

Resolution #5 Submitted by the New Hampshire State Grange Executive Committee
Subject: Clarifying language on Sale of Grange Halls

WHEREAS, there needs to be strength in the language of our By-Laws; and

WHEREAS, the language in our By-Laws needs to be clear; and

WHEREAS, Article XIV, Section 9, Division 1 and Article XIV, Section 9, Division 3 are not clearly worded; therefore be it

RESOLVED, Article XIV, Section 9, Division 1 First sentence "The Subordinate Grange will petition..." be changed to read "The Subordinate Grange shall petition..."; and be it further

RESOLVED, Article XIV, Section 9, Division 3 is changed from:

Division 3. Upon final approval of the State Executive Committee to sell said property, the New Hampshire State Grange will act as an escrow agent for said Grange. Upon sale of property the sum of \$1,000, if sale price is more than this amount, may at the discretion of the Executive Committee of the New Hampshire State Grange be left to the control of the Grange selling the property. This is provided that the Grange does not intent to surrender their charter. The remainder of the sale price will be placed in an escrow fund with the New Hampshire State Grange and controlled by the Executive Committee of the New Hampshire State Grange. The

New Hampshire State Grange will pay accrued income on this fund to the Subordinate Grange annually, if requested. Funds from said escrow account may be returned to the Subordinate Grange in such amounts as may be requested in writing by the Subordinate Grange upon a two-thirds vote of the New Hampshire State Grange Executive Committee.

To:

Division 3. Upon final approval of the sale by the State Executive Committee of the New Hampshire State Grange will act as an escrow agent for the Subordinate Grange. If the net proceeds from the sale is \$1,000.00 or less the Subordinate Grange may retain the entire amount provided it does not intend to surrender its charter. If the sale proceeds exceed \$1,000.00 the excess amount shall be assigned by the Subordinate Grange to the State Grange. Funds not retained by the Subordinate Grange shall be held in an escrow account controlled by the State Executive Committee. The State Executive Committee shall pay annually, in the month of April, to the Subordinate Grange, upon written request from the Subordinate Grange, accrued income and such portions of the principal as the Executive Committee may by a two thirds vote approve. Requests for portions of the principal shall be in writing, include reason for request, and be submitted at least four weeks in advance.

BE IT RESOLVED, that the National Grange Digest, Chapter 4, Article 4.3.3(A) be changed by adding the words "District or Territory", after the word State, so that the Article will read "Six or more Subordinate Granges working in a State, District, or Territory may apply to the Secretary of the National Grange for authority to organize a State Grange."

Subject: State Grange Executive Committee

WHEREAS, in 1978 the New Hampshire State Grange By-Laws were changed by increasing the number of Executive Committee Members of the State Grange from three to five; and,

WHEREAS, in 1978 there were 150 Granges in New Hampshire and in 2011 there are 65; therefore be it

RESOLVED, that the New Hampshire State Grange By-Laws, Article IX, Section 1 be amended by changing the number of members of the State Grange Executive Committee from five to four, so that the section will read, "The Executive Committee of this Grange shall consist of four (4) members, to which shall be added the Master with full privileges. The Overseer, Treasurer and Secretary shall be ex-officio members without voting privileges."; and be it further

RESOLVED, that this resolution take effect with the 2011 election of officers.

WHEREAS, the State of New Hampshire has made significant budget cuts in recent years; and

WHEREAS, these budget cuts have affected necessary services and safety in the State of New Hampshire; and

WHEREAS, the Legislature has not made any effort to find a source of revenue in over a decade; therefore be it

RESOLVED, that the New Hampshire State Grange go on record in support of a State Sales Tax on all non-consumable goods; and be it further

RESOLVED, that said Sales Tax be capped at two (2) points lower than the average of the five (5) remaining New England states.

State Lecturer Hannah West was called upon to give her report.

State Lecturer's Report, 2011

Worthy Master, Brother and Sister Patrons, and Guests,

"I started home twixt twelve and one. I cried, 'My God, what have I done?'"

That snatch of song rather sums up my feelings a year ago, when the euphoria of Installation wore off and reality set in. November passed in a blur of trying to find a committee and plan some events while attending National Grange and putting out the Granite State Granger. December brought a successful Deputy School and a little more structure in the Lecturer's Department. Many thanks to Past Lecturer Marie Hall who passed on the computer files of her Lecturer's program and sorted over the boxes of Lecturer's material before handing them on.

January began with a snowy ride to Albany, New York, for the Northeast Leaders Conference. At the Northeast Lecturers' meeting I was informed that I was Vice President of the NE Lecturers' Association, which meant New Hampshire would be hosting the Northeast Lecturers' Conference in 2012! January also brought three Area Meetings and the realization that I wear a few too many Grange hats. My fellow directors grew very tired of hearing my voice, although the local Grangers seemed willing to learn about Lecturer's work, the Granite State Granger, and e-mail bulletins. Thanks to my daughter Anne for driving to Dalton and to Jim, Arthur, and Tricia for letting me ride to Rochester with them.

State Overseer Chris Heath took over the task of running the Grange Bowling Event at Lakeside Lanes in March. It was attended by 67 adults and 4 juniors and was financially self-sufficient. We even have a bit of money left over for next year. This activity draws people who do not attend any other State Grange event, so we will be back at Lakeside Lanes in March of 2012, hoping for an increased attendance. The people who won prizes will be listed at the end of this report.

On May 14 New Hampshire hosted a Maine/New Hampshire Gathering at the Legion Hall in Gorham. At the request of the Maine State Lecturer the event was held in the middle of the day rather than the evening. Fifty people were present for the meal, and another fifteen came for the program only. All enjoyed good food and fellowship and a fine program prepared by Lecturer Sherry Harriman of Maine. This was a break-even event. All the money I collected for the meals was paid out to the American Legion to cover the food and a gratuity. Use of the hall was included in the price of the meal. I truly appreciate the work of Mary Tyler and Tillie Meyers in making arrangements with the American Legion.

On June 4 the Talent Show, renamed Variety Show, took place at the State Grange Building in Hooksett. There were 5 vocal, 1 instrumental, and 5 variety performances. Wilber Heath was Best of Show with his recitation of "Charlie and the MTA." I did not take an official count, but I think there were about 38 people in the hall. The "Kiss the Pig" Fundraiser Finale and Youth Sign-a-Song and Public Speaking contests were held at the close of the Variety Show. Cash prizes were given: \$15 for first place, \$10 for second place, and \$5 for third place in each category. An additional \$10 was given for Best of Show. Winners will be listed at the end of this report. June is a busy month, and next year I hope to schedule the Variety Show earlier in the year in the hope of increasing attendance. Heartfelt thanks to Bob Haefner and Lois Enman who stepped in to judge at the last minute, and a big thank-you to Kevin Belval for serving as Master of Ceremonies for the event.

The Northeast Lecturer's Conference was held in Bridgewater, MA, in early August. There were at least 18 people from New Hampshire present for some part of the conference, and many of them attended the whole session. The NH program "Season It Sweet" was well received. Many thanks to my daughter Mary West and her husband Kevin Belval for managing props and keeping everyone moving. My experiments with technology were not too successful, but I will remember lessons learned and try again. At the final banquet our State Master presented me with two picture frames and a generous cash gift from the Granges of New Hampshire. Thanks to all who made a contribution.

Wilber Heath participated in the Talent Show on "Northeast Night" and surprised and delighted himself and the rest of us by coming away with Best of Show. He will be going on to represent New Hampshire in the Night of Excellence at National Grange. With your donations to the Talent Fund we were able to give him a check for \$360 dollars, which, because he is a frugal man, will cover most of his expenses for transportation. It seems appropriate here to thank Marie Hall, because her participation in the "Kiss the Pig" fundraiser gave the Talent Fund a nice boost.

Next year the Northeast Lecturer's Conference will be in New Hampshire. Arrangements are incomplete at this time, but I hope that many of you will be able to participate in a conference in your home state.

September and October have brought the challenges of collecting contest entries, arranging for judging and prizes, preparing the Lecturer's Booklet for next year, and writing final reports. Winners in the Art, Photo, Creative Writing, and Create-a-Card contests will be listed at the end of this report. I hope many of you are here to collect your prize in person and take your entries home at the close of the session. Please visit the exhibit room downstairs to admire the wonderful talents of your fellow Grangers and find out who the winners are.

This year there will be a Photography Contest at National Grange, and I am asking you all to help select a "People's Choice" to send to Tulsa, OK. Be sure to put your vote in the box for the picture of your choice. Each photograph will be labeled with a letter of the alphabet. Indicate the letter of your choice and initial your "Ballot." One person, one vote, please. Because they have their own contest, photos will not be included in the "Best Three" selection process for items to be sent to National Grange.

Our State Master thought to increase communication by asking for quarterly Lecturer's reports. Each quarter brought a lower response. Next year we will try two reports, one in May and one in October, in the hope of increasing the response rate. I would like to publicly recognize the nine Granges who sent in all four reports this year: Baker's River, Blow-Me-Down, Crown Point, Daniel Webster, Harmony, Pineconia, Rochester, Sunapee Lake, and Winthrop.

Let us now consider the coming year. I have prepared a booklet with suggestions, guidelines, contest rules, and report forms for 2012. I have done what I could to make it user-friendly. It is my hope that Lecturers will take it apart and make copies of contest rules to give to interested members of their Granges. The booklet has a few specific topics for programs, but mainly it gives areas to explore, guidelines to consider when planning a program, and other information, which will, I hope, prove useful. It may be different from what you are used to seeing. It is the same advice for both Pomona and Subordinate Lecturers, because you are all Lecturers. It is built around the State Master's priorities and is intended to help bring them into reality.

As I prepared that booklet, I wondered how many Lecturers would even open it. It will come to your Grange in a large envelope containing information for many departments. If you are the Master or Secretary, please make sure your Lecturer receives it. If you are a Lecturer, please read it soon. It won't do you much good next October, when the Grange year is over.

Membership Director Anne Boisvert was called upon to give her report.

Membership Report

At Jim's installation last year it was announced to everyone that I would be the new membership director. It was a position I had been interested in since I was a Junior Granger and kept a collection of all the membership paraphernalia I could get (a copy of each pamphlet Roy Birard put out for people to take) and came home from New England Leader's Conference every year pumped up from the National Representatives' presentations and sure that Grange could conquer anything. Unfortunately my optimism, energy, inspiration, enthusiasm, and self-confidence had all dropped off considerably since that time. About two weeks after installation, I found out I was pregnant and there went most of the rest of my energy. At that point there wasn't much to do but hope and persevere, so I went about trying to find myself some committee members. I definitely did not find a wealth of enthusiasm in anyone I contacted, but fortunately Grangers are often cooperative even when they don't particularly want to be, so I managed to twist the arms of a few people and get myself a committee. I'd be the first to tell you that I don't particularly know how to use a committee to anywhere near its full potential, but they were helpful just the same and I hope to get better at that. January was full of area meetings, at which all departments, mine included, presented in several regions of the state. February brought the annual Farm and Forest Expo at the Radisson Hotel in Manchester in February. This year's theme was "Growth through Yankee Ingenuity." The exhibit sign was made of pine boards and duct tape and handouts included lengths of baling twine tied to cards with Grange information. Thank you to all those who donated to the "Made by a Granger" basket we gave for the auction and to those who made items for the "something from nothing" contest judged by visitors to the booth. Newspaper starter seed pots made by Beth Merrill were chosen as the winner. Thanks, too, to the

Grangers who volunteered their time and effort to man the Grange booth, greeting visitors with a friendly face and answering questions. This year's volunteers were: Beth and Arthur Merrill, Norman Brandt, Jim Tetreault, Bob Haefner, Gwen Yardley, Fran Everard, Mark Collins, Dot Haskins, Marion T. Jones, Hannah West, Allissa Estes, Jane Heath, and Gloria Davis. Our booth received second prize for the educational exhibitors. Please keep February 3th and 4th 2012 in mind if you would like to help staff next year's booth. The theme will be "Opening Doors to Our Future." Ideas are welcome.

In March, the State Master announced a program he was asking the membership department to sponsor called Grange Boosters, part of the Grange Growth priority on his list. Forms were mailed out and put on the website whereby Granges could send information on their new members to the membership department. These Granges would then be listed on the website so everyone could share in their success. Meanwhile, the new members would receive a welcome letter from the State Grange. The welcome letters were lost in the shuffle this year, but new welcome packets are in the works and will be mailed to new members listed on the Grange Booster forms I currently have and those I receive subsequently. Special thanks go to Gail Turcotte for giving me some help and suggestions for what to include in the packets. Hopefully the program will catch on better in the New Year as I only received information from four Granges this year: Arlington, Blow-Me-Down, Blazing Star, and Gilman.

In April, the big event was the Grange Growth Summit, a National Grange Program put on by Rusty Hunt, National Grange Membership Director at the State Grange Building in Hooksett. Many members from NH, Massachusetts, and Vermont were trained in membership growth techniques and readied to help Granges in their area who may be struggling or could just use a little help coming up with a new direction or a new project. Chichester, Daniel Webster, Halloween, and Watatic Granges hosted groups for the training. For the NH Grangers, the idea was to get some trained members from each Pomona so help would be available to Granges everywhere with minimal travel time for the teams involved.

In early May, a successful degree day was held at Dorchester Grange. There were three official candidates but several others who had never seen the degrees conferred. Thank you very much to Ida Hutchins for her invaluable help in making the event happen. Thank you also to Dorchester Grange, the deputy force, the youth officers, the State Officers, the members of Walpole Grange, and everyone else who helped out.

My daughter Rebecca was born on June 16. Her somewhat early arrival surprised the heck out of everyone involved and also kind of put a hold on any further membership department work for the season.

Now, after having three candidates at the degree day and receiving four responses all year to the Grange Booster Program, and knowing that my going into labor on a third Wednesday made it so that my own Grange didn't have a quorum that night, I was not feeling too optimistic about the state of things. You can imagine then that it just about knocked my socks off to find that seventeen Subordinate Granges and one Pomona reached a net gain in membership for the Grange year ending June 30, 2011. At this time I would like to congratulate the following Granges on that achievement: Arlington, Aurora, Blow-Me-Down, Centennial, Dorchester, Harmony, Joe English, Lake Shore, Londonderry, Mount Hope, Park, Peterborough, Pine Grove, Riverside, Somersworth, Walpole, Wicwas Lake, and Eastern NH Pomona.

As with anytime that new officers and directors begin their new positions, this year has included a learning curve for all involved. The membership department was certainly no different. Despite the somewhat unexpected circumstances and my lack of confidence in my ability to fulfill the duty of Membership director, the sky did not fall and in fact many Granges in the state did quite well membership-wise. Several membership events went off with reasonable success and people have sent me some suggestions to implement for the future. General Deputy Report

Worthy Master, National Representatives, Brothers and Sisters;

The Deputies have concluded the fall visits, the numbers have been crunched, and some conclusions have been reached. There are Granges that have improved, some have declined, and many that have stayed about the same as last year.

The Pomona Granges have assets of \$53452.51. Dues range from a low of \$4 to a high of \$15 per member. Number of meetings from zero to nine. Membership from 21 to 137. The most members at any Pomona meeting was 26 and only 1 Pomona showed an increase in membership. Pomona Granges should consider having a growth team from a neighboring Pomona come and work with them.

I hope that next year more Pomonas will work the fifth degree, either by themselves or in cooperation with another Pomona. The top scoring Pomona Grange was Cheshire County Pomona #6. Some type of appropriate award will be presented to them in the near future.

The Subordinate Granges have real estate valued at more than 2.7 million dollars. Other assets total nearly 1.1 million dollars. Dues go from a high of \$40 to 10 Granges collecting less than the State Grange By-Laws state must be collected. We will be in contact with those Granges who are in violation of our By-Laws not only on this issue but others as well. One issue is meetings, the By-Laws state that a Subordinate Grange must meet at least once a month. That is 12 months, not 8 or 10 months. Eleven Granges showed an increase in membership.

We went back to scoring Granges this year, the system will be changed slightly for next year but remain pretty much the same. It is hoped that by scoring again it will encourage those Granges that need a little help with officers will ask their Pomona Grange for assistance, thus encouraging and promoting visiting among our Granges.

We asked you to do the Sign of Caution and the Sign of Distress, and next year we will ask you to exemplify the Patrons General Sign.

During the fall visits, the Deputies asked a few questions about state session. The results of this survey are in no way a reflection of the entire membership, but only a small sampling. Many Granges that do not have delegates at State session say it is due to cost, distance or they are just plain lazy. We need to consider some changes to our session in the hopes of getting more Grangers to attend.

The Deputies worked the first degree at the one degree day we had this year. Thank you to those who took the time to travel to Dorchester for this event. Hopefully, we will have the chance to do the same again next year. I conducted a workshop at winter youth rally, and one on code reading at Spring Fling.

Steve Tracy continues to do good work in the field. Steve is able to do things many of us cannot or will not do, talk to strangers. Croydon Grange is doing well and Steve is working hard in Claremont and some other areas as well. Keep up the good work Steve.

Rusty Hunt was here in April to train us on reorganizing and reinvigorating Granges. We now have a good group of members who can and will come to your Grange and help. Please ask your Pomona Grange Master if your Pomona has a team available, or contact Bob Trombi, our Visioning Deputy to schedule a team to visit your Grange. I do not believe any Grange should close or consolidate without a Grange Growth team meeting with them at least once to see if there is hope for them to continue.

Two of our deputies are retiring after this session. Donald Ross and Marie Hall have given many years of faithful service to the Deputy force, and we wish them well in their future Grange journeys.

Your Deputies have traveled over 24,000 miles this year in service to the NH State Grange, with the General Deputy having over 9,000 miles of this total.

The top scoring Grange this year is Wicwas Lake Grange #292 of Meredith Center. One year ago, this Grange was nearly ready to close. However, a few dedicated members kept meeting each month, and since September of 2010, they have had at least 16 at every meeting, and usually over 20. At their October meeting there was 35 members. I would like to congratulate their Master Steve Durant and the members of Wicwas Lake Grange for their hard work to restore this Grange.

In closing, I would like to thank the Deputies for their hard work this year. I would like to say thank you to the State Master for giving me the opportunity to serve the NH State Grange as your General Deputy. I enjoy this position, visiting Granges, answering questions and helping where ever I am able.

Remember, the Deputy Force is here to assist your Grange, please do not hesitate to ask.

Honored Guests, Fellow State Officers and Brother and Sister Patrons:

It is an honor for me to deliver my first *Masters Address* as Master of the New Hampshire State Grange. Let me start off by saying that, "this entire year has been a whirlwind!" After installation of our State Grange officers, on October 31st, at the Winchester Town Hall, I was very excited about Trick or Treat that evening but, because of the length of the day, and after enjoying coffee, with my closest friend David Corliss, I prepared for Trick or Treat by getting the candy into a bowl, turning on the light, and I promptly fell asleep on the couch, not awakening until 8:30PM! I missed the entire event! The following Saturday, Past Master Beth Merrill and State Assistant Steward and 2nd delegate to the National Grange Arthur Merrill, and I left for Charlotte, North Carolina.

I thank the Merrill's for taking me under their wing, and guiding me through the process of going to National Grange as a delegate. I am pleased to have had the opportunity to serve on the Taxation and Transportation Committee. I thank Pete Pomper, the National Grange Lecturer, for his mentoring of me at the National Session, as well as the entire year.

When I became Master of this State Grange, I laid out a set of priorities for our State Grange. This *Masters Address* is framed in terms of those priorities. Please, take some time to review them.

Grange Growth: We wanted to grow the Grange in NH this year. Did we succeed? Here is what we did to accomplish that.

- We asked each Pomona Grange to appoint a Grange Growth Team to help strengthen the Grange in each Pomona jurisdiction.
- We appointed two special Deputies, an organizing Deputy Steve Tracy, and visioning Deputy, Bob Trombi. They will scout potential locations to organize new Granges, and to assist struggling Granges.
- We hosted a New Hampshire Grange Growth summit, during the month of April, in Hooksett. We asked each Pomona Grange Growth Team to spend the weekend with National Grange Leadership -Membership Director Rusty Hunt.

RESULTS:

- **POMONA GRANGE GROWTH TEAMS:** We had eight out of eleven Pomona Masters commit to our Pomona Grange Growth Program, by appointing full teams. Two additional Pomona Masters committed by appointing partial teams.

- **SPECIAL DEPUTY PROGRAM:** Bob Trombi, served as our Visioning Deputy, with the responsibility of helping Granges reshape their destiny and their mission. Bob had no opportunity to work with any Grange. Steve Tracy, our Organizing Deputy, worked this year to re-organize Claremont Grange with several meetings. Steve has also traveled to the North Country and worked with two additional Granges.
- **Pomona Grange Growth Summit:** The summit was held April 15-17 at the State Grange Building in Hooksett. We had forty one members who share an interest in growing the Grange. These member worked to become proficient in team training, to go into our local Granges, and try to” help them help themselves!” We visited four Granges that day practicing our skills. Mistakes were made in the organizing of this event but, these were more process than content. Anne Boisvert, Membership Director of the New Hampshire State Grange, “nervously” presided over the three day summit. Anne did a fine job putting this event together, thank you Anne. At this time zero Granges have been visited by Grange Growth Teams!

FOCUS ON RITUALISM: As I traveled the State, I heard members talk about how they missed the ritualism of the Grange. Thus we made the following changes:

- We re-instated Deputy Instructions and Inspections.
- We asked each Grange to exemplify the “sign of caution and “sign of distress.”
- We advised each Grange we were going to instruct and inspect on the opening and closing ceremonies.

RESULTS:

- The Deputies visited each of the sixty six Granges and collected data. Some of the data collected is:
 - Did the non-profit incorporation with the State of NH get renewed?
 - Was the 990-N post card filing with the IRS completed? As well as other financial data.
- During the spring visit, each Deputy imparted the sign of distress, and the sign of caution, with instruction that each Grange would be asked to exemplify these signs for the Deputy in the fall.
- Granges were inspected, on the opening, and closing in the 4th degree.

FUNDRAISING:

- At last year’s State Grange Session, the Delegate body set a fundraising goal of \$5,000.00
- We appointed a fundraising Chairman, and Committee, and charged them to come up with fundraisers to help support our organization.

RESULTS:

- The State Grange fundraising Committee raised a grand total of \$6,490.00

IMPROVE COMMUNICATIONS:

- We tried to improve communication by starting the Grange year having three area meetings.
- January 15th in Dalton,
- January 22 at Rochester
- January 29th at the State Grange Building in Hooksett.

- We asked each Department Director to do a mailing to our local Granges on a quarterly basis.

- We seek to improve Web Content and have created a Face Book page.

RESULTS:

- **AREA MEETINGS:** These meetings, as a whole, were well attended. Thank you to the State officers, Committee Directors and to the Granges who hosted us. I believe by having these area meetings we were able to bring the State Grange closer to our local Granges.
- **QUARTERLY MAILINGS:** We were not as successful as I had hoped. We did not get a mailing out to each Grange from each Department. I thank those Department Heads who did manage to get a mailing out each quarter.
- **IMPROVE WEB CONTENT:** Thanks to Webmaster, Wayne Turcotte and Information Director, Linda Neilson, who took on the task of improving our web presence, by making sure that our State Grange website was timely and had good useful information. Thank you Wayne and Linda for a job well done! Members have commented to me how much information they are able to find on our website. Face Book is a new medium for our State Grange and a learning curve for all of us. Linda has done a terrific job keeping the NH State Grange in front of the Face Book community. She has also assisted me with My State Masters blog, "The Grange Perspective from NH".

We have taken the opportunity to examine what happened during the past year! LET US FOCUS OUR ATTENTION ON THE FUTURE!

Our 2011 – 2012 Priorities stay the same for the coming year but, "how are we going to focus on them?"

GRANGE GROWTH:

- I am asking the State Membership Department to run a state wide promotional T- Shirt contest. The winning design to be printed and shirts awarded, to any member who brings in a new member.
- I am asking each Pomona Grange to take in at least three new members during the current Grange year.

- I am asking each member to make an effort to invite one person to join the Grange this year. I would like every member who invites someone to drop me a line telling me who they invited and the result. I will provide pre-addressed post cards at every event that I attend.
- I am asking each Pomona Master to select a Grange, within his or her jurisdiction that is struggling to assist them with revitalization.

FOCUS ON FUNDRAISING AND FINANCES:

- I am asking that we raise \$6,000.00 during the coming year.
- I am asking that we take a retrospective look at the current format of our State Convention.

FOCUS ON RITUALISM:

- We will ask every Grange to exemplify, and demonstrate, two pieces of secret work for the Deputy this year.
- We will ask every Grange to open in the 4th degree at least once per quarter in the coming year.
- We will ask every Pomona to select a Degree to exemplify, and demonstrate, during this coming year.

IMPROVE COMMUNICATIONS:

Communication in our order is of vital importance! The modern world is not going away. We need to continue using communication platforms, such as our State Grange website, Face Book, and Blogs.

- We will ask each State Director to offer quarterly mailings; due to high cost of postage we will encourage the distribution of this information via the grapevine.
- We will ask each member that has e-mail access, to assist us with communication by printing this information, and sharing with our fellow Grange members.
- We will ask each Pomona Grange Secretary to assist us by printing copies of this correspondence and distributing it to each Subordinate Secretary.

Outside of these priorities **our State Grange needs a project!** I propose we go back to our ritual where it talks about “Feeding the hungry helping the fatherless and the widows.” In this day and age of economic struggle the statistics show one in six Americans or fifteen percent are living in poverty! My proposal is that we work in partnership with local food banks to do food collections and collect 2,000 individual food items for distribution to those in need!

Sometimes you are away at other people’s Grange meetings, when you are really needed at your own. Thank you, Arlington #139 for your continuing support.

Annual Report to the Delegates of the New Hampshire State Grange

Worthy Master, National Representatives, Officers, Delegates, Brothers and Sisters all, thank you for the opportunity to report on the activities and status of the charitable foundation. I first would like to report that we have lost three of our officers. Ken Berry and Marie Hall our Treasurer and Secretary respectively terms have expired and they have chosen not to renew their tenures as Directors. Our Chair, Jean Abbott, has also decided to resign her position not only as Chair, but as a Director. We accept all three resignations with regret and thank them for their hard work and dedication to getting the Foundation started. We wish them well in the future and hope to see them back someday.

The foundation has of course, completed all of the startup requirements of a charitable foundation. It is a separate corporation from the State Grange and a 501c3 complete with by-laws. We did make some minor changes at this year's annual meeting to the by-laws. We are about to set goals for the next year and assign tasks to board members to complete the organizational phase of the Foundation and then begin the fund raising efforts. We will start with things like putting a policy manual in place.

Last year we grew the number of directors from 5 to 10 and this year we will add one more. On November 1 we have a Directors meeting at which we will add the 11th Director. Our directors now consist of 5 Grangers: Ruth Holmes, Linda Lauer, Henry Parkhurst, David Boynton and I. We also have 5 non-Grange Directors: Lorraine Merrill (Commissioner of Agriculture), Gail Jellie (Director of Agricultural Development at the DAMF), John Porter (UNH Cooperative Extension specialist emeritus), Sandy Salo (immediate past chair of the Associated Women of the Farm Bureau), and Bob Bernstein (Co-Director of Land for Good). We will elect one more Director next week.

We postponed election of Officers until the next meeting, on November 1, so that we could have a full slate of Directors for the election. In the short term, without a Chair or a Treasurer, we elected an interim Chair and chose Ruth Holmes and me to act on any financial matters that come up until the election of new officers.

We received \$99K from the estate of Clarence Sprague. We have not signed off yet on the receipt, since it was supposed to be \$100 K. The money is invested with Morgan Stanley Smith Barney. We also voted at the last meeting to name the Scholarship the Clarence Sprague – John West Scholarship.

We look forward to a working relationship with the State Grange.

State Grange Building Co-Director Anne Boisvert was called upon to give her report.

State Grange Building Report:

This was quite a transition year for the State Grange Building. Paul and Rhoda Davis retired from summer lawn maintenance and Claire Gagne retired from cleaning the building. Chris Heath has recently been hired to do both of those jobs. The Pansy Rebekah Lodge surrendered its charter, and the Grange is in the process of reclaiming the storage room the Rebekahs had been renting. The basement is still a bit of an issue, but it didn't have a drop of water in it even after Hurricane Irene, so there's hope. The durable medical equipment formerly stored there has been removed, opening up some storage space. A committee has been formed to get the historical artifacts in the basement properly taken care of and will meet there in mid-November to begin the process. Orkin Pest Control continues to check in on the building after an issue with carpenter ants last year.

The assembly permit was again renewed with the Town of Hooksett. With the replacement of one emergency light and a couple of smoke detectors, we passed the inspection without incident. The Knox Box ordered last year was mounted outside the building to hold keys to allow the Police or Fire Department access to the building in an emergency. The furnace was cleaned this fall and the fire extinguishers inspected. New energy star rated lights were installed in the kitchen since the old lights were working intermittently at best.

Hannah West has continued with taking reservations for the use of the building and arranging for the pick-up and drop-off of keys. Several groups have used the building for baby showers, birthday parties, and other such gatherings. Local Granges, the Gun Club, the NH State Grange Executive Committee, and the 2013 National Grange Hosting Committee have all been meeting at the building. Many other events such as the Grange Growth Summit with Rusty Hunt and the February Youth Rally were held there. The most unusual was of course the culmination of the Kiss the Pig challenge with live pigs penned and kissed behind the building.

The goal for the coming year is to get the basement under control and to spruce up the building and landscaping in preparation for visitors from across the country when the National Grange meets in NH in 2013.

Annual Report to the Delegates of the New Hampshire State Grange

Worthy Master, National Delegates, Fellow Officers, Delegates, Brothers and Sisters all, thank you for opportunity to report on the activities of the State Legislative and Agriculture Dept. You will notice that the Legislative and Agriculture Department is not giving awards at the banquet this year. Neither Legislative nor Agriculture awards will be presented tonight. Last year the recipient of the Legislative Award was not available for State Session. We presented the award at the Grange closest to his home, which happened to be Pine Grove. Master Linda Lauer allowed us to present the award at her regular Grange meeting. I was so pleased with that process that we are going to try it again this year with all awards.

During November, I will travel to several Granges around the State to present several awards. This means less travel for recipients, and an opportunity for me to visit Granges around the state, and it gives the local Granges a chance to host award winners. Who knows, maybe we can gain members as a result.

This year we are going to begin a new award, entitled a "Friend of New Hampshire Agriculture". This will show case individuals who are not necessarily farmers but go the extra mile in support of agriculture in the state.

We are in the process of reviewing all of the policies in our policy manual. About a third are done, thank you Sister Tara, a third are in process and a third to go. We suggested to National that we hold the 2012 Legislative Fly In here in New Hampshire for the First in the Nation Presidential Primary. Since it was moved up, we are concerned that we cannot pull it off.

Last year's Fly In went very well. NH had a large contingent go to DC for the event. We all lobbied the whole 4 person Congressional Delegation. We went with four specific bills to lobby for and while there requested support for NH agriculture from the delegation. We felt as though we worked together well as a team. The State Master and I were pleased to see that our Senators especially, work together on many non-partisan issues. While we were in Washington, several of us from New Hampshire along with Nation Master Ed Luttrell searched for and found the graves of 4 of the Founders buried in Washington.

In April at Spring Fling we hosted a panel of NH elected officials, who happened to be Grangers. The event went well enough that we will do it again next year. We also hosted a third Grange Day at the State House that included attendees sitting in the balcony during house session and a proclamation from the Governor.

The State Grange now has a seat on the Farm Bureau's Government Affairs Committee and on the Ag in the Class Room Board.

State Historian Report 2011

Worthy State Master, State Officers, Honored Guests, Patrons All!

It is a pleasure to present my report as your State Historian. Another year has passed and I can't believe how much this organization has done throughout the years. Despite the change for some members as they cope with going from a large membership to a smaller one, the result is the same. They continue to be active in their communities. The farms have gotten

smaller or closed and sold their animals to other farms. In some cases agriculture has increased with farming on a different scale. The members continue to write history without knowing it. It saddens me to see some members just going through the motions until they reach their 100th anniversary. Many think the Grange has no place in today's world. This is so wrong, so wrong. I would be so happy to assist a Grange to write their history or even make contacts. The State Grange Journals provide so much history and important information when someone calls looking for their relatives or Granges in their community.

This has been a busy year for the State Historian receiving telephone calls from people asking for information about their relatives or Granges they were involved in. I have had several calls about certain Granges in Alton, Concord, Dunbarton, and Lebanon.

As I was reading the various State Grange Journals, it was tradition that a speaker came from the Department of Motor Vehicles each year to report on the progress of the agency. It was reported the State Grange was active with this State Agency. One day, when I was riding with the Department of Fish and Game, the officer who was driving informed me of the State Grange's involvement in that agency. I told him that I couldn't believe it. He suggested I could find some information in the 1911, 1912 State Grange Journals. It seems the State Grange was very much involved in our State Government.

As I read the Memorial List this year for our Grange, I can't believe the names of the members who have been called to the Great Grange Above. It seems more and more members from our generation are being called to the serve our Great Master of the Universe. Whether we realize it or not, we write history for our home Grange as well as for the Pomona and State Granges every day. This year, we lost several members of the Pink Sash Family who at one time or another were very active in the office or committee post they held.

Rita Morgan served as State Ceres when her late husband Asa was State Master in the late 1950's to early 1960's. Asa and Rita held membership in Hooksett Grange and were very active not only in the Grange but in community affairs as well.

Speaking of Past State Ceres, many of us were very sad and surprised to learn that Doris Saturley had passed away. Despite being a school teacher before she retired, she managed to find time to accompany Past State Master John Saturley around the state when he was serving as State Master and as a position in the Assembly of Demeter. Doris taught school in several communities retiring from the Concord School District. Sometimes Doris would have a funny story that didn't seem like her. She would look stern, but she also had humor that you wouldn't expect her to say. I remember the story how when we met in the Northern Sector, their vehicle had problems and knowing a lot of Grange members would be coming down I-93 through the Notch, she stood out by the side of the road giving one of the Grange distress signs. People thought she was waving to everyone as they passed by.

Laura Eld left our Grange circle to join her friends from the Seacoast who are with our Heavenly Father. Laura served as Master for Ocean Side Grange trying to hold the Grange together. Laura served on the State Grange Home Economics Committee for several years. She could be very funny, but she could also tell you in no certain terms how she felt on a certain Grange item as well.

Abbott Rice from Wattannick Grange served his organization and town very well. He and his wife Annie would travel many Grange miles. You could see them at Grange functions in New Hampshire and also surprise us at New England Grange meetings such as New England Lecturer's Conference or New England Youth Rally. Abbott served on the State Legislative Committee in past years.

Winfred Campbell answered the call of our Great Master of us all. He needed a Grange Deputy and Win was more than capable of serving. He and his family were the rock of Warren Pond Grange. He assisted in the Installation of Grange Officers with the late Barbara Briggs or some other Installing Team. He and his family were dedicated Grangers who worked very hard in whatever capacity they were needed in. He and Marilyn were so proud to see their daughter Jane become a State Grange Officer along with son-in-law Bob and grandchildren become equally involved in the Grange and other community activities. Win served as General Deputy for Past State Master Everett Poore among his years as a Deputy.

As I look at the many members who have gone to the Great Grange above, some have never served on the State level. However, they will be missed and certainly wrote history in their own Grange. Many Granges have families who are the core of that Grange.

Here in the Shelburne/Gorham area, one such family was the Hayes family. This year, Florence Peabody left our circle to join her brother and several sisters. Florence held membership in Winthrop Grange along with serving as an officer and committee member. Florence was sister to Chet Hayes whom many will remember.

Herman Walker was a Grange member who along with his wife and daughter loved to bowl. Each year they would compete in the annual State Grange Bowling Championship. Herman would stand there studying the other bowlers, checking scores, and hoping he would be selected to the championships when they had a second round.

Speaking of bowling, the Grange Tournament lost a very competitive bowler David McLean who represented Wingold Grange. David was a Class A bowler and believe me he released the bowling balls with gusto. David didn't say much, but he was a big competitor in the tournament.

Marilyn Stevens from Chichester Grange was a member who had a disability, but never let that bother her. She held the office of Assistant Steward among others, but she had a hand

disability. However, she never complained and was a very valuable member of Chichester Grange.

I could write more and more about brothers and sisters who have left us. I am sure that many of them have already notified our Heavenly Father they are ready for Grange work. As I close out this portion of the members, I would like to end up with the death of Noreen Crawford who served as my Pianist when I was your State Master. I remember the day I asked her to consider being my State Pianist. She was so excited to be asked. And she did a very good job. I told her that if she could play my favorite march "Spring" she would be all set. She did and did an excellent job. So many times she felt she wasn't good enough because of some of our past pianists. I always told her that she was good and not to worry because she was creating her own path. Noreen also served on several other State Committees. Losing Noreen was tough because she was on my team, but also was from the baby boomer time.

I have finished the book I was writing and it is now is being edited. From there I am not sure what will happen. It has been fun remembering the old times for the baby boomers, remembering the wacky games, serious times when the Deputy would attend a meeting, and the protocol at State Grange Conventions.

I hope your Grange whether it is Subordinate or Pomona, has taken the time to compile a history. If not, I would be happy to help you in any way possible. It is important to stress the great things your Grange has done throughout the years. I am sure that you will see the many wonderful projects that have been done in the community by your members.

There are also Grange materials in the basement of the State Grange Building that came from Granges who have closed. If you have a neighboring town that once had a Grange, check with the Library or Historical Society to see if they would like the materials.

Report of Master's Address Committee

Worthy Master, Distinguished Guests, Officers of the New Hampshire State Grange, Delegates, and Patrons:

We present the following response to the Address of New Hampshire State Grange Master Jim Tetreault. We commend the Worthy Master on the time and commitment that he has dedicated to the Good of our Order and to advancing the interests of New Hampshire Patrons of Husbandry

We as a committee applaud the priority given to efforts to grow the Grange during the past year through appointment and training of Grange Growth Teams and the appointment of an Organizing Deputy and a Visioning Deputy. As our distinguished visitor Sister Sharon Croucher, Lecturer of the New York State Grange, reminded us on Friday evening, the Grange cannot be stagnant like a pond, but must be like a lake, with the constant influx of new people and new ideas. We as a committee, however, are concerned about the lack of

response to the availability of the Grange Growth Teams. We encourage Subordinate Granges to ask a Grange Growth Team to visit and share the knowledge that they gained at the Grange Growth Summit. Regardless of the size of our individual Granges, there is always a need for growth.

We commend the renewed focus on ritualism that has taken place, and welcome continued attention to this important aspect of the Grange. We also appreciate the fact that, through the collection of data on 990-N filing status and non-profit incorporation renewal as part of each Deputy's visit, potential problems for individual Granges were proactively identified and prevented.

We applaud the efforts of the Fundraising Chairman and Committee during the past year, and were pleased to hear that they had surpassed their 2011 fundraising goal. We encourage the continuation of fundraisers that involve the general public as well as Grangers, not only because it eases the financial burden for individual Grangers, but also because it provides an opportunity to tell the public about our organization.

The Worthy Master's efforts to improve communications are commendable. Response to the three area meetings that were held in January was overwhelmingly positive, as was response to the increased web presence.

We move on to the future of our beloved New Hampshire State Grange, and to the continuation of 2011-2012 priorities. Increased emphasis on Grange growth is, in the opinion of the committee members, becoming more important as we approach the 2013 National Convention in New Hampshire. Each of us needs to encourage our Subordinate members to continue on their Grange journey and complete the 5th and 6th degrees this year in order to complete the 7th Degree in 2013. An opportunity for a National Grange meeting this close to home may not come again for some time. Taking in at least three new members in each Pomona Grange in the coming year is a worthy goal, as is asking every Patron to invite one person to join the Grange.

The increased fundraising goal of \$6000 is, based on 2011 performance, achievable with some effort on everyone's part. The goal of looking at the State Convention to make it more affordable is admirable, but the committee members feel that keeping the Convention in a single location year after year should not be examined as an option.

Continued prioritization of ritualism in 2012 is welcome and reminds us of whom we are as Grangers. We have been and continue to be a fraternal organization.

The committee agrees with the Worthy Master that improved communications continue to be needed. The concept of quarterly mailings from each Department Head is good but, in order to contain costs, must rely to some degree on transmission via a central distribution point. We encourage each Subordinate and Pomona Grange to identify a central contact point for electronic communications, with that person being responsible for printing and sharing electronic communications that are received from Department Heads.

The ritual of our Order speaks of "...feeding the hungry, helping the fatherless and the widows." Recognizing the existence of economic struggles of so many of our fellow

Americans, the committee highly recommends that the Worthy Master's proposed project to partner with local food banks be adopted. We also encourage local Granges to consider working with their local media to publicize the good works that are performed every day by New Hampshire State Grangers but which tend to go unrecognized.

Finally, the committee thanks you, Worthy Master, for the privilege of serving on this committee.

RESOLVED, Article XIV, Section 9, Division 1 First sentence “The Subordinate Grange will petition...” be changed to read “The Subordinate Grange shall petition...”; and be it further

RESOLVED, Article XIV, Section 9, Division 3 is changed from:

Division 3. Upon final approval of the State Executive Committee to sell said property, the New Hampshire State Grange will act as an escrow agent for said Grange. Upon sale of property the sum of \$1,000, if sale price is more than this amount, may at the discretion of the Executive Committee of the New Hampshire State Grange be left to the control of the Grange selling the property. This is provided that the Grange does not intent to surrender their charter. The remainder of the sale price will be placed in an escrow fund with the New Hampshire State Grange and controlled by the Executive Committee of the New Hampshire State Grange. The New Hampshire State Grange will pay accrued income on this fund to the Subordinate Grange annually, if requested. Funds from said escrow account may be returned to the Subordinate Grange in such amounts as may be requested in writing by the Subordinate Grange upon a two-thirds vote of the New Hampshire State Grange Executive Committee.

To:

Division 3. Upon final approval of the sale by the State Executive Committee of the New Hampshire State Grange, said Committee will act as an escrow agent for the Subordinate Grange. If the net proceeds from the sale is \$1,000.00 or less the Subordinate Grange may retain the entire amount provided it does not intend to surrender its charter. If the sale proceeds exceed \$1,000.00 the excess amount shall be assigned by the Subordinate Grange to the State Grange. Funds not retained by the Subordinate Grange shall be held in an escrow account controlled by the State Executive Committee. The State Executive Committee shall pay annually, in the month of April, to the Subordinate Grange, upon written request from the Subordinate Grange, accrued income and such portions of the principal as the Executive Committee approves, by a two thirds vote. Requests for portions of the principal shall be in writing, include reason for request, and be submitted at least four weeks in advance.

RESOLVED, that said Sales Tax be capped at two (2) points lower than the average of the five (5) remaining New England states.

The Committee recommends the insertion of “for the State of New Hampshire” after State Sales Tax in the first resolved.

This resolution was amended and defeated by the Delegate Body.
