Centerpiece entries should be suitcommunities for new members, it's chalable for round table seating and shall be no taller than eight inches. Special consideration will be given to entries that conform to the convention theme "How Sweet It Is" and/or the goal of the Northeast Connection to make this an environmentallyconscious convention. Use of recycled components (cans, glass, plastic, etc.) is encouraged, as long as these components are easily available in larger quantities for "mass production" of the selected winners in each category.

Table favors can be designed to coordinate with a specific centerpiece entry or may be submitted as a separate entry.

A list of materials used must accompany each entry along with a label that identifies the name, Grange, and state of its creator and should also include the category and meal function for which the entry is intended.

It's important to keep in mind that centerpieces may be awarded to "lucky" diners at the conclusion of the meal function. Therefore it is helpful if they can be easily dismantled and packed away in luggage, or the unnecessary parts thereof disposed.

State Grange Historian Richard Patten

The Historian telephone has been busy since the last issue. I have been asked to find information about Granges in Laconia, Orford, Meredith, Tilton, and Colebrook. I have been enjoying doing the research about the Granges that were located in those towns. I have finished my book that is based on memoirs I have remembered. I have tentatively titled it "The Grange As Seen Through The Eyes of a Babyboomer 1966 to 2011". I am trying to find a publisher but unfortunately the cost is more than I can afford. I will start now on an official version taking up in 1998 to 2011. I will be covering State Masters Dan Bascom, John West, Beth Merrill, and the beginning of James Tetreault's term.

I have been also working with the NH State Police on the Grange History as they are getting ready to celebrate their 75th anniversary on October 13. They are having a banquet at the Courtyard by Marriott in Concord

Looking back to 1952, I found that the Granite State Granger made its initial visit in May of 1952 according to the State Master's Address. It further stated, "the subscription cost is small and the information that is contained therein will be most helpful in your Grange work. This magazine will be a contributing factor toward developing interest and enthusiam among members, which will ultimately reflect its purpose, that of having the members realize the significance of the organization of which they are a part, and which continuously renders service for the betterment of agriculture and community environment, thus realizing the need of improving our State, Pomona, Subordinate, and Juvenile endeavors. Nothing is more important in the growth and success of an organization than publicity." The State Grange also acknowledged the efforts of Fred E Beane, Editor of the Farm Page, Manchester Union Leader, for his time in keeping the activities of the Grange

news before the people.

The upcoming State Grange Session will feature resolutions for the delegates to vote on, whether it is public affairs or Grange related. In 1952, delegates were faced with a resolution stating no person may hold the offices of Master, Overseer, Steward, or Gatekeeper for a period of four years. The report of the Constitution & Bylaws was negative.

Another resolution passed by the delegates was favoring one meeting in July and August for all Subordinate Granges in New Hampshire. They did not recommend adoption of omitting meetings altogether in July and August knowing they would suffer in their literary and deputy scores. Today many Granges are meeting in the summer and omitting one each in January and February or not meeting at all in January and February.

The State Executive Committee voted to incorporate the Home for the Aged. The paperwork was filed in Concord at the State House. The State Master announced the name of the organization shall be "The New Hampshire Grange Home Incorporated." The Articles of the Incorporation were read and accepted. The purpose was to provide and maintain a home for Grange members.

The members who are alive today and were delegates to the 1952 session included: Richard Currier, Harmony; John L. Saturley, Pembroke; and Carl Adams was State Gatekeeper. There were 411 candidates for the Degree of Flora. In that class I found Ina Anderson of Rumney; Velma Pope, Bennington; Glenn Pease, Orford; and John L. Saturley, Pembroke. I also discovered my great uncle, Carl Patten of Bristol, was a candidate.

Well, it is time to close the 1952 Journal of Proceedings for now. Oh, and 1952 was my year of birth. Have a great rest of the summer and now it is time to count down the days to the State Session. Let's make it a great one.

Home Grown Politics Across New Hampshire Farmland to Concord and Washington **Bob Haefner** Legislative and Agriculture Dept.

Grace Boatright at the National Grange office has been selected and promoted to the job of the Grange Legislative Director. I think Grace was a great choice. Grace actually put this year's Fly-In together. I believe she has some good ideas that she wants to bring to the job. Grace will be writing a blog periodically, so watch for it.

In a couple of past Columns, I have talked about the ongoing saga of getting federal approval for our NH state meat inspection program. The saga continues. We sent a joint letter from the Department of Agriculture Markets and Food, the House Committee on Environment and Agriculture, and the Senate Natural Resources Committee to Tom Vilsack, the US Secretary of Agriculture, asking him to overturn his food safety people and approve our NH Meat Inspection Program. We have done some lobbying of his staff beforehand. All four members of our Congressional Delegation are writing a joint letter to Secretary Vilsack in support of our program. That letter should be out before this column goes to press.

The State Grange continues to work with the NH Farm Bureau on legislative and policy issues. I sit on the Farm Bureau Government affairs committee, and on the day I write this article I will be presenting Grange positions on issues to the Farm Bureau's Policy Summit.

I will now discuss a couple of things that are not directly Grange events, but are related to our legislative and agriculture positions. I presented, along with Dr. Carolynn Orr to the annual meeting of the Northeast Association of Departments of Agriculture. The topic was Animal Rights groups.

I just came back from a few days in New Jersey at the annual meeting of the Council of State Governments – Eastern Regional Conference. Representative Tara Sad, a fellow Granger; three other

Representatives; and A Senator from NH went to the meeting. We passed a total of seven resolutions, four of which came out of the Agriculture Policy Committee. Two of the seven were sponsored by NH.





New IPM Guide for Affordable Housing

Integrated Pest Management: A Guide for Affordable Housing is a new resource from the Northeastern IPM Center that will help affordable housing managers, owners, and agents use integrated pest management (IPM) to contend with a variety of urban pests in their facilities. It will also serve as a useful tool for anyone seeking to integrate IPM practices into a residential pest management strategy. The illustrated, 81-page guide gives readers

- a basic knowledge of pests and pesticides to help them make informed pest control decisions with a pest management professional;
- an understanding of how to implement IPM in housing;

•and tools to orient staff to their role on an IPM team.

Developed as part of a project called "Delivery of IPM Training to Public Housing Authorities," the guide was supported through an interagency agreement between USDA's National Institute of Food and Agriculture and the HUD's Office of Healthy Homes and Lead Hazard Control. The guide is based on the IPM in Multifamily Housing Training that is reviewed and supported by the National Center for Healthy Housing, Regional IPM Centers, National Pest Management Association, Pennsylvania IPM Program, National Center for Environmental Health Strategies, U.S. Centers for Disease Control and Prevention, U.S. Department of Housing and Urban Development, U.S. Department of Agriculture, and U.S. Environmental Protection Agency.

When the furnace at the State Grange Building was cleaned this summer, the technician reported that one of the legs supporting the oil tank showed rust damage and there was some oil at the bottom of the tank on the outside. I have stabilized the oil tank with a support structure made of pressure treated lumber. I don't think it will be going anywhere any time soon.

I also sprayed the parts of the tank I could reach with Rust reformer and neutralizer. The tank does not appear to be leaking as far as I could tell. I think the oil we are seeing is from years of accumulation from the fill pipe weeping a little on the top. That seemed to be the opinion of the oil company technician as well, when Anne talked to him on the phone.

The next plan is to remove the wooden cabinet next to the tank to be able to paint that side of the tank, but more importantly to replace the existing uncoated copper oil line with a coated oil line in a conduit to further reduce the risk of any issues in the future. When the air conditioner was serviced, the technician recommended that we bolt a piece sheet metal to the ductwork of the air conditioner to direct the water away from the furnace.
