An Appeal from National Master Ed Luttrell and the National Grange Executive Committee

The Grange grew from a small group of individuals with a dream, through lean years to a powerful and respected national organization with a local focus. Today we face challenges as serious as any in the history of our Order as our finances and our very authority for existing are under attack from two fronts.

Trademark Issue

The Grange has redressed many attempted infringements upon our name in the past six years, consuming more than \$2 million in that time. The National Grange has been obliged to expend this amount defending our good name, which has been rightfully ours for nearly 150 years.

These cases continue to consume our budget. Added to this, our members and staff continue to find additional infringements regularly. While most are settled amicably, all take money and time.

California Issue

You may be aware that the leadership of the former California state Grange declared last November that they are no longer part of our organization or subject to any of our rules. Yet they claim they are entitled to take our name and assets in California. This position not only affects the future of the Grange, but every national organization that charters subordinate units. Our Order cannot allow a precedent such as this to be created.

We are currently in both federal and state court to protect our Order, as the actions of the former California State Grange truly imperil the entire structure of the Grange. It has been the National Grange's belief that while we must fight to win this issue, we must do so as Grangers, maintaining the high ethical standards that our personal obligations require.

The good news from California is that delegates of 24 Community Granges have voted to reorganize the State Grange and the Charter has been reinstated by the National Grange.

Budgetary Impact

In the last six budget years 2008-2013, only 2009 and 2013 were deficit years for finances. However, in order to continue the effort to protect the Grange from both internal and external foes, the National Grange has reduced expenses as much as possible, both by cutting some budget items completely and reducing others to a minimum level. The big problems are that dues from California are missing from our income, the headquarters building had only been rented at a 90 percent level for the past year (now at 100 percent), and attorney expenses continue to be much higher than projected for both trademark and California issues. All other line items are near or below budgeted amounts.

Grange Advocacy, Inc. (a 501 (c) (4) organization) was formed in 2013 and the Grange Foundation (our 501 (c) (3) organization) was updated to meet the requirements of today. Both are vehicles that can be used to increase the influence and work of the Grange without additional Grange money. We are exploring ways of increasing revenue through the trademark, as well as other viable fund-raisers. In the short term we are seeking loans through State Granges and affiliate companies to remedy cash flow shortages.

Solutions

The National Grange has developed a detailed plan which contains the current situation, options, and actions we are taking. That plan has been given to each State Grange Master and National Officer.

We are conducting this appeal in hopes that our members will recognize

that our Order is one organization with different divisions or levels, and that each member has as much invested in the National Grange as they do in their Community Grange. We are exploring every possible way to generate additional revenue.

We are in process to borrow \$250,000 from a State Grange that has offered to help and may need to borrow more in the future. We have calculated that we can borrow what is needed and pay it back in ten years starting in 2016, but the National Grange Executive Committee would rather not borrow any more money than is absolutely necessary.

The National Grange officers and State Grange Masters each believe that the Grange has great value to our members, our communities, and to our nation. Some of that value is material benefits and much is in the opportunity to learn, grow, and make a difference through the organization. **Your assistance in recruiting new members and in aiding the National Grange is needed today.**

Home Grown Politics
*Across New Hampshire Farmland
 to Concord and Washington*

Well, the elections are over and New Hampshire is returning to normal for at least a little while. No more mail boxes stuffed with candidate literature, no more attack ads in the mail box or on TV, no more phone calls or, worse, robo calls. The top of ticket races were certainly negative. I wish we could be positive and run on our records and qualifications without trying to destroy our opponents. I did not make a single call, let alone a robo call. I mailed nothing and of course no TV or radio ads. I just ran on my record and my qualifications

The results of the election were interesting. Nationally the Republicans made big gains, all across the country, while here in New Hampshire we had a mixed bag. Governor, Senator and one of our two congressional districts went Democrat, while the same folks voted to give NH a Republican Majority in both houses and the Governor's Council. I only draw two conclusions. We are a purple state and "All politics are local." I guess name recognition and the candidates also matter.

This year the Legislative and Agriculture Department has given three awards at the state level. The Legislator of the Year was presented at the annual awards banquet to retiring State Representative David Campbell (d) of Nashua. Dave sponsored the gas tax increase that finally passed after his trying for years. Rep. Campbell was persistent and finally passed a bill that raised the so called road toll by 4 cents. I was one of only 17 Republicans to vote for it, but feel no guilt at all. It has been more than 20 years since the last increase. Asphalt costs have increased hundreds of percent and automobile gas mileage has increased significantly as well, leaving fewer and fewer highway dollars to fix our roads. I personally want to see the I 93 widening completed. That will be good for tourism and commerce and my commute.

Hillsborough County Pomona will be the host for the awarding of this year's Century Farm award, going to Brookdale Fruit Farm of Hollis. The farm has been in the same family and on the same land since 1847 and is the second largest fruit and vegetable grower in the state. They were the recipient of a "Farm of Distinction" award a couple of years ago. Dr. Christina Murdock, DVM is the winner of our "Friend of NH Agriculture" award given at Hudson Grange. Dr. Murdock is a graduate of Alvirne High School and their Vet Tech Program, and the FFA. She has a degree in Veterinary Medicine from Colorado State and is a large animal Vet. She is one of the few large and small animal Vets that is strictly a mobile Vet. She makes house calls for not only Elsie the Cow, but for Fido and the cat. Christina has also received an award from the NH Farm Bureau this year as one of the Young Farmers.

Your new Legislative and Agriculture team of Jim Tetreault and Tara Sad along with me look forward to the next two years under State Master Chris Heath. Our next meeting will be at Deputy School. One of the things we are looking at is to hold the National Grange Legislative Fly-In next year in NH timed for the Presidential Primary. This is a chance for State Grange Legislative Directors to fly in from all over to witness the NH First in the Nation Primary. Some other things we look forward to are: Hosting Northeast Leaders Conference in NH, Grange Day at the State House and of course Grange Day at the Big E.

I would like to thank everyone who has supported the new project by the Community Service Committee called "Santa Remembers Teens at Christmas." I am so overwhelmed by the support that has been received. We received many gift cards that will bring smiles to teenagers who otherwise might not have a gift to open on Christmas Day. Thank you for your generosity. The Christmas Season brings out the best in people and Grange members are no exception.

Grangers are known for their willingness to help others in need. I hope that you will continue to help those who are living in a shelter or struggling to make ends meet. There are many projects you can do during this time. There are Granges who adopt a family at Christmas providing gifts, a Christmas dinner, and possibly a ride to church for Christmas Eve service or Mass or Christmas Day worship.

Don't forget your own members, who aren't able to attend meetings due to the weather. Please make sure you send cards, maybe a gift, or Christmas poinsettia or Christmas cactus. Your Grange might adopt a senior citizen or a corridor at a local nursing home for the holidays. You could decorate the halls, see if they need an artificial Christmas tree with decorations, and have a Christmas party just before Christmas Day to spread a little holiday cheer. You might check with the home to see if the residents could enjoy an orange, banana, popcorn ball, and maybe cookies. You could also think about stuffing a Christmas stocking filled with little gifts. I know this sounds a lot, but these are some ideas. Don't forget the SPCA or Humane Society where the pets could enjoy treats, or surprise the staff with basket of supplies and animal food.

As we approach the winter season, it is a good time to see what your Grange can do in the neighborhood. If you have Senior Citizens living alone in their home, please remember to check on them. Ask

them if you can assist them with shoveling their sidewalks, mailbox, or steps if they have some into their home. Please offer to get their mail or newspaper if there has been a recent snow storm. Don't forget to extend an invitation to them if you are aware they are home alone for Christmas Eve or Christmas Day to enjoy dinner with your family. How about going over to offer your assistance in putting up their Christmas tree or Chanukah candle set and then take it down when they are finished?

Please talk with them about their heating system or if there is a power outage, what can they do or where should they go. Hopefully you will invite them into your home with their pet(s). See if they have a warning light that will activate if their oil furnace is not working or their oil runs out. The light should be placed in a window facing the road so someone will see it. Remember that if your neighbors aren't seen for a couple of days and you know they are home, then either call the police or go over to their home and try to raise someone. They may have fallen and can't get to a telephone for help.

Food pantries and homeless shelters need your help. Please remember the Fill an Empty Plate and try to do that once a month. Please check the codes on canned food that you are donating. You don't want to donate something that is outdated. Please check your homeless shelters to see if they need something. We need to pitch in and help wherever we can. They might appreciate magazines, newspapers, books, board games, card games, linens, pillows, etc. for the residents. It never hurts to extend a helping hand.

I know it may seem a lot for your Grange to do, I am only suggesting. You can pick and choose whatever you would like to do. Just remember the good that you are doing for someone less fortunate.

I am very proud of our Granges in New Hampshire. The reports you submitted were excellent. The judges had an extremely difficult time with the booklets. They couldn't believe the amount of work done by our members and the different projects. One judge told me it took them two days and 5 hours to narrow down the winning books. I was very happy

A Letter

November 3, 2014

Dear Worthy National Master Ed Luttrell and Worthy State Master Christopher Heath,

On November 1st my community Grange received a letter from the now-suspended California State Grange Executive Committee. After reading the letter, I feel they are showing their true colors. I am appalled at the way they are using our Grange ritual to fit their needs. If they want to quote our first degree obligation, they should quote it in its entirety.

In the presence of our Heavenly father and these witnesses, I do hereby pledge on my sacred honor that, whether in or out of the order, I will never reveal any of the secrets of this order, nor communicate the ritualistic work of this order to anyone unless legally authorized to do so. I will conform to and abide by the laws of my State and Nation; and the Constitution, rules and regulations of the Grange at all levels. I will never propose for membership in the Order nor sanction the admission of anyone I have reason to believe to be an improper person, nor will I oppose the admission of anyone solely on the grounds of a personal prejudice. I will not knowingly wrong or defraud a brother or sister of the Order or allow it to be done by another if within my power to prevent it. I will endeavor to be a true and faithful Patron of Husbandry, perform all the duties enjoined in this Order and aid others in the performance of the same. Should I knowingly or willfully violate this pledge, I will invoke upon myself suspension or expulsion from the Order."

Each and every one of us assented to this obligation and agreed to each and every line.

I believe our forefathers placed each item in the obligation in order of what they felt was most important.

1. Don't reveal the secrets or ritualistic work.
2. Abide by the laws of my State and Nation; and the Constitution, rules and regulations (By-laws) of the Grange at all levels.
3. The admission of members
4. Don't wrong or defraud a Brother or Sister.

5. Endeavor to the true and faithful.
 6. Perform all duties and help others.
- If you don't follow the first three items it is almost impossible **Not** to wrong or defraud a Brother or Sister and especially when our Constitution and Bylaws are not followed.

Our Constitution and Bylaws are the glue that binds our organization together. Without them what are we? If we lose this battle, the Grange will not be the only fraternal organization affected. This would set a precedent and the Masons, Eastern Star, Odd Fellows, Rebekahs, Elks and many others would be in jeopardy as well.

Therefore I urge each Grange and every member to assist our National Master and Executive Committee in any way possible to help save our Grange from this threat.

California Situation

In the fall of 2012 the now-former California State Grange claimed that they were not subject to the National Grange Digest.

In September of 2012 their Charter was suspended for cause.

In April of 2013 the Charter of the State Grange was revoked for cause and they did not appeal the revocation.

The National Grange has attempted unsuccessfully to seek a solution with the former California State Grange.

In November of 2013 the now-former California State Grange confirmed to the National Grange that it was disaffiliated and was no longer part of our organization.

On July 12, 2014 the California State Grange was reorganized with 24 Granges.

Due to this situation we are engaged in two separate cases against the former California State Grange:

1st: State Case asking that the former CSG follow the rules that they agreed to. This case was filed in September of 2012 and is currently scheduled for trial in June of 2015. As per normal legal actions, there is a counter claim against the National Grange. The only motion the judge has granted in this case is to delay the adjudication of the Grange charges against the former State Grange Master until the court case is concluded.

2nd: Federal Trademark infringement case against the former California State Grange. This case was filed in April of 2014. The Federal District Court we have filed in moves much faster than the State. This case should also be resolved in 2015 as the trial date is set for October 14, 2015. The former CSG has filed two counter-suits to ours. Our first motion to dismiss was favorably received by the Judge and resulted in the dismissal of one counterclaim and several of the affirmative defenses filed by the disaffiliated group, with permission to amend its

claims, if it could.

Since the fall of 2012 through the end of June 2014 the National Grange has expended \$390,879.06 in legal expenses dealing with the California situation.

In simple terms this situation is about the right of the Grange organization to have mutually agreed upon rules that all members must follow. While any member, or group of members, may choose to leave the Order at any time, they cannot take the assets (our name, the property, and money) when they do so.

It's Time to File Your Grange's Annual IRS Tax Return

This is a reminder to all Granges in NH that your fiscal year ended September 30, 2013, and now you have until February 15, 2014, to file your annual 990-N electronic tax return with the IRS. Failure to file for three consecutive years can result in a loss of your non-profit status.

The website address to file at is <http://epostcard.form990.org>. Complete filing instructions were mailed to every Grange in May of 2008. If you have lost your instructions or just need help please contact NH State Grange Treasurer Daniel Bascom, 123 Franklin Street, Rochester, NH 03867-2461; telephone 332-2164; cell phone 767-6613; or E-mail kdbascom@aol.com.

One change to the 990-N report this year is the amount of money earned. It has been raised from \$25,000 to \$50,000. So if your Grange has less than \$50,000 income you may file the 990-N report on line. The receipt you print upon completion of filing has also changed slightly.

If your Grange is unable to file on line, you may contact Dan Bascom for a paper copy of the 2010 990-EZ form, and he will mail one to you. The paper version changes every year so you must use the 2012 form this year. The paper version is also due to the IRS by February 15, 2014.

**State Grange Historian

Another State Grange Session has passed and we are now starting a new Grange year. We have a new State Master, some new State Officers, some new State Directors, and the return of committee members and deputies wearing a pink sash when they visit Granges. I know when I received a telephone call from newly-elected State Master Alton Carpenter to serve as a Junior Deputy, I couldn't wait to attend Deputy School, Deputy School and Leaders Conference was held at Ezekiel Webster Grange Hall in Boscawen for many years. There would be two hundred Grangers attending this annual event. Every Department Head and General Deputy along with State Officers would attend, be introduced, and offer remarks about new programs or dates for them to tell their members.

It was important for committee members, deputies, and other members of the Pink Sash Family to attend. This day was important because committees would meet to discuss their new program and iron out any confusion or possibly change something. It was important for committee members to try and attend Grange meetings. I have assigned members of my committee a district to attend the Granges in that district.

I was reading that in 1874, a set of By-Laws was accepted, It was up to the General Deputy and Deputies to see that the By-Laws were accepted and followed. William Stimson was the first General Deputy and in 1882 he gave his report. It was reported in 1901, that the success of the Grange in New Hampshire has been due to the caliber of the Deputies. The work of the Deputies in the field was essential to the growth of the Grange. Their Instruction and Inspection were only a small part of the work required of them. They have pitched in whenever needed, giving advice, providing degree teams, filling offices when needed, and doing their utmost for the love of the fraternity. It is stated that the work of the

General Deputy is the most difficult of all. He is the right hand of the State Master and must be responsible to the other Deputies, instructing them and tabulating their reports. He has to be aware of the other committee reports and activities of other officers and committee directors. An efficient General Deputy makes the operation go smoothly.

I enjoy reading not only the Grange Journals but the older issues that I can find of the Granite State Granger. I was reading the December issue of 1980 and found excerpts that the Editor of the GSG had printed. I thought some of them were very interesting. Here's a sampling of them:

Your Editor – "Why don't they call this meeting a Leaders Conference?"

General Deputy Edward Pratt - "I don't think we have any harder worker in this Grange than your State Master. We will ask only that you Deputies work as hard as he does."

State Master Phil Shattuck - "From now on, we won't refer to those guests attending our meetings as non-members. I ask you to refer to them as future members."

State Lecturer, Marion T. Jones - "We can look forward to State Master Phil again arranging the schedule for our bowling tournament this spring."

State Master Phil Shattuck to those wearing pink sashes - "Dress as befitting a State Officer or Committee Member.. if you wear a leisure suit, a tie is not required... but a tie goes with a dress suit. Wear your sash at all meetings which you attend except your own Subordinate and Pomona. When you are asked to fill a station, it is proper to remove your pink sash and wear the one denoting your station. Also, refrain from smoking during meetings, workshops, etc.. A smoking and relaxing break should be called occasionally during conferences, etc. If I (Phil Shattuck) can go for 1½ hrs. between cigarettes at a meeting, so can you! We realize that smoking bothers some, so please heed this."

I can't believe it was 42 years ago that I represented New Hampshire as State Prince, Diane Hewes as State Princess, and Ben and Joyce Creighton as Young Couple. Ralph Ford picked up me,

Al Carpenter (who was just elected State Lecturer), Marion T. Jones, Edna Moody from Bear Hill Grange, and Lucy Newton from Sunapee Mountain Grange for a ride to the National Grange Session in Hartford, CT. I was so timid, not knowing what to expect. I didn't have a lot of funds so I was very careful. I did meet a lot of youth from the other states. There were 310 members from New Hampshire who took the lessons of the Seventh Degree or Degree of Ceres. It was very impressive and different.

There were 4649 candidates who took the Seventh Degree. Bill Steel was the National Grange Youth Director at the time. I remember at the Home Economics Luncheon one of the waiters spilled gravy on my suit. I didn't say anything but several staff members came right over and got my suit jacket cleaned at no cost. I only had one suit and that was it, but I didn't say anything. When I had my interview, I had no idea two of the judges had sat at my table when this happened. I couldn't believe it. They told me I was so nice not to lose my temper.

I guess that's it for this time. I hope everyone has a Great Christmas and Happy Grange New Year in 2015!




