Resolution #5 ~ Submitted by: Claremont Grange #9 Subject: Safety of horse riders, horse drawn carts and carriages

WHEREAS: There is a law in NH to protect the safety of bicycle riders with very specific guidelines RSA **265:143-a Drivers to Exercise Due Care When Approaching Bicycle.** –Every driver of a vehicle, when approaching a bicyclist, shall insure the safety and protection of the bicyclist and shall exercise due care by leaving a reasonable and prudent distance between the vehicle and the bicycle. The distance shall be presumed to be reasonable and prudent if it is at least 3 feet when the vehicle is traveling at 30 miles per hour or less, with one additional foot of clearance required for every 10 miles per hour above 30 miles per hour, and

WHEREAS: NH law to protect horse riders and horse drawn carts and carriages does not have specific guidelines' but is open to interpretation RSA 265:104 Approaching Horses. – Every person having control or charge of a vehicle shall, whenever upon any way and approaching any horse, drive, manage, and control such vehicle in such a manner as to exercise every reasonable precaution to prevent the frightening of such horse, and to insure the safety and protection of any person riding or driving the same, and

WHEREAS: there are road signs that show the specific rules for passing bicycles but there are none regarding the passing of horses, horse drawn carts and carriages.

THEREFORE BE IT RESOLVED: That NH State Grange through its legislative department actively work with the NH State legislature to modify RSA265:143 to include the following language: "The passing distance shall be presumed to be reasonable and prudent if it is at least 3 feet when the vehicle is traveling at 30 miles per hour or less, with one additional foot of

clearance required for every 10 miles per hour above 30 miles per hour.", so that the final RSA will read: **RSA 265:104 Approaching Horses.** – "Every person having control or charge of a vehicle shall, whenever upon any way and approaching any horse, drive, manage, and control such vehicle in such a manner as to exercise every reasonable precaution to prevent the frightening of such horse, and to insure the safety and protection of any person riding or driving the same. The passing distance shall be presumed to be reasonable and prudent if it is at least 3 feet when the vehicle is traveling at 30 miles per hour or less, with one additional foot of clearance required for every 10 miles per hour above 30 miles per hour"

Be it further resolved: that once such legislative changes have been made that the NH Department of Transportation redesign the current bicycle safety road signs to show bicycles, horses, horse drawn carts and carriages so that the public is made more aware of it.

Standing Rules of the 142nd annual Session were read and accepted

Standing Rules of the 142nd Annual Session New Hampshire State Grange of the Order of Patrons of Husbandry

Town & Country Motor Inn Shelburn, New Hampshire October 22nd ~ 24th 2015

- 1. All persons, except special guests, must be registered. Nametags and programs will be issued at the Credentials table.
- 2. Admission to the meetings shall by nametag and 4th degree password only. Upon giving the password, the meeting Deputy will provide a colored sticker for your badge indicating that you are a member in good standing and will not need to give the password again. If you are not wearing your nametag you will be refused admittance. The 4th and 6th degree passwords will need to be given for admission to the opening of Session on Thursday and to the Conferral of the 6th Degree.
- 3. As a common courtesy to all members, cell phones are to be turned off, or set on vibrate. If your phone makes a sound during the meeting you will be expected to pay a fine of \$5.00 to the State Gatekeeper.
- 4. At least fifteen delegates shall constitute a quorum of the State Grange.
- 5. Every Subordinate and Pomona Grange in good standing shall be represented by the Master or his/her alternate and one other delegate from said Grange.
- 6. The voting body of the State Grange shall be all registered delegates.
- 7. Members attending as non-delegates may take part in discussion, with permission from the chair, but shall not make motions and shall not vote.
- 8. A member wishing to speak shall wait for recognition by the Master, and upon provision of a working microphone shall announce his/her name and Grange he/she is representing.

- 9. When two members rise to speak at the same time, the chair will first recognize the member standing the furthest distance from the Master's station.
- 10. No delegate shall speak more than two minutes on any question under discussion nor may speak a second time until all others who wish to speak have had the opportunity to do so.
- 11. All reports and other materials for the permanent record, immediately on presentation, shall be given to the State Secretary, via a Scandisk which the State Secretary has provided and a paper copy or any report.
- 12. The rules contained in the current edition of <u>Robert's Rules of Order Newly Revised</u> shall govern the meeting in all cases where they are applicable and in which they are not inconsistent with the By-laws and the Standing Rules.
- 13. These Standing Rules shall be presented to the members for adoption; a 2/3 vote shall be required for adoption.

State Session Coordinator 2014-2015

National Representative, State Officers, Worthy Master, Delegates, Brothers and Sisters All: After our State Session ended last year I had to start devoting all of my attention to the NorthEast Leaders Conference. The event was held in January at the Best Western in Portsmouth. This was the same location as it was seven (7) years ago. This location was much better as now the conference center has the Roundabout Restaurant that provided the catering for the luncheon and banquet.

As I had never done an event like this before it was way more of a challenge as I now had to deal with seven (7) states. At this conference we had 3 National Grange officers. Ed Luttrell, National Master, Burton Eller, National Legislative Director and Lillian Booth, National Junior Grange Director.

When a State Grange hosts a NorthEast Leaders Conference it is up to the host state to provide accommodations for Grangers who wish to attend the conference. I had no idea what NH needed to do for this conference. I tried to get answers from our State leaders but I was never able to get any help. In order to find out who was responsible for the National Reps room and meals I had to find out from National Master, Ed Luttrell when he arrived at the conference.

Back in December I found out from my Sales Rep at the Best Western that the hotel only had reservations for 15 rooms. I told her this is sure going to be a financial disaster. The conference room is \$200.00 per day however for every 20 rooms booked they do not charge a conference room fee. I did find out that it makes no difference what state you are from they all make there room reservations late. Thankfully when the room reservation date came all of the rooms that were being held for me were now filled. The hotel finally had to say that the hotel was sold-out and some attendees had to book another surrounding hotel.

State Treasurer Dan Bascom and Past Master, introduced the 34^{th} State Master Christopher E. Heath to present his first annual address.

Master's Address 2015

National Representative, Honored Guests, and Pink Sash Family members, Delegates, Brother and Sister Patrons: It is an honor to stand here and present you with my first address as the Master of the New Hampshire State Grange. As I reflect back upon this past year I think to myself, where has the time gone? It seems like only yesterday I was being installed as the Master of the New Hampshire State Grange at Hudson Grange Hall. When I addressed the assembly that Sunday morning I had four goals for the direction of the Granges in New Hampshire. These four goals were Growth, Ritualism, Family and Fraternity. Although these are a continuation of my predecessor's goals, they are still important to me and should be for the future of all our Granges. I had also set a personal goal for myself to visit all the Granges in the state and even though I did not make it to all of them, I was able to visit over fifty percent of them. It was eye opening and educational to say the least. I am planning on visiting the remaining Granges throughout the coming year and hope to finally reach my goal. Each Grange that I had the pleasure of visiting

were welcoming and happy to see the State Master coming to visit them. During those many visits I received plenty of comments and was able to make new friends across the state. Some of the comments that were made to me were that "they couldn't remember the last time they had a visit from the State Master", "it was nice to know that the State Grange still cares about the local Granges" and "it's nice to have visitors attending their meetings".

My first official duty as the State Master was to attend National Grange Session in Sandusky Ohio as one of the delegates from New Hampshire. This was not my first time attending National Session but it was the first time attending as a delegate. I gained a whole different perspective of how National Grange Session is conducted. I served on the Grange Law committee and had the opportunity to fill in as the Assistant Steward for a short time during session. It was a great honor to represent New Hampshire and I look forward to doing it all again this year.

Grange Growth - The Granges across the state have been working hard finding and initiating new members. Both Mohawk and Winthrop Granges have taken in 6 new members this year. Other Granges that took in new members were Halloween, Harmony and Wicwas Lake just to name a few. I was also glad that we were able to organize a new Grange in our state this past year. I received a phone call from a resident of Barnstead who expressed interest in starting a Grange. I met with a large group of residents from Barnstead in April and explained to them what the Grange is, what is required to start a Grange and answered many questions about the Grange. I left the meeting enthusiastic that we might be starting a new Grange in this town. When I had not heard back from the group by June, I was discouraged that the prospects of a new Grange might not happen, but in the middle of June I received a call from a representative of the group informing me that they had 15 members' sign the charter application and they had sent it into the National Grange. This was great news and this past Monday I had the pleasure of presenting the members of the newly organized Barnstead Community Grange #360 with their charter. They were really excited to receive it and they are already planning on holding an open house to increase their membership and gain more interest in their town.

I have been promoting Grange growth to all the Granges I have visited and I challenge each and every member to find new members. If you really care about our Grange and its future, it is your responsibility to jump on the bandwagon and find new members. The State Grange can supply you with the tools and provide help to accomplish this but Granges have to ask for help. Communication is important and following up is even more important. The New Hampshire State Grange has the tools, knowledge and resources to assist but it also takes the members in the local community to attain this goal. Community Grange members know the people in the town and are the familiar faces that the public will recognize. Granges need to publicize themselves if they want the public to see them. Make sure to have membership brochures in places where nonmembers can find them. Some of the public are not willing to talk to you about the organization but if they had some literature that explains what the Grange is, they would more than likely read it. If it was something they were interested in, they will contact you for more information. The State Grange has been accumulating these contacts at the Farm and Forest Expo for the past 4 years or more. This information is passed on to the local granges for follow up. These people are interested and usually only need someone to ask them to come to a meeting and then asked to join.

Ritualism - I am a big promoter of the ritualism of our organization and encourage all members to perform it at every meeting. Grangers should take great pride in learning their parts. The opening and closing ceremonies are impressive when they are performed correctly. I was pleasantly surprised that at almost all the granges I visited over the past year, opened and closed with the ritual. Granges should strive to exemplify the degrees for their new members. The degrees provide new members and seasoned veterans with the true lessons of our order. When the degrees are done correctly, they can leave an impression on those who witness them that will stay with them for their lifetime. We need to recognize those who memorize their parts and encouraged all others to learn them. There needs to be a State Grange sponsored degree day and I encourage the membership department to organize this event. This degree day should be heavily publicized so that all interested members will know the date and make all efforts to attend.

Family - Our organization has always been family-oriented and we need to make sure that members, who have family, bring them to the Grange meetings with them. As Grangers we need to approach families and encourage them to come see what our order has to offer them. We need to make them aware that we are a family organization that offers programming for all ages. Granges need to make sure that they provide programming and projects that the whole family can participate in. The new change to the Junior Grange membership opens up the ability for parents to include their children in the meetings. They should be encouraged to attend and the juniors should be given projects to work on while the adults hold their meeting. This is another way we can entice FFA and 4-H youth to join our organization. We need to invite these other youth organizations to attend our meetings and encourage them to bring their parents.

Fraternity - Ours is a fraternal order and we should be willing to help each other. Wicwas Lake Grange members showed us how to do this when they hosted a meet and greet event at Harmony Grange. They provided advertising, music, food and members to help with this event. As a result of this joint effort, Harmony Grange gained two new people as members. The Granges of the Northern part of our state have been practicing this for years. Not only do they visit each other and assist at each other's meetings but they also assist each other with events, programs and work together for good causes. Just think how much stronger our bond would be if we all started following this example. Granges need to get back to assisting each other and offering to help each other with projects. Alone a Grange can only do so much but when we combine our efforts, we can accomplish so much more.

We have so many new Masters and Secretaries in our Subordinate Granges across the state that I intend to hold area meetings to provide training to these new officers. These events will be open for all members but the topics will be geared towards the Masters and Secretaries. The state secretary and I will provide instruction to these officers on what is expected of them and provide the tools that these two offices need to perform their jobs to their best ability. I encourage anyone who is interested in learning more to attend one of these sessions.

I want to encourage all Granges to be involved in their communities. We need show them that we are involved with Agriculture, Family, Community Service, Legislation and any other subjects that fall within our organizations guidelines. We need to immerse ourselves in what is going on in our communities if we are going to fill a purpose. Exposure is a form of publicity and we can use this free tool to grow our Granges. Don't be afraid to get out of your comfort

zone and don't be afraid of change. Our Organization has not survived this long by sitting back and letting the world go by.

In conclusion I want to thank the delegates of the New Hampshire State Grange for having confidence in me to fulfill the office of State Master. I also want to thank the committee chairmen and my fellow state officers for your support throughout this past year. Without all of you, I would have had a difficult time accomplishing as much as I did. Thank you to my wife for being my sounding board, venting platform and my strength to continue when times looked bleak. Thank you to all the Grangers from around the state who make it a goal to grow and advance our order.

Last but certainly not least I want to thank my parents for supporting me and molding me into the person I am today.

Dan Bascom, State Treasurer was introduced and presented his annual report.

Worthy State Master; Brother Chris Heath, National Secretary Judy Sherrod, Fellow State Officers, Patrons all:

What a year we've had! After passing the budget at last year's session and the executive committee deciding that if the dues increase passed at National Session. We would not collect the dues increase until this coming January, thus causing us to go into the red by years end. Instead we ended the year with a surplus. Many things contributed to keeping us in the black. A very successful New England Leaders Conference was held in January. We became much more diligent in collecting back bonding and National Assessment payments. Our State Master with assistance from the executive committee went after all Granges who were delinquent on dues. I'm proud to say all but one have paid up and the last one should be resolved by next year. The back dues not only covered the dues increase but also allowed us to not withdraw the 3.5% quarterly payments from the operating fund. With the dues bleeding stopped our dues income should be much easier to calculate. We all owe the Executive Committee and our State Master a BIG round of thanks for their diligence.

This past year in reading the National Grange By-Laws I found out all defunct Grange accounts could be combined into one thus saving a lot of paper work and time both for me and Morgan Stanley. We are entitled to all the income generated from this account which will help balance the budget. I increased the principal of our operating account by adding the interest from the past few years. I was also able to recoup 7 & 8 year old accounts from Brookline/Wilton Grange and add them to this account.

Two executive committee members, Tricia Taylor and Wilber Heath, joined me at our annual meeting with John Habig at Morgan Stanley in July. Mr. Habig recommended we continue with our present investment and spending policy. Our investment plan currently allocates 60% equities, 38% to fixed income and 2% to cash and equivalents with combined goals of income and growth. This past year has been hard on our investments as the stock market has been down. Those of you with escrow accounts will most likely be looking at smaller checks this year. Each year I report to the IRS and update the list of all Granges that fall under the New Hampshire State Grange. This year 5 Granges had been dropped from that list and I re-added them, this indicates to me that these Granges have not filled their e-postcard reports and have lost their nonprofit status. I have had 2 requests from Granges to help refile for their nonprofit status, there is a lot of paper work involved and reinstatement is not guaranteed so please don't forget to file your e-postcard reports. It takes all of about 10 min. If you can't file on line please let me know and I will do it for you. Your e-postcard filings are due anytime now and need to be done by February 15, 2016.

Many years ago the State Treasurer and Executive Committee insisted that two signers be placed on every Grange account in all Community, Pomona and State Granges. This past year another organization I belong to lost its Treasurer very unexpectedly, at the time he was elected I served as President and insisted we have 2 signers on the account. Because of this we continue to have access to the account. I stress having 2 signers for this reason. I know of at least 2 state committees that have not done this. But this will be rectified soon. I urge each of you to go back to your Granges and make sure you have 2 signers on each account. Make sure the accounts are set up as either/or signers, this means you only need one of the two to sign your checks. I will not list you with the details of our financial status at this time as all accounts will be printed in the Journal.

We continue to carry the value of the State Grange Building at the purchase price of \$87,500.00. All Granges are required to send in their incorporation fee (\$25.00) to the State of New Hampshire by December 15, 2015. This keeps your nonprofit status current with the State of New Hampshire. Do not confuse this with the e-postcard which is with the Federal IRS. I again want to recognize some unsung heroes for their efforts this year. Marty and Ann Boisvert for their diligent work in keeping the State Grange building functioning properly. Also to Adam Paquin-Varnum for the excellent job he does in keeping the hall clean.

A huge thank you goes out to Hannah West for her untiring work on the Granite State Granger. This is one of the best communication tools we have and keeps us in contact with all Grangers. When sending donations for the GSG or other departments please write them out to "NH State Grange" and put what you are donating to on the memo line.

To all deputies and others, I had a very difficult time this year getting bills at year end, September 30th. When they come in late they affect next year's budget and not the budget year they were planned for. Also please remember all bills are to be sent to the secretary, not me, he then issues me a voucher requesting payment.

The 2016 Roster will have a new look and will require many hours of formatting so please make sure to send it to me on time.

The next item on my agenda was to make final edits to the journal of proceedings for the 141st Annual Session. I am pleased to report that for the second year in a row the Journal was completed and ready for distribution at Deputy School. The bylaws of the New Hampshire State Grange state that the journal needs to be completed by May 1st. I believe that this needs to be looked at and possibly changed as with the current technology that is available, it makes it possible to have the Journal completed shortly after the session.

This past year the New Hampshire State Grange played host for the 2015 North East Leaders Conference. The conference was held in January 2016 at the Best Western Hotel and Suites in Portsmouth NH. On Friday 120 Grange Leaders from all 7 seven New England States started arriving for a weekend of learning, sharing and fellowship. My role was to serve as the conference secretary and to handle the registration and meals for all attendees. Having never

being involved with this type of conference, there were many details that needed to be completed from developing and sending the registration forms to the Leaders from all over New England to recording attendance and meal choices for each participant and making sure that all credentials and conference materials were distributed at registration. I would like to thank our State Master Chris Heath for having confidence in me that things would go smoothly and for his help when needed. A special thank you to Ken Berry Session Coordinator for handling all the details with the hotel and making sure all guests were checked in and with correct accommodations his attention to details helped make this a successful conference.

Quarterly Reports ~ Near the end of each quarter a packet was sent to each Pomona and Subordinate secretary with information for the members as well as the usual report forms. I can't stress enough how important it is to complete the reports and send them in on time. What we pay to National Grange is based on the membership numbers from these reports. If I don't receive a report from a Grange the membership number use on my report is the number last reported. There have been times when a Grange report was submitted after my deadline to National and the Grange reports a loss of members. If these reports were sent in on time we wouldn't have needed to pay dues on the lost members now being reported. Please keep in mind that the mount for membership dues to State Grange will be increased beginning with the March 2016 report as a result of the increase we are currently paying National Grange.

Subordinate reports to the Pomona Secretary ~ several subordinate secretaries are sending the green Pomona report to me. This needs to go to the Pomona Secretary so that they can make sure their membership numbers are correct. When I receive one I only send it to the Pomona Secretary if the Grange is reporting a loss or gain of members.

Communications ~ As the Secretary it is our duty to keep our members informed and this is done with the reading of communications. I have been to meetings where the Secretary reports that they received a letter, minutes of the State Executive Committee, or the announcement of an event and said I have it hear if anyone wants to read it. This practice needs to stop, often times as a State Leader we are asked by members who didn't know about an event or something that they felt they should have been told. Only to find out that their secretary didn't read it at a meeting. I would like each Subordinate and Pomona Secretary and committee chairman to establish the following philosophy, if it's mailed to you for your Grange, read it out loud to your members.

Supplies ~ the supply department continues to be very busy filling orders. There will be changes to the supply department over the next few months as there have been some issues with how the supplies are requested and my receiving supplies from National Grange. Getting a scrap piece of paper with the quarterly reports needs to stop. These little pieces of paper at times get misplaced and orders are sent late.

To help with the ordering procedure I will be creating an order form which each Secretary must fill out for needed supplies. When the order is sent a replacement form will be included with the invoice.

State Session is here and with that comes the preparations associated with it. Program created, resolutions formatted, ribbons ordered, delegate packets assembled the list goes on and on. I

must admit that while this seems to be overwhelming I find it exhilarating and look forward to the whole thing coming together. There are some people that I would like to thank for assisting in the planning and execution of all that goes with State Session. Records of the December 11, 2014 meetings were reviewed, corrected and approved

Masters Report:

Hinsdale - Stopped by the Grange's meeting place on Sunday March 15th (scheduled meeting day) but no one was present at that the building. Drove by the Master's residence but no one was home. There has been no response after multiple attempts to contact the Master via phone by both the Deputy and the State Master. There was no response from the letter suspending their charter. There has been no attempt by the Master to contact the State Grange to discuss the letter. Requested the State Secretary to send a revocation letter to the Grange Master and in the letter I informed them that we are taking their charter. Contacted the Hinsdale Historical Society president to gain access to the building where the Grange is meeting to determine what is there for Grange property and to recover the charter. He said that he heard that the Grange folded over a year ago. Received from Jim Tetreault, a letter from the IRS informing the Grange that they are late filing their 990-N for the year ending March 31 2014. Turned this information over to the State Treasurer so he can file/contact the IRS to let them know what is happening with the Grange.

Grafton Star - I received communications from Ann Collins requesting permission to consolidate with Park Grange. I informed Ann that according to the by-laws, before we can proceed, we need a letter from both Granges involved in the consolidation. I sent a letter to the Master of Park Grange informing them that in order to proceed with the consolidation, we need a letter from their Grange requesting permission to start the process of consolidating the two Granges.

Mont Calm - I received a request to attend their May meeting to talk about the future of their Grange. The Secretary had sent a letter to the State Secretary stating that they were closing their Grange. I had spoken with the Secretary in December and she informed me that they did not want to continue. I explained to her that there is a process the Grange needs to follow in order to surrender their charter. I then provided her with the chapters in the by-laws where this process is explained. I informed her that before we decide to close their Grange, we would like to work in their community to get them some new members. She did inform me that they sent in their report and paid their dues.

Mt. Pistareen - I and the General Deputy have made multiple attempts to contact this Grange. The number in the roster just rings and there is no answering machine to leave a message. I am going to visit them to make sure that they understand what a Grange is and what the requirements are of the Grange. Also need to make sure that they know that the building still belongs to the Grange. I was informed that they think that the building belongs to the daycare that uses it on a daily basis.

Master's Conference - I attended the Master's Conference the last weekend in February. The National Master provided an update on the California Lawsuit. It appears that the judge is favoring on the side of the National Grange. A motion for summary judgment was filed for the defamation cases and the judge ruled in favor of the National Grange and Ed Luttrell. There were many workshops presented about growing our organization, area conferences and financial foundations. The National Grange may be partnering with a group that provides education to

new and beginning farmers. National will be providing more information on this in the future. Burton Eller spoke about the Legislative fly-in in May and the one being planned for New Hampshire in January/February 2016.

Membership Growth - There were 5 new members inducted at Mohawk Grange, 6 new members at Winthrop Grange, two new members at Rockingham Grange, two new members at Granite Grange and at least 2 new members at Aurora Grange. These are all great signs for our organization. There is another organizational meeting planned at Stewartstown. I will be meeting with a group in Barnstead on April 6th to discuss starting a Grange and the membership director has been working with a group in Stratham that is interested in starting a Grange. Farm and Forest was another great avenue in recruiting new members. We received over 25 RIP cards and the membership director has forwarded these to the Granges that are closest to the person interested in the Grange. I also received an email from a group in Ossipee that would like to have someone talk to them about the Grange and it's recent membership growth.

Visitation Contest - I would like to have the State Grange sponsor a visitation contest from July 1st to June 30th. I think this would encourage our members to visit other granges and rebuild those fraternal bonds that we once had in the Grange. My thought is we could offer a monetary prize for 1st, 2nd and 3rd places and maybe even have a Grange category. We could provide each member with a logbook that they will use to track the Granges they visit throughout the year. The Secretary of each grange (visiting) would "seal" the member's book at the meeting and write the date on the page. After June 30th, we would collect the books from every member that participated and then recognize those winners/Granges at State Session.

Webmaster - We need a new webmaster for the State Grange website. Wayne Turcotte has asked that we find a new person to handle this job because he and his wife will be doing more travelling and he feels that he won't have the time to commit to the job. I think that we should offer this job to a Granger and would like to ask via the grapevine if anyone is interested. If no one is willing to do this, I thought that maybe we ask Terri Fassio if she would be willing to do this for us. She works a couple of other State Granges administering their web sites. This might have a fee for her time/services. I have spoken with other State Grange Master's and have heard nothing but good things about her work and how efficient she is with updating information.

Area Meetings - I would like to hold area meetings for the Secretaries and Masters of all the Granges in NH. At these meetings I planned on distributing the By-laws of the National and State Granges. I would like to instruct the responsibilities of the offices to them so they know what they should or shouldn't be doing. I feel we need to make this a mandatory meeting and require that all Master's and Secretaries attend. If the Grange does not send representation I feel we should penalize them. This instruction is important and is needed by new and experienced officers. Too many Granges are not operating within the by-laws and this puts all of us at risk. I feel the State Grange can create a binder with the required information. We need to make sure that the Master and Secretary know that this information is to be passed on to their successor.

Secretary's Report:

• Quarterly Reports: one Pomona (Mascoma Valley) and two Subordinates (Hinsdale and Riverhill) are behind in reporting to the State Grange.

- Leaders Conference: roughly 130 attended the 2015 Northeast Leaders Conference held in Portsmouth NH. The attendees were happy with the accommodations, workshops and meal events. Thank you to Ken Berry for his efforts working with the hotel.
- NH Arms collectors: The Arms Collectors have decided to meet in a different location and have sent the keys back to the State Secretary.

Treasurer's Report:

- Income and Expense reports were presented and the Treasurer welcome any questions and comments
- Money from Brookline/Wilton Grange #211 has not yet been moved to the Defunct Grange Account.
- Bonding and Assessment balances are reducing due to a recent reminder letter sent to the Granges owing the money.
- Morgan Stanley Smith Barney year end report has been requested to be sent at a different time of the year. Still waiting for a response from MSSB,
- Defunct Grange Accounts: National Grange By-laws allows the State Grange to have the money placed in a trust account. If said grange is reorganized within seven years the money in the trust account minus the interest reverts back to the Grange.
- Income Tax report has been submitted
- Non profit filing: Dan reported that the time is approaching and Grange will need to be filing for this.
- Legal Fees: Dan reported that he keeps records of how much State Grange spends on legal fees when dealing with troubled Granges. It is believed that when these Granges close that any legal fee incurred by the State Grange is re-paid for fees from the money handed over from the grange before it is placed in the defunct Grange account.

Motion made by Chris Heath and Seconded by Wilber Heath to accept the Treasurer's Report. Vote was favorable.

Old Business:

A motion was made by Mark Collins and Seconded by Tricia Taylor to have the State Master appoint a committee to review the results of the survey conducted by the State Executive Committee at the 2014 State Session and report back with their recommendations. Vote was favorable.

New Business:

State Grange Building: During an inspection of the roof it was discovered that snow and insects are getting into the attic space as well as other winter issues. A motion was made by Mark Collins and seconded by Wilber Heath to ask the Building Management team to come up with a wish list of issues that they would like addressed and report back to the Executive Committee. A motion was made by Mark Collins and seconded by Wilber Heath to have the accumulated interest from this defunct account deposited into the general account annually. The vote was favorable.

Escrow Accounts: Motion was made by Wilber Heath and seconded by Mark Collins allowing the New Hampshire State Grange to receive a 5% management fee from the yearly accumulated interest from the Escrow Accounts. The vote was favorable.

Donation to National Grange: A motion was made by Beth Merrill and seconded by Wilber Heath to donate \$1000 to National Grange for Trademark Protection and Legal Fees. The vote was favorable with one no.

Chairman Robert Trombi called the meeting to order at 7:39 PM.

Records of the March 27, 2015 meetings were reviewed and corrections made. Motion made by Wilber Heath, seconded by Mark Collins to approve the minutes of the Public Session as corrected. Vote was favorable. Motion mad by Beth Merrill and seconded by Tricia Taylor to accept the minutes of the Executive Session as presented. Vote was favorable.

Masters Report:

<u>Hinsdale Grange</u> - I have revoked their charter. I worked with Jim T. and John Smith (Historical Society President) to get access to the building where the Grange equipment was being stored. I recovered some sashes, manuals, song books, staves, cloth and other small Grange items. I provided Bob Trombi with a contact number so he could recover the stations and any other items that were not recovered when I visited the building.

<u>Grafton Star Grange</u> - I instructed them in the procedure for consolidating. I informed them that both Granges need to follow this process in order to consolidate. I was notified of the meeting that they set aside to vote to consolidate with Park Grange. Bob and I attended the meeting and the vote was unanimous to consolidate with Park Grange. I informed them that barring no issues with the vote at Park Grange, they would be consolidated with them as of July 1st. I instructed Ann to pay Grafton Star's dues to the State Grange for the quarter ending June 30th, and informed them that all money and property is to be taken with them to Park Grange.

<u>Park Grange</u> - I instructed them in the procedure for consolidating. I informed them that both Granges need to follow this process in order to consolidate. I was notified of the meeting that they set aside to vote to consolidate with Grafton Star. I attended the special meeting that they had and it was voted unanimously to consolidate with Grafton Star. I informed the secretary that as of July 1st, all members of Grafton Star will be members of Park Grange. I informed them that all monies and property of Grafton Star will become theirs once the consolidation is completed.

<u>Mont Calm Grange</u> - I met with two members of Mont Calm Grange and discussed with them the process of consolidation. I informed them that they needed to locate a Grange that would be willing to consolidate with them. Informed them of the complete process that must be followed in order to complete the consolidation. Received a copy of a letter that they sent to Blow-Me-Down Grange. It appears that they will be voting to consolidate with Blow-Me-Down Grange in the future.

<u>Blow-Me-Down Grange</u> - I received a copy of a letter from Blow-Me-Down Grange notifying their members that they will be meeting to vote on the request from Mont Calm Grange to consolidate. I have instructed them on the process that must be followed in order to consolidate. It appears that they will accept the request and starting the process of consolidating.

<u>Riverhill Grange</u> - We gave this Grange a deadline to pay all of their back dues and to keep current on their current Grange dues. According to the last conversation with Jerry, he has not been receiving their current dues or anything towards their outstanding dues. They were given

until June 30th to get up-to-date on everything. I am preparing a letter informing them that I am going to revoke their charter for non-payment of dues.

<u>Carroll County Pomona</u> - This Pomona Grange only has two granges in it's pomona. The Pomona meets in the afternoon Tuftonboro Grange Hall. According to the information that I have they are unable to get a quorum to their meetings. I am going to send them a letter informing them that they need to work with the Grange Growth Team to get new members or I might be forced to suspend their charter. This might be difficult for them because of the time they choose to meet. I am hoping that they can get some new interest in their Pomona grange

Golden Rod - I have been informed that they are not holding legal meetings and have not for some time. I did get a request from them to have monies from their escrow to put bathrooms in their former hall which is now owned by the historical society. I was told by one of their members that the Grange is dead. I informed that member that the Grange is not dead and that they need to be working on gaining new members. I will be sending them a letter informing them that they need to work with the Grange Growth Team to work on getting new members and revitalizing their Grange otherwise I will have to take further action which might include suspending/revoking their charter.

<u>Hooksett</u> - I have been informed that they are not holding legal meetings, less than 7 members, and have been doing this for some time. They had requested permission from my predecessor to Consolidate but he refused their request. I will be sending them a letter informing them that they need to work with the Grange Growth Team to work on getting new members and revitalizing their Grange otherwise they do have the option to consolidate.

Friendship - I have not had a chance to talk with Phil Cain to see where he is with getting some more members. I will be suggesting that he have the Grange Growth team come to his area and assist his membership with finding some new members so they can get off of suspension. I was informed at Spring Fling that they are up to 12 members and need only one more to be legal.

Mt. Pistareen - Bob and I attended a meeting of this Grange and there were only five members present. They do not meet traditionally and it appears that they have never seen or done an opening/closing. I am working on a communication to the members to inform them that in order to remain a grange, they need to start having legal meetings, at least 7 members, in order to remain a grange. If they continue without having the correct number of members at their meetings, I will be forced to suspend their charter. According to the roster, they have 19 members on their books.

<u>Visitation Contest</u> - I announced the contest in the Granite State Granger. I had been waiting for the notebooks to arrive and they finally did this week. I did announce that the contest would run from July 1st to June 30th but this is going to have to change. I am working on a letter that will be included in Jerry's quarterly report that will explain the date changes for the contest. This will also include instructions for the Secretaries. I am going to change the date of the contest to be from October 1st to September 30th. This will give each Grange plenty of time to get the notebooks distributed to their members.

Jim Farmer Portrait - I was contacted by National Master Ed Lutrell with a proposition. They were working on cleaning out the National Grange Museum/Library to make it available to rent out. During this clean up they removed the portraits from the walls and are in the process of finding them temporary homes. One of these portraits is of James Farmer. He was an important part of the Grange movement in New Hampshire and He served as the National Grange Lecturer. He has asked the NH State Grange to find him a suitable temporary home here in New Hampshire. He is working on a contract that he will be sending to me. Once we have the contract, it will need to be signed and sent back to him. Once that has been completed, we will need to find a way to get the portrait here safely and provide it an appropriate place to reside while he is here.

Motion was made by Wilber Heath and seconded by Bob Haefner to accept the Masters Report. Vote was favorable.

Secretary's Report:

- With Hinsdale Grange being revoked we have now 60 Subordinate Granges with a total membership of 1610.
- A letter was sent to Riverhill Grange reminding tem of the past amount due to State Grange and the July 10th deadline to pay it.
- Friendship and Manchester Community Granges have not reported for the March quarter.
- 2015 National Grange Assessment bills have been sent to the Pomona's

A motion was made by Wilber Heath and seconded by Tricia Taylor to accept the Secretary's report as presented. Vote was favorable.

Treasurer's Report:

- Income and Expense reports were presented and questions answered by State Treasurer Daniel Bascom.
- A bill has not yet been received from the accountant for the IRS filing. Dan will contact them and get this taken care of.

A motion was made by Mark Collins and seconded by Bob Haefner to accept the Treasurers report. Vote was favorable.

Old Business:

• Wilber will be contacting t5he Building Team to discuss issue with the building and report back to the committee at the next meeting.

Wicwas Lake Grange continues to grow, maintaining its status as the largest Grange in the state, and once again they are the top scoring grange. Keep up the good work. The best news of this year, of course, was the announcement of the formation of a new Grange in Barnstead.

Pomona Granges

The Pomona Granges continue mostly unchanged. Those that have been struggling are still struggling, and those that are doing well continue to do well. There is nothing else that I can say about them that hasn't already been said.

I was happy to see that Arthur's plea was heard. We had a few Pomona Granges that performed the fifth degree conferral ritual this year.

The Challenge

The deputies were asked to issue a challenge to the granges. The purpose of this challenge was to get the grangers to do something outside of their comfort zones. For most granges, simply doing what they've always been doing is not resulting in success as far as membership is concerned. We were not asking for miracles, just trying to get granges to think outside their boxes. Some of the granges embraced the challenge and proposed some interesting ideas; others seem to have dismissed the challenge as soon as the deputy left the meeting. I did want to make a special mention of the goal that I thought best encompassed the spirit of this challenge: an effort by the grange to catalogue all the farms and farmers within their town.

Conclusion

I would like to thank all of the deputies who continue to do great work around the state; I would not be able to do this job without you. I would also like to thank the worthy master for trusting that I could meet the challenges of this office, and hope I have lived up to those expectations.

It is with great pleasure that I present to you my first report as your state lecturer. I was a bit nervous at first and wondered, Oh My!! What have I done!! However, I have enjoyed it immensely! It has been a fun and exciting year and I'm ready to keep going.

It all started at deputy school, where I had a chance to meet with Hannah West and go over all the duties of this office. I am very thankful for all the help she has given me this year and I want her to know that I couldn't have done it without her!

Next up was the Northeast Leader's Conference where I was able to meet with the other state lecturer's from New York, Massachusetts, Connecticut, Rhode Island, Vermont and Maine. We had a chance to plan the Northeast Lecturer's Conference to be held at St. Joseph's College in Maine.

March brought our annual bowling tournament at Lakeside Lanes in Manchester. We had a total of 69 adult bowlers and 16 junior grangers. I was very pleased with the turnout. As this was my first time running this event, I am thankful for everyone's patience and thank all who offered help. The top Grange was Rochester and the State Officers won the three-way challenge

between them and the Youth Association and the Youth State Officers. The complete list of winners was announced in the May issue of the Granite State Granger and will be added to this report. Our bowling tournament is scheduled for March 13, 2016 at the same location.

In April, I helped out at Spring Fling by presenting two workshops. One on Lecturer's Basics and the other on Mixed Media Art. Both were well attended and many ideas were shared. I hope that is a bit of a temptation for you.

Summer brought preparation time for the Northeast Lecturer's Conference, which was held August 3, 4, and 5 at St. Joseph's College in Standish, Maine. As this was the 100th conference, the Theme was "100 Years of ______". Our theme was Music. Other states had transportation, education, leisure activities, literature, discovery and agriculture. This conference is not just for lecturers. Any and all are encouraged to attend for some fun, fellowship, entertainment and a chance to learn something new. I was very pleased that we had 20 members from NH. Everyone was very helpful and willing to participate. Our program was well received and very entertaining. We had Marie Hall performing a sign-a-song, Hannah West led us in a walk through the Grange songbook, Mary West led us in some fad dances and we had guest appearances by several celebrities. Our State Master, Chris Heath came on stage as Michael Jackson doing the moon walk, Past State Master, and National Lecturer, Jim Tetreault appeared

as Elvis Presley, our State Pianist, Lester Gibbs rapped as Eminem and Mary West roared as Katy Perry. If anyone is interested, I have a few of the programs from the conference for sale at the Lecturer's exhibit for \$2.00. During Spirit Night the State Master presented me with the State Lecturer's gift. I was so pleased and say thank you to all the granges and grangers who donated. Gorham, Berlin, Groveton are a few towns in the Northern Sector that seem to be on the upswing. The last time we met here was about 5 years ago and what an ending we had. It was a good session and many of us woke up Sunday morning to find a foot and half of snow. Snow, yes snow, many of us didn't have gloves, winter hats, shovels, snow brushes only to get home and find around a foot and half to two feet of snow plus power outages. Welcome to autumn.

Thinking back a few years before that, I can remember the 102nd annual session of the NH State Grange which met at the Town and Country Motor Inn in Shelburne for this important time. This was a major election year for the State Grange. The State Grange opened in the Sixth Degree at 8:45 a.m. State Grange Home Economics Director Beverly Merrill presented The State Grange with a Bicentennial Flag. State Secretary Wayne Ingalls reported the following membership figures: 26 Pomona Granges with 6,040 members, a loss of 132; 204 Subordinate Granges with a membership of 13,677, a loss of 359; 25 Junior Granges with a membership of 484, a loss of 66. There were 101 Patrons who received the lessons of the Sixth Degree. Past State Master John L. Saturley served as Degree Master for the four years that State Master E. Norris Hall presided.

The year 1980 proved to be a very important one for the NH State Grange. I miss the various session committees such as Constitution and Bylaws, Good of the Order, Junior, Cooperative Activities, Public Affairs, Resolutions, Credentials, and Master's Address. Today we have Master's Address, Resolutions, and Credentials. The Resolutions Committee has changed from being a committee congratulating people, talking about the facilities, special guests, and more to now being a committee studying and making recommendations on all the resolutions. Sister Barbara Humphrey brought in a partial report of the Constitution & Bylaws Committee on Thursday afternoon. This resolution dealt with the State Grange electing its officers from the odd years to the even years to help delegates get to know the National Grange Officers before they had to vote. As it was, the NH State Grange and the National Grange elected officers on the even years thus new delegates from NH might not know who to vote for. The delegates present voted in favor of changing the resolution to become effective immediately, thus delegates who elected new officers last year would vote on Saturday for a new slate of officers. It isn't mentioned in the journal but I remember the High Priest of Demeter, C. Jerome Davis spoke to the delegate body and mentioned that in order for this to continue, every State Officer had to agree to resign their office. The current slate of State Officers each agreed to this decision and a new slate was elected.

This has been a very busy year for your Historian. Once again, I have been delivering or sending Grange Secretary minute books to Historical Societies or Libraries in towns throughout the state. They have been thrilled to get these. I have many more to get to new homes. It is a shame because these books contain so much history of Granges that have since closed. It is amazing what some of these Granges did, or tried to do and how many people were affected by their actions. I was pleased to deliver or mail to Candia Grange, Fremont Grange, Reliance. Grange in Salem, West Rockingham Pomona Grange to Derry, Glen Grange in Bartlett, Profile Grange in North Woodstock, Sugar Hill Grange in Franconia, Madison Cascade Grange, Mount Prospect Grange in Lancaster, and Crystal Lake Grange in Gilmanton. Iron Works. Please let me know if anyone can assist me with this project. There are many more to be delivered but due to the cost of mailing or price for gasoline to drive to these towns, I would appreciate any help. I would like to possibly get the remaining ones out of the State Grange building basement to see what ones could be delivered. I am looking for Bartlett Grange of Salisbury, Franklin, Ezekiel Webster Grange of Boscawen, and Rumford Grange of East Concord secretary books.

The Grange members, who serve in the State Legislature organized the annual Grange Day in late April at the State House. I was very pleased with the attendance of Grange members who came. A very good number of legislators stopped by a display I had put up. It was amazing how many remarked they formally held membership in Salem, Nashua, Reliance and Derry Granges. Many Granger members remarked it was interesting to see how the legislators voted on various issues. Even though we don't have 125 Grange members serving as State Legislators like they did in 1925, we do watch for bills that are important to our organization. It is important that we, as Grange members take a serious interest in the proposed bills that the various committees will be debating this winter before they come to the floor.

History is so important and this past year we lost a lot of history in this state Grange. The Great Master of the Universe must have felt that he needed more members. It was sad to lose more but I am sure they are all keeping busy.

I have enjoyed talking about members who may or may not have served on the State Grange level whether as a committee member, director, deputy, or a state officer, who have been called by the Great Master of the Universe. They worked very hard in their Subordinate or Pomona Grange and help write history that will be remembered for many years. The following members I will be talking about is very difficult because they not only served the State Grange in a variety of positions but I knew some of them personally. I also will be talking about former members or the family who thought they were still members when they passed away. Regardless of what the reason was, these former members did so much while they were our brothers and sisters.

Very recently Agnes Lawler, mother of Past State Flora Patrice Lawlor passed away. Although she didn't serve on the State level, she received her 25 year Silver Star membership seal this year as a member of Hudson Grange. She would have celebrated her 93rd birthday last Thursday. Our deepest sympathies are extended to Sister Pat.

One person who passed away hit me very hard was Robert Perry or known as Bob to many of us. Many today wouldn't know him, but he and I were best friends. He belonged to Bow Grange, went to Bishop Brady High School in Concord. He and I were elected as Masters of our respective Granges the same time. He organized Bow Junior Grange as I had organized Pineconia Junior Grange. He and I did a lot in Grange. He was chosen as State Prince and encouraged me to run for Prince in 1970 for 1971, however I didn't feel I was ready for that. He and I traveled to many Granges. He went on to become a Subordinate Deputy. He helped me with my Prince notebook and at the 1971 session in Concord, I was selected as the State Prince for 1972. He moved to California in the late 70's and I lost contact with him. His sister Beverly called me to say that he had passed away suddenly. They thought he was still a member because Bow Grange had merged with Pineconia. The whole Perry family were Grange members. He is buried in Concord and will be missed by those who knew him.

Stacy Cole, who held membership in Golden Rod Grange was a very familiar face in our Grange and Legislative circles. Stacy served many years on the State Grange Legislative Committee. His knowledge and insight of the State Government proved too be a major plus for the Grange. He showed another talent with his writing in the Manchester Union Leader writing about many interesting stories.

Dorothy Young Carruthers held membership in New Union Grange in Hopkinton and then Contoocook Grange when New Union Grange closed. In recent years she held her membership in Daniel Webster Grange when Contoocook Grange surrendered their charter. Dorothy was very active in early years, assisting the late Past State Flora Marjorie Emery with her installation of officers at various Granges. She held offices in her Granges, especially Secretary. Marilyn Campbell was a quiet lady who was always ready to help whenever asked whether it was assisting her late husband Win when he served as Subordinate Deputy or as General Deputy. She also assisted her daughter Jane when she was Co-Director for the State Youth Committee. Marilyn served on the State Grange Fair Committee and could always be counted on to have a smile and to say hello.

Sandra Baker was a dedicated Grange member, who could be counted upon to serve the Grange no matter what was needed. She was a member of Jaffrey Grange, Grand Monadnock Pomona, Pembroke, and Suncook Valley Pomona Granges to name a few. She served the State Grange serving as a member of the Deaf Awareness, Membership, and Fair Committees. Sandra and her family worked very hard in the Granges they were involved in. Elizabeth Abbott served on the State Home Economics, Publicity and Promotions Committee,

and as an officer for the State Grange Trustees for the Trust Fund. She served as an officer in Moosilauke, Grafton Star, Mascoma Valley Pomona, Grafton County Pomona, and always assisted her late husband Richard Abbott who served as a Subordinate Deputy. Betty and Dick went to the State Prison in Concord every week to counsel to the inmates. She loved to write poetry and she could write songs for the New England or known today as Northeast Lecturer's conference.

Priscilla Meyers, or many of us knew her as Tillie, knew her Grange work extremely well. She was a member of the Chester Hayes family in which several of her aunts, uncles, cousins all held membership in the Grange. She worked very hard in Winthrop Grange with her husband Burt. She served as Master several times along with serving on the State Youth Committee. She took

a lot of joking for being short but she didn't care. She and Burt worked on many Grange functions. They traveled many miles to support Grange functions. This is another case where we didn't know her aunt Cecilia Andrew, who played piano for Granges or installation ceremonies had passed away. I offered to let call Cecilia as she was an aunt to Tillie. Talk about being stupid, I was shocked when I called the Merrimack County Nursing Home and found out she had passed away almost two years ago. She had spoke her Grange and the memories that she had. She was a dedicated Grange member serving as Lecturer, Steward, and Pianist in her Grange.

I found out in doing some research for this year's Historian report that Eve Ward and Priscilla Powers, both Past Masters of Monroe Grange have died this year. When I spoke to Eve's husband, he told me that she had passed away in July of this year and was very upset that no one from the Grange sent a sympathy card. Edith told me her sister Priscilla Powers had passed away in January of this year. They were both Past Masters of Monroe and Mr. Ward thought they were still members of the Grange as they both had over 70 years of membership. I explained to him that White Mountain Grange of Littleton where they had gone had closed their doors. It is very sad that this is happening too much. I try to read at least three newspapers everyday looking for Grange membership in their obituary write up. Carolyn Conway of Jefferson was a very active member in the Grange and 4-H. She served as Master in Starr King Grange and when they closed, joined Winthrop Grange. She was always very friendly and helped the Grange in so many ways. She was very active in agriculture and 4H as well as the Grange. Carolyn was also in-laws to Barbara Frangione of Chichester Grange. Bernard Smith served his Grange at New Hampton very well. He is a Past Master of the Subordinate Grange and something that you don't read too often, a past Master of New Hampton Juvenile Grange. He was very active in the town of New Hampton serving on various Town Boards etc.

In closing, Worthy State Master, thank you for your support and I will continue my research, complete the update of my book with hopes to have it printed this next year. I love history and it continues to amaze me what this organization has accomplished. I would like to thank my wife Deb, State Secretary Gerry Leclerc, GSG Editor Hannah West, Brian Rossiter and all others helping me to get the Grange records out of the cellar.

It's a (503 C) Sprague/John West Scholarship. This was set up using a donation of \$100000.00 from a former scholarship recipient.

The meeting adjourned at 3:48 pm.

Session was called back to order.

State Master Heath introduced Lorraine Merrill the Commissioner of Agriculture for a few words. She was pleased to announce the recent opening of the Veterinary Diagnostic Lab and what the impact will be with this addition. She spoke of the recent budget issues the hiring of an assistant veterinarian, the 2014 success for the dairy farmers even though it was short lived. She also spoke of many other issues concerning the Agriculture industry.

Commissioner Merrill fielded questions from those in attendance.

With no further business to conduct the afternoon session of the second day of 142nd annual session closed in the fourth degree at 4:15 pm

The Friday evening session was called to order by State Master Christopher E. Heath at 7:30 pm, preceded by the marching in of the State Officers. Alyssa Estes served as Flag Bearer for the evening.

Roll call of officers found all State Offices present.

Roll call of Granges found a quorum.

Judy Sherrod from National Grange was escorted to the Master's station for remarks. She congratulated the youth for their march in and the opening ceremony. She thanked the New Hampshire Membership for their hospitality.

Beth Merrill, State Youth Director and Joann Brandt, Junior Director were introduced and presented their annual report of Youth Activities and Junior Activities.

Worthy Master, Distinguished Guests, Delegates, and Patrons All: It has been a privilege to accept the challenge of serving as Youth Director despite the apprehensions about how many years have passed and how much the world has changed since I served in this position back in 1988-1992. Hopefully, the youthfulness of the committee that I have assembled compensates for any lack of vim and vigor on my part! I was eager to meet with them at Deputy School in December to start making plans for the coming year. We are small in number, but huge in ideas and attitude. Please let me introduce them to you. Allissa Estes, Emilie Leclerc, Adam Paquin Varnum, and Zach Trombi. I am so proud of their enthusiasm and dedication and acknowledge and thank them for the personal and financial sacrifices they have experienced throughout the year.

It has been a year of highs and lows, but no matter what the circumstances, we were busy! The new Grange year started with the **National Grange convention** just a matter of days after the conclusion of our State Session. Adam Paquin Varnum, a member of our State Youth Committee attended the convention and filled in for me at the meeting of Youth Directors there. Luckily, Adam and his three travelling companions, Bob Paquin Varnum, Bob Trombi, and Arthur Merrill, managed to outrace the massive blizzard that followed them home and blanketed most of the state of New York with enough snow to shut down the highways for days.

I was happy to act as host to the other Youth Directors of the Northeast Region when NH hosted the regional Leaders' Conference. It was good to have the opportunity to discuss our mutual programs and to make plans for the upcoming summer regional Youth conference.

The first major event for us was the **Winter Youth Rally** held at the State Grange Building on January 31st. Somehow we were able to share the limited space with the Juniors, as well. Our day started with a meeting of the Youth Committee during which we laid out plans for the June Youth Rally. The youth activities of the day began with lunch, served by the youth committee and Juniors. We held workshops on Get Acquainted Games and Exploring the National Youth program. The highlight of the afternoon was a workshop and demonstration by the Winissquam High School FFA Parliamentary Procedure contest. They were inspiring in the way that they conducted their mock meeting and I think I can speak for the Grange audience and say that I was in awe of their presentation. I was not able to find enough youth members to make up our own team for this new contest at National Grange this year, but I have high hopes that we can get one assembled and presentable for 2016.

A number of brave members tried their hand at the **Grange Knowledge Test**, written this year by first-timer, Jerry Leclerc. Winners are as follows: 1st place, Arthur Merrill, Antrim Grange; 2nd place, Mary West, Chichester Grange; 3rd place (3-way) tie – Anne Boisvert, Chichester Grange – Chris Heath, Centennial Grange – Hannah West, Chichester Grange. Having three of the top five scores in this contest, I am assigning the task of creating the 2016 Grange Knowledge Test to Chichester Grange! Rounding out the activities for the rest of the day were a

craft activity, a delicious supper supervised by State Gatekeeper, Kathy Yardley and her kitchen crew, and the traditional Youth Association meeting in the evening.

The month of March offered up a weekend of bowling for our youth members. Bowling and more bowling! We held the Caroline Hall Cares fundraising event in the form of Glow Bowling at Boutwell's Ally in Concord with fifteen bowlers in attendance. It really was a fun evening and we raised a modest amount of money to donate to the NH Food Bank, falling far short, though, of the goal that the committee and I had set for ourselves. Some of the bowlers came with sleeping bags and camped out on the floor at the State Grange Building overnight. We arose early to depart the Grange Building before the church people's arrival. After a hearty breakfast we joined with members from across the state at the Grange Bowling Tournament in Manchester. This is where the youth team; made up of Emilie Leclerc, Cody Estes, Mary West, and Zach Trombi, bowled against a state youth officers team of State Assistant Steward, Adam Paquin Varnum, Pomona, Sarah Leclerc, Gatekeeper, Norman Brandt, and Chaplain, Matt Clark and the state officers team of Executive Committee member, Mark Collins, Treasurer, Dan Bascom, Steward, Arthur Merrill, and Master, Chris Heath. I am sad to say neither youth team won, so those eight bowlers that made up the youth bowling teams each paid a \$25.00 forfeit to the Grange charity of the State Officers' choice. A check for \$200 was sent to National Grange, from our Grange youth bowlers, and designated to go to the Name Protection Fund. After it was all said and done, we think that perhaps a late night of bowling the day before the tournament might have been a factor in the non-spectacular performance of the youth bowlers, so we are looking to hold our Glow Bowling event at a different time next year, NOT the night before the Grange Bowling tournament! Given the serious financial state that the National Grange currently faces, as was reported to this session yesterday, the NH Grange youth bowlers good-spiritedly propose the suggestion to the members of the State Officers' bowling team consisting of Chris Heath, Arthur Merrill, Dan Bascom and Mark Collins that, in the name of good sportsmanship and dedication to the Order, they also could make a similar contribution to the National Grange Trademark Protection Fund.

The youth committee sponsored a new event after Spring Fling. There were about 25 in attendance at **Fun** @ **Funspot** in Laconia. The Youth Director split everyone up into groups of four or five, and then handed some tokens and a scavenger hunt chart to each team to complete within a specific time limit. A few of the things were to talk to someone about the Grange and have them fill out a rip card, find someone that wasn't from New Hampshire, and take group pictures with a cartoon statue and on a carousel, in addition to playing a number of the video, pinball, skee ball and other such games to accumulate points. After everyone completed their list and came back together, we had delicious cupcakes and ice cream and declared a team the winner, which got 100 tokens to share among each other. After the team activities were over, everyone got to go out on their own and play any games they wanted. As Emilie Leclerc wrote in her article for the Granite State Granger, "Fun was had by all, and I hope more join us for the fun if we do it again next year!"

The **Sign-A-Song Contest** was held in conjunction with the Lecturer's Variety Show on May 2nd at the State Grange Building. The sad news is that only one contestant performed during the

contest. The good news is that Kathy Yardley (Walpole Grange) gave a moving interpretation of the song, "Blessings". Cynthia Lawson Whitaker, a RI Grange member and NH resident, was our main judge for the contest and with her Speech and Hearing Science degree from Rhode Island University and Sign Language Interpretation degree from UNH Manchester, a very qualified one at that. I am sorry that we didn't have more entries for her to judge and offer constructive comments. Also assisting with judging duties was Ida Hutchins, retired teacher from Austine School for the Deaf. Many thanks go to these ladies for their support of our program.

June Youth Rally was held at Copper Cannon Camp in Franconia, NH June 5-7. We had thirteen overnight campers and two daytime visitors, a modest increase over last year. The youth members participated in workshops where they created Grange commercials that were beautifully filmed and edited by Bob Paquin-Varnum. They created cards or art entries for the State Lecturer's contests, and they created a theme and formed a plan to construct a fair exhibit for the youth department. As it turned out, there were no entries in the Public Speaking contest, so I took the opportunity to give everyone a topic and each had to do a one minute impromptu speech. As there was only one youth planning to go, there were no representatives selected for the regional Grange Jeopardy Contest and there was no drill team practice, either. Electing a slate of officers was the main focus during the Youth Association meeting that was conducted in full form on Saturday evening before many of us headed out to the darkened sports field and played Flashlight Tag, a new adventure for some of us "older youth". Following a night of trying to sleep in unheated cabins in overnight temperatures below 39 degrees, on a sunny deck overlooking Mount Lafayette and Cannon Mountain, we were treated to a Sunday morning worship service conducted by Adam Paquin-Varnum and then finished the weekend with a visioning session. We were treated very well by the staff at the camp and look forward to future camps there, but are planning to return to the southern part of the state in 2016.

Northeast Youth Conference was hosted by Rhode Island this year, held at Camp Aldersgate in Chepachet, RI July 10-12. One of the saddest times of my year as Youth Director was when I realized that only ONE youth member would represent our state at this important conference. Thanks to Emilie Leclerc for her company on the drive to and from the camp and for her leadership for the Saturday evening vespers that NH was charged to do. I was very proud of her for being an exemplary model of our youth program! Also big thanks go to Chris Heath, Arthur Merrill, and Kathy Yardley who made the trip to take in part of the events on Saturday. Kathy did us proud with her performance in the Sign-A-Song contest and we were excited to hear when she was proclaimed the Best of Show and is eligible to perform her "Blessings" song for an audience at National Grange in Lincoln. Hopefully her family who was back home in NH working in the hay field on her behalf has forgiven her absence that day! There were three teams that competed in the region's Drill competition on Sunday, none of which was from NH, another huge disappointment. I hope we can regroup and get back in the game, so to speak, for next year?

While at the conference, Charlene Shupp Espenshade presented me with a stack of 52 Youth Achievement certificates that my predecessor, Sherrill Bokousky had ordered last year on behalf of the NH youth and young at hearts who earned them. Members of Antrim, Arlington, Centennial, Chichester, Gilman, Hudson, Manchester Community, Stratford, Walpole, Watatic,

and Wingold Granges will find those certificates included in your packets that you sign out from the State Secretary. Congratulations to you all on these accomplishments.

State Grange Youth Fundraiser! We heard of an opportunity to raise money picking up trash at the NH Motor Speedway in July. Picking up trash is a dirty job, but somebody has to do it and the NH Motor Speedway in Loudon pays \$7 per hour per person for non-profit groups who will send volunteers on race event days. A group of seven youth/young at heart members joined with Antrim Grange members to raise money for our 2016 National Grange travel fund. Many thanks to Chris Heath, Allissa Estes, Amy Schunemann, Kevin Belval, Mary West, Zach Trombi and Sarah Leclerc for helping out and thanks to Adam Paquin-Varnum for doing all the leg work and paper work to get this organized. We hope to return again next year with a larger and more profitable group!

As a result of the idea session at June Youth Rally and a construction meeting a couple weeks later, a **Youth Committee Fair exhibit** was entered in six fairs over the course of the summer and fall. I am so appreciative of the group that assembled the contents of the exhibit while I was incapacitated for several weeks in June. With a combination of set-ups, take-downs, and turnovers by Allissa Estes, Adam Paquin-Varnum and I, we entered and received premiums from Stratham, Cheshire, Hopkinton, Hillsborough County, Rochester and Deerfield Fairs. Thanks so much to you all for this great group effort and another contribution to the 2016 Travel Fund.

If you noticed, the **Youth Officers** you see here today do not fill the entire slate of officers. There is a variety of reasons for this, including other family obligations, last-minute transportation issues and such. I have asked each officer to sign a commitment form, dedicating themselves to their office for the entire year. This is an attempt to give our new youth members and idea of ALL the events at which they are needed to fill their office, and a reminder to some of our more experienced youth that there are responsibilities that lie beyond the special one here today. Also, the delegates have elected a record number of youth members to hold an office in the State Grange, which eliminates them from the possibility of being a youth officer because of restrictions within the by-laws of the NH State Grange Youth Association, thus, minimizing the pool from which to elect a full slate. While we've hit a couple of bumps in the road with this new expectation, I am encouraged by the participation of two new, first-time-ever youth officers today and see that there are more new youth members waiting in the wings.

I received a total of 4 Pomona reports and 13 Subordinate reports this year. That's not a great showing, brothers and sisters, you have to admit. Hopefully we can do better next year. And even if you do fabulous work all year and participate in many of the contests, events, and activities, if you don't send in a report, you don't get a score. Having said that, the top youth score for a Pomona Grange this year goes to East Rockingham Pomona with a score of 325 points. The top youth score for a Subordinate Grange goes to Antrim Grange with a score of 835 points.

The Photo Scavenger Hunt this year had one entry, so that cash award goes to Cheshire County Pomona Grange. Look for a change in format for this contest next year, as we will be seeking entries in a digital format.

We received three entries each in the Christmas Ornaments and Recycled Craft contest, which were judged by Crystal Seward, Kerriann Heath, Sarah Leclerc, and Amy Schunemann. Christmas Ornament winners are: first place, Beth Merrill, Antrim; second, Pat Izzo, Gilman; third, Ida Hutchins.

Recycled art winners are: first <u>and</u> second place Pat Izzo, Gilman third place, Allissa Estes, Somersworth Grange.

I think that about closes the book on the 2015 youth activities of the NH State Grange. You've probably heard me mention a couple times in this report that we are raising money for the 2016 DC National Session Travel Fund. There are many ways in which our NH Youth can attend this nearby and historic convention and participate in some way that will represent our State Grange. But they are going to have to earn their way there by entering one or more of these contests: Youth Ambassador, Young Couple, Young Adult, Public Speaking and/or Sign-A-Song, National Youth Officers, Grange Jeopardy, Parliamentary Procedure Team, and dare I suggest that the youth dip into another department and try to take on the role of representing our state in the talent portion of the Evening of Excellence? More detailed information on all of these can be found among the pages of the 2016 Youth Program booklet and on the state and national youth websites. Thanks to Allissa Estes for designing our new cover and theme: "Lead the way, to a brighter day". Some of what we have planned for you is new; some of it is "new old" and include such events as Pomona/Area Meeting Youth Assistance Meetings, Art Night, Moon Stomp, Fun @ Fun Spot, Portsmouth Scavenger Hunt, etc. I hope you'll notice that within the program booklet, of the 33 different ways your Grange can earn points for your youth score, 24 of those items have no age restrictions. So come on everybody, get your Grange Youth Committees ready to go, make a plan, and let's see you around the state at our various functions enjoying all the programs and events that support the youth members of the Grange! You can do it!

Speaking of support, I cannot end any report without thanking my husband, to whom I owe so much. He is chief bread-winner, and the best errand-runner, brainstormer, idea thinker, supper cooker, horse mover, pooper scooper, and wood chopper that I could ask for. This year he was my rock when I was down and out for a couple weeks with a serious infection and again at this session, when I was incapacitated all day on Thursday, he managed to fulfill his set-up duties as your State Steward, while still checking on me and getting the youth display tables set up and delivering programs in time for envelope stuffing. Without our younger members, our Granges grow weak and stagnant due to lack of enthusiasm and innovation needed to carry us forward. Once we learn to balance our Granges with the strengths of every age group, we will be close in our pursuit of achieving the perfect Grange.

State Grange Building Managers Report 2015

There are two major differences at the State Grange Building in Hooksett since last year at this time. One is the fact that the building has been re-painted, something that was desperately needed. The money for the paint and the painter came from a generous donation earmarked for that purpose made in memory of past State Master John L. Saturley. Perhaps many of you know how much John loved to paint and how important the upkeep of the State Grange Building was to him. The second difference is a large tree that was cut down after a storm broke several large branches, causing them to partially block the driveway.

In February there were a couple of issues with the furnace not coming on. After a couple of late night interventions with Marty the furnace guy from LaVallee Oil (whose last name is also Boisvert... what are the chances?) and the replacement of everything but the motor on the oil burner, the heating system started behaving itself.

In late spring, we took State Master Chris Heath up on his offer to help with the request of the Executive Committee to fix a couple of ceiling tiles in the kitchen and the dining room which were sagging. Marty wanted Chris there to be a witness if the whole ceiling should fall down when we tried to fix those few tiles. A similar situation had happened before which resulted in an entire tile ceiling crashing down on top of him. This time however things went more smoothly and the ceiling tiles were fixed without incident. Chris was a big help as Marty needed someone to push the tiles up from below with a springboard while he applied construction adhesive from above in the attic. The springboard props were removed a couple of days later... and the ceiling tiles stayed in place.

As for yearly building maintenance, the assembly permit was renewed with the Town of Hooksett. We passed the inspection again without incident. Eastern propane serviced the AC unit this summer. The fire extinguishers were inspected. A furnace cleaning appointment has been scheduled with LaVallee Oil.

Hannah West has continued with taking reservations for the use of the building and arranging for the pick-up and drop-off of keys. Several groups have used the building for baby showers, birthday parties, and other such gatherings. Other events such as Winter Youth Rally and the Lecturer's Variety Show were held there. The church group continues to use the building two days a week for services and Bible study. This partnership has been good for the building as it brings income, and the building is being used on a regular basis. Use of the building was down somewhat this summer, probably due to the bridge construction which made it very time consuming to reach Riverside Street.

Adam Paquin Varnum continues to clean the building regularly and do summer lawn maintenance.

We were recently asked by the Executive Committee to write up a list of all possible maintenance needed to upkeep and improve the building. Landscaping continues to be the most urgent need in our opinion now that the building has been painted.

In closing we'd like to again thank Adam and Hannah for their help in maintaining and managing the building.

Anne has been kind enough to remind me that there were 3 times more people using the theme this year over previous years, but we will try to get the free booth this coming year. During Farm and Forest Expo all the helpers brought in many rip cards, and can only hope they brought in a member or two. During the summer we managed to give out almost 700 pencils and countless numbers of wooden nickels with our website address on each one. This gives an initial contact and will hopefully help us as we continue to search for new members.

Much of my supplies that are available currently are in the program book that is in the packets. Please if you want a specific application use the name that is in the description. This allows me to serve you the best. I would like to take this time to thank our State Secretary for the many emails, mailings and calls I received when he was contacted for membership supplies.

Having touched on my program book please give it to your Membership Chair for I was saddened when a membership person was surprised for the first time seeing it, about a month ago, the person's comment was if I knew all this was available I would have asked for it. I told them they will have to be sure to get the new book from their Master this coming year as they are membership for their Grange, and if they don't get it, they will not have to tool they need to do their job.

Stephen Tracy, Outreach Deputy presented his annual report.

In a June 2010 GSG article I wrote called "What I did During Grange Month" I had just organized Croydon Grange and spoke on rebuilding Grange after having been trained by Rusty and taken Ed's challenge to activate or reorganize a Grange and I stated, "It may take awhile but here's a start." "I do hope that NH Grangers will feel comfortable with the money spent to send me to training under Rusty and Ed's tutelage. This is not the end of my efforts... I hope to repay you 100 fold by increase in membership across the state by putting my training into reality. Thank you for entrusting me with this challenge."

You win some, you loose some. Not everywhere I have worked has produced a new Grange but besides Croydon I have been instrumental in Manchester and Claremont and reactivated Upper Coos Pomona and Winthrop. I have assisted Mohawk with such new growth that they are balloting most every month and getting about 17 members out to each meeting. I'm figuring in the last 5 years I have been the reason we have about 30 new Grangers across the state. I have built up the Grange image in many communities and I have been able to 'give the Grange building fever' to others and the Grange Growth Team was started. Guess I did something right. Can I ask for all the people here who took any of Rusty's trainings to stand. (Ask individuals how many new members they have brought in.)

In April I had the opportunity to attend the ME State Grange Leadership Conference entitled 'The leader in all of us' with Chris. We got to learn about how to 'lead from behind' and 'how we should treat each other as if it was the last time we saw each other before leaving this life' and cultivating communities'. The Grange in ME is growing and we could learn a lot from them. Chris and I have discussed having a similar conference for NH.

Even though I have not been able to travel much this year due to the lack of transportation, I have been working for you still. I researched and presented information on grants to help the Grange and worked on getting the Grange advertised across the state. As promised last year I worked on updating the State Grange by-laws to be in compliance with state laws and to make us more welcoming. I have presented the grants, advertising possibilities and by law changes to Chris.

While I was still traveling I offered my assistance to Winthrop Grange who was down to about 2-3 active members and they were considering giving up. I said no. Those members spoke to people in town, I advertised a public meeting and they gained 6 new positive members (1 is a youth) from that night. There was a free meal of course. After the meeting the 2 attending older Grangers and I were discussing how the meeting went as we were picking up the meeting room. All of a sudden we noticed the new members (strangers a couple of hours ago) had congregated in the kitchen doing dishes, cleaning and making friendships. If any of those new members of Winthrop are present, please stand.

Mohawk Grange has had a jump in membership also. I place this on a good active Grange and good newspaper coverage of their activities. Also some members wear their Grange pins in public. I wore my Deputy badge to a public agricultural meeting and a couple that I did not know

were squinting at me trying to read my badge from across the room and then running up to me wanting to join the Grange.

One of the other new Mohawk members and my neighbor has kept me working on a Grange in Stewartstown. That Grange has not come to fruition yet so my neighbor took on associate membership in Stratford. He has been a big gung ho new member. Now wherever he goes and whoever will talk to him he is promoting Grange membership in NH and across the country. In less than a year from joining he has accepted the Overseer position along with Legislative/Ag chair in Mohawk and Lecturer of Stratford. Next step was Pomona where he took an Executive Committee position. He has also been my taxi since May. I would not have been able to attend Spring Fling or Legislative Day if he had not asked me to go and show him around. Although we are at polar opposites in spiritual and political paths, when it comes to Grange we put these differences aside and get the job done. Les Avery, please stand. Thank you.

Pomona's need help, not just in NH, but also in most states. I would like to ask the NH State Grange to consider hosting a meeting with the National Grange involved and other state Granges to really look into what Pomona's used to be that made them viable and work out a plan to make them viable again.

I hope you feel that spending Grange funds for my training has been worthwhile. Personally I feel it has been a waste.

Throughout this year I have been hearing of many NH Grangers who are friends to my face but have been backstabbing and mocking me behind my back causing ill will and blocking any progressive movement I try to institute. My Grange dream and reputation since I joined has been shattered by this activity. I try to be friendly and invite my supposed friends for ice cream or pizza at Grange functions and I'm told 'no, we are doing something else.' I later run into them gathered over pizza and one of them comes rushing up to me saying 'no, you are not welcome here.'

Several of my years doing membership in the Grange have been while I was unemployed but I gave my 'widows mite' giving the Grange more of my time and efforts than I should have. When my truck brakes gave out going to Farm and Forest I later heard that some richer person than I said I was such a waste since I can't even keep a perfectly good vehicle going. It takes money to maintain a vehicle and .30 a mile total income is hard to stretch into gas and maintenance.

Not only have I been ridiculed for my income level, of living within my means and can't afford designer label clothes, I have heard derogatory comments about my disabilities and how they affect my performance and the way I look, walk, and my spiritual path, etc. Not much about what I have been able to accomplish with my abilities.

"Wearing that garment is to teach you that those we admit into our circle are not chosen by outward appearance, and that we are not deceived by display in dress. It is to the mind and heart that we look for all good works; therefore, in your intercourse with the world, remember that a noble mind and generous heart are often concealed beneath the garments of poverty." I have heard that somewhere; has anyone else here heard that?

I have made suggestions of programs for this Grange to do to get the Grange into the community's eye as doing good to increase membership. These negative members have torn all those ideas to shreds. Later we hear of other organizations taking on those same programs and they gain notoriety and recognition for great work. How can I do my job of increasing Grange membership when some Grangers are tearing apart our public image and my personal image? Some of this even happened this week. I am banging my head against the wall and the wall is winning.

Our 1st Degree pledge states..."I will not knowingly wrong or defraud a Brother or Sister of the Order in word or deed; nor will I permit it to be done by another if in my power to prevent it. Should I knowingly or willingly violate this pledge, I invoke upon myself suspension or expulsion from the Order and thus be disgraced among those who were my Brothers and Sisters."

I consider belittling a low-income member who gives so much of his or her time, money and talent that he or she can't take care of their own needs or judging them on their disabilities or the way they look as wronging or defrauding a member?

I also feel backstabbing or verbally cutting someone's throat in public and in the Grange, being lied to and about is 'defrauding a member'?

Do these actions warrant a Grange trial? I have been told they do.

According to The Bully Project, these actions are bullying. Guess that is why that suggestion of a Grange project got shot down.

It is very difficult to go out in the public and speak positively about the Grange when I have been treated in this manner.

It is because of words and actions like these that I feel my dreams within the organization are ruined and also my interest in building the Grange has dropped like the world stock markets. I will always wonder if the actions of some of my brothers and sisters is why I never even got an interview or even a 'thank you for your resume and interest in the National Grange membership position' when Rusty retired.

Radio ads for The Bully Project state that 'a bully will stop within 10 seconds when a peer speaks up." For those few who have supported me, I thank you.

I belong to another statewide agricultural organization and it seems odd that they so appreciate my work that I have been asked to work on the state council and have been asked my opinion on many important issues and my opinions are sought after and appreciated. For another out of state organization I was offered \$17 an hour doing what I do for the Grange. Hmm, maybe I am appreciated; somewhere.

I have spoken at length about this pervading negativity in the Grange toward me with State Master Chris and I have told him I am considering giving my resignation as Outreach Deputy. Chris has worked very hard both as State Master and as a good Grange brother at trying to get me to change my mind and has worked across the state to change the negativity and backstabbing.

So Chris, since you have worked so hard standing up for me and believing in me and my efforts, I will accept your plea to stay on as the NH State Grange Outreach and Organizing Deputy at this time and I ask that you continue to try and turn this wave of negativity around before it ruins the reputation of the Grange in NH. I look forward to working with you in 2016. Due to your words and actions I will continue to work on building the Grange in a positive manner. Maybe together we can rebuild the Grange in NH.

Resolution #4 ~ Submitted by: Stratford Grange #238 Subject: NH State Police Coverage

WHEREAS, Troop F of the NH State Police based in Twin Mt covers 39% of the state and have the fewest number of troopers and

WHEREAS, most of these northern towns cannot support a town police department and

WHEREAS, other Troops with larger number of troopers cover smaller areas that have individual town and city police departments and

WHEREAS, some northern towns must wait over an hour for response during an emergency 911 call

THEREFORE BE IT RESOLVED, that the NH State Grange go on record supporting the NH State Police assign more troopers in Troop F scattered throughout the North Country.

Resolution #5 Adopted as amended

Resolution #5 ~ Submitted by: Claremont Grange #9 Subject: Safety of horse riders, horse drawn carts and carriages

WHEREAS: There is a law in NH to protect the safety of bicycle riders with very specific guidelines RSA 265:143-a Drivers to Exercise Due Care When Approaching Bicycle. – Every driver of a vehicle, when approaching a bicyclist, shall insure the safety and protection of the bicyclist and shall exercise due care by leaving a reasonable and prudent distance between the vehicle and the bicycle. The distance shall be presumed to be reasonable and prudent if it is at least 3 feet when the vehicle is traveling at 30 miles per hour or less, with one additional foot of clearance required for every 10 miles per hour above 30 miles per hour, and

WHEREAS: NH law to protect horse riders and horse drawn carts and carriages does not have specific guidelines' but is open to interpretation **RSA 265:104 Approaching Horses.** – Every person having control or charge of a vehicle shall, whenever upon any way and approaching any horse, drive, manage, and control such vehicle in such a manner as to exercise every reasonable precaution to prevent the frightening of such horse, and to insure the safety and protection of any person riding or driving the same, and

WHEREAS: there are road signs that show the specific rules for passing bicycles but there are none regarding the passing of horses, horse drawn carts and carriages.

THEREFORE BE IT RESOLVED: That NH State Grange through its legislative department actively work with the NH State legislature to modify RSA265:143 to include the following language: "The passing distance shall be presumed to be reasonable and prudent if it is at least 3 feet when the vehicle is traveling at 30 miles per hour or less, with one additional foot of clearance required for every 10 miles per hour above 30 miles per hour.", so that the final RSA will read: RSA 265:104 Approaching Horses. — "Every person having control or charge of a vehicle shall, whenever upon any way and approaching any horse, drive, manage, and control such vehicle in such a manner as to exercise every reasonable precaution to prevent the frightening of such horse, and to insure the safety and protection of any person riding or driving the same. The passing distance shall be presumed to be reasonable and prudent if it is at least 3 feet when the vehicle is traveling at 30 miles per hour or less, with one additional foot of clearance required for every 10 miles per hour above 30 miles per hour"

Be it further resolved: that once such legislative changes have been made that the NH Department of Transportation redesign the current bicycle safety road signs to show bicycles, horses, horse drawn carts and carriages so that the public is made more aware of it.

State Master Heath thanked the members of the Resolutions and By-laws for their service and accepted the report and ordered printed in the journal.

Richard Patten was presented to the Masters Station to present the Masters Address committee report.

We, the members of the Master's Address Committee, congratulate our Worthy State Master Chris Heath on his first year in office. We commend our State Master in his attempt to visit all the Granges in New Hampshire.

We concur with our State Master his reminder that outreach belongs to the individual patrons. The State Grange can assist, but they can't do it for them, which ties in with the General Deputy's call to visit neighboring Granges.

We support the idea of a degree day; however certain guidelines should be established. A minimum of ten candidates should be a prerequisite to justify the time and effort in holding the event,

We encourage the Grange to renew organizational ties with 4-H and FFA in hopes to attract new members.
