Worthy Master, Worthy National Master, State Officers, Delegates Brothers and Sisters:

As the Session Coordinator I would like to welcome all of you to the Lakes Region and hope that your stay here will be a pleasant one. Please take advantage of all the area has to offer during our down time and please take every opportunity to visit the display room as well as some social time with friends in the Hospitality Room.

The year was 2004, the late John West was State Master, the Lady Assistant Steward of the National Grange was our National Representative, the Red Sox won the World Series, and the hotel hot tub was bubbling over. In case you haven't already figured it out, this was the last time we were here at the Margate.

In your packets are evaluation forms; they are there for you to tell me what you like and don't like or what you would like to see or have at session. Please take time to complete them and comment. Constructive comments are best but will take what I get.

There is a question on meal prices that I already know the answer many of you will choose and that will be that they are too high. Let me assure you that this year, much effort was put into getting the best price possible. Deb & Dick Patten worked with the meeting planner, going back and forth with different options until one was finally decided upon at a reasonable price. Kerriann was told at the walkthrough that she could use a caterer for the banquet not on the Margate's vendor list. She found one more reasonable but because they were not on the vendor list they needed to pay a fee that would increase the price Kerriann was quoted. It ended up being cheaper to stay with what the hotel could offer.

Some of the obstacles in finding a facility that can accommodate our needs are

- Members in attendance: We are requesting space that can hold up to 300 people and we get maybe 125.
- Members are not spending the night at the hotel.
- Our food and beverage counts are low.

I think it is time that we have a discussion where we can really look at what we need for our session.

- Do we need all this space?
- Can we put the displays around the meeting room?
- Is it time to change the By-laws on when we meet and for how long our session is?
- Do we bring in speakers or performers to enhance our session and educate our members?
- How do we get those who don't attend to attend?

State Session should be a time to celebrate the past year and get fired up for the new one. That is why I'm asking for your help by completing the survey. I always looked forward to coming to session each year to see people that I hadn't seen since the last session. Hearing in the reports who won various contests. Which Grange was the high score for the year? Receiving the "New" programs. The list goes on and on. I believe that if we take a long hard look at our last few sessions and look for things to cut and add then we can once again have a session that members want to come to and activities that they want to participate in.

In conclusion, I would like to thank all who helped in preparing for the session. The delegates for attending and participating in the deliberations that are set before us and to the non-delegates for your attendance and interest in what the Sate Grange is doing.

New England Grange Building Trustee's Report 2017

The New England Grange Building trustees met five times this year. This is an increase over the normal three times. In January we convened at the Northeast Leaders conference in Rutland, Vermont to go over the unfinished business from the previous meeting held in July of 2016. The final figures from the 2016 Eastern States Exposition were reported as follows: Grange store took in \$28,266.30 of which \$1,768.50 was from the Quilt Raffle. \$15,142.03 was spent in purchasing supplies, entertainment, housing of volunteers and raffle supplies. Building expenses totaled \$4,962.58 which includes maintenance, insurance and office supplies. This means that the Building made a profit of \$13,124.27 from the fair. During the meeting the election of officers was held with the following results.

President - Noel Miller (CT) Vice President - Joe Goodrich (VT) Secretary - Chris Heath (NH) Treasurer - Vicki Huff (ME)

The next meeting of the trustees was held on the Fairgrounds in March at the Massachusetts Building. Items like the handicap ramp and the women's bathroom were discussed. Trustees also talked about the Junior display area and a way to secure the items being displayed. The staffing of the building during the fair was talked about. It was determined that we would need 139 volunteers to staff the building for the coming fair season. Each state would be responsible for three days. We also discussed participating in the parade on four days of the fair. There was much discussion on the Quilt raffle and it was decided to purchase a quilt rack to help display it. It was decided that we would have some flyers made up for the fair to hand out to people who purchase items from the store. The flyers would have general Grange information that would apply to all the states involved. There would be contact information for each state to enable fair goers to have contact information in their own state.

In July the trustees met at the New England Grange Building to clean up and prep the building for the fair. Beth Merrill rejoined the board at this meeting, upon the resignation of Adam Paquin-Varnum. Members gathered in the morning and put in three hours of work. Vacuuming, window washing, sweeping and dusting was completed prior to the meeting, which started promptly at 1 o'clock. The trustees were updated on the repairs and improvements that had been completed since the previous meeting. Final details concerning the tickets and parking passes were discussed. The store managers gave us the rundown on the new items that would be featured in the store and how the quilt raffle would be handled. Then they surprised us all by informing us that this would be their last year as building managers. The members then briefly discussed who the possible candidates would be to replace the building managers.

A special meeting was held in August to choose a new Building Manager for the 2018 fair season, resulting in the selection of former building manager, Connecticut's Dawn Percoski. Finding someone who can be available for seventeen plus days of the fair and also to attend several meetings during the rest of the year is a formidable task that will challenge us again when Dawn steps down from the position.

The numbers have been distributed and the New England Grange Building did about the same as last year. The total receipts this year were \$28,200 with \$12,809 coming from the store and \$15,500 coming from the crafts. This year the quilt did really well and raised \$4,075 which will be split between the Vermont Veteran's Home in Bennington and the Hurricane Relief Fund. The trustees were able to save \$2300 this year by replacing the full breakfast of the past several years to a continental breakfast on Grange Day. We had about 40 people march in the parade this year and were glad to have the National Lecturer, Chris Hamp join us. She said she's heard about the Big "E" for years and years and she and her husband, Duane decided they needed to make the trek from Washington State to New England to check it out. Sounds like a fun way to do research, doesn't it?

This year the fair was attended by 1,525,553 people over the 17 days and it seems like most of them came through the Grange Building. Think of all the potential new members that are out there!

The committee has been working diligently to get all of the preparation work completed that is necessary to host the convention. The team has been meeting once a month to review the guidelines that National Grange has set forth concerning the Session and the regions responsibilities. This year's team is made up of representatives from all the Northeast states and each state has a coordinator. I have volunteered to be the coordinator for the state of New Hampshire. I've had the pleasure of working with Beth Merrill at the last Northeast Regional Convention back in 2013 in Manchester NH.

The team started out by discussing plans for this year's National Session as it is our responsibility to send representatives to man a table to promote and encourage Grange members from around the nation to attend our regions conference. Each state was responsible for providing 50 crochet snowflakes to hand out during this year's National Session. Thank you to Ida Hutchin, Katherine Umberhind and Joyce for providing the majority of these snowflakes. The Connection will also be selling chances to win a gift certificate for a day at the spa located at the Stoweflake Resort, at this year's session. The money raised from this raffle will go to help pay some of the expenses we are responsible to cover.

The committee will coordinate volunteers who will come to help host the National Grange. New Hampshire will be responsible for providing volunteers for Wednesday. Volunteers will be helping with all aspects of the session. Anyone who would like to volunteer to help at Session should me. We will need help in the hospitality room, the production room, registration as well as other jobs that need to be filled. The committee is responsible for planning the host banquet, the breakfasts and luncheons being held during the week. They also have to coordinate speakers for these events. The committee plans the transportation, tours, flowers, ditty bags and other aspects of the convention.

Robert Trombi State Overseer, introduced State Master Christopher E. Heath to present his annual address.

National Representative, State Officers, Pink Sash family members, delegates and patrons all, as I stand here and present to you my third Master's address, I reflect on the many things that have happened over this past year and I struggled with what to say to you all. This year has had a lot of ups and downs for the Granges across New Hampshire. Personally, the past three months have been very difficult for me as the Master of the State Grange.

At the beginning of the June, I was notified that a Grange was considering closing their doors for good and approached me about the process for closing their Grange. I went to meet with them on multiple occasions to explain to them the process, answer their questions about Grange property and what would happen if they decided to close. The members did put forth a valiant effort to get new members into their hall but unfortunately they were unable to rejuvenate interest in their community. On July 10th, they voted to close their Grange. This was a very sad day for me. I do not want to have any more Granges close.

Recently, another Grange decided they too were going to close. They did notify me of their intentions but without adequate notice of when they would be voting to close. Questions about the procedure for closing a Grange were never asked and the Master decided that they knew what to do so no State Grange representation was present. This is not the correct way to perform this procedure and it is not acceptable. Unfortunately they closed their doors without the authorization of the State Master or the State Grange. If it were not for my compassion, sympathy and leniency they would not be closed..

We have had two Grange's consolidate this past year. The first Grange did notify me and followed the process laid out in the bylaws for consolidating. The second Grange was consolidated by authority of myself and the State Grange Executive committee. The Grange was struggling to meet the requirements and the action was the best thing for them.

Last month, I had to revoke the charters of three Granges for multiple reasons. One of those

reasons was that they had made no attempt to communicate with the State Grange and continued to operate under their own rules. Another reason why these charters were revoked was because they were not holding regular meetings with a quorum present.

The bylaws of the National and State Grange's are in place for a reason. For the past 150 years, these are the rules that we have been operating by. The rules are there for a reason and Granges need to follow them. I am happy to report that one of these Granges has had the revocation lifted and are currently working to become a Grange in good standing. I agreed to give them 12 months to work with the State Grange and come into compliance with the requirements of the bylaws. On a positive note, at their last meeting, I had the pleasure of obligating eight new members into this Grange. I am very hopeful that they will become successful in their community.

A second Grange, that had had its charter revoked has filed for an appeal with the National Master and has been granted a stay in their revocation. The State Grange will be working with this Grange to come into compliance with the bylaws which caused the revocation in the first place. I have assigned a deputy and a state officer to work with them closely to ensure that they adhere to the bylaws and become a productive Grange in their community.

The third Grange had not met for over two years and had basically abandoned their hall. This Grange has now been officially closed and I am in the process of collecting the Grange property and selling their hall. All of these actions are not what I wanted to do this year and if I could have done anything to avoid them I would have.

Unfortunately this is not the end of the consolidating, closing and revoking that has to happen in our State. There are other Granges that are not following or adhering to the bylaws of the National and State Grange's. I will do my best to work with these Granges to get them into compliance, but this takes the effort of the members of these Granges to get themselves back into compliance with the rules. The State Grange will make every effort to help and support all Granges.

Time and time again I hear members say that the problem is at the State Grange level. In fact the problem is not on a State level, it is on the community level. Granges need to realize that if there is a problem, they need to communicate it to the State Grange so that we can provide help and assistance.

You might ask yourselves why did I start my address with all of this bad news. The reason is because we all need to know the truth about what is happening with the Granges across our state. Not all Granges are in this deteriorated condition and many are thriving. I have been saying, since I was elected to this position, every Grange needs to work on membership. My articles in the GSG have tried to reinforce this message. The membership column in the GSG also has affirmed the issue and offered help. Disappointingly, the membership committee has not had one single request for assistance this entire year.

This is very disturbing especially when we review the membership totals for the year. Our membership numbers are headed in the wrong direction. Instead of staying steady or increasing, we are losing members. This is a trend that we need to reverse. We need to find new members to

come and be a part of the Grange. We need to acquire new faces that will become familiar faces. We need to teach and mentor these new people in the workings of the Grange and give them the tools they need to keep the organization going.

The Grange in New Hampshire has lost its identity. We need to find it again and make it viable in this day and age. We need to be able to attract new members, young and old and get them involved. The New Hampshire State Grange needs to establish this identity and provide the Granges with the tools and resources to make it relevant in the community. It is time for the members of the State Grange to consider working with an outside source in hopes that once we have a plan of action, we can be successful. I recommend that the delegates task the State Executive committee to find and work with a person whose job is to help companies establish a plan for Growth and Development.

We need to work with other agricultural based and civil oriented organizations to support the rural living that our state is famous for. More and more people are supporting local businesses and trying to live within the resources available locally. This is the exact movement that the Grange needs to be involved in. The Grange is the perfect place to get grass roots actions started and we offer the perfect platform to bring these actions to the people.

I recommend that the State Grange consider spend some funds on advertising the Grange. This can be through television, magazines and newspapers. We need to dismiss the stigmas associated with our name. We need to show the public that we are not a secretive organization. We need to inform them that we are not just for farmers. We need to reestablish our power in grass roots activision. We need to become the force that we once were so many years ago.

I recommend that we offer incentives to our members for recruiting new members. These need to be real tangible items that members want to strive for. They do not need to be exorbitant or lavish in nature but must be something that members will feel is worthy of their work and time spent recruiting new members. Money is always a good motivator and I can think of no one who wouldn't mind having some extra cash in their pocket for a minimal amount of labor.

Granges should be aware that the National Master has ruled that members can attend meetings electronically. This is a good incentive for new members who cannot physically be at every meeting to attend. Skype anyone? Conference call? This does not mean that you can have a meeting without a quorum of seven people physical present in the hall but it does mean that everyone can have the opportunity to be included in the decision making process on projects the Grange is working on and provide their input to the meeting..

Granges need to be reminded that the National Grange has instituted the Junior One Plus program. This is an opportunity to have young members join your Grange. It is a perfect opportunity to mentor and raise youngsters in the Grange. We have the opportunity to secure our future through this program. Once we have the juniors involved, we have the opportunity to get the parents involved. It is very important that the Secretaries accurately report these junior members on the quarterly reports.

Granges please remember to communicate with the State Grange. I have had quite a few

members bring to my attention that they have not been receiving information from the State Grange. I ask them if they have changed their addresses or their officers to which they reply yes. I then inform them that unless they tell the State Grange that this has happened, how then will we know to where to send the information? The State Grange does send a reporting form for a reason. We use these lists to create the roster that is then given to every Grange. It is very important that this information is kept up to date.

I have been made aware of an issue of Granges struggling to find insurance. It appears that the policy that used to be available for Granges has been discontinued. This is partially because of the lack of Granges in the state and not enough revenue to keep this type of insurance available. This is not just a New Hampshire issue. Granges all over New England are experiencing this same dilemma. I am working on finding a more affordable liability insurance for Granges but this is not an easy or speedy task. I recommend that the State Executive committee work with an insurance agent to find out the feasibility of having an umbrella policy for all the Granges. This will relieve some of the pressure on our Granges.

In conclusion, the members of the Order of Patrons of Husbandry need to start doing something now to control the fate of our organization. Each and every one of us needs to put aside our petty differences and work together to grow our Grange, mentor each other and new members, promote the organization to every and all people we come into contact with, and uplift each other in every aspect of our dealings. It is no longer about who did what or who is doing this or that. It is all about our love and dedication to the Grange that we all have. We all must make it our responsibility to ensure that our beloved Grange survives into the next century. All of us need to do our part. It is the responsibility of every member. Let's all reaffirm our title of Do'ers in the Grange. Let's help each other and show that brotherly and sisterly love that we are supposed to have towards each other. We must act now because if we go another year in the direction we're headed we may just cease to exist.

Dan Bascom State Treasurer presented his annual report.

Worthy State Master Chris Heath, National Master Betsy Huber, Fellow Officers, and Grangers All:

I guess when you're having fun, time flies. I can't believe State Session is already here. It has been an eventful year. All investments are up across the board. The best thing the Ex. Committee did was to move our accounts to Morgan Stanley. Yes, we have a down year once in a while but since I have been Treasurer our net worth has increased greatly.

Being Treasurer of 7 different nonprofits plus my regular job and our farm leaves me little time for much else. This year being no exception I found an IRS web site in early March that showed me what Granges had filed their e-postcard and those that had not. As many Granges had called me saying they were having trouble filing, I took it upon myself to file for them. I found 5 Granges that had not filed for 3 or more years and they lost their nonprofit status. I am now in the process of helping 3 of them regain their nonprofit status. The form consists of 19 pages and requires a fee of \$400.00 per filing.

Therefore, I am now filing for all Granges, so we don't have to go through this process. You will find your copy in your Grange packet from the State Secretary.

In examining the budget, you will notice we spent more than we took in. This is mainly due to National Session 2018. Each State in the Northeast region was charged a fee of \$ 4,500.00 plus we were required to purchase \$ 1,450.00 worth of T shirts to resell. Please buy yours today and help us recoup our money. In the past we have charged each Grange to help cover this cost, this was above and beyond the assessment already paid to National Grange. With our investments doing so well the Executive Committee felt State Grange could cover this cost this year. A fee will be levied once every 5 years by the Northeast Connection when National Session is in our region. You will notice a new line in the budget to set aside money each year for future National Sessions.

As I don't receive all financial statements until about October 15th, this leaves me very little time to complete my financial report for year end. All financial figures will be printed in the journal. I do have to say the State Master has and will continue to keep me very busy helping him with the work he continues to do. We are finally seeing some Granges that we have had issues with being resolved one way or another.

In September I discovered many Grange had not paid their 2015 National Assessment. A few others still owed us for bonding. I have sent them all bills to help recoup this money and some has already been received. Others have informed me their Pomona's pay them, only one Pomona has paid up so far. This, along with unpaid dues also affected our bottom line and if paid on time would have reduced our deficit budget even more.

In closing I am pleased to serve as your State Treasurer. I enjoy working with all our State Officers and am proud of each and every one of them and the work they do for our organization.

We began the year with 55 Subordinate Granges and a membership number of 1498; Manchester Community Grange #359 closed as of December 31, 2016. Leaving us with 54 Subordinate Granges. We lost 85 members from death, suspensions or demits and gained 18 members leaving us with a total membership of 1431 giving us a loss of 67 members.

On a positive note the following Granges did have a gain in membership:

The largest Subordinate Grange is Wicwas Lake Grange #292 with a total of 90 members.

As this report is being written it is important to note that several Granges are in the process of consolidating or closing and will be finalized by the end of the year and two other Granges are on appeal with the National Grange.

Pomona Granges: We currently have a total of 8 Pomona Granges with a total membership of 473. No Pomona's had a gain in membership. The largest Pomona is Pemigewasset Valley Pomona #18 with 85 members.

Following State Session my first priority was to finish assembling the 2017 NH State Grange Roster. I am happy to report that it was ready for Deputy School in December. This is a monumental endeavor requiring many hours of inputting of names, addresses, E-mail addresses, and phone numbers. Many of you may have noticed that several Granges had no Officer, Committee Chair or contact information listed on their page. Prior to this year, I had been coping what was listed the previous year and discovered that several of the Granges had very outdate information, so those pages were left blank simple because the Grange did not send in the Roster Information sheet.

The deadline for returning the form that was sent in the September mailing, was and for several years has been November 1st. Forms that were received after the deadline were added usually on a daily basis. The day came when I just had to get the Roster to the printer. The following day another form was received in the mail. Fortunately the printer had not begun printing and the Granges information was added. Hopefully this year every Grange will send it the form and all granges will be listed.

The Journal of Proceedings for the 143rd Annual State Grange Session was completed and ready for distribution in early February. I have usually had the Journal completed by Deputy School but with the Roster taking up so much time I was unable to get it completed. Another reason for

the delay is the death of Stephen Tracy. You may ask why this had anything to do with completing the journal. This document is the history of the activities, reports and results of the action taken at the session. Unfortunately I didn't receive an electronic or printed copy of his report that he gave at session. I was waiting and hoping that those going through his grange papers would find a copy which was never found even searching the computer that he borrowed came up with nothing. As a result all those giving report at session are now being asked to send me a copy prior to presenting it.

Having the journal completed quickly remains a priority to me so that those wishing a copy can receive one while the session is still fresh in their minds. I'm a little disappointed that very few Granges requested a copy of the journal and only 3 individual members requested one. I do hope that many did take the time to review the journal on the NH State Grange web site.

Near the end of each quarter a packet was sent to each Pomona and Subordinate secretary with information for the members as well as the usual report forms. I can't stress enough how important it is to complete the reports and send them in on time. What we pay to National Grange is based on the membership numbers from these reports. If I don't receive a report from a Grange the membership number I use on my report is the number last reported. There have been times when a Grange report was submitted after my deadline to National and the Grange reports a loss of members. If these reports were sent in on time we wouldn't have needed to pay dues on the lost members now being reported. I also need to stress that it is extremely important that the dues check accompany the report. Several granges are sending these separately which requires unnecessary documentation.

As the Secretary it is our duty to keep our members informed and this is done with the reading of communications. I have said this before and will say it again I would like each subordinate and Pomona Secretary and Committee Chairman to establish the following philosophy, if it's mailed to you for your Grange, read it out loud to your members. The communication doesn't need to be read word for word giving highlights is fine as long as the important information is shared. The supply department continues to be very busy filling orders. I am very pleased to report that a "NEW" order form has been developed and sent to all Granges. This has really assisted me in ensuring that all orders are filled and sent more efficiently. Receiving of membership award and supply requests on scrap pieces of paper or in an e-mail has ended. Each Grange is now required to send the appropriate completed forms to me. New blank forms are sent back with the order. This is done for two reasons, one this replenishes the Granges supply of forms and two, for those awards coming directly from National Grange receiving a new blank form lets the secretary know that I have sent the request on to National Grange.

Now that all the materials have been updated membership award forms and supply order forms have been placed on the newly revised NH State Grange website.

State Session is once again approaching and with that comes the preparations associated with it. The program was created, printed, and folded, resolutions formatted, printed and collated, ribbons ordered, delegate packets assembled the list goes on and on. I must admit that while this

seems to be overwhelming I find it exhilarating and look forward to the whole thing coming together.

In conclusion I would like to thank the members of the New Hampshire State Grange for the opportunity to serve as your State Secretary. Of all the opportunities that I have been given in the Grange this is one of the most gratifying experiences. At times I have asked myself "what were you thinking, are you crazy"? Then I remind myself that I come from a long line of Grange members and very proud to let people know that. Most of what I do is out of love for this organization and not obligation. I am very proud and fortunate to have my two daughters who are fourth generation members very involved and enjoy doing something with Dad. What more could I ask for.

Meeting called to order at 7:34 PM by Daniel Bascom.

The minutes of the April 20, 2017 meeting were reviewed and minor corrections were made. A motion was made Wilber Heath and seconded by Bob Haefner to accept the minutes as corrected. Vote was favorable.

Master's Report:

• Received a letter from West Thornton Grange requesting that the State Master be present at their July 10, 2017 when the members are expected to vote to close their Grange.

Secretaries Report:

- Barnstead Community Grange: Last reported September 2016. Currently 2 Quarters behind December 2106 and March 2017, and owes NH State Grange \$108.00 in past dues.
- Daniel Webster Grange: Last reported September 2106 however no payment (\$201.50) was received. No payment (\$201.50) was received with March 2016 report. No reports or payments for December 2106 of March 2017 (\$201.50) each. Currently owes NH State Grange \$806.00 in past dues.
- Granite State Grange: Last reported December, 2015. Currently 5 quarters behind and owes NH State Grange \$253.75 in past dues.
- Mohawk Grange: Reported for March 2017 however no payment (\$348.75) was received. No report or payment for September and December 2016 quarters (\$348.75) each. Owes NH State Grange \$1046.25.
- Pleasant Valley Grange: Last reported December 2015. Currently 5 quarters behind and owes NH State Grange \$471.25 in past dues.
- Prentice Hill Grange: Currently 2 quarters behind and owes NH State Grange \$201.50 in past dues.

Family Units: 2 Granges incorrectly reported their "Family Units". Both secretaries have been contacted and instructed as to how to report family units. One grange has reported incorrectly for two previous quarters, however I hadn't catch it and let it go. This past quarter they owe \$31.75.

Treasurers Report:

- Current Income and Expense reports were presented to the members and questions answered. With two weeks still left in the quarter the amounts in some lines will change.
- Jeremiah Smith Grange had not filed for nonprofit status and is being assisted by the State Treasurer.

Unfinished Business:

- A unanimous E-mail vote of the Executive Committee prior to this meeting regarding the hiring of an individual to clean the hall, mow the grass and clear the stairs and walkways of snow was held. Further discussion was held and Wilber Heath will be in contact with the Building Managers instructing them to hire someone at \$15 an hour.
- Dan announced that he needs to set up a meeting with Morgan and Stanley and will be including Tricia Taylor and Wilber Heath.

- Plus One Program: Chris Heath reported that he has been in contact with the National Master and it appears that there is no clear definition as to what the program entails. He is currently checking with Samantha Wilkins, National Grange Junior Director to see if an information is available.
- Current insurance coverage is expiring in July. Chris Heath will contact our carrier to see what our options are.
- Directnic (website host): changing all contact info to the State Secretary has been difficult. Chris Heath will be in contact with them to change and make sure all fees are paid and current.
- 2017 State Session: Walk through was conducted and plans are well underway. Some changes to the program. Banquet information will be going out in early August.
- 2018 State Session: Jerry Leclerc will contact the Best Western in Keene and set up a date to meet with them to write a contract for 2018.

New Business:

- Chris Heath and Bob Haefner recently did a radio spot in April on WTPL and spoke of Grange activities.
- Chris Heath gave an update on the National Grange/California State Grange case:

Willful Defiance of Federal Court Order Keeps Costing the Guild More Money

Judge Shubb awarded the National Grange its attorney's fees and costs associated with enforcing the \$145,000 attorney's fee award issued last September. As you will recall, Judge Shubb originally sanctioned the Guild for its "willful and deliberate" violation of the court order prohibiting the Guild from infringing any Grange trademarks. Thereafter, the Guild engaged in a concerted effort to evade the attorney's fee judgment, requiring the Grange to expend significant time and resources tracking down the money. The Grange's efforts eventually led the Guild to pay it over \$145,000, but that only represented part of what was owed, as the National Grange was entitled to recover its attorney's fees and costs in making the Guild comply with the sanctions award. Judge Shubb's order yesterday awarded the National Grange \$50,283 in attorney's fees and costs, and declared that, "because [the Guild] has yet to pay the costs awarded [to the National Grange], **the court will not state in this Order that defendant has satisfied the September 2016 judgment.**"

In addition, the National Grange has submitted supplemental applications for over \$19,896.62 of additional attorney's fees and costs that were not included in Judge Shubb's order.

The \$50,283 awarded brings the total cost of the Guild's violation of the court order to over \$195,000. In addition, the supplemental applications for fees and costs will add another \$20,000

to the Guild's tab. As a result, the Guild's refusal to obey the court will cost it over \$215,000 (plus accruing interest).

And, of course, until the Guild fully satisfies the attorney's fee award, Judge Shubb's order assigning all dues and loan payments being paid to the Guild to the National Grange remains in full effect. If your organization is paying the Guild, it must send that money to the National Grange pursuant to that order. I strongly encourage any such organizations to carefully consider the court orders and, if necessary, consult with independent counsel before sending any money to the Guild.

Motion made by Chris Heath and seconded by Bob Haefner to close in Public Session and enter in Executive Session. Vote was favorable.

Closed at 8:31 PM Reopened in Public Session at 8:45 PM

Chris reported that the Vermont State Grange has asked to borrow some of our 6th Degree staging when they host National Grange in 2018.

Next meeting: August 31, 2017

Motion made by Mark Collins and seconded by Tricia Taylor to adjourn. Vote was favorable.

General Deputy Andrew Savage was presented to the Master's Station to present his annual report.

Worthy Master, Brothers, and Sisters

This past year has been very challenging for our state grange, but that's probably not news to those of you who are here listening to this report. In fact, I think we have reached the point where we need to stop calling this a challenge, and acknowledge what it truly is. This is a threat to the very existence of our organization. It behooves us all to do whatever you can to help the Grange grow, before it really is too late.

Subordinate Granges

Declining membership has brought us to the point where nearly 1/5 of our current granges are in danger of losing their charter due to their lack of members. The subordinate granges continue to struggle, and in many cases the granges that need the most help are the ones least likely to request it. If we continue to close or consolidate granges at the rate we have been doing so these

last few years, we might just live to see the day where we lose our state grange charter due to a lack of subordinate granges.

I talked about three types of granges last year. The proactive, the reactive, and the nonresponsive. I believe these categories can also be applied to the way granges go about recruiting members. The proactive granges are the ones who are actively getting out into their communities to put on programs or events, and inviting the people who attend those events to come to their meetings. They always have membership paraphernalia on hand and are not afraid to hand it out.

The reactive granges are also getting out into the community, but they're leaving the membership brochures at home, or not engaging the public in a discussion about the grange itself. They're happy to take in people who show an interest, but they're not making that extra effort to create interest. Finally we have the non-responsive granges. These granges make no effort to follow up with non-members who show an interest in the Grange. When they are out and active in the community, they tend to maintain a low profile about their grange membership, and rarely ever have any membership paraphernalia on hand. Some of our non-responsive granges can legitimately claim that they just don't have the people to put on the events that might generate interest in their community. If they were here today to listen to my message, I would encourage them to help other organizations put on community events, but get approval to hand out membership paraphernalia. Sometimes the members of those other organizations would be interested if they knew what we had to offer.

We are a grassroots organization, and the State Grange doesn't have the resources to help all the granges that need it. That doesn't mean we will not try when asked, so don't hesitate to do so. What we could do in addition though, would be asking members from the proactive granges to reach out to their neighboring granges to see what they could do to help. Help doesn't always have to come from the top. Sometimes just visiting a nearby grange helps, because we all have more fun when there's more people around. More truly is merrier. It also provides an opportunity to share ideas for promoting the Grange. Having someone in a nearby town to share ideas with would probably be more productive than having to call upon a member of the state grange who might live an hour or more away.

After we get new members, some granges experience difficulty in keeping those members showing up at meetings. As odd as it might sound, learning the ritual is a great way to keep those members. Done properly, the ritual brings us together and makes us grangers, rather than a group of people sitting around a room. When you read straight from the book, you lose some of that energy that brings us together, especially if you're stumbling over the words. If you don't care about the Grange enough to learn the ritual as best you can, why would any new members care to learn it? I'm not asking you to rely solely upon your memory when doing the ritual; I'm just asking you to learn it well enough so that you can occasionally make eye contact with other people in the room while you're doing the ritual.

As far as total membership stands, about 1/3 of the reporting granges give a different number in their deputy report than they claim on the quarterly reports submitted to the state secretary. Although this discrepancy has little bearing on active membership, it would be nice to know for certain exactly how many members we have in our state.

Speaking of active membership, roughly 1/5 of the granges in our state have difficulty meeting quorum on a regular basis. I know this is the same fraction I gave earlier for granges with dangerously low membership, but the sad fact is that these are not all the same granges. Active membership is important because without a quorum, a grange can't reliably conduct business even when it's time critical. They will also have a difficult time properly performing the ritual, as members may never be sure which office they will have to fill. Also, as I mentioned before, the more people at a grange meeting, the more enjoyable the meeting tends to be.

There was a definite improvement in the number of granges filing their 990s this year. There are a few granges that still need to work on this issue, but my reports suggest that they are seeking that help. I feel that I do need to call some attention to the failure of granges to have their books audited by their executive committees though. According to my reports, nearly half the granges are delinquent in getting this done.

This year when the deputies visited the granges this Fall, we asked them to exemplify passage to different degrees. Although the level of ability each grange demonstrated varied, I was most disappointed by the fact that 1/3 of the granges didn't even make the attempt. How can we improve our ritual if the granges aren't even willing to make the effort?

Our efforts to emphasize the opening and closing ritual of the grange continue to have some success. The number of granges not performing any type of opening ritual has dropped slightly from about 25% to around 20%.

This year, we again continued to challenge the granges to accomplish a goal that would require them to get outside of their comfort zone. The intent of the goal this year was specifically aimed at membership. Sadly, this reduced the success rate from about half the granges down to around 1/3 of the granges, despite the fact that we increased the points awarded for completing the goal. We decided to recognize the two categories for scoring this year, small and medium granges.

These were based on the total membership of each grange so as to give the smaller granges a chance to gain some recognition. We do not have enough large granges in our state to validate a third category.

Based on the scores for granges who submitted their reports in a timely fashion the results are:

Small granges: 2^{nd} place – a 3 way tie between Claremont Grange, Gilman Grange, and Watatic Grange 1^{st} place - Baker's River Grange

Medium Granges: 3rd place – Wingold Grange 2nd place – Hampton Falls Grange 1st place – Blow-Me-Down Grange

Congratulations to all of these granges for the work and effort they have put into the organization over the past year.

Pomona Granges

There isn't much to say about the Pomona grange that has not already been said. I find myself in agreement with Arthur's assessment that the Pomona granges are no longer serving any vital purpose for our order.

None of the Pomona granges exemplified the fifth degree this year.

Some of the Pomona granges are struggling to find a purpose, but for the most part, they're simply meeting socially and sharing what the subordinate granges are doing.

Like the Subordinate granges, some of our Pomona granges continue with their struggle to gather a quorum at all their meetings. They are also having an even tougher time with book auditing than the subordinate granges. None of them are accomplishing this task in a timely manner.

The highest scoring Pomona granges this year are: 2nd place: Hillsborough County Pomona 1st place: Pemigewasset Valley Pomona

Conclusion

I would like to thank the deputies who continue to do great work around the state; I would not be able to do this job without you. It's a difficult, time consuming, and often thankless task, so I am here to give you what little I can in the way of thanks for all the time and effort you put into our organization.

Worthy Master, National Master, Officers, Directors, Delegates and Grangers all. This is my seventh report to you as your Legislative Director. Last year I announced that, now former Representative Sad and I had both left the NH Legislature. I am here to report today, that there is life after the legislature. It is amazing how often the both of us have said that we are glad we are not in Concord this term. There are very few Grangers left in the NH Legislature in Concord. That is a shame, Ninety years ago we had 105 Grangers representing their communities in the legislature, now I think it is four or five.

As your Legislative Director I continue to serve across a broad range of Agriculture and Agriculture related organizations. I am not only a member of the NH Farm Bureau, but also represent the NH State Grange on the Farm Bureau's Government Affairs committee. One of the goals I had as the Director was to move the Grange and Farm Bureau closer together. I have also now been elected to the board of the Hillsborough County Farm Bureau, where I will continue the message of Grange to the local Farm Bureau. I also have a membership in the New England Farmers' Union. I, along with Rep. Sad have for a number of years also been judges for the State FFA Convention and even went to the National Convention a couple of years ago as judges. We have also judged for 4H. We have both been active in State Agriculture and Rural Leaders as well, as members and are now staffing the same organization of rural leaders.

Last year we presented the Legislator of the Year Award to Representative Shawn Jasper of Hudson and the Speaker of the NH House. At the Awards Banquet this year we will give the award to Rep. Lynne Ober, Vice Chair of the NH House Finance Committee and Chair of the Finance sub-committee that over sees all state agencies except Health and Human Services, and Education. Rep. Ober is one of the hardest working representatives in Concord and serves Hudson, along with her Husband who chairs State and Federal relations and Veterans Affairs I would like to challenge subordinate Granges across the state, next fall, to host candidates' nights. You can do that for something as simple as school board debates or something much larger. It is time again for Grangers to stop complaining about government, elected officials and policies and do something, Write letters to the editor, write letters to elected officials, put on candidate nights, go to listen to candidates, know who you are voting for and what they stand for, or run for office or a board. Get involved. Thank you all.

Brothers and Sisters delegates alike, 2017 I had found myself leaving my good times as Membership director becoming the Agriculture Director for 2017. Having a great passion for agriculture, I gladly accepted. I had high hopes and came up with plans of things I wanted to complete this year. I created a booklet with applications and information of what programs that the New Hampshire State Grange Ag Department has available for Granges to call upon. It is true that I am asking for the Granges to help with travel for the speaker. Yet this year I had only 1 request made by Gilman Grange to come and talk about what we have available, and what awards we can do.

This year I once again have a booklet. This booklet is in the packets that you as delegates will be bringing back to your Granges. Not only will my booklet be in this packet but a program from all of the NH State Directors will be in the packet. Sadly when I've been visiting Granges I've been hearing "I never got this." This is why I'm going over what is in this booklet with everyone here. Page 1, a table of contents, Page 2, all the programs, and who my committee members are, Page 3, the criteria for all the Awards that we are looking for nominations, Pages 4-7 are the applications for all of these awards. If you know of a Farm (does not need to be A Grange member) that is 50 years or older, or a farmer that is just starting a farm and looks like they are doing a great job you may nominate them for young farmer. This past year, I did not receive a single filled out form, but thankfully a couple Grange members sent me some suggestions, one had brought a newspaper clipping to me at Farm and Forrest, Thank you Sherrill. And one Grange member called me and suggested two other recipients that he knew of, Thank you Richard. I do know that Pat Izzo has been looking into farms in Stratham and I can't wait until next year when I can see these farms suggested for their awards. There are a lot of farms out there that qualify for these awards and hopefully we can recognize more than 1 each year as they are very deserving.

Now that I've gone over my booklet let me tell you about the great time we had at Farm and Forest this year. With a lot of help from my committee and Membership we had multiple fun events for the Fair goers to do. Les Avery took the time to make a what is the seed find, and brought an antique butter turn, that many people got a turn to spin. Not only did he have these two things for everyone to do, but he also brought a round of a cedar tree for people to count the

rings and see how closely the trees rings grow to each other as cedars are very slow growing trees. Thank you Les for everything you bring to this event every year. We probably had enough with what Les had brought, but I had volunteered to do some things also. Though 1 of my ambitions didn't come thru for farm and forest (a chicken that would either lay an egg if given enough food, water and time {represented by different colored beads}, or would produce by product if given to much of any of these things), I was still able to come up with an incubator full of plastic eggs that when candled (a way of looking into an egg during incubation to check on development) would show blood vesicles, and embryo's growing. On the bottom of each egg was a number that coincided with what state the egg was in for development. Many a person would get to 20 or 21 to find that they couldn't see into the egg, so I would pop open the shell to reveal a fully formed chick demonstrating how it takes up the whole space inside the egg.

I also fixed Dudley's legs (at least for a while). For those who are not aware of it a few years ago at farm and Forest I had inspired to make a goat, out of rigid foam insulation, that would do what goats do, eat whatever gets put in their mouth. In this case it was a Fund-raiser someone would put money in his mouth someone would flip his switch and is mouth would open and close while he was eating the money. He got a lot of attention that year. But not nearly as much as he did this year.

This year Dudley decided to be gender reassigned to become a doe goat that could be milked. Using rubber washing gloves with 3 tied fingers and a sponge that filled the remaining cavity of the glove we managed to get the goat to be able to be milked. To keep things clean we used normal water that was stored in its body cavity and as people would milk air would be allowed into the container and more water would soak into the sponge. Many of the kids and some adults found it to be a fun way to pass time.

I loved how our booth looked this year and how engaged everyone was with the crowds of people. But sadly we got second place. Well there is always this coming year, and Membership and Ag as agreed to work together on it again. We are just waiting to see what the coordinators of the Fair have for a theme this coming year so that we can start coming up with crazy plans on how to get more interest in the Grange. I would like to thank everyone that helped in the booth this year, but would like to single out Jerry and Sarah Leclerc for their first time coming to Farm and Forest to man the booth, as it is always great to see new faces along with the always helpful repeat faces representing our Granges at our largest membership drive each year.

One of the things I really wanted to do this year was to set up a visit a farm Ag day Awards day. But about 3/4's of the way I realized between the cost of the awards, food, and things that we would need to have this day my budget of \$200 dollars, would fall a few bails short of a full hay wagon. This made me start looking into other possibilities. This year we are giving the 2016 century farm award to Sanctuary farm in Sunapee, NH, and 2017 century farm to Sullivan farm in Nashua NH, A friend of the Farmer award to Concord Farmer's Market, and a young farmer from Concord NH by the name of ______. I have been putting Exhibits in the fairs to help raise money for my budget to put on a good 1 day event to promote Agriculture better this coming year, and will hopefully be able to do something at a farm over sitting in a banquet room. In final thoughts as I am writing this I would like to let everyone know that Laraine Merrill has decided to not continuing being the NH State Ag Commissioner and when we see her at this year's session please thank her for all the hard work she did during her time as the NH State Ag Commissioner. Remember if we as individuals, and groups, do not stand up for farmers and time tested Agricultural practices, more and more regulations will make it impossible to produce our own food here in United States, and we will become dependent on foreign countries to get our food. Don't just hug a farmer, feel free to contact representatives in the State and Federal levels when you feel that the farmer may be getting pinched with new regulations, for no matter how hard we work on protecting farms, there are people and groups that work just as hard to see farming end.

In closing I would like to thank all the members on

my committee, Richard for letting me do my awards at the awards banquet this year, my mom for putting up with me having a 4'X4' confused goat in the living room while I worked out how to make him become a milk-able girl, and finally Chris for appointing me as the Agriculture director of the New Hampshire State Grange.

Educator – James P. McCollum, Jr. – Concord, NH

The Educator of the Year is James P. McCollum Jr. who is currently the Principal at Rundlett Middle School in Concord, NH. James has been the principal at Rundlett since 2016.

He was previously the principal at Laconia High School from 2012-2016 and Laconia Middle School from 2005-2012.

His experiences at Rundlett include establishing online grading, PBIS Universal Team and developed school-wide rubric, revised discipline plan and weekly reflection for students and staff. He has established academic and behavioral recognition for behavior monthly and academics quarterly.

He has had the honor of several recognitions and publications. His hobbies and interests include Fishing, Weight-training, Tennis and Golf. He was a co-founder of Mentoring Together and Stand-UP Laconia.

Police Officer - Chief David Wentworth - Sugar Hill Police Department

The Police Officer of the Year is Chief Dave Wentworth. Dave was hired in Sugar Hill in April 2003. He was promoted to Chief in 2007. He has served Sugar Hill until his retirement just last month, September 2017.

Chief Wentworth's love for the community of Sugar Hill is evident in his daily dealings with the residents and tourists. Just recently when work on the state highway blocked easy access to a Sugar Hill business, Chief Wentworth not only put up additional Detour signs but purchased the extra signs with his own money.

He put a program in place to visit residents who live alone; a welfare check that is much more like a visit. He spends extra time during the June and Autumn Foliage seasons ensuring that locals, tourists and photographers as well as landowners are safe and protected as they visit the Sugar Hill area.

Chief Wentworth works closely with the school community. Bike Safety, reading to the children, lunch at school are just some of the activities that bring him closer to the children. Over the last three years Chief Wentworth and the Sugar Hill Police Dept. has participated in an intern program.

Chief Wentworth has many years of community service with the Above the Notch Humane Society and participates in many local non-profit events such as the annual Special Olympics Law Enforcement Torch Run.

Firefighter – Captain James Paquette – Hudson Fire Department

Captain Paquette started his career with the Hudson Fire Department in 1994. He is a vital part of the team. Captain Paquette is currently assigned as the Shift Commander for Suppression Group 2 and coordinates the daily activities for the emergency services division.

This past year Captain Paquette was part of the committee that worked with North-Point Construction Management on the renovation to the Lenny Smith Central Fire Station. He not only worked as a member of the committee but also coordinated the project internally so employees were kept up to date and informed throughout the process. He is always looking to make sure the safety and health of the Hudson Fire Department staff is being addressed and that the project stayed on schedule helping all to continue to meet the vision and mission of the Hudson Fire Department.

First Responder – Matthew Fallon – Concord NH Fire Department

Firefighter Matt Fallon joined the Concord Fire Department on April 3, 1999. Throughout his career he has developed a reputation as a trustworthy firefighter who makes the Concord Fire Department better every day.

He has served the department over these past 18 years with fidelity and commitment to the citizens of Concord.

Firefighter Fallon planned and participated in a work day for retired Pittsfield Fire Chief Gary Johnson, who was dying of cancer. He also spent several days on his own doing projects at Chief Johnson's home, unknown to all but Chief Johnson's grateful family. He is also the first to step forward when an active or retired member needs something, from moving to a new home to plowing and sanding members' homes when they were unable to do so themselves.

He has served several terms on the executive board and negotiating committee of the Concord Professional Firefighters Association, IAFF Local 1045. He also was a leader in reenergizing the awards committee, rewriting the standards for awards and bringing it to its new home at the Concord City Auditorium.

NH Fish and Game - Conservation Officer Joseph Canfield

Conservation Officer Joseph Canfield began his law enforcement career working for Sandwich Police Dept. After four years he joined Moultonborough Police Dept and served 11 years as a full time police officer. He performed additional duties during these 11 years such as Field Training Officer, Firearms Instructor, and Glock Armorer etc and eventually attained the rank of Sergeant.

Joe was hired by the department of Fish and Game in 2013. He was assigned to the 26 Patrol encompassing the towns of Meredith, Center Harbor, Holderness, Sandwich, Moultonborough, Tamworth, Ossipee and Effingham. His daily duties include patrolling his assigned towns for hunting, fishing and OHRV activity and he routinely patrols his assigned area by motorized boat, kayak, ATV, snowmobile and cruiser. Joe has investigated and prosecuted numerous wildlife and OHRV crimes and violations.

Joe was selected to join the Advance Specialized Search and Rescue Team in 2014. This team specializes in winter and rough terrain search and rescue missions. He has been instrumental on several rescues and on one occasion was able to call in a National Guard Black Hawk helicopter and clear a small area on the side of a steep mountain enabling a critically injured patient to be extricated by hoist and transported to the hospital for life saving emergency care.

On February 11, 2016 during the annual Ice Fishing Derby eight snowmobiles went through the ice on Lake Winnipesaukee which resulted in 3 deaths to include two drownings. Joe and his team were able to locate both of the drowning victims with the ROV and recover them before a snowstorm the next day. One victim was recovered in 21 feet of water and the other in 72 feet of water.

Most recently State Police opened a cold case in the hopes of following up on an old lead with new technology. Joe was requested to search a stretch of the Androscoggin River for a pickup truck utilizing the Side Scan Sonar and ROV. The pickup and driver had been suspected to have driven into the river 19 years earlier. Joe found the pickup, skeletal remains inside and closed the case.

Joe is joined here tonight by his wife Kelly; they have 3 children Alaina 6 years old, Josiah 4 years old and Malachi 2 years old.

NH State Trooper – Trooper First Class Stefan Czyzowski

Trooper First Class Stefan Czyzowski is an 11 year veteran of the NH State Police and is assigned to Troop B in Bedford patrolling the highways and providing police services to the cities and towns of Hillsborough County. TFC Czyzowski is a team player who exhibits the traits of fairness, professionalism and a steadfast work ethic.

During the past year TFC Czyzowski initiated 1,005 motor vehicle stops and initiated 63 criminal investigations. Those investigations resulted in 66 criminal arrests to include 25 arrests for impaired driving.

TFC Czyzowski was recently selected as a member of the State Police Mobile Enforcement Team (MET); a result based initiative to combat the State's focus on illegal drugs. He was the only member of Troop B to be selected for this important assignment.

In addition to his numerous responsibilities as a patrol trooper, TFC Czyzowski is also a member of several specialty units. He is an experienced trainer and one of the Division's best Field Training Officers. TFC Czyzowski has tested his leadership ability while on staff at the NH Police Academy. He is also a member of the Division's Special Weapons & Tactics Unit (SWAT) and is also a state-certified instructor for the National Advanced Law Enforcement Rapid Response Trainer (ALERRT). In this capacity he is one of 3 troopers responsible for training all law enforcement personnel in addition to state employed civilian staff in the proper response to an active shooter threat.

Every year he coordinates the efforts for "Cops on Top", a fundraiser in the form of a hike up Mount Washington that benefits the surviving children of police officers nationwide that have been killed in the line of duty. He is also the Troop B liaison to the Special Olympics where he coordinates and participates in the Torch Run every year.

Year after year he is continuously within the top three performers in the troop as it relates to responsibilities and activity.

A brief recess was declared for State Officers to return to their correct position. State Youth Director Sarah Leclerc, was presented to the Master's station to present her annual report.

Worthy Master, National Representative, Fellow State Officers, Brothers and Sisters, All;

It gives me great pleasure to be presenting my first report as the Youth director! When the state master asked me to take on this role back in October last year, I thought that he was crazy. I was extremely hesitant to take on the new role, especially after I started working on the State Grange website. However, after a little prodding and convincing, I accepted the role, and haven't looked back since!

Our first gathering as a youth team took place at Deputy School last December, where we sat and had a meeting of the minds to plan out what we wanted 2017 to look like. The report was accepted and ordered printed in the Journal.

State Master Heath, introduced National Master Betsy Huber.

State Historian Richard Patten was presented to the Master's station to present his annual report.

Worthy State Master, Worthy National Master, State Officers, Patrons All,

It is a pleasure to report what has been going on as your State Historian. It has been close to fifteen years since the New Hampshire State Grange last met in city of Laconia. The Lake City is home to the famous MMS Mount Washington tourist ship, Sophie C, and the Doris E who take countless tourists for a beautiful ride around Lake Winnipesaukee. For many years, the State Lecturer sponsored a ride on the Mount Washington for Grange members and their families and friends. Winter time, countless fishermen come up to the frozen lake to try their luck at ice fishing.

Prior to those visits, the State Grange had not been here for many years. I was reading the 1934 Journal of Proceedings and read that the State Master, in his annual address, reaffirmed the support of the organization of a State Police force. In two years, this became a realization. Today, the NH State Police especially those who have been on the department for many years will thank the Grange for their jobs. Also in 1934 the Grange continued to be opposed to Daylight Savings Time. The Grange continued to be opposed to all kinds of gambling especially Pari-Mutual Betting at race tracks in the Granite State. The Grange favors the conservation and propagations of wildlife in New Hampshire, including the Fish and Game Department under proper guidelines.

In 1934 it was reported by the State Secretary that as of September 30, there were 10,801 Pomona Grange members. Hillsborough County Pomona Grange led with 1,062 members; Eastern New Hampshire Pomona was second with 1,060 members. East Rockingham Pomona Grange had 1,015 members. As of September 30, 1934 there were 279 Subordinate Granges in NH with a membership of 26,596 members. Rochester Grange was the top Grange in the State with 455 members and 100% of dues. This year, 2017 being the 90th anniversary of the Juvenile/Junior Grange in New Hampshire, in 1934 found 13 Juvenile Granges with a membership of 785 boys and girls. There were four new juvenile granges organized: Lower Intervale in Plymouth with 17 charter members; Lawrence Juvenile Grange of Belmont with 37 charter members; Golden Rod Juvenile Grange of West Swanzey with 28 boys and girls; and Loudon Surprise Juvenile Grange of Loudon with 28 boys and girls. There were 89 applicants for the Degree of Flora. Looking at the list, I recognize Ervin Buttrick, Ethel Clement, and George Shaw. These mentioned had become Deputies, State Officers in the years to come. It should be noted this session was held from December 11 to December 13 at Colonial Theatre in Laconia.

The State Grange returned to Laconia December 13 to December 15, 1938 for its annual session. The State Master reported in his address the NH State Police Force became a reality through the tireless efforts of the Grange in the Legislature. It should be noted that there were 125 members of the Grange who were serving in the Legislature. The State Master also stressed the Granite State was further ahead of any state in Rural Electrification. In New Hampshire there was a Standing Committee that advocated the use of Rural Electrification.

It was reported the Degree of Flora was conducted on 218 candidates including the Honorable Edward Gallagher, Mayor of the city of Laconia. Some of the candidates that evening included: Carl S Adams, Ruby Carpenter, the Huckins family of Ashland, and Edwin Prescott of Concord The membership in 1938 showed Pomona Granges, 9,940 on twenty Pomona Granges with Eastern New Hampshire Pomona had 1,062 members; Merrimack County Pomona had 938 members; and Hillsborough County Pomona was third with 868 members. The Subordinate Granges found a membership of 26,262. Rochester Grange remained the top Subordinate Grange with 483 members; Capital Grange of Central Concord was second with 315 members; Uncanoonuc Grange of Goffstown was third with 272 members. The Juvenile Grange membership found 800 boys and girls in 22 juvenile Granges. Fremont and North Hampton Juvenile Granges were organized during the year.

This has been a very busy year. I have continued to attempt to return Grange Secretary minutes to local Historical Societies. I have been pleased to returned the following Granges minute books: Keeneborough Grange of Brentwood, Walbach Grange of New Castle; Trojan Grange of Troy; New Durham, Bow Lake Grange of Strafford, Capital Grange of Downtown Concord, Lebanon Grange, Androscoggin Grange of Milan; Hiram R. Roberts Grange of Rollinsford; Dover Grange; Tri Peak Grange of Hill; Oceanside of Hampton, Marshall P. Wilder of East Rindge; and Profile Grange of North Woodstock.

I can't thank State Master Chris Heath and his assistant enough for going into the basement at the State Grange Building in Hooksett to get the 50 boxes of Grange Secretary Minutes books. It is my hope to continue getting this project completed. For the books that I have returned, people have written notes thanking me for getting them returned and can't believe how much their Grange did. This session I am hoping to return the records of The Weirs Grange and Lawrence Grange of Belmont.

I am not sure if it is because I was in police work for 30 years, but I enjoy research. This year I had 17 calls from people asking about relatives or friends who were members of the Grange. They were looking for years of membership.

I received a telephone call from a party in Georges Mills regarding Grange books that were found in the upper floor of a barn that had been purchased by a family who were not Grange members. I went and did some research and found Rockland Grange was located in Georges Mills. I drove to Warner and this lady was good enough to bring all the boxes she found. Evidently Rockland Grange had organized a library of some sort. They had library cards all preprinted with lines, names, a place for dates to be entered when books were checked out. This Grange had a major influence in Georges Mills. It is unknown as to why this Grange closed.

I received a call from a gentleman from North Salem reference Reliance Grange, which was located in Northern Salem. He found a group of membership books containing the names of members who belonged to Reliance Grange. Salem had three Granges at one time, Enterprise, Salem, and Reliance. I informed him these books should come back to the NH State Grange; however he photocopied the pages and mailed them to me.

Another caller thought their grandfather was a past State Master. I spent three days going through rosters, journals, and finally found the answer. As many might remember the Deputies were referred to a Deputy State Master when they were on official business. I found the name, who had been a member of the Subordinate Deputy Force in the 1950's. We are all making history in this organization whether you realize it or not. This past year, we lost members to the Great Grange Above who created a lot of history. Their contributions to this great Order are very important and it is critically important that we preserve and honor their

memory.

Edith Anne Emery: Edith served this organization very well. She belonged to Monroe Grange, then White Mountain Grange in Littleton and then Concord Grange when White Mountain had closed. I first met Edith when she was State Lady Assistant. She was very quiet but she knew her Grange work. Following her four years as State Lady Assistant Steward, she was elected and served the next four years as State Flora. I can still see her standing at the microphone in Flora's Court. She served as State Flora with a very dignified and elegant manner. She memorized her part in the degree to perfection. She also served on the State Education Committee. I also didn't know that she was Debbie's music teacher at Woodsville High School. She was very active in the McClure's Band which could be seen in parades, concerts in the area towns, and at North Haverhill Fair.

Dorothy Haskins was another Grange member that stunned many of us when she passed away recently. She and the late Marion T. Jones were the backbones of Daniel Webster Grange in Webster. When Sister Marion passed away, everything seemed to fall on Dorothy's shoulders. I was honored to give a eulogy at her funeral. I first met Dot in the late 1960s when she was one of the ushers and usherettes for the NH State Grange Session in Concord. She helped many of us with what we had to do. She served as Master for Daniel Webster Grange, Merrimack County

Pomona Grange and she helped Wicwas Lake Grange and Bartlett Grange whenever she could. She served as State Pomona for 4 years with pride and dedication. She served as Community Service Director and State Subordinate Deputy. She was always ready to help whenever needed. She was very active in Webster, supporting many clubs with public suppers, public breakfasts, working at Hopkinton Fair, or the annual Old Home Day Celebration. She has even given the homily at church when the Pastor wasn't there. Dot is going to be missed

Patricia Cutter, wife of Past Master Arthur Cutter of Bartlett Grange, Salisbury passed away in June. Pat was a nurse and always one to help whenever asked. They moved to Georgia a couple of years ago due to health reasons. She was one who wanted the Grange to keep going in Salisbury, but luckily even though they moved away, they transferred to Concord Grange. Helen Murray was an icon in the Concord-Penacook area. I first met Helen as a child when my parents would go shopping at the old Giant Store in Penacook. Helen was a member of Riverhill Grange acting a Secretary and always had a smile. She and her husband operated a chicken hatchery when my dad would go and buy his baby chicks. In later years, they changed and became a Murray Farms Florists selling flowers like annuals, perennials, bushes, trees, and vegetables. Then their children became Grange members and got involved in the farm business. They expanded selling mums in the fall, and Christmas trees, wreaths and baskets for the holidays. Helen served her Grange well as Master, Secretary and Treasurer. Many are going to miss her at the farm.

Robert Lowe was an extremely active member of Rockingham Grange in Epping. Robert's mother Edith Sewall served as Lecturer for many years. Robert always had a nice smile whenever you would meet him.

Arline French was very involved with the dictionary program that Granges throughout the Granite State and in our country have been donating to third grade students for many years. She served her Grange well being a member for over 75 years. She celebrated her 103rd birthday and then was called to the Great Grange above. Arline loved going to Hawaii, but when she came back, she would come to Grange in Concord. Originally she had joined Blackwater Grange in Andover and then transferred to Concord Grange when she moved to live at Havenwood in Concord.

Edythe Craig was a very quiet but valued member of Sunapee Lake Grange of Newbury. She was also a doctor, which many people didn't realize. It was very common for her, Francis Ward, and Carol Fortune to travel to meetings in the area. She served as Master for Sunapee Lake Grange in past years and was a very faithful Grange member who could be counted upon to do whatever was necessary.

Betty Dudley was another valued member who was called to the Great Grange above. She also reached her 103rd birthday this year. Betty's real name was Florence Betty Dudley, she and her late husband David Walter originally lived in Woodsville for many years. She worked as a secretary for Cray Oil Company in Woodsville for many years, then going to work for Grafton County Nursing Home in North Haverhill. She and her husband belonged to Mount Gardner Grange in Woodsville where she and her late husband both served as Master. She moved to Bow to be near to her daughter when David died. She transferred her membership to Bow

Grange and then when Bow merged with Pineconia Grange now known as Concord Grange. Several years ago she moved back to Woodsville and always would send a donation for us to help with our projects.

Linwood Paine was a very quiet gentleman but he was an excellent piano player. He held membership in Great Meadow Grange before transferring to Arlington. He enjoyed playing the piano and also married Lucy Thompson who belonged in Arlington Grange in Winchester. He would help her with the Junior Grange. Linwood did what he could to help with the Grange but his greatest gift was playing the piano.

Stephen Tracy was called to Great Grange above not long after last year's State Session. It was a shock to many members of the organization. I first met Steve when he was in his late teens and belonged to Blow me Down Grange. He became State Prince in 1979 and served as Master for Blow-Me-Down Grange. He and Michael Earle traveled to many Granges through the state. Then for unknown reasons, he was not seen for many years. Then one day he became active and showed a keen desire to work diligently in the Upper Coos area. He was appointed a Deputy to help organize new Granges. He worked trying to convince people in Manchester, Barnstead, and Croydon to organize a new Grange. His tireless efforts to keep Upper Coos Pomona and especially Stratford Grange active were successful but he traveled a lot as he tried to organize a Grange in Stewartstown and Milan.

Evelyn Merrow just got called to the Great Grange Above two weeks ago. She was 98 years old and an 84 year member of the Grange. She served as Past Master Mount Prospect Grange of Lancaster and then transferred her membership to Pembroke Grange.

I have not mentioned much about the 90th anniversary for the Juvenile/Junior Grange organization in New Hampshire. I have located many of their record books. We had many Juvenile / Junior Granges in the Granite State. It seemed like it would go in spells. The biggest problem was trying to find mature adults to serve as Matrons and Patrons or later to be known as Leaders. In my research for Junior Granges, I found we had close to 160 chapters in our state throughout the years. As of this day, the senior Junior Deputy living is Virginia Clark followed by Rhoda Davis. The senior Junior Superintendent is Rhoda Davis followed by Carolee Barrett. I, Richard Patten was the first male Junior Deputy and the first male Junior Director followed by Gerald Leclerc. The senior Juvenile Matron is Dorothy Bartlett of Bartlett Juvenile Grange in Salisbury. The senior Juvenile Patron is Burton Meyers of Winthrop Juvenile Grange, Shelburne. I was going through rosters and found some members of today who were Juvenile/Junior Grange Members: 1975, Grace Leone had been serving as Matron/Leader since 1966 for Banner Junior Grange; Rick Hayes and Judy Leone were officers of Banner Junior Grange in 1975; Jeffrey Bailey was serving as Lecturer in Sandown Junior Grange in 1975; Sandra Cyr was serving as Matron of Sunapee Lake Junior Grange; Sheila Phillips was serving as Matron for Surry Junior Grange in 1975 along with Beth Yardley Merrill serving as Master for Surry Junior Grange in 1975; Gerald Leclerc was serving as Master for Wattannick Junior

Grange in 1975. In 1985 Kathy Yardley was serving as Master for Walpole Junior Grange with Mrs. Gwendolyn Yardley serving as Leader; Camille Twiss was serving as Leaders at Brookline Junior Grange, with daughter Kathleen Twiss as Master and son, Brian serving as Lecturer. I could write much more but I will leave this to Junior Director Joann Brandt to report on this.

As I close this report, thank you worthy State Master Chris Heath for your confidence in me as I continue to research the fabulous history of this Great Organization. It just amazes me as I research the history of what I find. I am distributing paperwork to various family members to help with history of their family as I prepare to write the 4th history book of the NH State Grange. I would like to thank my wife Deb for typing this and proofreading it. I apologize for having Grange journals and rosters out by my chair doing my homework. I would like to thank everyone who assisted me with this report.

For the past two years our State Master has been urging his Directors to make their reports more memorable, informative, and interesting. This year he added, "Describe what you do," and I was inspired. To properly understand this report, you need to know the names of a cast of characters who make my work possible and whom I thank with all my heart. They are my daughters Anne and Mary; their husbands Marty Boisvert and Kevin Belval; Joyce Terrill, who is Marty's aunt; and Kevin Sweet, who works in the Commercial Department at the <u>Concord Monitor</u> newspaper. You also need to know that our State Grange quarterly paper is printed on the presses at the <u>Concord Monitor</u> and mailed from the Epsom, NH, Post Office. Now, with recognition of Clement Moore, author of "A Visit from Saint Nicholas," here is:

The Granite State Granger

In early November somewhere in my house on goes my computer and out comes my mouse. An e-mail goes out to Directors I choose, "The deadline is coming, please send in your news." I find the last issue and make a new copy, change dates on the masthead so it won't look sloppy. I highlight the old news and then hit "delete." The pages now look very empty and neat. In a state of suspense for the news I then wait. Some Directors are early while others are late. As the columns come in, I copy and paste. I fix up the spelling and prune out the waste. Every inch must be filled, no less and no more, in pages that can be divided by four. An e-mail is sent out to Grange members all, "Send news for the paper, this is the last call." Anne Boisvert comes over the pictures to enter. She pops them right in, if I place them off center.

But, as empty spaces begin to diminish, the stress starts to build for the race to the finish. The pictures are toned and, when they are just right, all is sent to the Monitor's FTP site. With the pages submitted, I pick up the phone to tell Kevin Sweet that the paper is done. Then a message at Concord Bulk Mail I can leave, to reserve EMM trays, each with a sleeve. And now I must wait, for there isn't a hint of how many days it will be 'til they print. At last it is printed and then we must trundle in the car, off to Concord to pick up each bundle. Any bundles we drop off, nine, eight, or seven, are speedily processed by Mary and Kevin. The rest go with us, not always by choice, to be folded by Anne, me, and Marty's Aunt Joyce. If he isn't too tired or busy or mean, then Marty *might* help with the wafer machine. He's the fastest of all, but if he won't do it, one way or another we all will get through it. Now folded and wafered on various tables, the papers are ready, but where are the labels? To answer my e-mail sent off in a tizzy, the State Secretary writes, "Sorry, I'm busy." He needs his own life, but I wish he'd remember I want to mail these on the first of December. When the labels arrive, they have to be counted and then on the papers most carefully mounted. In order by zip code they go in the trays. This process should take only hours, not days. And then comes a task that I never must shirk. I download the USPS paperwork. I call the Post Office in joy, not in sorrow. "What time can I bring a bulk mailing tomorrow?" We load up the postal form, trays, and a check, and drive off to Epsom, a very short trek. Then comes a brief pause, for we never do know what the clerk will remember from three months ago.

And then I can do what I've often rehearsed; I mail the receipt, so I'll be reimbursed. I leave the main lobby and head for the dock to unload seven boxes by eleven o'clock.

And I think as the dolly is rolled out of sight, "The paper is mailed. I can sleep well tonight.

The NH State Grange building in Hooksett has had a quiet year for the most part. Perhaps the most exciting thing that happened was during the furnace cleaning appointment last December. The technician asked Anne to come down to look at the vent pipe to show her it needed replacing. He said it was in bad shape and might fall apart any time. As he said this, he touched the pipe with his finger and "poof" the whole thing fell in a pile of rust and dust. Once they both stopped coughing, an arrangement was made to have a new pipe installed later that day. The only other inside maintenance which was done was to replace eleven lightbulbs in early October. For about half the year, the church continued to meet a couple of times a week for services and Bible Study. In late summer they let us know that they would no longer be using the building as their group had grown quite small. Not long before that, Adam Paquin-Varnum who had been cleaning the building informed us that he would no longer be doing so. He had been seeking replacement for some time, so we knew it was coming. No likely candidates stepped forward but we've heard that Jerry Leclerc will be doing cleaning at least temporarily. Chris Heath cleaned it before the last group rented the hall. It is also rumored that the Executive Committee is changing the rental agreement to include a deposit to be returned if the hall is left in good shape.

The building was used for a few Grange events such as the Winter Youth Rally, the State Lecturer's penny sale and banquet, the Junior 100th Birthday party, some Executive Committee and directors' meetings, and the State Officers' Rehearsal for the Sixth Degree. Several other groups rented the building for one event or another, including a group who has used it several times for things such as an International Women's Day speaker panel and other gatherings including an amazing cultural dance in traditional dress witnessed in a small part by Marty and Rebecca when they went to replace the batteries in the thermostat at the request of the renting

group. We believe it is kind of special that we can provide them with place to celebrate their heritage in this manner.

The building remains in desperate need of landscaping work. In mid-June Anne Boisvert and Mary West removed enough bittersweet so that the sign on the front of the building is readable. Chris Heath and a friend did a lot of trimming and mowing in mid-July. A few people expressed interest on Facebook for a garden makeover in the spring, so we will work on getting that scheduled.

As for yearly building maintenance, our inspection for the assembly permit with the Hooksett Fire Department will be on October 30 at 1:30pm. We do not anticipate any major issues with the renewal. The fire extinguishers were inspected last November and will be again next month. A furnace cleaning appointment has been scheduled with LaVallee Oil in late December as usual.

This has been a very quiet year for the membership committee. We lost our director early in the Grange year which was a big loss to the department. Steve Tracy was a great ambassador for the Grange and was very dedicated to building our membership. Finding someone to fill his shoes has been very challenging. We did make a plea to our members for volunteers but as of this date, we have not found a director. We have made at least four attempts to notify Granges across the state that the committee is available to help with recruitment. We have offered physical and material assistance to any Grange that wanted help in having a membership drive but disappointingly, not one Grange has asked for help. We are surprised by this and hope that this is not the trend for the year to come.

We were able to assist the Agriculture committee with the Farm and Forest Expo in February. This included setup of the display, manning the booth, and helping to tear down after the expo had finished. Over 15 names were collected through the rip card system. Those names were then recorded and given to the respective Granges in the areas that the people were from. The committee then mailed welcome letters to all the people who filled out a card. Unfortunately, the letters that were mailed were never answered. We also never heard back from any of the Granges to see if any of these potential members visited or joined. This is not good for the Grange in New Hampshire. If we can't even get new members from the few who are looking to join, then how are we going to get anyone to come be a member? We have essentially told these prospective members that we are not interested in them.

There have been a few Granges that have taken in new members this year and we applaud you
for your hard work. We know it is not easy to go out of your comfort zone and ask someone to join the Grange. We need more Granges to follow this example and start growing. New members are our future and without them, we will go nowhere. Once we have those new members, we need to keep them engaged in what we are doing. We need to give prospective members opportunities to learn how the Grange operates and show them how we work. We need to listen to their ideas and let their enthusiasm to try new things go forward. Just because it didn't work in the past doesn't mean that it won't work now. We need to give them the chance to fill in an office and mentor them on how to perform the duties of that office. We need to make sure that we listen to what they have to say and be willing to give their ideas a try.

The State Master has been telling us for the past three years that membership is everyone's responsibility. Are we are all too tired? Are we all just ready to give up and stop being the DO'ers in our community? This committee believes that this is not true and that the next year will bring a net gain in membership for all of the Granges in the state.

We will continue to promote Grange wherever we go in hopes that someone will want to join the Grange. Will you be one of the Do'ers who help Grange Growth in your community or will you be one of people who will not see the Grange thrive into the next century? Now is the time to jump on the "Grange Train" and grow our organization. The Grange has so much to offer our society today and if we just think outside of the box, we can make a difference. For all of you who make and donate items to sell at the Big E, a heartfelt thank you. The items you so graciously make and donate really do support the grange building at the Big E. I will send the list of most wanted items to all of you in my first letter to you right after the holidays.

We continue to collect mittens, hats and gloves for our Mountain of Mittens. Thank you so very much to all of you who keep your knitting needles going to help warm the hands of our children in the State of NH. We discontinued the Galoshes from Grangers project this year as it was felt we were asking a lot of our subordinate granges to support our mittens project as well as Nighty Night Hugs project. However we encourage Granges to continue to look for boots on clearance at the end of the season and make that well needed donation to your local schools, boys and girls clubs etc.

The Nighty Night Hugs project is still active. Last year at this State Session we collected and disbursed almost 120 sacks which included a book, a blanket and a stuffed toy to 11 homeless

shelters throughout the State of NH. Dick delivered 9 sacks to Manchester for one of the family shelters and they were so grateful as were many. But a sad fact that he learned that day is that they have an average of 26 children at any one time at that shelter alone. Our goal was to fill 50 sacks last year and distribute to 6 shelters and we filled 120 for 11 shelters.

This year I asked Granges to make and put these sacks together and to give them to your Family Services State Committee representative in your area. I also asked that each subordinate let me know on the report form how many were done. The problem is I didn't ask each subordinate to let me know how many sacks they did. Nonetheless, the number of subordinates reporting that they did prepare some appear to be low in numbers. I am hopeful we don't lose sight of this project. I know there are some granges that put a great number of sacks together. If every grange could supply 2 sacks or the money for them we could cover all 11 shelters. Please consider this the goal for 2018.

Community Service is alive and very strong in the Granite State. I am so pleased and proud of all the work the Grange members are doing out in their communities. Some are working along

with other organizations, individuals, businesses, and politicians to help improve their town. There are many different community projects that Granges are involved in whether they organized it themselves or joined others. Grange members have always been known to make sure their communities are the best they can be. This year was no exception with the number of reports and booklets that I have received. A total of 15, 111 volunteer hours were reported. If you add in the hours not reported by Granges who did not send in a report, then we could have gone over 17,000.

The judges were amazed at how active Granges still are in this state. They thought like so many others the Grange was history. It amazed them as they read the books submitted by the Granges all of the projects undertaken by the members. Not everyone has the talent to make a booklet. The single page reports sometimes tell a better story than a booklet. But to be judged to go to National a booklet is required.

I received two Pomona Grange reports, those being Northern New Hampshire and East Rockingham. I appreciated what they wrote on their reports as to what the Granges in their Pomona Granges did this year.

I received 21 Subordinate Grange one page reports while I received 11 booklets. The one page reports contained information that proved how busy Granges were. I will start with Mohawk Grange in Colebrook. They spent 32 hours 4 times a year doing roadside cleanup. They donated money to the Got Lunch program; donation to the Colebrook Area Food Pantry, sponsored a member for the Chief Maloney 10K run; another member for the Two Rivers Ride for Cancer; donation to Helping Hands food pantry; donated gifts for Bonnie Days Christmas Gift Giving Program;

Hampton Falls Grange is very active with the Pease Greeters for members of the Military coming back from their tours of duty in Iraq or Afghanistan.

They also delivered new dictionaries to the local school.

Resolution #1 Submitted By: NH State Grange Executive Committee Subject: Election of Officers at National Grange

WHEREAS the election of officers process is defined in National Grange Digest of Laws 10.4.1 as "ELECTIONS -- 10.4.1 Nominating speeches shall not be allowed in any of the Granges in

the various divisions of the Order (Junior, Subordinate, Pomona, State or National) at the time of the election of officers; but in the election of officers, a member may present the name of another member as a candidate for a Grange office provided this rule has been adopted by the Grange having jurisdiction. A motion to close nominations is never in order and members may vote for a member whether the member's name has been placed in nomination or not." and,

WHEREAS in all divisions of the order, except the National Grange, this process is followed by the numerous Granges across the country and have for as long as the organization has been in existence and,

WHEREAS the delegates at National Session could spend this valuable time doing other important requirements assigned to them instead of guessing who they should suggest as the officers of the National Grange and,

WHEREAS the election of Officers at National Session is traditionally conducted by secret ballot and counted by the Assistants and the Steward and,

WHEREAS the National Session has now been shortened to cut down on expenses but still has the same amount of work to complete,

THEREFORE, BE IT RESOLVED: that the election of officers at National Grange be conducted in the same manner as prescribed in the Digest of Laws and the National Master will open the floor for suggestions for the officers of the National Grange.

The Resolutions Committee thought that this suggestion for change in the nominating procedure at National Grange is a good one, saving time and making the process more streamlined and in keeping with the manner in which the State Granges nominate their officers. The vote was unanimous in favor of this resolution.

The resolution was adopted by vote of the delegate body and will be forwarded to National Grange for consideration!

Resolution #2 Submitted by: NH State Grange Executive Committee Subject: Electronic Device Substitution

WHEREAS the price of paper is increasing every year and the cost of printing is expensive and,

WHEREAS the use of paper is creating a large burden on paper producers and natural resources around the world and,

WHEREAS this is a gross misuse of our natural resources and it is affecting our environment and,

WHEREAS the National Grange supplies paper copies of all resolutions, that are submitted, and other paperwork to all the delegates, officers and staff each year at National Session and,

WHEREAS the National Grange reprints most all of the changes to resolutions and redistributes these papers to all the delegates, officers and staff and,

WHEREAS the National Grange is and has been trying to reduce the costs to the National Grange by eliminating programs and distributions and,

WHEREAS today's technology could provide a cheaper alternative to the National Grange's current process for providing these documents to the delegates, officers and staff during National Session

THEREFORE, BE IT RESOLVED: that the Executive Committee of the National Grange be tasked with researching the cost of alternative methods of providing these documents during National Session and,

Be it further resolved that the National Grange Executive committee report their findings and make recommendations to the delegate body at the 2018 Annual Session and,

Be it further resolved that the delegates at the 2018 Annual Session vote on the said findings of the National Grange Executive committee

The Resolutions Committee noted that the current system of providing hard copies of every resolution and report to every member delegate results in a huge waste of paper and expense. Modern technology has provided alternative methods of disseminating information and material.

This resolution does not mandate that the current system change – it only asks that the Executive Committee research the matter and report back to the full body next year.

The Committee thought this is an excellent idea, and supported recommending the resolution unanimously.

The resolution was adopted by vote of the delegate body and will be forwarded to National Grange for consideration!

Resolution #3 Submitted by: NH State Grange Executive Committee Subject: Beverages at NH State Grange Banquet

WHEREAS Article XII, Section 1, Division 11 of the New Hampshire State Grange by-laws reads

"NH State Grange policy shall permit the use of alcoholic beverages in fundraisers, in

demonstrations or as gifts. Such containers shall remain sealed at such Grange meeting or activity. (10/30/2010)" and,

WHEREAS the New Hampshire State Grange has recognized outstanding citizens at their annual State Grange banquet for many years and,

WHEREAS these guests are not members of the Grange and are not required to abide by the rules and regulations of the Order and,

WHEREAS the New Hampshire State Grange is not officially in session or in an official meeting during the banquet honoring these guests and,

WHEREAS the guests to this banquet may prefer to be able to purchase beverages that are not typically supplied during the meal and,

WHEREAS these guests consume beverages that are both alcoholic and non-alcoholic in nature and,

WHEREAS these beverages that our guests like to consume are not made available unless contracted by the New Hampshire State Grange when making plans for the banquet and,

WHEREAS having these beverages available during the banquet could possibly lower the cost of the meal, depending on the property, if it is contracted

THEREFORE, BE IT RESOLVED: that the New Hampshire State Grange change Article XII, Section 1 Division 11 by adding the words "with the exception of a NH State Grange Banquet where alcohol may be served" after "Such containers shall remain sealed at such Grange meeting or activity." so that it reads "NH State Grange policy shall permit the use of alcoholic beverages in fundraisers, in demonstrations or as gifts. Such containers shall remain sealed at such Grange meeting or activity, with the exception of a **the annual** NH State Grange banquet where alcohol may be served. "**by a vendor who is licensed to sell alcohol by the glass in the state of New Hampshire.**

The Resolutions Committee was split on this issue. The majority felt that the allowance of alcoholic beverages only at the Annual Meeting Banquet was not in opposition to the Grange tradition of no alcohol at Grange functions. The Annual Meeting Banquets have become a public celebration of the heroes in our state, and we invite not only the honorees but their families, friends and co-workers to share in the celebration. The majority felt that these non-Granger guests are used to being able to have a glass of wine at a dinner banquet, and, in a public place such as a hotel ballroom where the banquets are always held, they should be able to purchase the beverage if they should so choose.

In addition, the majority felt that most hotels and banquet facilities will charge less for the catering and facilities if they know there will be a cash bar, which is profitable for the venue.

The minority felt that the Grange's tradition of no alcohol at meetings or activities should be continued, and that the non-Grange guests should abide by our rules when participating in the banquet.

The amended resolution was defeated by vote of the Delegate body!

Resolution #4 Submitted by: NH State Grange Executive Committee Subject: Junior Grange Membership

WHEREAS the Junior Grange was adopted by National Grange as a division of the order in 1888, a mere 21 years after the formation of the organization and,

WHEREAS the Junior Grange was patterned after the Grange - Order of the Patrons of Husbandry and,

WHEREAS the Junior Granges are subject to the National Grange Digest of Laws that govern the divisions of the Grange and,

WHEREAS the Junior Grange members pay dues to the State Grange's annually and,

WHEREAS the Junior Grange annual word, badges, manuals, equipment and other organization specific items are controlled by the National Grange and,

WHEREAS most Junior Grange members graduate into the Subordinate Grange at the age of fourteen and,

WHEREAS the National Grange now has the one plus program that entitles Junior members to participate and become Junior members of a Subordinate Grange and,

WHEREAS Junior Grange members are hopefully the future members of the Subordinate, Pomona, State and National Granges and,

WHEREAS the National Grange no longer exempts members who achieve continuous membership of 50 years,

THEREFORE, BE IT RESOLVED that the National Grange recognize a Junior Granger's membership towards a member's continuous membership total and,

Be it further resolved that the National Grange make this retroactively effective as of November 2013

The Resolutions Committee felt that the Junior Granges are, indeed, as much a part of the Grange as Cub Scouts are to Boy Scouts, where their training follows them as they pass from cub to scout. The Junior Grangers put in the work, they pay dues, learn ritual and participate in Grange activities. The years they spend as a Junior Granger should count to their lifetime participation toward a Golden Sheaf.

The vote in favor of recommending this resolution was unanimous.

The resolution was adopted by vote of the delegate body and will be forwarded to National Grange for consideration!

Resolution #5 Submitted by: Chichester Grange #132 Subject: Grange Bowling Day

WHEREAS, the State Grange bowling day is an event full of fun and lighthearted competition; and

WHEREAS, there are four levels of competition to give people the opportunity to compete against other Grangers at the same skill level; and

WHEREAS, intentional or not, some Grangers are entering the bowling competition at a level lower than their skill level; and

WHEREAS, this is causing an unbalanced playing field; and

WHEREAS, the closing of the Fourth Degree states that 'also in work and recreation...whatever we do, strive to do well;"

THEREFORE BE IT RESOLVED that the State Lecturer (or whoever is in charge of the event) keeps a record of the scores from year to year and uses the three-game average from the previous year to place each participant into the proper division:

A Division 90+ Average B Division 80-89 Average C Division 70-79 Average D division 69 and below Average.

AND BE IT FURTHER RESOLVED that a first-time participant or someone who is coming off of a multi-year absence will use the honor system to suggest which division they should be placed in.

The Resolutions Committee felt that this resolution put too much responsibility at the feet of the State Lecturer, who would be tasked with coming up with the perfect skill level determination for

the bowling competitors. We also felt that the Bowling Days should be days of camaraderie and fun, and not cut throat competition.

For these reasons, the Committee voted not to recommend this resolution, but leave it to the delegates to debate and decide.

The resolution was defeated by vote of the Delegate body!

Resolution #6 Submitted by: Cheshire County Pomona #6 Subject: Future of Pomona Grange in New Hampshire

WHEREAS interest and involvement in the Pomona Grange in New Hampshire has declined

THEREFORE BE IT RESOLVED that the Pomona Degree be retained as requirement of membership to the Sixth Degree, conferred at a time and place determined by the State Executive Committee, and that the individual Pomona Granges in New Hampshire cease to exist.

BE IT FURTHER RESOLVED that if this resolution passes, all of the assets of the Pomona Granges effected be divided equally among the active Subordinate Granges of said Pomona Grange.

The amended resolution was defeated by vote of the Delegate body!

Resolution #7 Submitted by: Claremont Grange #9 Subject: New Hampshire tick and other insect borne disease information system

WHEREAS the New Hampshire State Grange passed a resolution in 2016 to support the formation of a New Hampshire based online Lyme Disease support/information system and

WHEREAS the owners of equines and livestock in the state of New Hampshire are also seeing an increase in other airborne diseases besides Lyme Disease by ticks and other insects, and

WHEREAS the 2016 resolution is considered to limited in scope to enact upon by some New Hampshire policy makers

THEREFORE BE IT RESOLVED that the New Hampshire State Grange supports the formation of a New Hampshire based online support/information system to be used by the owners of animals affected by tick and other insect borne diseases.

The resolution was adopted by vote of the Delegate body!

Resolution #8 Submitted by: Arlington Grange #239

Subject: Health Care Reform

WHEREAS The Affordable Care Act was signed into law with the intension of providing comprehensive health insurance for all Americans at a reasonable cost

WHEREAS over the last seven years the benefits of the health care law have become more popular and have become more appreciated by the public

WHEREAS the implementation of the new health care system has exposed a number of flaws in rafting of the legislation that need revising

WHEREAS no other social welfare program that has been implemented has been perfect the first time around

THERFORE BE IT RESOLVED The New Hampshire State National Grange support a bipartisan effort to repair the healthcare law affordable care act.

The amended resolution was adopted by vote of the delegate body and will be forwarded to National Grange for consideration!

Resolution #9 Submitted by: Walpole Grange #125 Subject: Controlling Invasive Aquatic Species in New Hampshire's Waterways

WHEREAS, New Hampshire's water bodies have become increasingly infested with non-native, invasive aquatic species such as Trefoil and Zebra Mussels, and

WHEREAS, invasive aquatic species have no local, natural predators and thus they crowd out valuable native plant and fish species in our lakes, streams, rivers and ponds as well as add to costly maintenance and repair of boats, docks and other marine structures. If not controlled, these invasive aquatic species will eventually take over the major waterbodies of our state and diminish the value of those waterbodies for sports, recreation and other uses, and

WHEREAS, The State of New Hampshire and many local municipalities currently provide modest funding to volunteer based, locally controlled lake associations, boaters clubs, sports clubs and other similar private, volunteer staffed organizations to carry out invasive aquatic species monitoring and control programs on about 40 of New Hampshire's major waterbodies, or about half of the infested water systems in the state, therefore

BE IT RESOLVED, that the New Hampshire State Grange encourage the State Legislature to enact legislation directing the Department of Fish and Game to implement an invasive aquatic species management program that is designed to reduce the occurrences of invasive aquatic species in our state's lakes, rivers, streams and ponds by 90% by the year 2022, and maintaining their occurrences at these levels thereafter, and

BE IT FURTHER RESOLVED that the State Legislature enact legislation that directs the Department of Fish and Game to work with, and provide funding to, local volunteer based private groups, such as lake associations, boaters clubs and sports clubs to develop and implement appropriate invasive aquatic species management programs for each major waterbody in New Hampshire.

The resolution was adopted by vote of the Delegate body!

The State Master thank the committee for their service and ordered this report printed in the Journal.

Richard Patten was escorted to the Master's station to give the report of the Master's address committee.

Worthy Master, Worthy National Master, Delegates, Brothers and Sisters all,

We the members of the Masters Address Committee would like to commend our State Master for all his hard work and many miles that he has committed to our organization.

As we have been informed from our Worthy Master, this year has been a turbulent one. Unfortunately, due to multiple reasons Granges have had to either close their doors or consolidate. Also, reported by the Worthy Master, not all closings or consolidations have happened in the correct procedure. It is evident that the regulations and bylaws that are in place for a Grange to consider closing/consolidating is not common knowledge.

The committee recognizes that the Journal of Proceedings is not commonly requested from Granges. The Masters Address contains important information that is relevant to all Grange members. Therefore, we recommend that the Masters address be sent by the State Secretary to all Grange Masters and Secretaries with the expectation that it will be read at their meetings.

The committee is also in agreement with the Worthy Master that the image of the Grange and knowledge that we are still active must be brought to the forefront. We therefore endorse the Worthy Masters recommendation that the NH State Grange Executive Committee consider adding publicity as a line item in the budget, and allocate the necessary funds.

Electronic meetings, while we must acknowledge that technology is an essential part of everyday life, we must remain true to our ritualism. The committee agrees that the physical presence of members is an important part of being a grange member. However, every member should be able to have a voice and we encourage that in whatever way possible.

Junior Grange, we need to encourage our young people, who will be our future leaders of our organization. The committee echo's the words of the Worthy Master, it is imperative that the juniors that exist in your Grange be communicated to the State Secretary and the State Junior Director.

While reviewing the address, the committee has noticed a theme. Communication. Only with effective communication can we make our organization successful. To the delegate body, please make sure that your roster information is submitted to the State secretary in time for printing the roster. This is what many people use to send communications to the granges.

Membership, the committee agrees with the recommendation that an incentive program be initiated at the state level. With providing an incentive program this often increases engagement. We encourage the delegate body to support the Worthy Master in the incentive program. We further recommend that a dedicated membership director be chosen that is not the Worthy Master. We believe that having someone dedicated to this task would help alleviate some of the work from his plate.

With regards to the insurance policies for granges. We indorse the Worthy Masters recommendation for the NH State Grange Executive committee to take on the project of seeking a plan for our granges. With hopes that we could find something more cost effective and beneficial to our membership.

As an organization, we must put aside our differences and come together to ensure the survival of our great organization. To quote our Worthy State Master. "We must make it our responsibility to ensure that our beloved Grange survives into the next century".

In closing we would like to thank you Worthy Master for all your hard work. We would like to acknowledge and thank you for your candor. You have provided the delegate body with the true condition of the NH State Grange even though it must have been extremely difficult to both say and hear.
