The first day of the 146th Annual session of the New Hampshire State Granges was opened in the Sixth Degree with worthy Master Christopher E. Heath and the officers of the New Hampshire State Grange at 7:00 PM.

Roll call of officers found all officers present except for the Gatekeeper and the Musician.

The Grange was then lowered to the Fourth Degree.

Roll call of Granges found a quorum present.

State Steward Arthur Merrill announced John Plank, Assistant Steward of the National Grange and Master of the Indiana State Grange and his Susan as our honored guest and in waiting. The Assistant Stewards escorted them to the Master's station. John and Susan both spoke briefly and are looking forward to our session and meeting with us.

Joann Brandt was escorted to the Masters station to present the report of the Agriculture Committee for Norman Brandt, Director.

Worthy Master, Delegates, Brothers and Sisters, or whomever wishes to hear this,

Another year has come and gone. It seemed to blow thru on a jet stream and I wish I could be here to be giving this report myself. Thank you Mom for reading this for me.

After last session, I was able to get my program out with the rest of the committees. I hope everyone got to see them and took advantage of the information I was able to put in them. I do understand that some Granges did not get them, I cannot see a way to remedy this as not only were they available last year hard copy but also could have been downloaded off the State Grange website and either kept digitally or printed and had as a hard copy. Hopefully this years' will be just as available.

After State session came Deputy School, the Ag committee met and spoke about possibly seeing about doing a north country, south country Maple distribution Co-op, as we understand that Grangers in the North make so much less money for their maple than us Grangers in the South do, when we make maple syrup. Sadly I have not had the time to iron out the details of this program to have it at full stream right now. I can see it working best if we can find people here in the southern part of the state that may be interested in supplementing their maple sales to come up with amounts maple they are interested in and during some of the State events it can be brought down and distributed in batches, making shipping of product reasonable and easy, if anyone is interested in working with this please contact me and I'll try to work harder on this.

In February, Membership and Ag teamed up and did Farm and Forrest expo again. This year we had piglets, chicks and lots of people talking to Grange members about the farm animals, thank you for everyone that helped.

I tried sending out programs thru the Grangevine so that interested Grange members could attend. After not seeing much interest in it, I gave up, as my time was set more and more into all the animals and getting ready for my nieces to start showing.

In July I took some time out of the Stratham fair and went to a pig workshop that was held here in NH. It was a great little program and seeing that it had been over a decade since the last pork program like this in NH I was surprised how few had attended but those that had attended were extremely interested and enthused. I wish I could have gone back for the full day to do the nutrition part but I got stuck doing the Pigs at the fair, feel free to read your Granite State Granger to learn more about that.

This year, in total, I found myself going to 7 fairs (I only was planning on going to 3), but last minute for 4 of them I was asked to transport my niece's animals to the fairs with her. Deerfield fair taking the most time as it consisted of 1 cow, 29 pigs, 5 geese, 2 turkeys, 4 chickens, and about 15 ducks. Starting at 7AM and ending at 11PM 5 trips later I got to go to bed. Having been to so many fairs this year and reading the Market Bulletin (put out by the State) made me wonder would it be worth doing a Grange Premium for 1 Exhibitor at each fair chosen by a Grange Member, using the criteria of knowledge of agriculture, care of their animal at the fair(if they have one), knowledge of other organizations that are Agriculture oriented (no they do not need to know about Grange to receive it, but if they get it my bet is they will look into what Grange is).

This year I had asked for applications for Ag Awards in July to hopefully get an outing at a farm and Awards day at said farm. Last minute in August I received an award application from a Grange member, not authorized by their Grange, which made me wonder do Granges really want to have farms recognized anymore? I will most likely be giving the 2019 Centennial award to Bartlett Dairy Farm in Concord as it is the only application that was filled out and received for Centennial farm. But I still wonder, Am I to be inspecting these Farms if they are suggested by an individual Granger over the Grange or just pass the buck if something goes wrong after giving the award? I personally thought that a good portion of these awards was a way for the Granges to be more involved in their community, if it is coming just from the State Grange will it help the subordinate Granges at all?

Hopefully this session the Legislative Director will be going over some of the bills that are currently in the House and Senate that not only will effect farmers but will also effect animal ownership in general. As it is, with the budget, somehow a law change was added that will make many more people have to choose between

becoming animal hoarders, break the law, or shell out money to become legal and have to have their private residence inspected by the State or SPCA without appointment. Along with requiring more stringent care rules, such as one species per building (defined as 6 sided unit), Stainless steel dishes (two sets as one will be sanitized while the other is being used), and much more. As there was not a defined section of what pet animals are, they are going to be decided by the Agriculture department, As the NH State Agriculture Commissioner had so gratefully said in one of the bulletins, this law is retroactive, that means if you have breed these animals (that have not been put on the list yet) in the quantity that would require you to register as a pet vendor, and sold them since July 1 st 2019, you better do it ASAP for if they become listed you will have been in violation and subject to the law and all penalties of breaking it.

Well, this seems to be getting long, and we were warned about being over wordy, so I'm going to leave it with; Think where civilization would be without Agriculture. Could we have cities if they rely on hunting and gathering? Without the Farmer could there be enough food for the work force that keeps us all occupied during our free time? Could we enjoy nights out with friends at meetings? Could we relax for a weekend voting on resolutions, giving out awards, and having a fun time with great people?

It is with pleasure that Gloria Davis and I report to the delegates of the New Hampshire State on behalf of the Membership Department for 2019.

First, of all we want to thank Worthy Master Chris Heath for the opportunity to serve as his Co-Membership Directors for the past year, and we look forward to serving another term.

Our year began at the annual Deputy School in Concord, where we met for the first time to plan our year. Our committee was made up of the following individuals: Karlena Henry, Crystal Seward, Adam Terrell, Anne Boisvert, Sherrill Bokousky and Steve Durand.

We set out our Agenda for the year:

- Farm and Forest Plans
- Surveys of members
- Discussions on how to bring our State Grange Session to more members
- Area Membership Conferences
- Fairs

At our meeting at Deputy School, we crafted a **member survey** that was designed for Grange members, not for Granges. Every Grange member was should have received one. The results of this survey are interesting. One member commented that she was 90 years old, had not been to a Grange meeting since she sent her husband off to World War II, but continued to pay her dues and become a Golden Sheaf member because the Grange meant so much to her in her younger years. We were surprised by the results from the members; in our opinion, the results don't match the reality of our current situation. I want to thank State Secretary Jerry Leclerc for his assistance in the copying and supplies that made this survey possible.

The results are as follows:

227 surveys filled out (one in each category was grange name blank)

25 with no comments or score

16 poor

28 fair

103 good

55 excellent

Our first event for the year was the **Farm and Forest Exposition** in Manchester at the Center of NH, on February 2nd and 3rd. This event was a joint effort with the Agriculture Committee. The theme this year was "By culturing our heritage we strive for a promising future".

The Membership Department wants to thank the Youth and Juniors for their assistance at this event. Farm and Forest is always a great opportunity to reconnect with our roots in Agriculture, and to promote the Grange values and the services we offer to our Community.

Area Membership Conferences this year offered three conferences in the three areas of the state. Our first conference was hosted by Antrim Grange on May 18, 2019. The Presenter at our first conference was Joe Stefenoni, who presented on the traditional process of asking people to join the Grange.

Our second conference was held was hosted by Rochester Grange on June 15. Our presenter at this conference was TJ Malaskee, Past Master of the Minnesota State Grange. Richard W. Patten, State Historian was presented to the Master's station to present his annual report.

Worthy State Master, National Grange Representatives, State Officer and Patrons all!

It is a pleasure for me to report to you what has been happening with the State Historian this year. Despite what many might think, I have submitted articles to the Granite State Granger, keeping the State Historian's Blog on Facebook, researching through countless State Grange Journals and trying to locate past royalty for the history book I am working on. I have had nice conversations with Past State Prince of 1966 Lawrence Corey from Monroe Grange, who is now living in South Carolina... He was thrilled to hear about the Grange in NH. I located the 1965 State Prince Norman Hall and State Princess Sally Seaver. Norman helped me a lot in locating Sally Seaver, who is now living in Maine with her husband who was a member of West Thornton Grange. They now belong to a Grange in Dover FoxCroft, Maine. The 1968 State Prince was Donald Shattuck, who is now living in Florida. Richard Seaver who was State Prince in 1969 is living in Minnesota He continues to write to me asking about different members. I have a special section in my book about the past royalty.

I continue to look at the Concord Monitor and The Union Leader for obituaries to see if there are members of the Grange. Many times they list their organizations including the Grange but not any name of the Grange. This doesn't count the telephone calls I receive from funeral directors or family members trying to locate if the person is still a member or how many years they belonged. In many cases it takes a few hours or days to locate this person. In some cases the person had changed last names or not living in the same community.

I enjoy reading the journals of past State Sessions. It is unbelievable how much this NH State Grange has accomplished. I found something very interesting as I was reading the journals. How many have ever heard of the Ceremony for Laying Corner Stones for Grange Halls? It was very interesting as I wonder how many Granges when they built their halls used this ceremony. I will not read the ceremony but all officers had a small part in the ceremony with the Master appointing a Marshall to direct the ceremony.

I was reading the State Grange Journal of 1879 and found it to be very interesting. The State Grange met in Mirror Hall in Manchester on December 16 and 17. Several State Officers were absent thereby having the State Master Dudley Chase appoint brothers to fill Steward. Gatekeeper, Treasurer, and sisters to fill Ceres, and Pomona pro tem. The delegates voted on 61 articles for the by-laws in the NH State Grange. It was voted by the delegates to authorize the Executive Committee to purchase the State Officers new regalia and the jewels of the office. In addition, A Subordinate Grange cannot appoint a Past Master to be a substitute to the State Master if the Master cannot attend. The State Master announced the following Session Committees: Constitution and Bylaws, Good of the Order, Finance, Cooperation, Master's Address, Executive Committee, Claims and Grievances, Mileage and Per Diem, Subordinate Granges, Trials and Appeals, Domestic Relations, and Unfinished Business. The State Master in those days followed the Order of Business as stated in the Subordinate Grange. I noticed the fees for membership were: five dollars for men and two dollars for women in the Subordinate Grange. The exception will be for charter members which will be three dollars for men and fifty cents for women. Religious and political will not be tolerated as discussions in the work of the Order, no

political or religious tests for membership shall be applied. I also found that a Grange in the seacoast area protested to the Executive Committee that there will not be a second Grange organized in Rochester. Rochester Grange had already been organized but efforts were underway to start a second one, which this Grange protested.

I was reading the 46th annual session held in Laconia at the state armory on December 9 to 11, 1919. The Grange cooperating with the Department of Agriculture and Bureau of Markets held sixteen winter meetings. It was reported the attendance was very large. During the months of August and September eleven field meetings were held in cooperation with the Farm Bureau. Once again the attendance was excellent. The State Master Fred Rogers concluded his address by saying The Grange today occupies an enviable position before the world; its influence along legislative lines is greater than ever before in its history. This position has been gained by a wise, safe, and same policy. He further stated Let us make the coming year the best ever by improving the conditions of our farms and homes and teaching the highest ideals so that we can maintain our present high position.

The Sixth degree was conferred on 200 candidates. A special meeting of the NH State Grange was held in cooperation with Hillsborough County Pomona and Peterborough Granges. The Sixth Degree was conferred on 100 patrons. Prior to the Sixth Degree, 43 patrons received the lessons of the Fifth Degree. The State Secretary reported as of September 30, 9,611 members in the Pomona Grange. Hillsborough County Pomona had 1,007 members followed by Belknap County Pomona with 899 members; Carroll County Pomona a net gain of 131 members followed by Eastern New Hampshire with 82 members. There were twenty Pomona Granges in the state.

There were 274 Subordinate Granges in 1919 had a membership of 28,254 members. There are five Granges that are inactive. Capital Grange of Concord had 419 members; Rochester had 395 members; Amoskeag of Manchester had 365 members; Cheshire Grange of Keene had 368 members; and Nashua Grange had 355 members.

Let's take trip to 2009 and see what took place at our State Session in Hampton Beach. The Ashworth by the Sea has been a great place to meet. The State Secretary reported there were twelve Pomona Granges with a membership of 917 with Merrimack County the largest with 139 members. There were 71 Subordinate Granges with a membership of 2287 with Wingold Grange the largest with 76 members. The Junior Grange situation was very poor with two Junior Granges and one closed as of the September 30 quarter. There was a fun event called the Patron's Plunge raising \$2,700 dollars for the Grange. The participants included: the Youngest, Matt Haefner; Oldest, Robert Haefner, Longest Time in Water, Allissa Estes; Most Appropriate Costumer, Rick Bailey; Chicken, Donald Ross; Funniest Costume, Chris Heath; Most Money Donated, Hannah West. The winner of the 4x4x4 contest was Gwen Yardley. The sad note was it was ten years ago that Past State Pianist, Jeanne Higgins passed away among several other Pink Sash members.

This past year as your State Secretary read the roll of members who have left our Grange on Earth and now are in Heaven. They will be greatly missed by all who knew them. As I begin to speak about these members. There is not a day that goes by I don't think of Marion T Jones, Edward Pratt, Elizabeth Cournoyer, Scott Eastman, John L Saturley, B. Franklin Hayes to name a few. I can still hear Marion's playing on the piano, or her speak Yes knowing it could be done. Or Betty Cournoyer and her hearty laughter. Eddie Pratt always talking to me like a second dad about Grange. I could go on and on but hearing John L. Saturley's voice during the Sixth Degree will always be a memory.

We as members of this great organization don't realize or maybe we, that the history of this Grange is made by you each moment. Whether it is in your local Grange, Pomona, Junior, or State Granges, you are creating history. Some of the members below that I will be speaking about may never have served on the State level, but the history they created in their local Grange is known to many.

Carl Adams, Past State Master of the NH State Grange, past Master of Lebanon Grange, served in NH State Legislature where he was appointed to several committees. He was very active in the city of Lebanon. In addition he had a family farm of which he never neglected his chores. He traveled many miles during his term as State Master. I got to meet him in his last year as State Master in 1967. He installed many Subordinate and Pomona Granges through the years. He also assisted State Secretary Scott Eastman with his installations. There was no doubt that Carl was very popular with the members. He was quiet but when asked he would give you sound advice as to what he would do He served as a Subordinate Deputy, then became State Gatekeeper, served as Steward before he thrust into office of State Master. He served in that office with dignity and knew his Grange work extremely well.

His mother, the late Clara Adams served as State Ceres and traveled to National Grange with him. I was honored to have organized a surprise early 100^{th} birthday party when the State Grange last met here at the Fireside Inn in West Lebanon. He was honored to have several State Legislators in the Lebanon area come to celebrate this special time with his wife Pat and his family. He was senior State Master living at that time. I could write so much about Carl but I need to close saying, Well Done Good and Faithful Servant and I am sure he is with our members who are in Heaven and they welcomed him with open arms. At this time, I would like the Assistant Steward and Lady Assistant Steward to approach the Master's Station. I would like to present a bronze Grange Marker with a flag for his grave.

Barbara Frangione passed away in January and she was a dedicated Grange member. She served as Master of Chichester Grange and Catamount Grange of Pittsfield. I knew how much she loved agriculture and I was so happy to appoint her as my State Agriculture Director. She worked with her committee very hard in promoting agriculture. She was very active in 4-H for years. She served on other State Grange Committees. She taught school at Pembroke Academy for 18 years. Barbara was a member n several organizations as a member the United Methodist Church of Chichester. She sang in the Suncook Valley Choral. She will be missed by so many in Chichester. Her home is on a big hill overlooking the town. Across the road is a big pasture that the Marston Family have cattle grazing She was a master gardener. Barbara, I know you are in heaven talking to Herbert and John West, and many others. Well done, good and Faithful Servant.

Arthur Glidden is another member I was proud to have met. He and his wife were very active members of the Grange. Arthur served on the State Membership Committee as well as others. He was a Past Master of Lake Shore Grange and Past Master of Effingham Grange and Carroll County Pomona Grange. He knew his Grange work very well. He was a 60 year member of the Grange and he was 96 years old. He was residing in a nursing home when he passed away.

Judith Abbott was another special friend. She was Master of Harmony Grange and served her Grange very well. I met Judy and her husband when I was placing foreign exchange students. They hosted a young man and he enjoyed his year. They even went to visit him in his country. Judith was very active in Sanbornton her Grange friends will miss her very much.

Jane Cooper Fall was a great member following in her mother's footsteps with the Educational Loan Fund serving as Secretary for many years. Her mother Lillian Foss Cooper served as secretary until her passing thereby passing the torch to Jane. She loved her position as Secretary and worked very closely with the State Treasurer. She was very knowledgeable and took a deep interest in Education. Jane will be greatly missed by all who knew her.

Marjorie Burnett left our Grange circle recently and left a major void. She and her husband John traveled to many Granges helping wherever they could. Marjorie was very active in Danville Grange, which was her home Grange. She also became an affiliate in Liberty Grange, Gilman Grange, Rockingham Grange of Epping, Salem Grange, along being a Past Master of West Rockingham Pomona 'She was a Past Master of Danville Grange and Past Matron of Sandown Junior Grange. When I became a Junior Deputy, Sandown Junior Grange

was in my district. I met Marjorie who was Matron and her two children were members. She worked very hard with the juniors. I appointed Marjorie as State Contact Committee Director when I became State Master.

Carol Fortune really shocked me. I had no idea she was ill and her passing will leave a major void in Sunapee Lake Grange. She was a Past Master of that Grange as well as Matron for the Junior Grange. I was pleased to appoint Carol as a Junior Deputy. She would do anything in Junior Grange Camp to make it successful. We would laugh in the morning because a member of her Grange came to help her with the Sunapee Lake children. Well, I guess Carol didn't get to much sleep as the member snored very loud. She had a great smile and helped her children so much. They were her life. Carol, thank you for all your work with the juniors.

Constance Carr, known to many as Connie also left our Order to be with our Heavenly Father in Heaven. She was a Past Master of Grafton Star Grange, serving as a member of the State Home Economics Committee for several years. I first met Connie and her husband at Grange Family Weekend. They were very friendly and good friends with Past State Overseer Elwyn Chamberlin. She traveled many miles both in Vermont and New Hampshire to promote the Home Economics program. She was a member of Mascoma Valley Pomona Grange holding an office there. Thank you Connie for your service.

Patricia Valliere left our Grange to be with her family and friends in Heaven. I first met Pat when she served on the State Youth Committee under State Director Alton Carpenter. She was a member of Mount Forist Grange in Berlin, serving as Master along with other officers. She was also a member of Androscoggin Valley Pomona Grange serving as Master. She was appointed State Membership Director and serving in that capacity for a few years. She traveled many miles with Elaine Nichols who also served on the State Youth Committee. However she took an inactive role in the last ten years or so. Unknown to many, she moved to Bedford and lived in a retirement home. It was a surprise when I learned she had passed away.

Richard Keniston was a Past Master of Riverhill Grange in Concord. He and his family worked very hard for the Grange in helping to keep Riverhill Grange active. He was appointed to the State Membership Committee where he served for a several years. However due to health reasons, he had to become an inactive member. He also endured the loss of his son who passed away suddenly.

Some of these members you might know but they were very active. Katherine Bush was a Past Master of Ezekiel Webster Grange in Boscawen. She was a very active member before being a resident of the Merrimack County Nursing Home. I received a telephone call from a member asking why she wasn't listed as a Grange member in the obituary. I told her that I knew her but when Ezekiel Webster merged with Daniel Webster Grange of Webster, somehow she got left out. Katherine was a 75 year member of the Grange.

Marion Scott, wife of Past Master Walter Scott of Bartlett Grange in Salisbury is another member that was a member of Daniel Webster Grange in Webster. When Bartlett Grange closed, their members became members of Daniel Webster. Marion was very active in Salisbury, including 4-H, church, and in the town Old Home Day celebration. She was in her mid-90's when she passed away. I also received a call from someone in Salisbury asking the same question as Katherine Bush. She was also a niece to my grandfather the late Arthur Scott who served as a Deputy for many years.

Ann Woodard served Mohawk Grange of East Colebrook extremely well. She and her husband were the main staples of this great Grange. She served as Master and Secretary for many years. Her contributions to Mohawk Grange and Upper Coos Pomona were many. She cooked for many public suppers to help raise money for the Grange and Community events in Colebrook.

Darriel Peterson served as Master for Oak Hill Grange in Francestown very well. I met Darriel when I was State Lecturer and she was Lecturer for Oak Hill Grange she entered in many of the Lecturer's art and photo contests. She was a great member that will be missed. She was also a member of Contoocook Valley Pomona Grange.

Beatrice Hopps was someone I didn't meet when I traveled to Groveton Grange as a Junior Deputy. However, when her obituary was in the newspaper it listed as being a long time member of the Grange. So I went and did some research and sure enough she and her late husband Elias were members of Cape Horn Grange and then it closed. They became members of Groveton Grange. Elias was a Past Master of Cape Horn Grange. Beatrice was a Past Matron of Groveton Juvenile Grange. She lived to be 100 years old and she was very active in the Groveton/Northumberland area.

Arlene Merrill Noseworthy passed away recently and I read her obituary in the Union Leader. It was very extensive and mentioned all the activities she was involved in the Plymouth Fair entering many exhibits in the agricultural portion of the fair. I found out she was a Past Master of West Thornton Grange and Past Matron of West Thornton Juvenile Grange. I also learned this member was a sister to the late Winston Merrill of Littleton, whose late wife was Beverly Merrill, past State Home Economics Director.

Patricia Ford passed away recently and she was a Past Master of Mount Livermore Grange. She was a very active member whose efforts to keep this Grange from closing were endless. She will be greatly missed by her members.

Roy and Dorothy Birard, I was in total shock to find out that Dorothy had passed away last November and Roy just passed away in mid-July. This couple were very special to Deb and I. They were very supportive of the Grange. Roy being a past State Executive Committee member, State Membership Director, Past Pomona Deputy, Past Master of Mt. Washington Grange, Past Master of Northern NH Pomona Grange. They traveled many miles from the Northern Sector to the Southern portion of our state. They were the backbones of Mt. Washington Grange in Whitefield. Roy was like an uncle to Deb as he reminded her of the Fournier family uncles. They will be so much missed.

Norman Hall was the son of E Norris and Lillian Hall, Past State Master and Ceres. Norman was a Past Master of Nashua Grange and then became a member of Brookline Grange. He was also a Past State Prince being honored in 1967. Norman's wife Mary Shea was the daughter of Past State Master Philip and State Ceres Madeleine Shattuck. She also served as a Junior Deputy before she passed away. Norman's sister Barbara Ford was a Past State Junior Director. Norman was a big help to me earlier this year as I was trying to locate past royalty. He was a noted funeral director in Nashua. Norman was a dedicated Granger.

Philip Yeaton of Short Falls or Epsom was from a large Grange family. He and his family not only were active in the Grange but also owned a large dairy and beef cattle farm. They were members of McClary Grange of Epsom serving as Master among several offices. He was also a Past Juvenile Grange Master of McClary Juvenile Grange. He was instrumental in organizing the Epsom Historical Society, active in the Odd Fellows Lodge and Agriculture. His farm continues today on Route 28 in Epsom.

I would like to mention that I once again purchased flowers for the Grange Memorial Stone in the NH Veterans Cemetery for Memorial Day. I also have received nice thank you letters from towns that I had sent Secretary Minute Books to. I have more to send and hopefully this next year I can accomplish that.

I also hope to get my committee together to help organize the History Room at the State Grange Building. That is my goal for the coming year. I appreciate any help in getting cabinets at my former residence to my new residence this year.

I apologized to members who think this report is maybe too long, but it is important that our new members realize and understand how much this organization meant to people, not only in the Grange but in the community. For many years, the Grange Hall was the center of activity. Between square dances, public suppers, fairs, parades, voting for the municipal, state, and federal elections and churches made the Grange Hall

the place to go. History in my opinion is very important. I am asking each Grange to appoint a Historian to organize a history of their Grange. I would willing to help anyone do this.

I would like to thank our State Master Chris Heath for his support, Hannah West for always reminding me it is time for an article for the Granite State Granger. She has agreed to be Librarian for the Museum Room in our State Building. I appreciate the efforts of Rhoda Davis, Esther Herrick, Shelley Huntoon, and Debbie for willing to help organize that room. It has been difficult to find a day that our State Master can be with us. It is my top priority with their help to get it organized and catalogued as to what is there. I also would like to this opportunity to personally thank Cam Twiss, Rhoda Davis, Donald Ross, Norman Brandt, and Jerry Leclerc for their telephone calls and visits and most of their support to Debbie and me. It has been a difficult time for both of us. There are several of us who have had similar difficult times and I have tried to be there for them. When I took my First Degree at Pineconia Grange, I was taught that we despite age differences were Brothers and Sisters in this organization in good times and in bad times. It is in the bad times that we try to reach out for a few words to help cope, but many times there is no one there. I realize we are all busy in many ways but if someone needs support, try to be there. A few words is worth so much. Thank you Worthy State Master for your support as I continue to research and write the history according to my version of 53 years. The people who mentored me to reach heights in Grange I never thought possible.

I would like to close this report by dedicating it to our most Senior Past State Master who is now serving our Heavenly Father in the Great Grange above. I am not sure if I want to thank Brother Carl Adams for bestowing the senior living State Master honor on me or not. I know I have been told I live in the past but the Grange has been good to me and I will always be thankful for the support I have received. When I was not good enough in school, Grange was there and made me feel I had something to offer. I would like to thank Hannah West for her help and information when someone passed away. It seem possible I remember Hannah as a teacher at Concord High School when I was a student.

Thanks to Debbie and our State Master Chris Heath for their support. It means a lot.

State Overseer, Robert Trombi introduced State Master Christopher E. Heath to present his annual address.

National Representatives, State Officers, Pink Sash family, delegates, brothers and sisters patrons all.

As I was preparing this year's masters address I was really struggling with what to say to you all. I honestly feel like I have been a broken record that keeps playing the first 10 seconds of the song over and over again. I hoped that the message I have been sending over these past four years would have conveyed the urgency we need concerning the changes in our thinking, actions and reactions. I know that there is truth behind the message I

have been trying to spread since I became the State Master. Many Granges are struggling and we need some drastic changes in some of our Granges if they are to survive into the next decade.

I want to try to paint a picture for you, in your mind, of a possible future Master's address concerning the status of the Grange in New Hampshire. Close your eyes, try to draw a mental picture of what I am going to say to you in your mind...... Brothers and Sisters, what a great year we have had in the Grange. The Granges in New Hampshire have had a fantastic year. We have organized 10 new Granges and initiated over a thousand new members. Financially we have had great returns on our investments and as a result have earned over an additional million dollars in our coffers. Our smallest Grange in membership is now at eighty-five members. We have a total of three hundred healthy, thriving Granges across the state. At our latest degree day we exemplified the first four degrees for over thirty new members. We have organized three new Pomona Granges and have three hundred and fifty new Pomona members. At State session the sixth degree was administered to ninety-five new initiates and the average age of those new sixth degree members is thirty-five. We organized five new Junior Granges and have sixty new junior members across the state bringing our total to two hundred and fifty active kids. We have three buses scheduled to go to National Grange so that many new members can take the seventh degree. Forty Granges will receive their Distinguished Grange award and the State Grange will be recognized for a net gain in membership......So now go ahead and open your eyes now.

By a show of hands, how many of you would love to hear this news at our State Session? I know I wish this was what I was going to you today. Wouldn't it raise our Grange spirit and make us want to strive to improve these numbers for the following year? We would all have a better disposition concerning the future of the Grange if all this were true. I know that I would be so happy if we had accomplished these achievements this year.... I would have been so proud as well as humble to give this report to you as the Master of the NH State Grange.

The reality is not so hopefully. The truth is that we have had another Grange close since June 30th, 2019. One Grange has been consolidated since September 30th, 2019 and yet another Grange is set to consolidate by December 31st, 2019. We have had a Grange vote to surrender their building to the State Grange because they can no longer afford to keep it. Another Grange has approached the executive committee requesting permission to sell their hall because they do not have funds to make much needed repairs.. Currently the State Grange have, in our possession, two Grange halls from closed Granges that need to be disposed of because we can't afford to keep them.

This is a sad state of affairs for our Granges in NH but it is the truth. I dislike having to share all this negative news but I really do try to be transparent with you, our members. Unfortunately there is more disappointing news to come to you here today. We are aware of two other Granges that are not able to have meetings and will most likely be closed within the next year unless something can be done to invigorate them and get them meeting again. We have two Pomona Granges that are in the same boat and have challenges trying to get a quorum present to hold meetings. These trends are all things we as Grangers should want to see stopped. This is clearly not a good direction for our organization to be going and we must all do our part to help reverse this direction.

You might be sitting there thinking to yourself, "What can I do to help my Grange or another Grange near me?" The truth is you can show your Grange and your Grange family some love and offer to help them. This might be through volunteering at one of their events or by assisting them with recruiting new members. Maybe you know someone from their town that is looking to be a part of something bigger. Maybe by helping a neighboring Grange, they will in turn offer to help you. We all know the saying "Many hands make light work", well let's get in there and help lighten the burden that we all feel.

So why are we not all out helping each other? There may be many reasons for this but one of them stems from many years ago when Granges competed against each other to be the best in the State. This stigma has stayed with us even though we no longer have this degree of competition at a state level. Grangers need to realize that competitiveness is good when things are good but now when things are bad, we need to work together and

strive to revitalize the Grange everywhere. Competition is good and healthy but I don't believe that this is what our organization's founders wanted us to do, we were meant to help each other and be there for each other through thick and thin.

We have had some small but positive achievements this year in the area of membership. At least six Granges, which I know of, have obligated new members this year. I don't have a full accounting of how many but the numbers that I have heard put this figure at around 25 new members and this is only the ones I have heard about. This is awesome news that makes me happy and makes me feel good inside. It should also make you happy and encourage you to go find some new members for your Grange! These little steps are what is going to save the Grange in New Hampshire. These gains in membership help but this doesn't offset the number of great grangers that have gone on to the Great Grange above. It is a sad realization that we are losing more and more members at an alarming rate. Membership needs to be our major focus for the next decade. The Granges need to implement a strategy for how to gain more members by getting out into the community and spreading our Grange message.

In my opinion, it is time that the State Grange consider creating a paid position within the state grange that would be responsible for public relations /membership recruiting. I charge the members and delegates to consider this recommendation. I envision this position would be a person who would work with our current Granges. They also would be working in non-Grange communities to drum up interest in our great organization. If we were to invest thirty thousand dollars a year for the next three years to a position such as this, the return on this investment could be so much more. Many Granges need help re-establishing their presence in their communities. Grange is considered the best kept secret in many communities and we need to reverse this fact. Granges used to be the center of the community and a place where everyone would get together. The Grange was responsible for educating, entertaining and providing for the community. The community, in turn, helped the Grange in continuing the great work and service that they provided. We need to get back to this mentality and start making the Grange the focal point of the community. The Grange and its members have so much to teach and share with people. Society has lost some of the great arts and our organization could be a leader in bringing these back into our home towns.

I know that there are members who are tired of listening to me say that membership needs to be a priority. Some Grangers are tired of hearing me say this and that they would rather keep going in the direction they are going. They appear to be happy with the way things are going and don't want to leave their comfort zone. I say to them, if you keep doing business as usual, your Grange will not be around in 10, 15 or 20 years. We need to look at the big picture. We need to change our thoughts where we can and for those who choose not to jump on board, we need them to not create roadblocks for others who want to change. Change is scary but it is also good. Sometimes it is bad but how do you know if you never try it. This couldn't be more evident and relative in this world at this time.

This past year has been a very difficult road for me as a person I have been through a lot and things have been tough. I recently found out that my full time job will be coming to and end due to restructuring at my company and now I am faced with finding a new job. This is a change in my life that is going to affect me drastically. I had hoped that I would be at my current employer until I retire but that is no longer a possibility. Change was bound to happen and I am embracing it like a champ. Oh how I wish I could have seen the future before all of this happened. For those of you who have never filled in as a leader in an organization, you have no idea how much time and money it costs to be a volunteer. Please don't let my statement scare you from volunteering. Not all positions are as labor intensive and costly as this one can be. I have had to make some difficult choices in my life and in the Grange and if I had to make them again, I wouldn't change a thing.

I hope that I can somehow inspire you to go home to your community Granges and be a Grange Hero. We need more Do'ers in our organization who not only do things for the Grange but also in the community. Our world needs more heroes and people who are out to change the world. The world we live in has changed tremendously. Generational gaps have been made and seem to be getting farther and farther apart. Most of

today's young people are only joining when they get something for being involved. The truth of the matter is we have less and less Do'ers. What is going to happen when they are all gone?

Our Grange leaders need to start training/mentoring their replacements. All too often when I go to Granges, people are asking me how they do this or where do they go to find that. It used to be that when someone new went into a new office in the Grange, others would help educate and instruct them on how to do their job. This is happening less and less now. Is it because we don't want to share or is it because the old officer passed away and no one knows how to do it properly? This is on every level of the Grange. We all need to be more conscious of the fact that the next person who is doing the job may not know what to do. We need to help these new officers like we were helped when we were new.

In closing I would like to thank all of the Grangers who have supported the State Grange over the past year. Without you there would be no State Grange and no future for this organization. Your dedication and determination has brought us to this point in our journey. Your actions when you return home from this annual session will help determine the future. I hope that you can catch the Grange spirit and take it back to your Granges and communities. Always look out to see where you can make a difference. Don't be afraid of being different and certainly be a good ambassador for the Grange. Be a hero today, tomorrow and forever. I hope the best for all the Granges in the new Grange year.

State Treasurer, Daniel Bascom presented his annual report.

Worthy State Master Chris Heath, National Reps John & Susan Plank, Fellow Officers, Grangers All:

This is my seventh year serving as your State Treasurer. Last year I presented you with my first deficit budget and yes, we ended the year with a deficit \$1,259.00 using the 3.5% spending that we have done for the past 6 years. This year I am proposing another deficit budget using a 5% 3 year rolling average spending with a deficit of \$2,084.00. This will be my first year having to pull money from principal. The budget will be addressed tomorrow when we present it for approval. This is partly due to the Executive committee deciding to alleviate NH Granges from paying the National Grange Assessment fee. This fee will be covered by interest received from our invested funds.

My report last year stated when I became Treasurer in 2012 our operating fund was \$158,944.00 which has increased to \$254,311.00 in 7 years. An increase of \$95,367.00. This is due to the watchful eye of the executive committee and the great investment strategy of the Morgan Stanley Investment Firm. We have been averaging 7 to 8% per year during this 7-year stretch. Some years as low as 3%, some years as high as 12%. This is a much better interest rate than you can get on any saving, checking or money market account. Wilber Heath and I met with John Habig, Financial Advisor at Morgan Stanley in April. The recommendation was for us to continue with our investment strategy.

As I have stated in the past, I don't receive all financial statements until about October 10th, this leaves me very little time to complete my financial report for year end. All financial figures will be printed in the journal. This year due to our one-week early session, I was fortunate to complete the September quarter, compile the budget and have my books ready for audit on October 13th.

Monday night I completed the epostcards for all Granges, it took me about 8 hours over two nights. The copy for your Grange is in your packet, if, for some reason you misplace it I can send you a new copy. I am doing this for each Grange so you will continue to retain your nonprofit status.

I am working with the State of NH to have those Granges who have lost their nonprofit with the state to get reinstated. I hope to have this project completed early in 2020. In 2020 each Grange should receive notice from the Secretary of State to renew your nonprofit status/incorporation fee. This is the \$25.00 that you pay to the state every 5 years.

Last December was a very trying time for Kim and I, losing both our mothers and Kim being laid up for 8 weeks with a pinched nerve in her back. I would like to give all of you with one big hug, your support with cards, calls and meals got us through. Learning to run the dishwasher and washing machine wasn't easy, but Kim never complained about my cooking.

Now on to the next chapter in our life, retirement! We will be retiring on November 15th, becoming snowbirds, winters in Florida and summers in Maine. I plan to keep the Treasurer's office running as usual. Our new contact information will be printed in the roster. 28 days until retirement, but who's counting.

I would like to thank each and every one of you for the confidence you have entrusted in me and thank you for asking me to serve as your Treasurer.

State Secretary Gerald J. Leclerc presented his annual report:

Worthy State Master, National Assistant Steward, Delegates, Brothers and Sisters

This is my seventh report to you as your State Secretary.

Subordinate Granges:

We began the year with 47 Subordinate Granges and a membership number of 1279. Barnstead Community Grange and Granite State Grange both surrendered their charters as of September 30 2018. This leaves us with 45 Subordinate Granges and a total membership of 1162, a loss of 117 members.

The largest Subordinate Grange is Wicwas Lake Grange #292 with a total of 84 members.

There are several Subordinate Granges that are currently behind on reporting and owe past dues to the State Grange, and others that are not meeting regularly or not holding meetings as prescribed by the By-laws of the State Grange. I will be making recommendations to the State Grange Executive Committee on how to get these Granges in compliance.

Pomona Granges:

We currently have a total of 8 Pomona Granges with a total membership of 408, which is a loss of 65 members from 2018. No Pomonas had a gain in membership this past year. The largest Pomona in the State is Pemigewasset Valley Pomona #18 with 85 members.

The two months following State Session is the busiest time for the secretary's office with completing the journal and putting together the roster. Normally this isn't difficult but as I began the process, the new Membership Directors asked me for address labels for all the members of the Grange. What should have been an easy task turned out to become a major undertaking.

The database as of right now can only print an address label for an individual member which is fine if that is what you want to do. However, in this situation it would have been more efficient to print one label per address which includes all the members residing at the address.

The 2019 NH State Grange Roster was ready for Deputy School in December. This is always a monumental endeavor requiring many hours of inputting of names, addresses, e-mail addresses, and phone numbers. Most Granges did submit a form so very few pages were left blank.

No matter how many times this is proofread, some corrections and updates are always needed. Roster corrections were sent to the Granges, and hopefully made it to the Masters' and Secretaries' copies. I am asking all secretaries who have not yet sent in the new form for the coming year to please make sure that this from is filled out clearly. Most of the corrections that needed to be made were because the information was difficult to read. For those who have sent the form already, thank you. If something is not clear, you will be receiving a call from me.

Each year as I print and mail the Roster, I can't help but wonder how often, if ever, this is looked at or used. Does you Master and Secretary know where their roster is? Would it be more beneficial to condense the information that is included? Should we prepare a Roster with just the State officers and State team members along with the meeting dates and time of each Grange with just the Master and Secretary listed?

The Journal of Proceedings for the 144th Annual State Grange Session was completed and ready for distribution in early January. Having the journal completed quickly remains a priority to me so that those wishing a copy can receive one while the session is still fresh in their minds. The Journal was submitted and placed on the NH State Grange website, and I hope that many of you reviewed it. I am pleased to be to report that 10 Granges and 3 members requested a copy of the Journal, which is up from last year.

Near the end of each quarter, a packet was sent to each Pomona and Subordinate Secretary with information for the members, as well as the usual report forms. I can't stress enough how important it is to complete the reports and send them in on time. What we pay to National Grange is based on the membership numbers from these reports. If I don't receive a report from a Grange, the membership number I use on my report is the number last reported. There have been times when a Grange report was submitted after my deadline to National, and the Grange reported a loss of members. If these reports were sent in on time, we wouldn't have needed to pay dues on the lost members now being reported. I also need to stress that it is extremely important that the dues check accompany the report. Several granges are sending these separately which requires unnecessary documentation.

Last year, I had mentioned that, in an effort to encourage each grange secretary to report on time and every quarter, I would be instituting an "Honor Secretary" award and will make a recognition at next year's Session. I unfortunately failed to share the requirements on how a Secretary could achieve the Honor. As a result of my oversight, I will recognize all Secretaries who have sent in the reports on time.

Worthy Master, Brothers, and Sisters

It's been a short year, but that didn't make it any easier than the previous ones. As we look back upon this past year, let us not lose Hope for the future. We should always be on the lookout for ways to make changes to what we are doing so that we can attract and retain new members.

Subordinate Granges

This year we tried to reward granges for the following:

- Following proper procedures
- Performing ritual
- Growing the membership
- Participating in state level activities
- Being active in their communities

To promote this agenda, we made a few changes to the scoring system. I want to spend some time going over the reasons for, and results of, these changes.

First we changed the financial section. With the state treasurer filing the 990N reports for the subordinate granges, it made sense to de-emphasize the need to file the report at the subordinate level, but we still want our granges to keep those filings as part of their records. Roughly 80% of our granges met this expectation, so keep up the good work.

We wanted to stress the importance of auditing the grange's financial records, so we doubled the award a grange could get simply by bringing the executive committee together with the treasurer and secretary once every 3 months. Only $1/3^{\rm rd}$ of our granges were up to this challenge, so perhaps the other granges should consider auditing their books immediately before or after a regular meeting.

In addition to giving a large amount of points for ritual work, we made another increase in the award for performing subordinate degrees. We know that not every grange can gather enough members to do them alone, so we strongly encourage you to invite another grange (or two) to help you out. All granges who participate get to claim the points. I believe that it is more important than ever to renew the tradition of performing degrees, before we lose the knowledge of how to do them properly. 10% of our granges answered this challenge, and I hope to see an increase next year.

Membership is vital to the survival of our granges, and this year the membership committee put together three events focused on promoting membership. In addition to getting points just for having one member of your grange attend a meeting, there was also a prize raffle. Whether it was the points, a strong interest in keeping our granges alive, or the prize, they were well attended. 50% of our granges were able to claim these points. This is a much better response than we got from trying to get our granges to complete membership related goals outside

of their comfort zone, so I am pleased with this change. We also increased the value of new and reinstated members, but this didn't meet with the same level of success.

The last changes were an effort to increase involvement from current members. We are now giving additional points for having two delegates at state session instead of one to encourage greater participation. Because this was changed after state session, any impact will not be measurable until next year.

The biggest change we made this year was to abandon the push for the granges to have a visioning session, and instead offer an unlimited amount of points for entries in state level contests. I would say this was a success, as there have been almost no visioning sessions in the last few years, and more than $1/3^{rd}$ of the granges reported participating in contests. I am certain this does not reflect some granges that simply overlooked an opportunity to claim extra points. The most entries claimed by a single grange: 23 (230 points).

The last thing I want to mention on the subject of involvement is that we need some new faces to join our deputy force. For a very small investment of your time, you can enjoy making a big impact on a grange (or two) in your area. We all enjoy seeing new faces at our meetings, so why not volunteer to be that new face that brings delight to another grange?

Finally, as we have always had good reports of grange involvement in their communities, we opted not to adjust the award for community participation. Over 90% of our granges were awarded points this year.

And now the part you've all been waiting for, the highest scoring granges for the past year.

Small granges:

3rd place – Baker's River Grange

2nd place – Arlington Grange

1st place – Antrim Grange

Medium granges:

3rd place – Rochester Grange

2nd place – Mohawk Grange, Blow-Me-Down Grange

1st place – Wingold Grange

I would like to point out that despite being a 'small' grange, Antrim Grange was actually the highest scoring grange overall. Congratulations to these granges for the work and effort they put into this organization and I hope you continue to do well in the future.

Pomona Granges

Similar changes were made to the scoring for the Pomona granges, but there was no evidence of success in encouraging the Pomona members to do more.

None of the Pomona granges have kept up with auditing their books.

None of them reported exemplifying the fifth degree this year.

None of them reported an increase in average attendance.

The highest scoring Pomona grange this year was: Eastern New Hampshire Pomona

Conclusion

Once again I have to thank all of the deputies who continue to volunteer their time and expertise. Your commitment to this organization is the only thing that makes this job possible. We had a couple of team

members retire this past year so it's more important than ever that we find grange members who are willing to step up and take their place. It will take some of your time and energy, but please believe me when I say that it's well worth it.

Robert Haefner, Legislative Director presented his annual report.

Worthy Master, National Representatives, Fellow Officers, Delegates and Grangers all,

Greetings. We started our year off with a meeting of the Legislative committee at a restaurant in Marlborough with all members in attendance. It was an organizational meeting and we set up our plan for the year. In the spring we had 2019 Grange Day at the State House. While the group was small, we had a full day. We for the first time attended the opening of the Senate session. We were introduced by Senator Carson. We also sat in the House Gallery for a short while and Virginia gave us a tour of the State House. It happened to be Hot Dog Day. Some stayed for the hot dogs and others went to the Barley House for lunch. In the afternoon we toured the NH Historical Society Museum at the Tuck Library. That was followed by a stop at the Governor Winant statue where Sister Tara gave us the biography of the former Governor.

This year, as members of the committee talked about a Legislator of the Year, we were unable to decide on a good candidate. We finally chose not to give the award this year, for the first time. We want the award to recognize a job well done that is above and beyond and non-partisan.

Tara and I traveled to National Grange session last November to discuss two topics. We started the discussion on the National Grange Legislative Fly and had Lunch with the National Master and Burton Eller to discuss what the National Grange is doing with lobbying to expand Rural Broadband across the country. The lack of Broadband in many parts of Hampshire are a significant problem for Grangers across the State. Tara Sad and I, in our role as Policy Consultants to the Council of State Governments, put on a major Policy Summit on Broadband in Wilmington Delaware. Yes, NH Legislators were represented among the multi state attendees. We had a follow on to that in Pittsburgh in July.

Our Major project for this year and into next is to host the National Grange Legislative Fly – In here in New Hampshire, timed for the First in the Nation Presidential Primary. Our planning is well along. We are working with Burton Eller at National Grange. You will be among the first to learn, that Secretary of State Gardner has just in the last couple of weeks, set the date of the Primary for Tuesday February 11. There for we have set the dates for the Fly-In. We will have National Grange attendees fly in or drive on Thursday February 6. Stay tuned for the agenda for the Fly-In. Now that we have a date, we can set up a contract with a hotel, reserve vans, plan meals and events. Four years ago, we had great attendance and a bunch of youth. We hope to duplicate that again. I hope with this notice that we can attract a better group from New Hampshire. Our initial plan calls for the Fly-In to start with a gathering and Pizza party on Thursday evening. Over Friday and Saturday, attendees will have an opportunity to work on the Campaign of their choice. Spending half a day at a campaign was a big hit last time. We are also expecting the other highlight to be spending some time at the center of New Hampshire where the press is located and broadcasting from, including the spin rooms. You are sure to spot a candidate or two or more. We will also try to set up a tour of the NH State House and a meal or two. We are looking for an available speaker with knowledge of the primary and its history.

In doing some research for this report I have determined that this is the 10th Anniversary of the incorporation of the Grange Foundation. So Happy 10th Birthday, Grange Foundation.

The Foundation was founded on the basis of a bequest from Clarence Sprague, who in the 1930's, received a scholarship from a local Grange in NH. Sprague was so grateful for that support in his early years from the Grange that he wanted to return the favor and remember the Grange in his last will and testament. The Grange, being a 501c8 organization rather than a 501c3 that receives tax benefits, spurred the NH State Grange Executive Committee to look to establishing a foundation to accept and manage the bequest.

What are the goals of the NH Grange Foundation? To support students going on to receive an education beyond high school. The Foundation serves an important function for Community Granges across the state. The Foundation is able to accept monies on behalf of local Granges, allowing the donor to receive a tax benefit. Does your Grange look for donations in the Community? Right now we have one Community Grange that is using the Foundation, to help with a major restoration of their Hall. I encourage you to talk to the members of Antrim Grange about how they are doing this. It could be a major benefit to your Grange

I want to thank the members of the Foundation board this year for bearing with me. As many of you know in 2014 I stepped away from Grange officer's leadership, because of the state of my mom's health. Many of you may not be aware, but my mom's health took a serious downward spiral starting at Christmas time of 2018, and it came to head in May of 2019, almost resulting in her death. We were lucky, the right doctor walked into her room on that first Sunday of her hospitalization asked the right questions, and we were lucky to have the right answers. The lawn maintenance was a bit of an issue, but I believe that is in the process of being taken care of. I would like to thank Kevin Belval who dropped everything and arrived for a couple of hours of work to clear the hayfield after I arrived to give the key to a renter and found that things were a bit more overgrown than I had realized. While he was doing that, I did a lot of weeding of the side gardens.

The occupancy permit has now been renewed after a small amount of maintenance to the emergency lights. The fire extinguishers were inspected by a different company this time as I found the one we usually used had gone out of business. The exhaust fan on the stove was cleaned and reinstalled and the place where the cover attaches was repaired so that the cover could also be put back on.

Just this month, a church has begun using the building regularly on Wednesdays and Sundays. We have rented the building several times again this year to members of the NH Nepali community for various events. It is actually rented today for a baby rice-feeding ceremony, which is a blessing and celebration of a child who is about six months old and includes ceremonially giving the baby a spoonful of rice as a first solid food. There have also been a handful of Grange events and committee meetings held at the hall.

The next major thing on the horizon, quite literally, is that if you stand in the State Grange Building parking lot and look up you will see that the chimney is a mess. It has had little to no maintenance in years and recently was (we believe) struck by lightning. A representative from Crown Chimney came to look at it yesterday and will be preparing a quote to replace it as both the inside and outside are damaged quite badly. I did call seven other places, five of whom never returned my call. One called and asked that I send a picture but I never heard from him again after that. The seventh is completely booked and could possibly look at us for next spring or summer. Crown Chimney is based in Hooksett so it is local and they are very nice and professional so I think they will be a good choice for us.

Well done, Grangers! Thank you so much for your contributions.

We again asked for donations for the Mountain of Mittens project. Thank you to all of you who contribute to this cause, there will be many warm hands this winter because of you. If you forgot to bring mittens to state grange, you certainly can still help by taking them to your local schools, boys & girls clubs, shelters, etc. We ask that you please keep a count to include in your year-end report so we can get an idea of the total number of items that have been donated. It's nice to know how big an impact we have around the state and also where we might need to make a much needed donation.

We've had a lot of participation in the Night Night Hugs project this year. Again we asked granges to put the sacks together and take them to shelters in their area or to call on us if you needed help distributing them. We are happy to do that if necessary. As with the Mountain of Mittens project, we ask that next year you record how many sacks you made and delivered on your year-end report form. We don't know if the goal set forth last year by Deb & Dick was met (which was for every grange to supply two sacks or the funds for them so that all 11 shelters are covered), but the reports received indicated that a good number of granges did in fact give out these sacks.

We've kept most of the program the same for next year with a few small changes. As directors we are planning a much more in depth meeting with our committee at Leaders School in December because we have lots of ideas for the coming year, including new small project ideas for granges to do on their own as well as larger state projects which hopefully we can do together as a group. We look forward to sharing those with you in January.

Community Service is still very much a part of our granges, as we saw from your reports. Some granges do lots of small but meaningful projects and activities while others do projects on a much larger scale.

Wicwas Lake Grange #292 partnered with a local church to plan and put on a benefit ham & bean supper with a donation box and raffle baskets which raised over \$15,000 to benefit a young boy diagnosed with a rare and life-threatening illness. They also presented a community children's Christmas party with a cookie walk and a meet and greet with Santa Claus. They voted as a grange to support legislation to correct and change the spelling of Lake Wicwas and traveled to the state house to lend support at the Senate hearing for the bill.

Concord Grange #322 organized the 69th annual Concord Christmas Parade and a Christmas Tree lighting ceremony and celebration outside the state house in Concord, complete with fireworks, live music, horse-drawn wagon rides, a petting zoo for the kids and a visit from Santa Claus.

Smaller granges are no less busy, as was evidenced by Watatic Grange #36, who completed almost every project and activity on the report form. The members donated gifts, clothing, personal care items and food to seven different shelters and missions, provided 400 dictionaries to third graders in eight different schools, and traveled out of state to an assisted-living facility where they brought a full dinner and entertainment to a group of twelve nuns who reside there.

Hudson Grange #11 provided turkeys to a local food pantry for the Fill An Empty Plate project, distributed the drug deactivation system packs from RALI New Hampshire, and adopted a needy family for Christmas, providing them with several hundred dollars' worth of food and gifts.

Joe English Grange #53 coordinated a Memorial Day Program with their elementary school, paying tribute to those who have made the ultimate sacrifice and also placed over 200 American flags on veteran's graves in their local cemetery. They gave a \$1,000 scholarship to a high school senior and their "bag ladies" made 65 sleeping bags which were given to several homeless shelters.

Mount Hope Grange #77 hosted a sugar-on-snow party for the community of Landaff, organized a town-wide trash cleanup and created a prize-winning float for the Lisbon Lilac Festival.

Hampton Falls Grange #171 organized and presented a Christmas fair, gave 100 dictionaries to third graders and served as Pease Greeters for departing and returning troops at Portsmouth International Airport.

These are just some of the ways our granges support their communities. No matter how large or small the projects are, what you do for your community can have a lasting impact on the lives of people in need. Don't ever think that your project is too small or that no one will care – only you and your grange know what is needed by your town and its citizens.

A number of granges have honored members of their community with special awards during the year. It is an honorable thing to do and we are so pleased that grangers take the time to seek out deserving folks in their communities who are worthy of recognition for their efforts. Most granges choose to honor a teacher, police officer and/or firefighter as well as a community citizen, but have you thought about other awards that might be appropriate? Some granges salute our agricultural roots with an agriculture or farm award, and even a young farmer award. Other ideas might be a youth service award or maybe a community spirit award, or even a business award for a local business that makes a positive impact on its citizens and community. We encourage you to really think about the ways that your town or city has benefited from other people's time and energy and create meaningful awards and presentations that honor them and the efforts they have made. We strongly feel that all of these awards should be presented in your communities because that is where the efforts of the recipients are most truly recognized, and not at the state level – these are, after all, COMMUNITY awards. You will notice in next year's program that we will not be asking for nominations for community award winners for state level awards.

That being said, we did go ahead with the awards this year since they were already listed in the program for the year. We did choose a firefighter, police officer, educator and first responder from nominations we received. We are also honoring a state trooper, a fish & game officer and a lifetime achievement recipient. We were informed that because of the change of date of our convention this year only one of the recipients of all of these awards was able to attend last night's banquet and award presentation. Arrangements will be made to present the other awards at a later date.

Budget was presented by Robert Trombi, Chairman of the State Grange Executive Committee.

Expense budget was presented: Motion made and seconded to accept the Expense Budget. Motion made and seconded to add a line item for the 150th celebration at \$500 a year to a maximum of \$2000. Voted favorably. The budget as amended was voted favorable.

Income Budget was presented: Motion was made and seconded to accept the budget as presented.

Arthur Merrill was escorted to the master's station to present the report of the Pomona Study Committee.

Worthy Master, Brothers and sisters:

On September 16, 2018 twenty-three members representing the eight Pomona Granges currently holding charters in the state of New Hampshire met at the State Grange building in Hooksett. Five questions were asked by the State Master, Chris Heath. Here are the questions and some of the responses given.

#1 What do you get from Pomona?

Pomona is a good place to hear what the other Granges are doing, and to make new friends.

#2 What do you think Pomona Granges should be doing?

Pomona should be doing degrees. Pomona should hold social events instead of business meetings. Pomonas should help the Subordinates. Sit was suggested that only four officers might be needed (Master, Overseer, Treasurer, and Secretary).

#3 Would you attend Pomona meetings if they were more than one hour's drive away? If it was one the members wanted to attend and it was worthwhile, they would. Again mentioned should be more social.

#4 Should Pomona Granges close?

Close and distribute funds to the Subordinate. There has been talk of change for many years, but no plans, and no follow through. We've been talking about what to do with Pomona Granges for more than 100 years.

Three ideas for the Pomonas to consider: Ritual, social, or assist Subordinates with degree work. It was suggested that Pomonas could pick one of the three and report any successes or challenges to State Grange after one year. Pomona needs to be challenged to do something different, and they need to feel they have some freedom to see what works for them.

- #5. If Pomonas were redistricted, how many would there be and where would they be? One thought was for (A) three, another was for (B) four Pomona Granges in the state.
- (A) Three new Pomona Granges would look something like the following: A line starting at the Mass. border in Nashua, at Route 3, going north to Concord, then continuing north on Rt. 93 to Tilton. Another line from the Vermont border at Lebanon going east through Tilton, to the Maine border would divide the state into three parts.
- (B) Four Pomona Granges would be: 1) leaving Northern New Hampshire Pomona as is (would be a problem in itself), 2) the present Hillsboro County Pomona, Cheshire County Pomona and the western part of Suncook Valley Pomona would become one Pomona, 3) the present East Rockingham, most of Eastern NH, and the eastern part of Suncook Valley would become one Pomona, and 4) the present Mascoma Valley Pomona, Pemigewasset Valley, and the northern two Subordinates currently in Eastern NH would be the fourth Pomona.

Other comments and recommendations:

Presently four or five of the Pomona Granges are meeting quarterly. There is very little, if anything, that any Pomona is currently doing that the Subordinate Granges couldn't be doing.

This fall, during the Deputy visits, two Pomona Granges did not met with the Deputy, two others met, but did not have a quorum present. The other four had between 7 and 21 members present. Not one Pomona had all the Subordinate Granges in the district represented.

It is the recommendation of this Committee, that the current eight Pomona Granges in NH be closed as of December 31, 2020. All monies belonging to these Pomona Granges may be distributed by these Pomona Granges to the Subordinate Granges within their jurisdiction as they see fit. Three new Pomona Granges shall be organized and opened between January 1, 2021 and June 30, 2021 according to the recommendations as stated in #5A above. It also is recommended that NO OTHER Pomona Granges be organized in the state of New Hampshire unless it receives a favorable vote of the delegate body of the New Hampshire State Grange.

Worthy Master, Honored Guest and Brother and Sister Patrons

It is with pleasure that I, on behalf of the Resolutions Committee, present the 2019 Resolutions Committee report. I want to thank the members of the committee – Jozi Best, Bob Haefner and Jim Tetreault – for their work in reviewing and making recommendations on the five resolutions that we were presented.

Resolution #1

Submitted by: Hampton Falls Grange #171

Subject: Judicial System Reform

Whereas: The New Hampshire Court system is not set up for low income people.

Whereas: Some judges make decisions with much of their own personal bias and not on the evidence presented.

Whereas: It costs more than \$10,000 to appeal a judge's judgment if the judge chooses to dismiss a motion to reconsider.

Whereas: Some of these judges constantly make boas decisions regularly.

Be It Resolved: That the New Hampshire State Grange supports a justice reform that will allow a low cost method of having your cases reviewed by an external judge.

Be It Further Resolved: That we believe that if a judge is not found to be bias regularly that they be dismissed from the bench.

Recommendation:

The Resolutions Committee felt this resolution, while well-intentioned, is unnecessary. There is currently a legislative committee that has been working on addressing the needs of the poor in the court system. They are already passing legislation to help those who cannot afford the high costs of litigation.

As to the judges, there is a Judicial Conduct Board in charge of oversight of NH judges. A person who feels they have been treated unfairly by a judge, or that a judge is biased against them, can file a complaint with this board, who will rule on it. The Board even has the ability to remove a judge from the bench.

Because of this, the Resolutions Committee Recommended Not To pass this resolution, by a Vote of 4 to 0.

There being no amendments, there was a motion and a second Not To Pass, which was passed.

Resolution #2

Submitted by Antrim Grange #98

Subject: New Hampshire State Grange Session

Whereas: Article V, Section 1, of the New Hampshire State Grange By-laws states:

"This Grange shall hold its regular annual meeting between October 15 and the first Thursday of November, preferably the Thursday before the fourth Friday of October of each year, convening at a time and place designated by the Executive Committee. The location selected must provide complete access and accommodate all members, including those with wheelchairs, with walking disabilities, with hearing or sight disabilities, and be a healthy, smoke-free environment. (10/25/2008)(10/29/2011)"

Be it resolved the Article V, Section 1, be changed to read:

This Grange shall hold its regular annual meeting **between October 15 and October 28**, convening at a time and place designated by the Executive Committee. The location selected must provide complete access and accommodate all members, including those with wheelchairs, with walking disabilities, with hearing or sight disabilities, and be a healthy, smoke-free environment. (10/25/2008)(10/29/2011)"

Recommendation

The Resolutions Committee felt that this proposed change in the State Grange Bylaws is a good one. The wording is enabling, not mandatory. It allows the Executive Committee to set the first date of the Annual Meeting from Thursday to Friday. This will allow flexibility when necessary, but doesn't necessarily change the traditional first day of the Annual Meeting. Because of this, the Resolutions Committee has voted to **Recommend** this resolution, by a Vote of 4 to 0.

<u>There were two amendments offered from the floor, both of which were moved and seconded and ultimately passed. The amendments were:</u> This Grange shall hold its regular annual meeting **between October 15 and October 28,** convening at a time **the meeting start time, duration** and place designated by the Executive Committee. The location selected must provide complete access and accommodate all members, including those with wheelchairs, with walking disabilities, with hearing or sight disabilities, and be a healthy, smoke-free environment.

There being no further amendments, a motion to accept the resolution as amended was seconded, and then passed resolution.

Resolution #3

Submitted by: New State Grange Executive Committee

Subject: Grange Liability Insurance

Whereas: If a member or visitor to the hall is hurt, the Grange could be sued to cover the costs;

Therefore be it Resolved: That the New Hampshire State Grange By-laws be updated with the following additions.

Under article XII General provisions, add the following:

Section 5 – Insurance

Division 1, A Grange must have general liability insurance to cover the organization in the event of an accident.

Recommendation

The Resolutions Committee felt that this proposed change in the State Grange Bylaws is a good one. The new Section 5 will require all granges to carry general liability insurance, to cover them in the event of an accident, whether the accident takes place at a grange hall or at an event sponsored by a grange. While the Committee recognizes the fact that liability insurance can be expensive (approximately \$100 per quarter, or \$400 per year), the potential costs from a liability lawsuit are staggeringly high. For their own protection, we feel it is in the best interests of the granges to carry general liability insurance. Because of this, the Resolutions Committee has voted to recommend this resolution pass, by a Vote of 4 to 0.

<u>There was one amendment offered, which was moved, seconded and accepted. It read:</u> Division 1, A Grange must have show proof of general liability insurance to cover the organization in the event of an accident. <u>There was then a motion to pass this resolution as amended, which was moved and seconded, with the resulting vote was in favor of the motion.</u>

Resolution #4

Submitted by: Wingold Grange #308

Subject: NH Agriculture

Whereas: NH has a diverse economy which includes Agriculture.

Whereas: Agricultural operations are under increased pressure.

Whereas: The current Commissioner of Agriculture appear not to be standing up for farms.

Whereas: The NH State Grange did not appear to be represented at this year's bills that could be used against Agricultural Operations.

Be it Resolved: That the New Hampshire State Grange support any bill that protects all aspects of Agriculture.

Be it Further Resolved: The New Hampshire State Grange Legislative Director actively and visually move against any bill that is in the House or Senate, by putting in a letter during the hearing and possibly get news articles released to multiple public venues.

Recommendation

The Resolutions Committee discussed this resolution at length. We agree that the Grange should support agriculture in the State of New Hampshire whenever possible, but only insofar as our existing Policies allow. We have established policies for a variety of issues, including Agriculture. The policies are created through resolutions passed at the Annual Meetings. These give a clear path to what our State Grange stands for on issues. It is not up to the Legislative Director to review each and every one of the over 1,000 bills filed every year in Concord to determine which have anything to do with Agriculture, and then, on his or her own, attend the hearings and lobby for or against the bill, without the direction of the full Grange. That is the role of a paid lobbyist, which the Grange no longer has in Concord. Also, the committee objects to the third 'Whereas', which claims that the Commissioner of Agriculture is not standing up for farms. Commissioner Shawn Jasper has, in fact, been working tirelessly this year on his initiative to help save our disappearing dairy farms, among other issues. Because of this, the Resolutions Committee has voted to recommend **Not to Pass** this resolution, by a Vote of 4 to 0.

The Master of the Wingold Grange withdrew this resolution.

Resolution #5

Submitted by: Wingold Grange #308

Subject: Driving Rules

Whereas: When driving you must have control of your vehicle at all times.

Whereas: When an accident occurs while you are driving that involves wildlife, the fault belongs to the driver.

Whereas: When a driver hits a person the fault belongs to the driver.

Whereas: The road is a public domain and with few exceptions (such as limited access highways), animals can travel, and be transported, under their own power.

Be it Resolved: That all animals (humans, wildlife, domestic animals, etc) be treated equally in the eyes of the law while crossing the road.

Be it Resolved: That a driver must compensate the owner of any animal struck for the damages.

Recommendations

The Resolutions Committee feels that there are existing laws for reimbursement of to the owner of the value of a dog (466:42-b Civil Recovery. – Whoever wrongfully kills or maims, entices or carries away a licensed dog shall be liable to its owner for its value in a civil proceeding.) But who is to determine the compensation? Does a purebred poodle have a greater monetary value than a beloved family mutt? Who is to determine the value? The claim is made in this proposed resolution that the fault always lies with the driver whenever an animal gets killed in an accident. If a moose, deer, dog, cat or turtle darts in front of a vehicle, it is not the fault of the driver if that animals is killed. The same is true of a person who is killed. If the person runs out in front of a car, giving the driver no time to stop or avoid an accident, it is not the driver's fault. And, in the law, animals and people are not treated equally. Animals are either wild or they are domesticated, but they are property – not humans. Because of this, the Resolutions Committee has voted to recommend this resolution **Not be Passed**, by a Vote of 4 to 0.

There being no amendments, there was a motion and a second from the floor that this resolution not be passed.
