#### AGRICULTURE REPORT

Brothers, Sisters, Delegates, and State officers alike, I stand before you to give my 2022 report.

This year started with great hopes and dreams within our committee, let's work on doing Agriculture programs that the Granges can modify and take home and apply it to their Granges. Let's work on a website that lists farms in New Hampshire. All great ideas and if implemented would have been a feat.

But let us now dwell on what we failed to do and move on. In February we did our yearly Farm and Forest and Garden Expo. Kids could harvest eggs from our chicken pen or pull up veggies from our various gardens make price tags and put them on the farm stand. We got to chat with many people with questions about Grange and Farming in general.

On April 13<sup>th</sup> I received an email from Bob Haefner introducing me to a gentleman that had contacted the Commissioner of Agriculture (Shawn Jasper) looking for his family Farm to be recognized for Century farm as his grandfather was 96 years old and had grown up on the property taking over the farm from his parents before passing it onto one of his children who passed it to one of his children. As we on the NH State Grange Agriculture committee believe that Grange is rooted in their own community I quickly replied to the gentleman and at the same time asked his local Grange of Harmony if they would like to investigate his family Farm to see if they think the NH State Grange should honor their farm with the Century Award. After many emails and conversations Harmony Grange was able to set up a date of July 8, 2022, to Award the award to Barks Family Farm in Sanbornton, NH. I have set up a little power-point to introduce you all to Barks Family Farm and I hope you will enjoy it. (Power Point presented.) We also have setup a display at Deerfield Fair this year on Types of Tomatoes and Potatoes. We were able to secure a blue ribbon and lots of educating.

The next event we have going on is in November. On November 12 we will be awarding the only New and Young Farmer award that was submitted to us for consideration. Slope Side Farm in Lancaster NH, submitted by Watatic Grange #36. They are not available to be here this year to receive it, but Watatic was able to set up a time and place to present it. As the venue isn't very large, we are going to limit the number of people being invited. If you would like to be invited, please see me some time during State Session if I have not already spoken to you. But at this time, I will introduce you to this farm and all it has done. (Another power-point presentation presented).

For those of you that have not had time to keep up with everything that has been published in the Granite State Granger, allow me to quickly update you on what has gone on in NH and around the country. Quickly as I think I can hear the State Master dozing off behind me. Let's Start with A as in Avian Influenza as of typing this report USA has had 47.73 million farm birds test positive for Avian Influenza with 830,000 of them being discovered in October alone (well pat when it was expected to disappear.) With only two farms or 400 birds total being found and euthanized here in New Hampshire, one in the spring (March) in Rockingham County and one in the fall (September) in Merrimack County with 75 wild birds testing positive this year.

With over 1 million Meat Turkeys, 10s of millions of egg laying hens and many meat chickens being euthanized you may understand why shortages and price increases are projected for the poultry market this year. With the war in Ukraine, and droughts in much of the world Grain shortages have been found, coupled with increases of gas prices the price of Grain for livestock has almost doubled since last year. Much of the prices going to middlemen and transportation companies. Even though there is much more to talk about I'm just going to give you a heads up on some problems on the horizon. First there is 1 disease not yet in USA but causing problems with pork outside of USA and can devastate the US pork industry if it is allowed in. There is a current Rabbit disease that has made it to USA rabbit hemorrhagic disease As of April 2022, RHDV2 has been confirmed in <u>WILD RABBITS</u> in New Mexico, Arizona, Texas, Colorado, California, Nevada, Utah, Idaho, Wyoming, Montana, and Oregon.

RHDV2 has been confirmed in <u>DOMESTIC RABBITS</u> in all states with wild cases as well as Tennessee, New York, Kentucky, Mississippi, Minnesota, South Dakota, Georgia, Florida, and most recently found Connecticut.

At this time, we would like to thank everyone that has been helping us this past year and hope we will get more one this coming year.

#### NH TRUSTEES OF THE NEW ENGLAND GRANGE BUILDING

Worthy Master, National Delegates, State Officers, Delegates, and Patrons:

There were five meetings held this year in December, February, March, May, and June. All were Zoom meetings, with the June gathering being a hybrid meeting of members on site for the annual cleaning session and others from the region logging in via internet.

Tasks that the board addressed were appointing Noel Miller (CT) as Building manager, Dawn Percoski (CT) as the Crafts and Hand goods manager, and Barbara Giguere (MA) as the Needlework Contest manager, with Claire Logan (RI) staying on as the General Store manager; fundraising for and installation of a new, stone-coated steel roof system, warrantied for 100 years at a cost of \$45,760. The roofing company allowed us to pay a deposit at the time of the job and the balance after this year's fair. NH State Grange donated \$1500 toward the roof project; considering a list of suggestions, submitted by youth members from Massachusetts, for improving the Grange messaging within the building. These suggestions were received with a varied response, but I hope the trustees will open their minds and hearts to adopt some changes and thus, involve younger members in the operation of the building, a necessity for its existence and survival. One suggestion we tried to adopt, but proved trickier than first thought, is to add Grange related décor items to the fireplace area. We could use some help in coming up with these display pieces, so are putting the call out for all you Grange historians to check your collections to see if you have something suitable that you would loan to the New England Grange Building.

Brother Trombi and I made the trip down to the NEGB in August to assist other volunteers in pricing handmade items for sale. We also delivered the New Hampshire needlework contest entries and the handcrafted donations sent in by our generous Grangers. This date usually incorporates the heavy lifting involved with receiving cases of jams, jellies, pickles, and sauces for the general store, but the delivery schedules this year didn't work out for that day, so I made a return trip the next week to help with that.

Due to a lack of manpower, the upstairs balcony and state rooms have been closed to public access for several years, but the trustees decided to make an effort this year to get enough volunteers so we could open it at least on Grange Day. Brother and Sister Trombi joined Arthur and I and together, we occupied the New Hampshire room so that fairgoers could see for themselves, "What is up there?" It was amazing to see and hear the delight expressed by the visitors for either: getting their first glimpse or finally getting a chance to revisit that area of the building. While meeting the public this day, we met a young couple from Dunbarton who expressed interest in becoming members, so we forwarded their contact information to Joe English Grange in New Boston. You never know how many Grange-growing seeds you plant any time you interact with non-members, even if you are more than 100 miles from home! Certainly, these state rooms are an under-utilized feature of our building that, with some assistance, we could develop more to help tell the Grange story to our visitors. Later, the four of us joined other Grange members and rode on the trolley in the Grange Day parade. This was a fun and easy way to participate, since management is still limiting marchers due to covid restrictions, and our trolley car followed the one occupied by the very talented Mardi Gras band that played lively music throughout the route.

The Rhode Island State Grange donated the quilt for the annual charity raffle, which raised \$5,633.50 for the Outreach Program (food pantries). In lieu of a set price for each ticket, we ask for donations only and the fair guests were generous this year, making this the most we've raised since starting this program in 2005, the year of Hurricane Katrina.

All revenues were up this year, across the fairgrounds and in our building. The sale of handwork and crafts took in \$21,743.86 and the general store earned \$18,041.88. We started the fair with an overabundance of knitted and crocheted hats, but sales were brisk thanks to a few blustery, cold days during the fair and then Manager Dawn divided up what was left and sent them back to the states to distribute to local charities. She reports, *"We sold almost all of the Christmas ornaments. Mittens were low to begin with, but they all sold. Most of the kitchen towels sold. We have 1 box of scrubbies left. All the catnip and most of the dog toys and items went.* 

I'll be putting together a list of items we would like to have for next year. Top on that list are bigger afghans. We had many people looking for more than the lap sizes. The quilts all sold at the higher prices. As long as they are quality, people did not mind the prices.

We seemed to have priced correctly as we didn't have to do mark downs. We also didn't have to pack large quantities away. Next year, all we will need to do is bring out the items and sort. There's no need to take out things for remarking, so we will be able to spend less time with the start up."

We DO so much appreciate all your lovely handmade donations and hope for you all a fruitful, productive year that we may yet again benefit from your generous gifts of time and craftsmanship! Proceeds from these sales go to the maintenance and upgrades of the building.

The 2022 Big "E" had an attendance of 1,603,354, with six record-breaking days, one of which was an all-time high record of 177,789 fairgoers on a single day. Most of the attendees made the decision to go maskless this year, after being required to wear them inside buildings last year.

Can you help the New England Grange Building in 2023? We gladly accept donations of quality handmade, hand-crafted items to sell. Knitting, crocheting, baby items, pet items, hanging dish towels, scrubbies, greeting cards, hats, scarves and mittens, Christmas ornaments, woodworking items, etc. are all great additions to our sales table. Store set-up dates in late August and early September need volunteers. During the fair, which runs from September 15<sup>th</sup> through October 1<sup>st</sup>, we need volunteers to run the checkout counter (it's very low-tech, believe me!), supervise the quilt raffle table (it's Maine's turn next year to make the quilt and designate the recipient charity), do demonstrations, act as hosts in the NH state room on NH Day (Friday, Sept 22<sup>nd</sup>) and Grange Day (Sunday, Sept 24<sup>th</sup>), attend Grange Day, ride on the trolley in the daily parade on Grange Day. #### FAMILY & COMMUNITY SERVICES REPORT

Worthy Master, Distinguished Guests, and Patrons all,

It is our pleasure to present the annual report of the Family & Community Services department. This has been another challenging year for New Hampshire Granges as we continue to navigate the ongoing COVID-19 pandemic. We recognize the difficulties that keep us from doing a lot of the activities and projects that we have done in the past, and we are grateful for the reports from Granges that have done their best to keep participating in our program despite these difficulties. To those granges and their Family & Community chairpersons we say, "thank you", and ask that you congratulate yourselves and give yourselves a well-deserved pat on the back for your efforts.

We began our year with our planning session at Deputy School. We went over the program for 2022 and planned our first ever "Family & Community Day" to be held in May. We made a few changes to the baking contest, eliminating judging at the Pomona level and instead inviting all subordinate first place winners to bring their blueberry muffins to be judged at state session. We also decided to open the contest to junior grangers as well. After our planning meeting we shifted gears to work on our Glencliff Home project. We packed 120 gift bags of puzzle books, pencils, candy, tissues, and other goodies to be delivered to the residents at the Glencliff Home for the Elderly in Glencliff, NH. This year we decided to deliver the bags ourselves and asked Ida Hutchins to be our guide. We met her at the Baker's River Grange Hall, and she gave us a guided tour of the area as we drove. When we arrived at Glencliff, the staff and residents were

happy to see us and very grateful for the gift bags. We are already preparing for this year's bags. If you or your grange would like to donate items for the bags, please let us know, we would welcome your support.

For something new we created a suggested quarterly activity for granges to do at their meetings during the year. The challenge was to create paper decorations using a different shape each quarter. For example, the first shape we asked you to try was a heart. Since it was the first quarter (January, February, and March) the hearts could be used for Valentine's Day, or you could arrange them together to make a shamrock for St Patrick's Day. We heard from a couple of Granges – Claremont Grange #9 and Hillsborough County Pomona #1 - who tried the challenge. Claremont Grange made several different decorations for different holidays and Hillsborough County Pomona put a picture of their members holding their creative decorations in the Granite State Granger. Were there other granges who tried this activity?

On May 21st we held our first ever Family & Community Day at the state grange building in Hooksett. Turnout was low, with a total of nine grangers in attendance. #### **GENERAL DEPUTY**

Worthy Master, Brothers and Sisters:

This is my final report as your General Deputy. First, I would like to thank the Worthy Master for giving me this opportunity to serve in this capacity. I also would like to thank and recognize the twelve Brothers and Sisters who travelled throughout the state this year to visit Granges. Jane, Dan, Matt, Andrew, Sarah, Tricia, Norman, Mark, Chris, Beth, Jim, and Ida.

One year ago, as we gathered, there were 39 Subordinate Granges in New Hampshire. On November 6, 2021, Beth and I went to Landaff and were present when Mount Hope Grange #77 voted to close after 145 years. Maybe you read an article about this Grange in the NH Union Leader that said, "Television, and the Lawrence Welk Show in particular, may have played a role." There were twelve members present, but the decision to close had already been made. Their minds were made up. Could we, as a State Grange, have done more to help them sho they wouldn't have closed? Many times, I think, just someone visiting will make a Grange think twice. Someone else who cares about them, listens to their problems, give them some ideas, let them vent their frustrations. Sometimes those frustrations are with the State Grange. They believe the State Grange doesn't care.

On June 30, 2022, Golden Rod Grange #114 of Swanzey, after existing 136 years, consolidated with Arlington Grange #139 in Winchester. Presently, Meriden Grange #152 is in the process of consolidating with Blow-Me-Down Grange #234 of Plainfield.

From reports received, ten Granges own real estate valued at between \$31,000 and nearly \$400,000. I believe there are six or seven other Granges that own real estate; however, no reports were received. Several Granges are still not meeting, having stopped more than two years ago at the beginning of the pandemic. This State Grange must do something to get these Granges active again.

At least twelve Granges took in new members. Hopefully, next year that number will increase. Granges were asked what they are doing to reach out to all their members. Responses ranged from sending meeting minutes via email to all members, Zoom meetings that allow those who are unable to attend in person, Facebook posts, and others.

Granges are active in their communities by holding Meet the Candidate nights, cleaning up roadsides, donating dictionaries via the Dictionary Project, planting and sharing community gardens, organizing and/or participating in Old Home Days and town festivals, hosting farmer's markets, producing Grange Fairs, awarding scholarships, assembling food baskets, assisting needy families, entering parades and fair exhibits, collecting, and distributing gift cards, and many more.

After looking at all the reports received and adding all the scores, the number one Grange for 2022 is Antrim Grange #98. This busy Grange took in five new members AND conferred the First Degree, both of which are awarded high points on the score sheet.

#### **Pomona Granges**

One year ago, there were eight Pomona Granges in New Hampshire. Today there are still eight Pomona Grange in New Hampshire. I thought about ending my remarks about Pomona Granges there, then I thought better of that. According to the by-laws of the New Hampshire State Grange the duties of the General Deputy include reporting the condition of each Grange. So, here it is.

There is one Pomona Grange that has not "gathered" in at least three years or held a legal meeting in six or seven years. Another Pomona held one meeting this year. We find yet another met twice, but only once with a quorum. Two more Pomona's met three times with quorums with never more than nine members present. This next Pomona met four times, each with a quorum, having nine to eleven present. The seventh Pomona met five times, four with a quorum and never more than nine present. That brings us to our last Pomona holding four meetings with an attendance ranging from thirteen to twenty members present.

So, in conclusion, there is just one Pomona Grange that met the minimum requirement of four times, with the required quorum each time, and enough members present to fill the officers' chairs. The others are just limping along, meeting because the by-laws say they should.

It appears that one new member joined a Pomona this year.

Have the Pomona Granges in New Hampshire outlived their purpose? What is their purpose? There is not a Pomona in the state that is doing anything, according to the reports, to assist the Subordinate Granges in their district. When was the last time your Subordinate Grange had a visitor from your Pomona who was not also a State Grange official? I believe it is time, probably past time, for this State Grange to take drastic action. Close all Pomona Granges. When members join a Subordinate Grange and are obligated, they should also be obligated in the Fifth Degree. The Fifth Degree should be conferred at State Grange at least every other year. Some action must be taken. This is one thought. Or do we continue to allow Pomona Grange to stumble along, doing nothing until they all die a slow, lingering death. It's your call.

#### STATE MASTER'S ADDRESS

State Officers, National Representative, and all Patrons of Husbandry:

Welcome to this 149th session of the New Hampshire State Grange. I am grateful to be standing here giving this report. Please bear with me as I might stumble a bit.

Thankfully this past year has been better in terms of the pandemic. Most Granges have gotten back to normal and are meeting in person on a regular basis. There are some Granges that have not met since the pandemic hit, and if they choose not to meet now, they should be closed or consolidated. "The Pandemic" is no longer a valid reason to "just not meet".

Jane and I were honored to represent NH at the National Grange Convention last November in Wichita, Kansas where Jane served as Chair of the Grange Growth Committee, and I served on the Citizenship and Taxation Committee. There were many resolutions discussed and voted on as well as election of officers. It was exciting to be a part of such an important process. We were also able to have Deputy / Leaders School in person last December. It makes such a difference when we can have everyone together.

Last year, one of my goals was to have more resolutions presented at State Grange. At Leader's School in December, I gave all Deputies information to be presented to Granges at their spring instruction in an attempt to encourage increased participation in the resolution process. Unfortunately, as of this writing, only two resolutions have been received by the State Secretary. This is an issue, not only in NH, but nationwide. National President Betsy Huber wrote in The Patrons Chain newsletter on October 21st, saying: "While State Sessions are full of fun, fellowship, food, and contests, an important purpose is to discuss and set policy for our organization for the next year. So far, it's been a bit disappointing to see very few resolutions coming to National Grange from the State Sessions already held. I'm sure your members are not happy with everything going on in Washington and your State Capitols! Your membership in the Grange gives you a greater voice than you can possibly have as an individual voter. We should take advantage of that power and use it to change things we don't like. The resolution process is how we do that.

It's too late this year to write and consider resolutions to send to National Grange but make some notes while you're engaged in those discussions at your Sessions about issues you can address throughout 2023 to present next year. It's never too early to start working on those resolutions!" With the National President addressing this subject, it is clearly not only a NH issue, but ideas for addressing Legislative issues cannot be allowed to fall by the wayside. Addressing issues for the public good is a big part of the Grange legacy. Remember that resolutions don't just have to deal with Grange topics, but issues in communities, but state or national topics as well. I am sorry to say that I was unable to appoint a new Legislative Director for 2022. This position needs to be a person who has knowledge of what is happening in our State House as well as the National Legislature. I am hopeful that this position can be filled with someone willing to go the distance and keep our grangers in the know.

Another goal I had was to be sure all Granges were reaching out to those members they do not see in person. The Fall Deputies report asked how and what Granges were doing to reach this goal. Unfortunately, the General Deputy reported that the only outreach was emailing them about a meeting or sending them the minutes. My suggestion had been to talk with those people in person, send them a personal email asking them to join you or send them a card and to ask them why they are not coming to Grange meetings. After your members were contacted, then discuss at your meeting the answers received to see what can be done to make your meetings a place everyone wants to be at.

It is time once again that the By-laws of the NH State Grange should be read over carefully to verify that what is there is currently needed. This is something that should be done every few years. My recommendation is that the State Master appoint a committee to review the by-laws and write resolutions for any changes needed to be brought to the 2023 State Grange Session to be voted on by the delegates.

This past year I received requests from two Granges about consolidating. One Grange was on the verge of having their charter pulled, but instead decided to consolidate with a nearby Grange. In both circumstances they were unable to have a quorum to make the vote, so in one circumstance I made the decision to consolidate them. The other Grange was waiting to hear they were accepted for consolidation. I feel there are many more Granges that need to think about consolidating due to lack of members or not even holding meetings. It's not something any of us want to think about, but the number of Granges in our state is dwindling. What can we do to help these Granges get back on their feet? Can a committee be appointed specifically to go to Granges that are having these difficulties? Can the rest of us as dedicated Granger's step in to help them figure it out? I do not have all the answers but feel it is something that needs to be dealt with.

In December there will be a very important position to fill. Hannah West is stepping down as Editor of the Granite State Granger. She has been in this position for 26 years and has done the very important job of keeping our members informed of what is going on and what has happened within our organization. Let's all applaud Hannah for her dedication and years of service. Do we have someone who is willing to fill those shoes?

Can you believe that next year is the Sesquicentennial of the NH State Grange? Our organization has been a prominent presence in NH, being involved in local communities for the betterment of society for 150 years! Think of all the lives that have been touched during those 150 years. Let's make next year a special one while we toot our own horn with all that has been done in our state. Our annual session in 2023 needs to be the best ever. A sesquicentennial committee was formed, but unfortunately two of the members have had to resign. We need interested members who are willing to go the distance to plan celebratory events and make next year's State Grange Convention a one to remember. If you are this person, please see Gloria Davis.

As mentioned in my article in the Granite State Granger, I have decided not to run for a second term as your State Master, nor will I seek a position on the Executive Committee due to health issues. With those health issues being short term memory loss and reading difficulties, I also suggested to the Executive Committee that we not hold the Sixth Degree this year. I know there are several members who are disappointed in this decision, as Past State Master's could have stepped in to take my place. So, my apologies to those of you who felt we should have had the degree this year.

There is much to be done in our organization, and I feel that I am currently not up to that task. I would have liked to have done more this past year to address the issues I have stated above, and I wish I could continue in this position to take on those tasks, but do not feel I am up to it. I would like to thank the members of the New Hampshire State Grange for your support and especially the State Officers and Directors for standing beside me and helping me through my term. With special thanks to my family, especially my Wife Jane, for helping me along this challenging path!

We hope there will be someone to step forward and rise to the challenge of trying to fill her shoes.

To accomplish this, we encourage others to join the committee and ensure this celebration is one that will create community awareness and wonderful memories for all of us! The conferral of the sixth degree is important to many of our members. While we understand the personal challenges you have faced, we encourage future State Officers to ensure the Sixth Degree is performed annually and if there is an officer unable to be prepared for his/her part, a

suitable replacement step in for them. It is important for Grangers to not lose touch with the degrees of our order.

We commend your work Worthy Master and wish you the very best.

#### **RESOLUTION AND BYLAWS COMMITTEE**

Worthy Master, National Representative, and Brother and Sister Patrons all,

It is with pleasure that I present the 2022 Resolutions Committee report on behalf of the Committee. I want to thank the members – Sister Jozi Best and Brothers Bob Haefner and Jim Tetreault – for agreeing to participate on the committee.

We had only one resolution submitted to the committee this year, which, while not what we had been used to seeing in the past, is one more than we received last year. The committee met via Zoom on October 24 to discuss this resolution, suggest editorial changes, and to vote on whether or not to recommend it for passage by the delegates.

Resolution # 1 Submitted by: Hudson Grange #11 Subject: New Hampshire State Grange Roster

**WHEREAS,** A Roster with contact information for State Officers, State Team Members as well as selected officers and committee chairpersons for Subordinate and Pomona Granges as well as Junior Grange Leaders is prepared annually by the State Secretary. and

**WHEREAS,** The State Secretary is bound by the State Grange By-Laws with sending two copies of the Roster to each Subordinate and Pomona Grange as well as the Junior Leaders. and

**WHEREAS**, the intended use of the roster is for communication purposes, between State, Subordinate and Pomona Granges such as knowing meeting nights, times and locations, as well

as to know who to send an invitation to for a Special Meeting event such as Home Economics Night, Youth Night, Past and Presiding Officer Night. and

WHEREAS, many of these Special/Event Meetings are either not being held or invitations are not being sent so the need for a printed copy of the roster is not beneficial to the Granges. and

WHEREAS, the cost to print and mail the 2022 Roster was roughly \$900. and

**WHEREAS**, with today's technology and the ability to place the information gleaned from the Roster onto the State Grange web site, leaves one to question, does each Grange need two copies?

**THEREFORE, BE IT RESOLVED,** that Article VIII, Section 7, Division 4 of the NH State Grange By-laws be changed to,

"The Secretary shall also keep **and publish** annually a complete Roster. It will contain the names and numbers of all Junior, Subordinate and Pomona Granges in the State. It will also list the names, addresses, e-mail addresses and telephone numbers of the Master, Lecturer, and Secretary of each. It will also list the Leaders of Junior Granges. **The Secretary will submit the completed Roster to the Web Master by the last day of December for submission on to the New Hampshire State Grange web site.** She will send a copy to the Master and Secretary of each Subordinate and Pomona Grange and to each Junior Leader on or before the first day of February. One printed copy will be provided to a Subordinate, Pomona or Junior Grange leader at no cost by using the Supply Department order form. One printed copy will be provided to a State Officer or Team Member upon request at no charge. The Secretary shall conduct the correspondence of this Grange and other duties as generally devolve upon the office."

**BE IT FURTHER RESOLVED,** that if this resolution passes, it will take effect with the 2023 Roster.

How it is currently printed in the By-laws

"The Secretary shall also keep and publish annually a complete Roster. It will contain the names and numbers of all Junior, Subordinate and Pomona Granges in the State. It will also list the names, addresses, e-mail addresses and telephone numbers of the Master, Lecturer, and Secretary of each. It will also list the Leaders of Junior Granges. She will send a copy to the Master and Secretary of each Subordinate and Pomona Grange and to each Junior Leader on or before the first day of February. The Secretary shall conduct the correspondence of this Grange and other duties as generally devolve upon the office."

The Committee discussed the merits of the proposed Resolution and noted that the purpose was to reduce the number of rosters sent to the Subordinate and Pomona Granges to one from two, noting that the information on the rosters was accessible on the State Grange website, and available through the Master's. The committee agreed.

There were, however, some editorial changes that were suggested, and these were voted on and accepted unanimously.

#### The resulting vote on the amended resolution was unanimous in favor.

The amended Resolution brought before the delegates read as follows:

Resolution # 1 Submitted by: Hudson Grange #11 Subject: New Hampshire State Grange Roster

**WHEREAS,** A Roster with contact information for State Officers, State Team Members as well as selected officers and committee chairpersons for Subordinate and Pomona Granges, as well as Junior Grange Leaders is prepared annually by the State Secretary; and,

**WHEREAS**, The State Secretary is bound by the State Grange By-Laws to send two copies of the Roster to each Subordinate and Pomona Grange, as well as the Junior Leaders; and,

**WHEREAS**, the intended use of the roster is for communication purposes, between State, Subordinate and Pomona Granges, such as meeting nights, times and locations, as well as a Special Meeting event such as Home Economics Night, Youth Night, and Past and Presiding Officer Night; and,

**WHEREAS,** many of these Special/Event Meetings are either not being held or invitations are no longer being sent, so the need for a printed copy of the roster is not necessary for the Granges to have; and,

WHEREAS, the cost to print and mail the 2022 Roster was roughly \$900; and,

**WHEREAS**, with today's technology and the ability to place the information gleaned from the Roster onto the State Grange website, it puts in question the need for each Grange to have two hard copies.

**THEREFORE, BE IT RESOLVED,** that Article VIII, Section 7, Division 4 of the NH State Grange By-laws be changed to:

"The Secretary shall also keep **and publish** annually a complete Roster. It will contain the names and numbers of all Junior, Subordinate and Pomona Granges in the State. It will also list the names, addresses, e-mail addresses and telephone numbers of the Master, Lecturer, and Secretary of each. It will also list the Leaders of Junior Granges. The Secretary will submit the completed Roster to the Web Master by the last day of December for submission to the New Hampshire State Grange website. She will send a copy to the Master and Secretary of each-Subordinate and Pomona Grange and to each Junior Leader on or before the first day of February. One printed copy will be provided to a Subordinate, Pomona or Junior Grange leader at no cost by submitting a Supply Department order form. One printed copy will be provided to a State Officer or Team Member upon request at no charge. The Secretary shall

conduct the correspondence of this Grange and other duties as generally devolve upon the office."

**BE IT FURTHER RESOLVED,** that if this resolution passes, it will take effect with the 2023 Roster.

How it is currently printed in the By-laws

"The Secretary shall also keep and publish annually a complete Roster. It will contain the names and numbers of all Junior, Subordinate and Pomona Granges in the State. It will also list the names, addresses, e-mail addresses and telephone numbers of the Master, Lecturer, and Secretary of each. It will also list the Leaders of Junior Granges. She will send a copy to the Master and Secretary of each Subordinate and Pomona Grange and to each Junior Leader on or before the first day of February. The Secretary shall conduct the correspondence of this Grange and other duties as generally devolve upon the office."

The Motion was amended by the changes noted highlighted in gray above. This amendment passed. The resulting amended motion was seconded and passed with a show of hands.

I wanted to quote from National Grange President Betsy Huber's recent article in 'The Patron's Chain' newsletter entitled 'Use your voice in the resolution process' "While State Sessions are full of fun, fellowship, food, and contests, an important purpose is to discuss and set policy for our organization for the next year. So far, it's been a bit disappointing to see very few resolutions coming to National Grange from the State Sessions already held. I'm sure your members are not happy with everything going on in Washington and your State Capitols! Your membership in the Grange gives you a greater voice than you can possibly have as an individual voter. We should take advantage of that power and use it to change things we don't like. The resolution process is how we do that."

The number of resolutions submitted have dropped precipitously recently, and the Resolutions Committee is here to help you through the process of developing and writing them. Contact us and we will be there to help.

The following resolutions were submitted following the deadline, and so the committee didn't have the opportunity to meet, discuss and vote on them. So, I will be presenting them to the delegates for their vote without recommendation.

Resolution 2 Submitted by: Antrim Grange #98 Subject: Conferral of Sixth Degree

**WHEREAS**, it has been announced that the NH State Grange will not confer the Sixth Degree this year, and,

WHEREAS, the Granges and members in New Hampshire were not included in making this decision and,

WHEREAS, many members look forward to the Sixth Degree conferral each year, regardless if there are actual candidates and,

**WHEREAS**, it has been evident in recent years that the traditions of Grange ritual are swiftly eroded as a result of easing routine degree work and,

**WHEREAS**, participation in the exemplification of the Sixth Degree is one of the General Duties of all State officers (NH State Grange Bylaws, Appendix Q, pg. 48),

**THEREFORE**, **BE IT RESOLVED** that the NH State Grange confers in full form the Sixth Degree each year at State Session, or at a special session called for that purpose.

#### This resolution was defeated.

Resolution #3 Submitted by: Claremont Grange #9 Subject: Hunters acquire landowner permission for use of hunting cameras, drones and tree stands on their property

**WHEREAS**, landowners strive to protect their properties, livestock and other animals, family and themselves; and,

WHEREAS, many landowners open their land to hunters and other outdoor enthusiasts; and,

WHEREAS, landowners need to know who are enjoying activities on their land for safety and liability reasons; and,

**WHEREAS**, there is often a need for landowners to communicate specifics of one's property, such a crops, trees, livestock, enclosures and structures to local and state governing agencies, insurance companies and such;

**THEREFORE, BE IT RESOLVED**, that the New Hampshire State Grange and its delegate body support legislation by their New Hampshire State Legislators that requires prospective users of game cameras, tree, stands, and drones to acquire permission of the landowners for such usages with complete knowledge of and adherence to all rights and laws set up concerning such equipment;

**BE IT FURTHER RESOLVED**, the NH State Grange Legislative Committee update its Legislative Policy Handbook with this new policy.

This motion passed with a show of hands.

Resolution # 4 Submitted by: The NH State Grange Resolutions Committee Subject: Committee to Review State Bylaws

**WHEREAS**, The Bylaws of the NH State Grange have not been updated as a package in a number of years; and,

WHEREAS, it is recommended that organizations review and update if necessary their bylaws every three to four years; and,

**THEREFORE**, be it resolved that the State Master appoint a by-laws committee to review and update the State Grange by-laws.

**BE IT FURTHER RESOLVED,** that the Committee bring the recommended changes to the bylaws before the delegate body for approval at the 2023 State Grange Session.

#### Motion was passed by a show of hands

After having noted the existing text in the bylaws which read 'She will send a copy to the Master and Secretary of each Grange....' and being surprised to see that the pronoun 'she' was used, it was decided that it is time for a review of our bylaws. To that end, Jim Tetreault has proposed the resolution that you have before you now. The Resolutions Committee supports this resolution.

Resolution #5 Submitted by: Wingold Grange #308 Subject: Civil Asset Forfeiture

**WHEREAS**, Civil Asset forfeiture laws allow police to seize property, money, or assets if police merely believe it is connected to criminal activity. Police do not have to file charges or even establish guilt in these cases before seizing and keeping property and there is no limit to what police can seize; and,

WHEREAS, Civil Asset forfeiture was implemented during prohibition to curb bootleggers; and,

**WHEREAS**, there is no proof that Civil Asset Forfeiture has ever stopped or slowed down any bootleggers; and,

**WHEREAS**, assets can be forfeited if someone is found guilty of a crime without the use of Civil Asset Forfeiture, and it is very expensive to defend forfeited assets I court; and, **WHEREAS**, an officer can use Civil Asset Forfeiture without charging a person for a crime; and,

**WHEREAS** there are no consequences for an officer with Qualified Immunity who uses Civil Asset Forfeiture for ill reasons; and

WHEREAS, there has been an increase of Civil Asset Forfeitures since the 1980s; and,

**THEREFORE BE IT RESOLVED** that the New Hampshire State Grange support any legislative effort put forth to limit or eliminate the use of Civil Asset Forfeiture; and

**BE IT FURTHER RESOLVED** that a copy of this resolution be sent to National Grange to be supported by the Grange as a whole.

#### The motion was defeated on a show of hands.

Resolution #6 Submitted by: Wingold Grange #308 Subject:Criminal Justice

WHEREAS, the courts have trouble keeping up with all the cases that come before them; and,

WHEREAS, Lady Justice holds a double edge sword symbolizing that justice cuts both ways; and,

WHEREAS, it is expensive to defend yourself from accusations that may not be true.

**THEREFORE BE IT RESOLVED** that the NH State Grange support legislation that would require the prosecuting party to pay all costs of a trial if the defendant is found not guilty, or if the case is dismissed

# Move to send back to originating Grange for clarification was seconded and the motion passed.

Resolution #7 Submitted by: Wingold Grange #308 Subject: Qualified Immunity

WHEREAS, it is common knowledge that absolute power corrupts absolutely; and,

WHEREAS, Qualified Immunity was implemented by the supreme court in 1967 without any precedent before said date; and

**WHEREAS**, it was implemented in a way that allows it to cover any action that is done by a civil servant as long as there has not been a ruling on the same matter prior to 1977; an,

**WHEREAS**, this prevents courts from rectifying actions that could be otherwise be considered illegal if they weren't protected by Qualified Immunity; and,

**THEREFORE BE IT RESOLVED**, that the NH State Grange support changes to Qualified Immunity to limit or eliminate it by legislative means; and

**BE IT FURTHER RESOLVED** that a copy of this resolution be sent to National Grange to be supported by the Grange as a whole.

# Motion was made and seconded to send the resolution back to the originating Grange for clarification.

#### Motion passed.

Resolution #8 Submitted by: Wingold Grange #308 Subject: Domestic Animal Vehicular Homicide

WHEREAS, New Hampshire currently has laws that address dogs and cats being struck by motor vehicles; and,

WHEREAS, drivers should always be in control of their vehicle

WHEREAS, if you hit a person with your car, you can be found guilty of vehicular homicide; and,

WHEREAS wild and domestic animals are attracted to roads for salt, food and easy travel; and,

WHEREAS, if a driver hits a wild animal, the driver is automatically at fault and,

WHEREAS, domestic animals are an important part of their family's life;

**THEREFORE**, **BE IT RESOLVED** that the New Hampshire State Grange support legislation that states that owners of domestic animals hit b motor vehicles shall be free of fault for any legal or civil liability pertaining to such incidents; and

**BE IT FURTHER RESOLVED**, that this legislation stipulate that the driver of said vehicle is automatically at fault for any incident and will be required to make restitution to the owner of the domestic animal.

#### STATE SECRETARY'S REPORT

Worthy Master, National Representative, Pink Sash Family Members, Delegates, Brothers and Sisters all.

This is my tenth report to you as your State Secretary. In looking back at what has happened in the past ten years I'm concerned about our future. Let me share with you the opening of my first report in 2013.

The condition of the Granges in New Hampshire are as follows: As of June 30, 2013, the New Hampshire State Grange has 11 Pomona Granges, with a total membership of 688, of which 188 are Golden Sheaf members. The largest Pomona is Merrimack County Pomona #3 with 103 members.

As of June 30, 2013, the New Hampshire State Grange has 64 Subordinate Granges, with a total membership of 1806, of which 413 are Golden Sheaf. The largest Subordinate Grange is Wicwas Lake #292 with 81 members.

Now let's come back to the present!

The condition of the Granges in New Hampshire are as follows:

Subordinate Granges:

We began the year with 39 Subordinate Granges and a membership number of 1032. In November 2021 Mount Hope Grange #77 Surrendered its charter after 145 years of service to the Landaff community. Golden Rod Grange #144 after 136 years of service to the Swanzy community consolidate with Arlington Grange #139. This leaves us with 37 Subordinate Granges and a total membership of 951, a loss of 81 members.

The largest Subordinate Grange in the State is Wicwas Lake Grange #292 with 82 members.

Pomona Granges:

We began the year with a total of 8 Pomona Granges with a total membership of 363. As of June 30, 2022, we have 8 Pomona Granges with a total membership of 340 leaving us with a loss of 23 members.

The largest Pomona Grange in the State is Pemigewasset Valley Pomona #18 with 71 members. The total Pomona membership number may be lower simply because no reports have been received from Northern NH Pomona #5 and Mascoma Valley Pomona #7 for more than a year.

During my report last year, I had reported that the State Master had received a letter from a concerned member regarding things that we as a State Grange could improve on.

There were two items that I felt I was in violation of. The first is "State leaders need to respond to emails and phone calls in a timelier manner" This past year I returned calls and responded to e-mails within the first 24 hours of the and leaving messages when needed.

The second, "Documents should be reviewed on a regular basis and noted at the bottom when last revised or reviewed so members will know if they have the current form." Now every form used in the Secretaries Department has been reviewed or amended and the date that this revision or review was done is included at the bottom of the form. The several copies of the newly revised forms were sent to each secretary and were placed on the secretary page of the website.

This past year the supply list was updated with the new pricing reflecting the changes made by National Grange for some of what they provide. This was sent to all secretaries. The supply department continues to fill and send orders. I have noticed this past year has not been as busy as in previous years and wonder if Granges are not using the forms. A big area of slow down seems to be in the Membership Awards. The list that I reported on earlier is one of the shortest lists to date during my time as State Secretary. #### STATE GRANGE BUILDING MANAGER

Somehow, I suppose in part due to the expenses involved, the Executive Committee of the State Grange has supervisory privileges over the State Grange Building Manager. It hasn't always been the most amicable or functional arrangement and in recent years I have been assigned a liaison to help make sure I am aware of what they expect me to do or what is being done by them that affects me. Those dynamics took an abrupt turn when I became my own liaison following last year's election. It turned out to be a good year for that to happen, as there was a lot to be dealt with and therefore especially important that everyone be kept in the loop.

#### Chapter 1: Eight loud alarms

In February, the Hooksett Fire Department called State Secretary Jerry Leclerc to set up an assembly permit inspection for the State Grange Building. Clearly that meant that someone new was in charge of that, since I usually have to chase someone down to have that done. Sure enough, some new regulations appeared to be in place, specifically applying to the issue of smoke and CO2 detectors. In order to get our assembly permit renewed, I purchased and installed eight new detectors, all of which can "talk" to each other and to anyone who is unlucky enough to be in the hall if a problem arises. Rather than just one of the three previously installed detectors going off, now all eight will go off at once and tell you to evacuate the building immediately as well as announcing very, very loudly where the smoke or CO2 has been detected. This could of course be helpful if there is an emergency as there is zero chance that you would be left unaware. If you accidentally burned some toast, however, you may find yourself needing to explain your mistake to several neighbors who may also evacuate since that's how loud the alarms are. Together you and the neighbors may need to run several miles away and hope your hearing returns. Actually, your best bet if there is not an actual emergency would be to put in the earplugs you have of course been carrying for just such an occasion, bravely walk toward the detector in the location announced, and press the "silence" button.

#### Chapter 2: The Air Conditioner

You know that week where the heat index was at least 100 for several days in a row? Fortunately, in this area of the country, that narrows things down to one week. At any rate, near the end of that week, the church contacted us to say that the air conditioner had not been working well and that one of their members had investigated the problem and found that the blower downstairs was frozen solid. A technician from Eastern Propane who usually services the air conditioner came out and told me that we were low on coolant and there were enough small leaks in our considerably past its prime system so that refilling the coolant was no longer a long term solution. He said it was past reasonable repair, and we needed a new air conditioner. He also recommended we consider replacing the furnace at the same time as he had noted its condition when he went downstairs to look at the blower. At that time, I began investigating the possibility of a replacement HVAC system.

#### Chapter 3: The Furnace

In early October we were again contacted by the church to let us know that the heat wasn't working either. This time I called Dead River Company who is now our oil company since the owners of LaVallee Oil retired and sold the business to them. A technician came out to look at the system and immediately zeroed in on the blower being the issue. Remember the blower that had been frozen up when the air conditioner was failing? It turns out that both systems use the same blower... huh. I should have seen that one coming. I returned from picking my daughter up from school to find the following hand-written analysis by the technician: "The capacitor on the blower motor was bad, so I put a new one in. The blower motor is also bad. To get the correct motor, I need to pull the blower. The screws for this are so rusted and deteriorated I cannot remove them without breaking them. After that the unit is so rusted, I may not be able to resecure the blower after repairs. I also need the blower out to make sure the heat exchanger has not been damaged due to the current issue. We need to speak to someone prior to spending \$2000 or more on a unit that you may want to update instead." It was a fine polite note that basically said, "do you really want us to try to fix this thing?" I had mentioned to him up front that we were looking into replacing the whole HVAC system. At that point I redoubled my efforts to get replacement quotes. In the meantime, two large room space heaters with built in thermostats have been providing enough heat to manage at this time of year. Two Saturdays ago, Executive Committee approved one of the three quotes I got, and a new furnace and air conditioner is scheduled to be installed by Ethical Home Pro this coming Monday. Conveniently, the company that checks the fire extinguishers for the year is able to stop by then as well.

#### Chapter 4: The Usual Stuff

Orkin Pest Control continues to monitor the building quarterly to keep tabs on pest activity such as the mice and carpenter ants. Issues dealt with included a few mice, one vole, and a nest of bald-faced hornets. Beth Merrill continues to clean the building regularly. The building has gotten considerably more use in recent months after a couple of years with almost no rentals due to Covid concerns. A few other small issues were dealt with such as getting the back door lock fixed as a screw had broken inside the mechanism and replacing a few outdoor lightbulbs and one motion light fixture. The most noticeable difference at the building is the change to LED lights throughout. The difference is striking. Thank you to Mark Collins for your assistance with that process.

I will close with an excellent note I found on the door of the State Grange Building just over a year ago thanks to the church which uses the space twice a week. I forgot to include it last year in my report, and it was too good not to be included somewhere. "You Didn't Miss the Rapture. The Service Has Been Postponed Until Next Sunday. – The Pastor"

#### STATE TREASURER REPORT

Worthy Master Bob Trombi, National Reps Lynette & Don Schaeffer, Fellow State Officers, Brother's, and Sister's all.

We have an unsung hero in our midst, she has dedicated many, many, many years of her life to Grange and I am sure she will continue to do so for many more years to come. So, I would like to dedicate this report to **Hannah West** as she retires as **Editor in Chief** of the Granite State Granger. Thank you so much Hannah.

What a difficult past couple years we have had. Still trying to recover from covid (some Granges are still not meeting) and now inflation is affecting us all. Gas, food, and heating oil prices are ridiculous, and investments are at an all-time low. Our operating fund has gone from \$293,000.00 on December 31, 2021, to \$226,000.00 on September 30, 2022. If we don't have to touch this money it will hopefully rebound in the future. With that said some money will have to be used to pay for the new heating system at the State Grange building.

We ended this past year with a deficit. For the first time since becoming Treasurer ten years ago, I had to withdraw \$ 5,000.00 from principal to help pay outstanding bills. I expect next year will end in a deficit as well with unexpected expenses with the State Grange building. To help compensate for the additional costs the State Executive Committee has increased rental fees.

I am still very frustrated with dealing with the IRS. I cannot get a clear 990 filing for Wingold Grange even though we have received a letter from the IRS reinstated their nonprofit status. They don't have enough help to upgrade their computer logs. I hope as they rebuild their workforce this will change soon. With that said, I have completed 990 filings for all other Grange's, and they are included in your packets.

This past week I had a request to investigate the incorporation status of a Grange. In doing so I found out back in December of 2020 I had sent out letters to 6 Granges that had still not filed. This is supposed to be done every 5 years. These 6 Granges still have not filed and have lost their incorporation status. I am willing to work with this Grange to get their status updated. As for the other Granges, unless you request my help you will be on your own.

I have completed the IRS paperwork for our account Hennessey & Vallee PLLC and have dropped it off to them to complete our IRS filing. I will not bore you with the financial figures as they will be printed in the journal. Speaking of the Journal of Proceedings my pages are completed and are included for the Secretary to add. If any of you have questions or concerns, please see me after the meeting.

It has been a pleasure working with State Secretary Gerald Leclerc, as he is retiring this year, I will miss working with him. Yes, we have had our ups and downs but together we have helped

keep the Grange afloat. If I am reelected this year, I will endeavor to help the new secretary with getting their feet wet and will help keep them on track.

Last, I again would like to thank Kim for putting up with all my ranting and raving when the accounts don't balance with the bank statements. Usually, I have transposed a number incorrectly and it just takes me awhile to find it. Thank you all for your confidence in me.

- The rental agreement between The State Grange and The Baptist Church has been signed. A money market for the original deposit paid when the first lease was signed has been set up.
- Granite State Grange Hall: The purchase and sales agreement has been finalized and once all parties agree the signing of the papers will take place. This should be done before the next meeting.

New Business:

• Rockingham Grange: 12 NEW members have been obligated and there are still 8 more applicants in waiting.

- Arlington Grange: After some discussion Mark Collins volunteered to assist Arlington Grange with the selling of their hall. He will keep the committee informed as things progress.
- Concerned members letter: after reviewing the letter in more detail, it was decided that at Leaders School, the letter will be shared with those present and reasonable accommodations be made for each.
- Mascoma Grange Minute Books: The Historical Society are no longer in need of the books and would like to have them go someplace else. A motion was made by Mark Collins and seconded by Beth Merrill to give them to the New Hampshire Historical Society. Vote was favorable.
- The Treasurer and Secretary signed the money market account this morning and a new credit card account was opened with TD Bank.
- Aurora Grange has Pomona dues from members of Northern NH Pomona and doesn't know what to do with them. The secretary will contact them and have the dues sent to State Grange.
- Electrician: The lights in the dining area as well as other areas need to be looked at. Beth will work with Ann Boisvert to see about getting this taken care of.
