The Assistant Stewards escorted Sister Kathy and Brother Glen to the Master's station. Sister Kathy and Brother Glen thanked Sister Tricia for inviting them and voiced their appreciation of the State Officer drill. They were both impressed. They look forward to a great Session. The Assistants then escorted the Gibsons back to their seats.

Steward Norman Brandt announced State Senator Howard Pearl, farmer and Concord Grange member, as an honored guest. He welcomed us to Concord and congratulated us on the great honor of celebrating our 150<sup>th</sup>.

The Standing Rules for the 150<sup>th</sup> Annual Session were read. A motion was made by Christopher Heath and seconded by Gloria Davis to approve the rules. It was a vote in the affirmative.

Norman Brandt shared the report of the Agriculture Committee, which included a photo presentation on Slopeside Farm in Lancaster, NH, whose owners Susan and Michael Greene were given the New Farmer award, and Corliss Farm of Northfield, NH, winner of the Century Farm award. *The report was accepted and ordered printed in the Journal*.

Steward Norman Brandt announced honored guest Commissioner of Agriculture Shawn Jasper. Commissioner Jasper spoke on the state of agriculture. Before the Grange was organized NH farms focused on sheep. Now NH dairy farms are struggling. His family had a poultry farm, and were members of a vibrant poultry growers association that is now defunct. However, the pandemic showed us the importance of local food supplies. Mr. Jasper thinks the most important goal is to make farming profitable. Farming organizations need to work *together* to get this message across. He suggested there might be a place for the Grange in the NH Food Alliance. The NH Department of Agriculture will be moving to Granite Place off of Rumford Ave. in Concord, hopefully before the end of the year. He encouraged us to contact him with any questions.

Diane Collins, Chairman of the Trustees of Trust Funds, was escorted to the Master's station to give her annual report. *The report was accepted and ordered printed in the Journal*.

Beth Merrill presented the report of the NH Trustees of the New England Grange Building, which included show and tell of homemade Christmas ornaments that could be made and donated for sale at the Big E, a beautiful photo of the New England Grange building and video footage taken inside the building during the Big E. She also mentioned that we received \$4000 in grant money from the National Grange for offering vaccinations. *The report was accepted and ordered printed in the Journal*.

Brother Glen Gibson shared a video letter from the National Grange. In it, National President Betsy Huber announced that last year there was a net gain in membership for the first time in nearly 70 years. The National Grange building is still on the market. She also shared about grants for reducing stigma around addiction and mental illness, and the Affordable Connectivity Program.

At 11 am, the gates were closed for the annual Memorial Service, under the direction of State Chaplain Kathy Yardley.

The afternoon session was called to order at 1:33 pm. Trevor Clark was escorted to the State Master's Station where he introduced State Master Tricia Taylor to give her first Master's address. *The report was accepted and ordered printed in the Journal*.

Gerald J. Leclerc, Session Coordinator, was escorted to the Master's station to give his report. *The report was accepted and ordered printed in the Journal.* 

Christopher Heath, Webmaster, whose email address is <u>webmaster@nhgrange.org</u> presented his report. *The report was accepted and ordered printed in the Journal*.

Daniel Bascom presented the State Treasurer's report, which included a presentation to members of Wingold Grange who have officially had their nonprofit status reinstated by the IRS. *The report was accepted and ordered printed in the Journal*.

Arthur Merrill, Chairman of the State Grange Executive Committee, presented the report of that committee. *The report was accepted and ordered printed in the Journal*.

Robert Haefner presented the report of the Legislative Committee. *The report was accepted and ordered printed in the Journal.*

He also mentioned a new book called <u>Preserving Old Barns</u> put out by the NH Preservation Alliance. Copies are available for sale. He also represents the Grange with the Future Farmers of America. *Both reports were accepted and ordered printed in the Journal*.

Mary West presented the State Secretary report, which included a movie trailer for "State Secretary: Blood, Sweat and Tears". *The report was accepted and ordered printed in the Journal*.

Matthew Clark was escorted to the State Master's station to give the State Lecturer's annual report. *The report was accepted and ordered printed in the Journal.* 

After a brief recess, members participated in the member workshop "Community Grange and You" – teaching how fraternity matters - led by Kelly Riley, Rhode Island State Membership Director and Northeast representative of the Shipmates Program.

With no further business to conduct, the first day of the 150<sup>th</sup> annual State Grange Session was closed in the 4<sup>th</sup> degree at 3:58 pm.

The second day of the 150th Annual State Grange Session was opened in the Fourth Degree by Master pro temps Trevor Clark.

Roll call of officers found all stand-in officers and all elected officers present. Roll call of Granges found a quorum present. The minutes of yesterday's session were read and approved with corrections.

Steward Norman Brandt announced Kathy Gibson, Lady Assistant Steward of the National Grange and her husband Glen Gibson, Past Master of the Massachusetts State Grange as our honored guests. Sister Kathy shared that they are having a great time, especially enjoying their meals with NH members. Brother Glen said "ditto".

Steward Norman Brandt announced additional honored guests, RI State Master Walter Hartley, RI State Ceres Danielle Hartley and National Junior Ambassador Nettie Hartley.

Youth Director Rachel Scanzani was escorted to the Master's station to give her fifth and final report. She presented awards for the holiday wreath, social media presence, and poster contests. *The report was accepted and ordered printed in the Journal*. The State Master announced our new Youth Director, Andrew Savage.

Joann Brandt, Junior Director, was escorted to the Master's station with Junior Ambassador Nettie Hartley and NH Juniors Rebecca Boisvert, Jared Clark, and Alexander Belval, to give her annual report. The tellers were released and thanked for their service while the Assistant Stewards escorted National Representative Kathy Gibson to the Master's Station for a few words. Sister Gibson again thanked the State Master for inviting them. She enjoys seeing how states differ in their sessions and appreciated last night's Flora's Court, our officer swap for the session opening, and the enthusiasm behind the annual reports. She reminded us that registration is still open for the National Grange Convention in Niagara Falls, NY, November 14-18. There is an interested buyer for the National Grange building, though the study period has been extended. If the sale goes through, Grange would stay in the building for one year but move to the eighth floor. She mentioned the National Grange vaccination program and strongly recommended the program information for what to do if you're diagnosed with cancer, which is still available on the National Grange website. Sherrill Bokousky, Grange Services Director, was escorted to the Master's station to give her report. *The report was accepted and ordered printed in the Journal*.

Gloria Davis presented the report of the Sesquicentennial Committee. *The report was accepted and ordered printed in the Journal.* 

James Tetreault was escorted to the Master's station and joined by Gloria Davis to present the Membership report. *The report was accepted and ordered printed in the Journal.* 

Kathy Yardley and Joyce Martin, Family and Community Committee Directors, attired in hat and backpack, were escorted to the Master's station to give their annual report. They presented awards for needlework, teacups, and community service notebooks and reports. The roll cake baking contest judging was ongoing. Next year's baking contest will be hand pies or pasties. Joyce's backpack is sponsored by a nonprofit called Planet People, designed for use in trash pick-up for adopted spaces. Granges are encouraged to look into adopting spaces for clean-up in their communities. *The report was accepted and ordered printed in the Journal*.

Announcements: Delegates were reminded to return their binders and nametags when they leave. Program packets will be available at the credentials table after lunch and must be signed out. National Grange t-shirts are available in the display room, as are the Affordable Connectivity bags. Voting notebooks should be returned to the State Overseer. Lecturer's contest entries should be picked up from the display room.

After a recess for lunch, the session reconvened at 1:39 pm.

Arthur Merrill, Chairman of the State Executive Committee was escorted to the Master's station to present the 2023-2024 Income and Expense Budgets. A motion was made by Jim Tetreault and seconded by Kathy Yardley to adopt the Income Budget as presented. It was a vote in the affirmative. A motion was made by Christopher Heath and seconded by Lester Gibbs to accept the Expense Budget as presented. It was a vote in the affirmative. The income and expense reports were accepted and ordered printed in the journal.

Tara Sad, Chair of the Resolution and Bylaws committee was escorted to the Master's station to present her report.

Resolution #1: Therefore be it resolved that NH Granges be encouraged to seek partnerships with community members to facilitate the use of our Grange Halls as preschool and daycare facilities, entering into a symbiotic relationship with support growth of existing care providers and those interested in entering the field, while increasing the profile of our organizations purpose and the value of supporting us and our buildings.

The committee recommended an amendment: "...facilitate the use of our Grange Halls, with required levels of liability and property damage insurance by both parties as preschool..."

A motion was made by Donald Ross and seconded Arthur Merrill to move the question. It was a vote in the affirmative. After discussion, the resolution was defeated.

Resolution #2: Resolved that veterinary technicians be able to perform standard procedures such as required vaccinations, Health and Safety Assessments, health papers for sales, exhibits as part of their licensed duties. Be it further resolved that the NH State Grange support legislation that veterinary technicians be qualified and licensed to perform common veterinary tasks such as but not limited to: required vaccinations, health and safety assessments, health papers for sales, exhibits and shows.

The committee recommended passage of the resolution. After a brief discussion, the resolution passed.

The report of the Resolutions Committee was accepted and ordered printed in the Journal.

After a brief recess, Past Massachusetts State Master Glen Gibson, with assistance from National Lady Assistant Steward Kathy Gibson, installed the newly elected officers: Flora Lynn Clark and Executive Committee members Gerald Leclerc and Lester Gibbs. There was a round of applause for the NH State Grange kazoo band members Emilie Leclerc and Anne Boisvert as well as appreciation for the installation team.

The State Secretary movie trailer was replayed by request.

Credentials Committee co-chairs Emilie Leclerc and Adam Paquin-Varnum were escorted to the Master's station to presented their report. *The report was accepted and ordered printed in the Journal*. Debra Patten was the winner of the credentials table's guess the candy corn contest.

Unfinished business: Arthur Merrill reminded the State Officers that they are part of a committee to maintain the Thompson Memorial in Littleton, which could use some repair.

Jane Trombi reported on Grange Revival 3.0, held in July in the Upper Peninsula of Michigan. There were 130 in attendance at a lovely campground with tent sites and cabins. Members were free to do as they pleased but convened for community dinners. The next revival will be in Utah in 2025. *The report was accepted and ordered printed in the Journal*.

The winner of the Hudson Grange Red Sox quilt raffle was announced. They raised several hundred dollars to help repair their hall roof. Gerald Leclerc shared that The Riverside Inn in Hooksett hosted the National Grange convention in 1913, with 15,000 visitors in attendance, very close to the location of the current State Grange building.

After a brief recess to prepare the hall, the annual meeting of the New Hampshire Grange Foundation Meeting took place at 3:00 pm. Members voted to approve the election of Directors David Babson, Andrew Savage Linda Lauer, and Josh Marshall, and Officers President Jim Tetreault, Vice President David Babson, Treasurer Andrew Savage and Secretary Tara Sad.

Announcements: Last chance to bid on the silent auction and purchase National Grange t-shirts! Don't forget to take your items from the display room. Please turn in your binders, nametags, and evaluation forms and pick up your program packets. Matthew Clark has been appointed as the third trustee for the New England Grange building.

With no further business to conduct, the third day of the 150<sup>th</sup> Annual State Grange Session was closed in the 4<sup>th</sup> Degree at 3:25 pm.

#### **Saturday Evening**

The Annual State Grange Banquet was held under the direction of State Ceres, Gloria Davis. A delicious meal was prepared and served by the staff of the Holiday Inn. While attendees enjoyed chocolate cake, Xander Belval and Mary West, Lynn Clark, and Brian and Roberta Twiss reprised their talent show entries. Kathy Gibson performed a sign-a-song and Christopher Heath provided comedy. Kathy Yardley announced the winners of the baking contest: 1st place Denise Hupper of Wicwas Lake Grange, 2nd place Lois Enman of Rochester Grange, and 3rd place Terry Jo Terrell of Walpole Grange. Anne Boisvert read the proclamation for the traveling gavel and explained that it will continue its travels through December 31, as not all Granges received it. Gerald Leclerc read the history of the gavel, a symbol of freedom and independence, written by Wayne Ingalls. Master Tricia Taylor presented Kathy Gibson, National Lady Assistant Steward and her husband Glen with a few New Hampshire made gifts as a thank you for attending our session. Starting with the completion of last year, Watatic Grange had sent in the following: The Members of Watatic Grange #36 are pleased to nominate Susan & Michael Greene of Slopeside Farm in Lancaster, NH, as candidates for the 2022 NH State Grange New Farmer Award through the Agricultural Department. The Greene's moved to Lancaster from Boston, MA in 2017. They were both seeking a more rural lifestyle. Susan immediately started a garden and in the good soil of northern NH she achieved success in harvesting enough produce to preserve and display at the 2018 Lancaster Fair. In the ensuing months, Susan and Michael increased their garden area, installed a high tunnel greenhouse and applied for and received status as a Certified Organic gardener. She is now able to raise produce and flowers that she sells to a local store, several restaurants and to local residents through a CSA. The farm's website, Slopesidefarmnh.com, describes in detail the full scope of what the farm grows and its mission as a small Certified Organic farm in the North Country of NH.

After reading over many PDF's and visiting their website I agreed that they should receive an award. As I feel that awards are best presented in their community, I requested that Watatic Grange members find a nice location local to them for the award. As you can see by the photos we did have a nice little crowd attend for the award. Thank you Watatic for the nomination.

Now let's talk Century Farm award. This year one of my committee members and his Grange submitted a Century Farm award recipient that I was surprised had yet to receive their award, not only because in a few more years, if the farm restructures it could be in the running for the bicentennial, having started 1847, but because the name is familiar with the Grange, Corliss. I'm not Richard Patten, so I will not be going on about the name but their family, until a few years ago, was a Grange family. Harmony Grange once again spearheaded the gathering of the community for me to go up to Northfield to the farm to present to the Blackey family, who took it over when George Corliss's health was declining. As I have written a bunch in the Granite State Granger about the farm, I will only touch on it a little here. Sadly, they had to stop being a dairy farm as help was getting thin, but before getting rid of the last of their milkers they bred their cows with Beef Bloodlines allowing them to continue farming. They are now producing eggs, and beef and venturing in different directions to see how they can continue. Some of their neighbors have started working with the Blackey Family, with Stirling and Craig making daily decisions, to start farming with them. It sounds promising. As you can see by the slideshow, we had a good turnout and a beautiful day to present this award.

During Deputy School our committee met up and discussed 2023. We decided we wanted to put on a program open to all. After discussing and taking in prior conversations with the Asst. State Vet Nate Harvey we had settled on the unsettling topic of internal parasite control, with how to test your animals to determine how to increase your production. Notices were sent out and nobody had signed up. Slowly even some of my own committee members were starting to tell me they could not attend, causing me to send out a notice of cancellation. I'm hoping that we can try doing the program again as the cost of having a vet come out to work it out with you is very high and testing for internal parasites is easy. I would say best practice would be to monitor yourself and consult your Vet on how to treat and this part was going to be a focus of the discussion.

Due to late frosts and very cold days during the winter last year peaches in NH didn't come from NH trees, and grapes, apples, and strawberries were also affected. Then having a wetter and cooler year also affected many of the other crops planted. I know I had made the choice early on I was not going to do the meat chickens I normally produce, and by the end of the season I was glad I made this choice. I'm sure everyone has read about stuff at my farm so I will save you all from some updates and end this paragraph right here.

Farm and Forest was held at a later date and a new location this year, the Deerfield Fairgrounds. Once again Ag and Membership had worked together on the display. Sadly, the display did not come out as I had hoped, but after much waiting for information, I moved forward with a Plan II. Why II? Because when a ship is sinking you start coming up with other plans. In this case instead of a mighty maple or oak tree with 360 branches demonstrating Granges that had started and closed being dead branches and Granges that are still around being live branches, it became a spruce tree, tall, proud, and only live branches seen. You can see a sad representation of this exhibit in the back of this room. Even though I have not heard of anyone getting any new members from Farm and Forest Expo this year, we had many people stop in and talk about how Granges have affected their life in their towns and some even took pictures of the contact leaves that showed how to attend or contact a Grange. Thank you to Joann Brandt and Gloria

Davis for staying up late the night of set up for the Farm and Forest cutting out and taping on the limbs on the tree.

Though not directly due to my position here in the New Hampshire State Grange, I would like to talk a little about Deerfield Fair this year. My mom and I have been Super and Assistant Super attendant of the Grange area of the Deerfield Fair. This year we had 11 Grange booths filled by Granges and Committees, and 9 others filled by Scouting and Community organizations. Many people come through to look at the booths and every so often we can hear them ask each other "What is a Grange?" At times they find the answer themselves. Other times they stop and ask us. This year we had two separate people that not only asked what a Grange is but asked where one is local to them and how to join. First was a family from New Durham, NH. After much talking with them, we allowed them to take a photo of the contact information for Rochester Grange, in a book that Harmony Grange had made to go with their Grange Exhibit. The other was a couple of people that live here in Concord, that were very interested in the Grange. We once again opened Harmony's book to display the Concord choices and they took a photo and walked off. Shortly following I called Debby Patten and left a message to let her know someone was interested in attending a meeting. I have not heard from either of the Granges if they had been contacted, but I do think if people are considering looking into Granges but cannot find one locally how are our Granges going to get new members? Fewer and fewer Granges are taking the time to exhibit in the fairs and at some time and point fairs may decide not to even bother setting a space up for Granges to display in. If this happens, how are we going to let people know we exist?

Well, now I'm just going way out of my scope of discussion so I will end my talk today with a thank you to the worthy State Master for your continued support for the Agriculture Committee. Thank you Adam, Jozi, Scott, and Les for being on my committee and all the ideas you have and time you spend working with me. And thank you everyone that had to sit through this report without falling asleep.

#### FAMILY & COMMUNITY SERVICES REPORT

Worthy Master, National Representatives, Patrons all;

Where has this year gone? 2023 has seemed to just fly right by.... We sincerely hope that your Grange year has been a productive one. Honestly, we are very proud of the response to the challenges we gave to your Granges last year, particularly in the baking contest. We wish you could have stood at the front of the room at last year's session when we announced the 2023 baking contest would be a ROLL CAKE – the silence was almost deafening! We were not sure if you didn't like the idea or you maybe didn't quite understand it until we explained it to you. Either way, you rose to the challenge and tried your very best, and in the end that is all we could ask for.

At Deputy School in December, we made plans for our second annual Family & Community Day to be held in May. We also packed bags for the residents of the Glencliff Home which we typically send at Christmas time, but due to a scheduling conflict we delivered them in February instead. This actually worked out well since the residents receive Christmas gifts from their families and the staff anyway so our bags arrived at a time when they were really quite welcomed. The new activities director there is very accessible and easy to communicate with so we will work with her to see when she would like the residents to receive our bags. If your grange would like to donate to this project, we would definitely appreciate the support. We are

currently packing bags for about 75 residents, as the facility only has staff to handle that many. We like to pack things such as coloring books, crayons, small packs of tissues, crackers, candy, pencils, hand lotions and sanitizers, playing cards, etc. Let us know how you would like to help. If you have a nursing or retirement home in your community it would be a great thing to do there as well.

We held our second annual Family & Community Day on May 20, at the State Grange building in Hooksett. Attendance was up from last year with 15 Grangers participating during the day. We began the day by working on crafts for the Grange store at the Big E. Several members made Christmas ornaments and put together do-it-yourself craft kits while others decorated items such as trinket boxes and easel backed note boards. Just before lunch we had our second annual cookoff event which had 100% participation all around! Mac N Cheese was the dish this year. All entries had to be made from scratch, of course, and could either be made in a crockpot or baked in the oven, all with recipes included (which we have copies of at our table in the display room). Thank you to all who participated in the needlework contest. The directors of the Northeast region state granges are currently working on next year's needlework contest brochures, making any necessary rule changes and/or additions, and we welcome your input. Also, Family & Community chairpersons: please be sure to let anyone you know who does needlework that this contest is open to anyone, member or non-member.

Grangers across the state were very busy this year making items to send to the Big E for the store in the New England Grange Building. We received donations from Gilman Grange, Rochester Grange, Pembroke Grange, Walpole Grange, Claremont Grange and Watatic Grange. Gilman Grange sent 50 crocheted hats, 16 knitted scarves, 20 doilies, and 45 pocket crosses. Rochester Grange sent two each stuffed toy Santas, aprons, adult size and child size hats, afghans, coaster sets, dishcloths and scrubbies, plus dish towels, pot holders, scarves, tissue box covers and 16 pair of mittens. Pembroke Grange sent 37 pair of mittens, 3 tissue box covers and a number of dishcloths, as did Watatic Grange, who also sent a lovely crocheted child's sweater and skirt set and a crocheted child's dress. Thank you all for your contributions. They were greatly appreciated.

For the baking contest this year, we challenged you all to make a roll cake, any kind you wanted as long as the cake was made from scratch. The filling could be store bought or from scratch. Judging by the silent room when we announced this contest last year, it was evident that our choice wasn't very popular. Surprisingly though, there were a lot of comments from Grangers, most of whom said it wasn't as hard as they thought it would be! Kathy was asked to be a judge at Mt Pistareen Grange and she got to test SEVEN roll cakes, all of them unique. Interestingly enough, they had seven members present that night, so 100% participation. Kudos to Mt. Pistareen Grange for that!! We invited the first-place winner of each subordinate Grange to bring their entry to be judged here at state session. We had a total of nine entries here today! And the winner is.... DRUM ROLL PLEASE.... Denise Hupper, of Wicwas Lake Grange. Congratulations!!

Of course, you all want to know what you will be making next year, don't you? Stay tuned for contest rules and explanations, which are included in our printed program for 2024.

As always, we were blown away by New Hampshire Granges' contributions to their communities in the form of service. Of the Granges who sent us year-end reports – which totaled 12 subordinates and 2 Pomonas – there were a total of 17,125 hours of community service given in the name of the Grange!

We received four nice report booklets. We also received two extended paper reports that we want to mention. Carolyn Ross, chairman from Gilman Grange #1 sent a detailed report for her Grange's community service activities, which included donations of hats, mittens, scarves, gloves and stuffed toys to the Exeter school and police department, 385 dictionaries to six area schools, 143 Christmas cards for Meals on Wheels clients (complete with Market Basket gift cards inside), six Night Night Hugs bags and a number of other items to the Cross Roads House in Portsmouth, and three elementary school backpacks to a needy school. Thank you Carolyn, and the members of Gilman Grange for the wonderful work you have done in your community. Rockingham Grange chairman Judie Harvey submitted a detailed report of her Grange's project of creating a donation garden to provide fresh produce to the local food pantry, and a community garden to provide space for local residents to grow their own vegetables. The Grange had their property surveyed and had some adjacent properties improved to ensure that the Grange building's neighbors were happy with the changes they made. They removed some unhealthy trees, cleared the lot, installed a driveway, built a fence and constructed twenty-one boxes for the garden, not to mention the time spent planting and weeding. Judie included several photographs of the progress of the project, and of the fruits of their labor. What a great effort by Rockingham Grange! Worthy Master, Brothers and Sisters:

I would like to thank the Worthy Master for giving me this opportunity to serve. I also would like to thank and recognize the Deputies who visited Granges. Dan, Norman, Lester, Christopher, Ida, Sarah, Arthur, Beth, Andrew, Tricia, James, and Leroy.

Last year there were 36 Subordinate Granges in New Hampshire. Mt. Livermore, Riverhill, and Pine Grove are either not meeting or are contemplating closing. Some of these have not met since 2020 when the pandemic hit us. Today we have at least 35 Granges after the consolidation of Meriden with Blow-Me- Down. We need to meet with a few of these to determine what their intentions are.

We had 30 reports so far this year with 13 showing that they have real estate that is listed from 20,000 to 476,000. There are other Granges that have real estate, but to date I have not received reports from these.

There are Granges that are meeting via Zoom and we applaud these as they are continuing to carry the torch. Many have reported community activities within their communities and showing the community that we are still active.

As far as scoring goes, of all the reports I have received, Antrim #98 had the highest score totaling 1400. And Joe English #53 a score of 1125. There were 5 Granges that scored at 900 or better.

#### Pomona Granges

#### **GRANITE STATE GRANGER**

Worthy Master, State Officers, National Representatives, Distinguished Guests and Brothers and Sisters,

At State Session last year, after Hannah West had given her final report as Editor of the Granite State Granger, it finally hit us. After 26 years of service, Hannah really was retiring and it looked like no one was ready or in place to take over the Granite State Granger responsibilities. None of us knew what the future of the Granite State Granger looked like. We were not even sure if the Granite State Granger had a future.

I sat there for a moment and thought, now what? Pat and I looked at each other and didn't say anything—by January both of us would be fully retired, was this something we could do, would Hudson Grange #11 work with us to keep the Granite State Granger going, can we really do this? We needed to know more. So, when session closed on Saturday, we approached Hannah and asked if we could meet with her to learn more of what was involved in putting the Granite State Granger together.

Hannah called and we got together just before Thanksgiving. We spent the day learning what was involved and what had to be done. Pat and I talked all the way home, and for days after, about what we would have to do and how we could make it happen. After the holidays, at a meeting of Hudson Grange, we had a very long discussion about taking over the Granite State Granger with our members and when all was said and done, we decided to give it a shot.

Initially, we did not make any commitment and we didn't let too many know we were thinking about it just yet. There was still a lot to do and set up before we could start the next issue.

We learned really quickly that we would not be able to do the Granite State Granger the same way Hannah did. Logistically, it didn't make sense for us to travel to Concord for printing or to Epsom for mailing and then we found out the software Hannah used to create and set-up the Granite State Granger had been discontinued. We had thought perhaps the Nashua Telegraph could help us with the printing but they no longer do any printing in town. It was at this point we started wondering what the heck we were thinking!

We persevered and appointments were scheduled with three different printing companies in Southern NH.

Printer #1 Windham—We were brought to a small meeting room and discussed our project with several people. They suggested several options we had on how to set up the Granite State Granger and then they explained options they had on printing and mailing the Granite State Granger. We left there with a lot of information and names and phone numbers on how to reach them if we had any questions.

Printer #2 Nashua—We arrived and told the girl at the counter we were there to meet with the manager to discuss a printing project. The Manager came over to the counter and spoke with us for about 15 minutes. We gave her an idea of what the Granite State Granger was all about and what we needed. She explained what they could do and felt they could meet our needs. She gave us some pens and note pads and told us to call if we had any questions.

Printer #3 Salem—After waiting in the very quiet lobby and not seeing anyone around for about 15 minutes, we were about to leave when someone behind a partially closed door called out and asked if someone was out there. We followed the sound and found the owner in his office shutting down his computer. He asked how he could help us and we explained. He wanted us to get him files from the last Granite State Granger from the Concord Monitor, had questions about the mailing file and offered to send us a template. We were out of there within 10 minutes.

On March 30, 2023, Pat and I met with the Executive Committee to discuss the quotes received from the printers, what each printer could/would do and our plan to keep the Granite State Granger going. We said that we would be willing to make a 3-year commitment and after a few questions and a little more discussion, the Executive Committee gave us their blessing to proceed and begin a new chapter of the Granite State Granger. We left the meeting full of ideas, excitement and, to be honest, fear!

We spent a lot of time getting things in place (such as: setting up email lists, sending out emails, collecting articles from state officers, department directors, community granges and members). We developed several templates and tried different formats—the Granite State Granger you received in the mail in June and September is the format that has worked best. As we went along putting together the two issues, we made changes, had email issues and fixed glitches. Being new to all of this, it was expected. We have some thoughts and ideas that we are tossing around and

have received a number of suggestions regarding some changes and/or additions to the Granite State Granger.

#### HISTORIAN REPORT

Worthy Master, Brothers and Sisters:

This report will be a brief look at some of the Brothers and Sisters who have filled two of the offices of the New Hampshire State Grange in its first 150 years.

Masters: There have been 34 Brothers and two Sisters elected Master. Four served two years, twenty-five served three years, one served five years, five served six years, 23 served four years and one served 12 years.

One Master, William Stinson, resigned after three years - our only Master to resign. B. Franklin Hayes also served three years as that was the time that the State Grange changed its election of officers from odd to even years. Charles McDaniel served the second year of William Stinson's term and then two full terms subsequently.

Nahum Batchelder served 12 years as Master. He was Governor of New Hampshire and also served as Lecturer, Executive Committee, and six years as Master of the National Grange.

Two Masters, William Stinson and Nahum Batchelder moved from State Grange Secretary to Master. (Any thoughts on that, Sister Mary?)

One State Master, John Hammond, went directly from Master to Secretary. Master Richard Patten was later Secretary and our present Master, Tricia Taylor, was previously State Secretary.

Secretaries: There have been 15 Secretaries of the New Hampshire State Grange, serving from four to 30 years. Two Secretaries resigned: Wayne Ingalls and Richard Patten.

Two Secretaries died in office: Scott Eastman, after serving 29 years and John Hammond. Pearl Harbor was attacked on December 7, 1941. The NH State Grange session started on December 9th. John Hammond died on December 8th.

Several months ago, we offered to host the National Grange Legislative Fly-In timed for the First in the Nation Primary. We have hosted the Fly-In all six presidential primaries held since the start of the Century. National was not ready to make that decision at the time. The Democratic National Committee's decision was to remove New Hampshire as the first primary and give it to South Carolina, was the cited reason. Burton Eller wanted to see how that issue would shake out. We were notified earlier this month that there would not be a Legislative Fly-In in New Hampshire this year. He added that there would be a Fly-In in DC in the spring. The reason cited is that the status of the Primary is in flux and the opportunity to work on campaigns was limited this time. We will not host a Fly- In this year.

Not hosting the Fly-In is helpful for me, since I have been busy, but it is a disappointment for the NH State Grange and your Legislative Director. Hosting the Fly-In for the FITN is one of the best things we do for the National Grange. The resolutions that we work on do not have any of the whereas reasons, or statements, as they are called at National, so determining the actual intent of the resolution can be difficult at times. We do want to be careful about changing the intent of the resolution.

I thoroughly enjoyed the week and was happy to welcome Chris Heath when he arrived in Nevada. We were a small group this past year with only Leroy Watson there to join us. I expect to see many more faces at this year's Convention. After all, it's at Niagara Falls! It was a long week but the espresso bar in the lobby kept me going. I'm hoping there is one close to this year's convention.

Our yearly Deputy School was well attended by Officers, Directors, and Committee Members. It was at the NH State Grange Building again. The committees meet in pairs to work on coordinating their ideas and events for the coming year. I was pleased with the collaboration I heard and saw going on that day. We had a good lunch and then the Deputies gathered to hear their instructions for their visits. This year each Grange was asked to update their bylaws. Some of the Granges didn't know where their bylaws were, and some hadn't updated their bylaws for some time. And some were right on the money. We will be looking for the bylaws again this year as not all were able to get them updated over the summer.

I was able to attend the Junior/Youth Day at the State Grange Building for part of the day. As usual, people were enjoying the activities for both age groups. I want people to remember that you do not have to be a "youth" to enjoy these activities. Six of us attended the June Youth Rally and had a very good time doing the Photo Scavenger Hunt in Concord. My group only had to call a friend once. We did Google a couple of times as well. I urge everyone to support our Youth and Junior Committees and the events they plan! I must not forget the Lecturer's Day as

well as that of Family & Community Services. As always Matt and Lynn kept us busy and entertained. The painting workshop had all its participants engaged and the Jeopardy game that afternoon was also entertaining. Unfortunately, I was unable to attend the Family & Community Services Day but from what I heard those who did attend enjoyed themselves.

The President's Conference was held by Zoom this year as the National Grange has been doing their best to reduce their budget. It was jam packed with discussion about the National Grange Annual Sessions and answering questions such as why is it important, how do we make it pay for itself, where and when should we hold it, etc. Betsy Huber reviewed Conflict Resolution, the Judicial Process, the Trial, and the Appeal. Communication was also a big topic.

As the spring wore on, I was able to attend both conferrals of the Second Degree. Both events had new members who were seeing the degree for the first time. Both were well worth watching, as was the 5<sup>th</sup> Degree this past Saturday night at the NH State Grange Hall. My instructions were worked in and around other commitments, although I did have to ask for coverage the night my grandson graduated from high school. Several of the Pink Sash family made it north to Stratford Grange when they celebrated their refurbished hall by cutting the ribbon. It's well worth seeing. The building was even moved back from the road, making it safer. The town really supported this rebirth of the building.

Overall, we have not had a gain in membership this year, but several Granges have taken in new members which is all to the good. I did close Northern NH Pomona this year. They have not met for several years now and the distance to be traveled to attend a meeting in the north is a deterrent. The members have been transferred to Pemigewasset Valley Pomona; although their ride will be considerably longer now, there is no other Pomona north of Pemigewasset Valley Pomona. Meriden Grange consolidated with Blow-Me-Down back in the spring as they have also not met for some time and were down to ten members.

Traveling continued into the summer and fall. First, the Worthy Ceres and I were off to the Grange Revival on the Upper Peninsula of Michigan. We had good weather for traveling out there and for all but one day while we were there. What a beautiful area! And those lakes are incredible. It's like looking out at the ocean. We've already signed up for the next revival in 2025 in Utah. Road Trip! In September, I made it down to the Big E for the first time in about 30 years or so. It has grown immensely. I was able to work in the NH Grange Building for the day which I was happy to do. We do need more people to volunteer to go down and help. Arthur and Beth were manning the New Hampshire room so that visitors could go in to view it and ask questions. That only happens when there are enough Grangers there to work the floor downstairs. Volunteers don't usually work long shifts and they get to see the Expo. Make a day of it! It's worth visiting.

As many of you know we have partnered with American Income Life. They have offered every one of our Grange members that is in good standing a free \$2500 death or dismemberment policy. You do need to return the card with the name of your beneficiary if you would like the coverage. They will be calling to see if you are interested in any of their other products which are not free. You are not required to talk to them or zoom in with them if you don't wish to. Just tell them no, thank you.

We also have a new program called the Affordable Connectivity Program or ACP. This became available through the Job Act which supplied the money to the FCC who gave the National Grange a grant to spread the word. There is a table in the display room with lots of the supplies we received as a state. Each of the signs, placemats, business type cards, etc., have a barcode which can be scanned and will take people directly to the website. This program is trying to reach people who can't afford the internet, people who can't afford a laptop, etc. If people qualify, they may get a \$30 a month subsidy towards the internet. This program is the next step in getting the internet to everyone. The Grange was instrumental in getting rural electricity across the country, and then broadband. Let's keep the ball rolling and make this program available to as many people in this state as possible. Each Grange has a bag to pick up in the display room along with a sign and the wire posts to stand it up. Please get them out in your town where people can see them. If you are able, we would love for you to take extras to put out in the towns around you. This is a good thing and could put the Grange back on the map again! Be sure to sign the sheet to show who picked up the bag for each Grange.

I am looking forward to the Conferral of the Sixth-Degree tonight and we do have several candidates, which is truly exciting! My grandson was supposed to be one of the candidates, but his boss overlooked his request for time off and booked him all weekend. However, I do have other family members of state officers taking the degree tonight, along with members of other State Officer families. It's good to see the next generations joining us.

I am sure you are all aware that this is our 150<sup>th</sup> Anniversary of the New Hampshire State Grange. We had a successful send off with a successful raffle for the beautiful quilt made in honor of the Sesquicentennial. The Freedom Gavel was reintroduced at the Session and began its travels around the state. Unfortunately, it did not make it to all the Granges in New Hampshire, but it did get to most of them. There are many pictures of the Granges the gavel reached this past year. All the people who were present to see the gavel signed the book that traveled with the gavel. Some of us were able to sign the book several times as we were responsible for taking the gavel to multiple Granges. I'm pretty sure that our Worthy Overseer, Arthur Merrill, holds that record. Tomorrow evening will be the Celebration Banquet for the Sesquicentennial. One hundred fifty years this State Grange has been meeting!

Building Manager, Noel Miller, presented each state with a framed photo of the New England Grange Building lit up at night during fair time. (Photo shown to assembly at this time.) Discussion at this meeting resulted in the decision to purchase a large screen television to show a running loop of videos about the Grange to educate the visitors about our organization. In the summer it fell to me to provide this footage from NH and I did my best to find something appropriate. I am sure my limited technology abilities were a frustration to the Brother from Massachusetts who put the video show together. I hope a concerted effort can be made within the NH membership to provide something better for our portion of the video next year, so maybe someone with better skills and equipment than I will volunteer to take this project on? An even more important need for a volunteer is for someone willing to fill the third trustee spot available to New Hampshire. If you have any questions about the position, please consult with the Worthy Master, whose job it is to appoint someone to fill that spot.

A second meeting was planned for the Northeast Combined Conference to be held in April, but for various reasons, the region couldn't pull off the return of this event and it was canceled. It's been some years since it was last held and it's been problematic getting it started back up again. It should be NH's turn to host the conference in 2024, so we will see what happens!

The traditional work/cleaning meeting was held on site at the building in July, but without Tricia and I, as we were on our return trip from the Grange Revival in Michigan that day.

I made my annual trip down to the NEGB in August for what I've named "Jam Day". Assisting other volunteers to price and stock jars of jams, preserves, sauces, relishes, popcorn, etc., is the order of the day for that trip. I also deliver at that time any donated handcrafts I have collected on behalf of the Family and Community Committee.

This year we were able to hold a community service project at the Grange Building in cooperation with the National Grange. We provided outside space for the American Society of Consulting Pharmacists to give free flu, RSV, and COVID booster shots to anyone who wanted them. 3600 shots were given during the fair. I got my booster shot on day two of the four days that I volunteered at the Grange Building. Although there were five days of rain, the public did respond for getting vaccinations. In appreciation for providing this access to the ASCP, each affiliated State Grange received \$4,000.00 from the National Grange, and the New England Grange Building received \$5,000.00 for hosting and lots of promised equipment should be coming our way after the National Grange convention.

Our Worthy Master Tricia Taylor attended on Grange Day and volunteered at the cash register most of the day. Arthur and I were also present and hosted visitors in the NH room upstairs. It was satisfying to see and hear the delight expressed by the visitors who appreciate this one chance to see the second level of the building, normally closed off to the public. Volunteers attending on Grange Day may join other Grangers and ride on the trolley in the daily parade.

This year, Maine State Grange donated the quilt for the annual charity raffle, which raised \$4,461.00 for House in the Woods, a veteran's camp in Lee, Maine, and the adoption agency, Maine Children's Home. In lieu of a set price for each ticket, we ask only for a donation to get a chance to win. Grange volunteers sit at this table day in and day out reciting the spiel over and over to alert fairgoers of the opportunity to win a quilt and support a good cause at the same time. It will be NH's turn to provide this quilt and choose our charity of choice in 2025.

The weather wreaked havoc on attendance throughout the fair this year with several days of rain and a few more days of threatening rain; although total attendance for the fair did exceed one million visitors and several days had record-breaking attendance figures for that particular day of the fair. Consequently, the Building's revenues were down this year with the sale of crafts taking in \$16,350.73 while the general store earned \$15,922.81. Scrubbies, dish cloths, hanging towels, baby items, and Christmas ornaments continue to be big sellers. We almost sold out of scarves. Hats and mittens are always a good seller, as are pet items such as catnip fish, tennis balls on a rope and other such treats for the four-legged members of the family. Last year a request was made for more large size quilts and afghans, which sold well this year, with our customers showing a willingness to pay the big price for them. I, myself, made three afghans, actually finishing one on Grange Day. I happened to be working the cash register the next day, the last of four days that I volunteered at the building, and served the happy customer who purchased it. Prior to the fair, I was finishing a large afghan at my local needlework group and one of the members there asked if she could purchase it. So, I was able to deliver a check on my next visit to the building even though the afghan itself never made it out of New Hampshire!

We DO so much appreciate all your handmade donations and hope that we may again benefit from your generous gifts of time and craftsmanship in 2024! For Granges who claim to have no

needleworkers, perhaps someone in your Grange could do a little research, find an idea and bring supplies to a meeting so members can make a few simple items before or after the meeting with the intention of sending them along to the New England Grange Building. You can find lots of tutorials on YouTube for cute and simple Christmas ornaments, for example. (Some examples were displayed.) Gift tags can be made from old Christmas cards. Proceeds from these sales go to the maintenance and improvements to the building.

I hope each member can find a way to support this unique part of our Grange heritage in 2024. There are plenty of small ways (and one big one for the person who fills our vacant trustee spot) everyone can contribute to help preserve the legacy of the Grange at the Eastern States Exposition.

#### RESOLUTIONS COMMITTEE

Worthy Master, National Representative, and Brother and Sister Patrons all,

It is with pleasure that I present the 2023 Resolutions Committee report on behalf of the Committee. I want to thank the members – Sister Jozi Best and Brothers Bob Haefner and Jim Tetreault – for agreeing to participate on the committee.

We had only one resolution submitted to the committee prior to the deadline this year, which is the same number that we received last year. The committee met via Zoom on Saturday, October 14, to discuss this resolution, suggest editorial changes, and to vote on whether or not to recommend it for passage by the delegates.

2023 Grange Resolution: Strengthen Granges and their halls with community partnerships.

Whereas, Grange organizations support communities, and their Grange buildings contribute to the historic & pastoral aspect of NH's community centers, but are easily overlooked when it comes to funding for maintenance;

**And whereas** Grange membership continues to decrease, and the organization struggles to be seen as relevant in the eyes of community members;

**And whereas** one of the greatest challenges to families is the unprecedented shortage of childcare openings, and the need for convenient support of adults who would benefit from a similar setting;

And whereas it is reasonable and prudent that our organization, whose work has always focused on supporting families and the community, seek to address these issues. Mount Pistareen Grange has hosted a preschool since 1996, operating with a waiting list for a majority of that time. This relationship allows the Grange to offer the building at a lower rent value, while the preschool community helps support the building upkeep.

**Therefore, be it resolved** that NH Granges be encouraged to seek partnerships with community members to facilitate the use of our Grange Halls as preschool and daycare facilities, entering

into a symbiotic relationship which supports growth of existing care providers and those interested in entering the field, while increasing the profile of our organizations purpose, and the value of supporting us and our buildings.

The committee recommended an amendment to this resolution to require that adequate liability insurance be acquired to protect the subordinate, Pomona and NH State Grange from liability.

The wording of this amendment reads:

Therefore, be it resolved that NH Granges be encouraged to seek partnerships with community members to facilitate the use of our Grange Halls, with required levels of liability and property damage insurance by both parties, as preschool and daycare facilities, entering into a symbiotic relationship which supports growth of existing care providers and those interested in entering the field, while increasing the profile of our organizations purpose, and the value of supporting us and our buildings.

I wanted to quote from National Grange President Betsy Huber's article in last year's 'The Patron's Chain' newsletter entitled 'Use your voice in the resolution process' "While State Sessions are full of fun, fellowship, food, and contests, an important purpose is to discuss and set policy for our organization for the next year. So far, it's been a bit disappointing to see very few resolutions coming to National Grange from the State Sessions already held. I'm sure your members are not happy with everything going on in Washington and your State Capitols! Your membership in the Grange gives you a greater voice than you can possibly have as an individual voter. We should take advantage of that power and use it to change things we don't like. The resolution process is how we do that."

The number of resolutions submitted has dropped precipitously recently. If you have ideas but are unsure of how to develop and write them, the Resolutions Committee is here to help you through the process. Contact us and we will be there to help.

The following resolution was submitted following the deadline, and so the committee didn't have the opportunity to meet, discuss and vote on it. So, I will be presenting them to the delegates for their vote without recommendation by the committee.

Veterinary technicians licensing.

**Whereas,** there is an acute shortage of practicing large animal veterinarians in New Hampshire **Whereas,** some vet hospitals are only treating large animals when they can be transported to the hospitals

Whereas, there is an increasing number of vet hospitals with no large animal practitioners Whereas, it is often not possible for a large animal owner to transport the animal needing treatment due to time, or lack of transport vehicles

Whereas, there are excellent Veterinary technician programs with qualified graduates who could fill in some of the gap by taking on more of the routine procedures such as: Required vaccinations, Health and Safety assessments, health papers for sales, exhibits and shows. Using

Veterinary technicians will help to free up the veterinarians' time for more serious critical services.

**Resolved,** Veterinary technicians be able to perform standard procedures such as required vaccinations, Health and Safety assessments, health papers for sales, exhibits as part of their licensed duties.

**Be it further resolved** that the NH State Grange support legislation that Veterinary technicians be qualified and licensed to perform common veterinary tasks such as but not limited to: Required vaccinations, Health and Safety assessments, health papers for sales, exhibits and shows.

#### STATE GRANGE BUILDING MANAGER

As you may or may not recall, last year's report closed with the promise of the imminent installation of a new furnace and air conditioning system at the State Grange Building in Hooksett. Sure enough, on the Monday following State Grange, the system was installed by Ethical Home Pro and has been a wonderful thing. There were zero reported problems with either the heating or the cooling system throughout the year and everyone was very glad to have a dependable and efficient solution to the issues we dealt with previously. It has a new thermostat which can be controlled remotely from an app on my phone so that if a renter forgets to turn the heat down, I can easily fix that and I can also arrange for the heat to be turned up an hour or so before a group arrives without driving over to do so; that is if the internet decides to work that day but there is a fix in the works for that as well.

If your house is anything like the one I live in, there are always a number of things that could use an intervention of some sort. The State Grange Building is certainly no different. Besides the aforementioned internet, a couple of current interventions on the horizon are as follows: Landscaping: Jerry LeClerc expressed interest in helping make the building look more presentable as far as mowing and especially the gardens around the building. The Executive Committee decided to create a position of a groundskeeper which will begin in the spring of 2024 and include monetary compensation for hours worked up to a certain amount, similar to the arrangement of the Janitor position. Various factors contributed to the position not being started in 2023. One of these was the matter of a shed which the Executive Committee voted to have added to the grounds several years ago, but you know how those things go. One had to be picked out; we had to determine where we were allowed to put it according to the town; those options had to be discussed at length; it had to be ordered; it had to be constructed; etc. I am happy to report that the shed is now finally in place. It still needs to have a ramp made for it because it turned out to have to be constructed on a base (which was of course not included) but we've made a lot of progress. It is not perfect, and it may or may not be where the town of Hooksett would prefer it, but it is there and constructed to the best of my ability with minimal injury. It is currently storing a small lawnmower, a wheelbarrow, and a scythe. I think it doesn't look too bad myself.

The floor: The tile floor has been on the watch list for a number of years and is quickly approaching the end of its useful life. Mark Collins and I have a preliminary plan to take care of the issue of the cracked tiles at the door between the main hall and the dining area and the door

between the main hall and the anteroom. A full floor intervention needs more research but is creeping up on the list. If anyone has any connections or suggestions, I am open to hearing them. I am a pretty good laborer, but not so much a master craftsman when it comes to such things.

A few other small issues were dealt with such as replacing the flags, replacing the toilet seat in the women's room, and tightening the auto close mechanism on the front door. Orkin Pest Control continues to monitor the building quarterly to keep tabs on pest activity such as mice and carpenter ants. The Orkin man will be very glad to have a groundskeeper on duty soon because this past summer was crazy with plants nearly overgrowing the building with all the rain and such. It is not a good look for the Grange and equally problematic for pest control. Beth Merrill continues to clean the building regularly. The church continues to use the building twice a week; the Grange Crafty Ladies have been moving into the building for a few days at a time each month; several Grange events were held such as Deputy School, the Mac and Cheese Cook-off, the Lecturer's Paint Day event, Youth Rally, and a Junior Grange fun day; and various other renters use the building occasionally. We also were part of the Light Up the Village event this past Christmas season with the building lit up with Christmas lights and decorations thanks to Jerry Leclerc and the Merrills and a craft fair inside as part of the event. This year I believe we will again be participating and our building will be similarly or even more extravagantly decorated and used as an area people can stop in from the cold to eat food they may have purchased at the outside food trucks.

Incidentally, if you haven't stopped in during one of those Crafty weekends, I would highly recommend it. You can bring your own stuff to do, or someone is usually willing to help you use nifty supplies and devices you might not have at your house to make a fancy card such as could be entered in the State Lecturer's contests or that type of thing. You can pretty much show up at any time of the day (or night) on Thursday, Friday or Saturday and a friendly face or two or six or more will be there to greet you. Well, maybe you should contact Beth Merrill ahead if you plan to show up at 3am, but someone really would be there. You can spend half an hour, seven hours, or three days. It might be my favorite use of the State Grange Building currently as it makes great use of the space and provides a fine opportunity for fellowship and creativity.

This year started with electing a new secretary and should have caused me many headaches trying to break her in. Instead, I found Sister Mary to be a breath of fresh air. Being the daughter of a past State Master and having served as subordinate secretary has helped her a lot. She has taken the bull by the horns. This is not to say she didn't have questions. Fortunately, I was able to answer most of them. We should all be pleased Mary has so much family support, Kevin, Anne, Hannah and yes even Xander. When you need a job done ask a busy person to do it. I am pleased to say our financial status is very stable. We seem to have weathered the storm caused by the COVID epidemic. For the first time since COVID, Tricia, Mark and I met with John Habig at Morgan Stanley to go over our accounts. Mr. Habig assured us our accounts should remain stable. There will continue to be ups and downs, but with everything said our accounts should be strong. I continue to use only 5% of operating and defunct Grange accounts based on a three-year average on June 30, each year.

This year has, as usual, brought up many new challenges. The new bonding charges are bringing in many questions. Each Grange needs to look at their financial standing as of June 30. This is only what you have in your checking, CD's and savings accounts. If it is \$5,000.00 or under you pay the usual \$50.00. If you have \$10,000.00 or more the amount goes up from there. If you can't figure out what your Grange should pay, please call me. I will be compiling a list of what each Grange pays so we can send out bills next year. Keep in mind each year you will have to reevaluate your financial standing and what you should pay.

Last fall we had a new furnace installed in the State Grange building. This was covered by donations and money from the defunct Grange account. Anne Boisvert has done a wonderful job keeping the executive committee informed as to what is needed at our building. She also singlehandedly assembled the new shed for storing the lawnmower and gardening tools. I also want to give kudos to Antrim Grange for keeping the hall clean. The hall rentals have also increased by over \$2,200.00 from last year. Thank you all for your hard work.

Would the members of Wingold Grange please come forward? Each year as soon as October 1, arrives it becomes time to file the e-postcards for each Grange. Back in 2017, when I took over filing, I had five Granges who had lost their non-profit status. In the next three years I was able to get four of them reinstated. Since that time (six years) I have struggled with the IRS to get Wingold Grange reinstated. In 2020, IRS sent a letter stating they had been reinstated but every fall I could not get an accepted 990 e-postcard. I am finally very, very pleased today to present Wingold Grange with an accepted 990 e-postcard from the IRS.

Another project I keep an eye on is the incorporation status of each Grange. I am pleased to report all but one Grange are now up to date. I have sent them a reminder and hope it will be done soon. In 2025, every Grange will have to refile again.

Yesterday I dropped off paperwork for our CPA to file the 2022 taxes. It takes about 24 hours to pull all the paperwork together and I am quite relieved when it is done.

After the IRS paperwork is done, I complete the pages the secretary needs for the Journal of Proceedings. At the request of our new secretary, I am ready to email them to her as soon as the 2023-2024 budget is passed.

2024 is going to be a very interesting year for Kim and I. We will be fulfilling an item on our bucket list. The one top item in our retirement is to go cruising. On January 4, we will be heading out on a world cruise for 111 days, returning April 25. We will be connected to the internet and able to receive emails. I will also have global calling on my phone. I may not be able to respond to questions quickly due to the time changes, but I will respond to texts, calls and emails when I am able. To those Granges that have escrow accounts I will endeavor to get your spring checks out on time. If there is a problem, you should still have them by the end of May. Anne Boisvert,

by the approval of the executive committee, will be assisting me by handling all deposits from the secretary. Thanks, Anne.

At times I rant and rave when my accounts don't balance, usually due to a mistake I made. It's amazing Kim is still with me. She gets to hear the brunt of my frustrations and usually walks out of the room. Thank you, Kim, for still putting up with me.

- Motion made by Christopher Heath and seconded by Tricia Taylor and Anne Boisvert to authorize, whomever, to set up auto renewal with our website hosting company. Motion declared passed on January 13.
- Motion made by Tricia Taylor and seconded by Christopher Heath to approve the minutes from State Session. Motion declared passed on January 16.
- Motion made by Beth Merrill and seconded by Anne Boisvert to approve the December 10 Executive Committee minutes. Minutes declared approved on March 21.
- There was also discussion of the South Hooksett Grange charter for sale on eBay.

The meeting was called to order at 7:19 pm by Chairman Arthur Merrill.

Granite State Granger update by Pat Bailey and Pat Lawlor on behalf of Hudson Grange: They solicited quotes from three companies – Allegra, Minuteman Press, and Wharf – but had the best impression of Wharf. Wharf can do the printing and mailing, using their bulk permit. Pricing is dependent on paper pricing. The plan would be an 11 x 17 folded layout in black and white print, estimated twelve pages. An electronic option could be made available with a preference request included in the first issue. There will be a dedicated email address for submissions.

Motion was made by Mark Collins and seconded by Beth Merrill that Hudson Grange be authorized to move forward with their GSG proposal with Wharf Industries with a budget of up to \$3000. It was a vote in the affirmative.

Granite Grange real estate update by Tony Lacasse:

He has been working with architects in Nashua for some conceptual designs (pro bono) as to what the property could be. Unique properties are difficult to value. Under zoning ordinances in Milford, the building is now zoned single family residential. It could also be a daycare, church, home business or farmstand, but only through a variance, so he's recommending a single-family home. The plans drawn up are for a two-story with an accessory dwelling unit. Once the hall is cleaned and the marketing team does their work there will be a broker open house with a Grange Hall set-up as an homage to the history. The deep cleaning estimate he obtained is \$950, or \$1200 with trash removal. He would recommend getting two more cleaning estimates to compare. His recommendation would be to market it at \$150,000 with the hope of selling it within six months. For next steps he recommends cleaning, a yard sale on the property, listing no later than May 1 and closing by fall.

Motion made by Chris Heath and seconded by Mark Collins that Tony Lacasse be allowed to market Granite Grange Hall for \$150,000. It was a vote in the affirmative.

Motion made by Chris Heath and seconded by Mark Collins to pay Annette Wilcott cleaning up to \$1200 to clean and remove trash from Granite Grange Hall. It was a vote in the affirmative. Motion made by Mark Collins and seconded by Chris Heath that Beth Merrill and Anne Boisvert be authorized to clean out Granite Grange as they see fit. It was a vote in the affirmative.

Master's Report: The Notice of Interest documents have been filed with the County Registries of Deeds, and an affidavit for Granite Grange have been sent. Blow-Me-Down has accepted Meriden Grange's request to consolidate. Tricia Taylor and Chris Heath will help coordinate the sale of Meriden Grange.

The New England Grange Building Trustees met at the Big E in January. Adam Terrill has agreed to be the third NH trustee. Beth Merrill will be chairing the committee to investigate appointing one youth as an ex-officio member. Tricia Taylor has been nominated as an ex-officio trustee of the Eastern States Expo. The Northeast Leaders Conference has been canceled. Mt. Livermore is now paid up with dues and bonding, so no action was required there. Wingold's status with the IRS has been updated. Dan Bascom will set up a meeting with Morgan Stanley this spring. The by-laws committee has been appointed: Wilber Heath, chair; Arthur Merrill, Rick Bailey, Matt Clark, Tara Sad, Sarah Leclerc, Leroy Watson, and Josie Best. Jerry Leclerc was interested in the Pomona Committee for National but no volunteers are needed at this time.

Representatives from American Income Life reached out about a relationship with NH State Grange, offering a free \$2500 accidental death and dismemberment policy to each NH Grange member. Motion made by Christopher Heath and seconded by Beth Merrill that we agree to the American Income Life relationship and send them mailing labels for our members. It was a vote in the affirmative.

Tricia Taylor attended the National Grange President's Conference via Zoom. There was a session on about the National Grange conference, as well as discussions of member benefits, resources, and the website. New Hampshire Day at National Session is Thursday, November 16. New Hampshire is in charge of the hospitality that day so we need a new state hospitality chair.

A motion was made by Christopher Heath and seconded by Bob Haefner to accept the Master's report. It was a vote in the affirmative.

Treasurer's Report: The 2022 taxes were completed and signed in February. The property exemption paperwork was sent in for Hooksett and Milford. The oil pre-buy is holding steady. Dan Bascom sent e-postcards to eight Granges. Bonding is in except for Pine Grove and Mascoma Valley and Northern NH Pomonas. Hillsborough County Pomona, Hudson, Blow-Me-Down, Lakeshore and Londonderry have lost their non-profit status with the state of New Hampshire.

A motion was made by Christopher Heath and seconded by Tricia Taylor to accept the Treasurer's Report. It was a vote in the affirmative.

Secretary's Report: Mascoma Valley (one quarter), Northern NH (13 quarters), Blow-Me-Down (one quarter) and Pine Grove (four quarters) are behind on their quarterly reporting. I have been fielding questions from Stratford Grange about liability insurance, Crown Point Grange about closing, protocol for old rosters and whether or not Granges are charging dues of their non-exempt golden sheaf members. The bank accounts have almost been updated.

A motion was made by Mark Collins and seconded by Tricia Taylor to accept the Secretary's report. It was a vote in the affirmative.

Old Business: The lease with Liberty Baptist Church has been signed. Arthur Merrill is still working on Norman's Grange history list for the Farm and Forest Expo as well as a list of all State Officers. He also still needs to get in touch with the Town Hall in Goshen about the possibility of a Grange museum.

Christopher Heath has reached out to Spectrum and Xfinity soliciting quotes for updated internet service. He did get some information on the Executive Committee policy handbook. The sesquicentennial logo has been converted to a usable form. The current committee is Gloria Davis and Christopher Heath with Lynn Clark as Secretary and Andrew Savage as Treasurer. Anne Boisvert has not been able to make progress with the Town of Hooksett for a building permit for the shed. She did speak with Jerry Leclerc about the State Grange building groundskeeper position and suggested we create an agreement for those services.

New Business: It was decided that New Hampshire will host a regional leader's conference in 2024. Stratford Grange is hosting a spring bazaar on April 1. Centennial Grange has requested \$5000 from their escrow for replacement of windows on their hall. Motion made by Beth Merrill and seconded by Mark Collins that we approve that request as stated. It was a vote in the affirmative with one abstention.

Motion made by Christopher Heath and seconded by Bob Haefner that Mark Collins work with Dan Bascom about the auto renewal of the web hosting and Zoom account being moved to the State Grange credit card.

The suggestion was made that email votes be confirmed with statement of who made and seconded the motion. Arthur Merrill has also asked that we approve minutes via email so they can be more promptly sent out in the quarterly packets.

Bob Haefner has been asked to host the Primary Fly-In.

It was suggested that there be a work day for the State Grange building driveway on April 22 at 9am.

Task List Review: All of the flags at the State Grange building have been replaced. Kitchen lights have not been installed. Mary West is still searching for the background check records.

Next meeting will be Thursday, August 31 at 7:00 pm at the State Grange building.

Motion to adjourn made by Mark Collins and seconded by Christopher Heath. It was a vote in the affirmative. Meeting closed at 10:15 pm.

Offer #1: \$285,000; no inspection, no due diligence, \$10,000 down – looking to convert to residential, with prior experience in similar renovations

Offer #2: \$225,000; no inspection, 10 day due diligence, \$10,000 down – intends to follow architect's suggestion

Offer #3: \$235,000; no inspection, 10 day due diligence, \$10,000 down – intends single family conversion

Option to purchase from Milford Community Center Coalition: \$10,000 non-refundable deposit to hold property for one year with suggestion that monies be used to repair roof; decline buyer commission. If additional time needed, an additional \$5,000 would hold the property for another 90 days.

Tony reviewed the agreement, but strongly suggested we retain a real estate lawyer for a more comprehensive review and to represent us.

Motion made by Bob Haefner to accept offer #1. Seconded by Tricia Taylor.

Discussion: Granite Grange closed in 2017 and has not been insured since that time. The State Grange pays for water and electric at the building. Offer #1 gets the building off our hands quickly.

*In favor of option agreement:* The group has a family connection to the hall, wishes to preserve it as a community hall and is working to obtain grant money and nonprofit status. The group was

not aware that the hall was available until it went on the market. It would be a great PR story to save the hall.

Concerns voiced about option agreement: Milford zoning board may not approve community hall use. Everything might fall through and we'd be back to square one 455 days later.

Tony shared his interpretation of pros and cons for all four possibilities. Roll call vote: Four in favor, two opposed. Motion passed.

Arthur Merrill and Tricia Taylor will sign for the sale, effective May 10, deposit goes in escrow, close on May 19. Tony will notify other buyers and the Coalition via phone. Meeting ended at 8:40pm.

**Treasurer's Report**: We reviewed the income and expense reports for the third quarter. A motion was made by Christopher Heath and seconded by Tricia Taylor to accept the reports as presented. It was a vote in the affirmative.

The treasurer of West Thornton Grange received dividends from the Electric Co-op, which should be sent to the State Grange in future. A motion was made by Christopher Heath and seconded by Beth Merrill that that money be earmarked for the GSG so former West Thornton members can benefit from it. It was a vote in the affirmative.

Hillsborough County, Blow-Me-Down and Londonderry Granges still have not filed their Secretary of State incorporation fees.

Tricia Taylor, Mark Collins, and Dan Bascom met with Morgan Stanley. Investments are in good shape.

The basic bonding premium is \$50 for subordinates and Pomonas. Granges with more than \$5000 in their treasury will need to increase their bonding for 2024. We will notify Granges of the potential increase in the September quarterly mailing.

Secretary's Report: Mascoma Valley (two quarters), Northern NH (14 quarters) Blow-Me-Down (two quarters), Pine Grove (five quarters), Arlington (one quarter), Blazing Star (one quarter), Dorchester (one quarter), Mt Livermore (one quarter) and Wingold (one quarter) are behind on their quarterly reporting. I have been working hard on updating the database after the first American Income Life benefit card mailing resulted in more than 100 returns. A partial second mailing has gone out, with more to follow once AIL provides additional materials. Approximately 140 members have signed up for benefits so far.

A motion was made by Christopher Heath and seconded by Tricia Taylor to accept the Secretary's report. It was a vote in the affirmative.

Master's Report: Tricia has been busy with Deputy work and attending Grange Day, the second degree at Antrim Grange, June Youth Rally, Centennial's second degree, the ribbon cutting at Stratford Grange, the Grange Revival in the Upper Peninsula of Michigan, and Family Weekend and the presentation of the Century Farm Award. Northeast Youth Rally was cancelled due to rain damage. She, Wilber Heath, and Arthur Merrill visited Meriden Grange regarding preparations for sale of the hall. A Meriden Grange yard sale was held Memorial Day weekend, but the hall is still far from sale-ready. The deed for Granite Grange Hall was signed and payment promptly sent to the State Treasurer. She will serve as Chair of the Citizenship and Taxation Committee at National Session this year. Rockingham Grange has filed a new survey with the Rockingham County Registry. The National Lecturer is looking for names of veterans who have not yet received a quilt of valor. National Grange has partnered with the Oregon Institute for a Better Way who received a grant through the FCC under "Roots of Connectivity." The Affordable Connectivity Program aims to bridge the digital divide by offering subsidized internet plans, free or discounted devices, and digital literacy training to underserved communities. According to the FCC over 20 million households are already taking advantage of this. Materials are available for each subordinate Grange to share with their communities.

A motion was made by Christopher Heath and seconded by Beth Merrill to accept the Master's report. It was a vote in the affirmative.

**New Business:** Northern NH Pomona will be closed as of September 30, 2023, with members being transferred to Pemi Valley Pomona. The State Secretary will send notifications accordingly.

The State Grange legal counsel, Donald Whittum, Esq. retired effective today. A motion was made by Tricia Taylor and seconded by Christopher Heath that we retain the counsel of Carl Potvin, as recommended by Mr. Whittum. It was a vote in the affirmative.

A motion was made by Christopher Heath and seconded by Tricia Taylor that we approve the request for escrow funds from Hudson Grange as soon as we receive the escrow request form. It was a vote in the affirmative.

Realtor Tony Lacasse has inquired if we would be willing to open up the State Grange building for Hooksett's Light up the Village for attendees to eat and use the facilities. A motion was made by Mary West and seconded by Tricia Taylor that we open up the State Grange building for Light up the Village. It was a vote in the affirmative.

We discussed ideas for the tile floor repair in the State Grange building.

A motion was made by Mary West and seconded by Anne Boisvert that we allow Arlington Grange to keep \$3000 from the sale of their hall rather than the usual \$1000. The motion failed. A motion was made by Chris Heath and seconded by Anne Boisvert that we contact Arlington Grange and ask them to send us the check they received for the sale of their Grange Hall, minus the \$1000, and that they submit a form requesting escrow withdrawal. It was a vote in the affirmative.

A motion was made by Chris Heath and seconded by Tricia Taylor that we ask Leroy Watson to be our second delegate to National Session. It was a vote in the affirmative.

**Budget Review:** A motion was made by Tricia Taylor and seconded by Beth Merrill that we reduce the membership budget to \$1000. It was a vote in the affirmative. A motion was made by Anne Boisvert and seconded by Mary West that we increase deputy mileage reimbursement to \$0.50 per mile. It was a vote in the affirmative, effective for the spring 2024 visits. A motion was made by Beth Merrill and seconded by Christopher Heath that we increase the Grange Services budget to \$300.

**Task List Review:** There is now a storage shed at the State Grange building. It still needs a ramp.

Chris Heath suggested we switch to a T-Mobile 5G tower for internet, which operates off the cell phone tower, as we've had internet issues at the State Grange building. A motion was made by Christopher Heath and seconded by Tricia Taylor to discuss the idea at the next meeting when more members are present. It was a vote in the affirmative.

A motion was made by Christopher Heath and seconded by Tricia Taylor that we create a groundskeeper position for the State Grange building offering \$15/hour, not to exceed 39 hours/year. It was a vote in the affirmative. Anne Boisvert will follow up with Jerry Leclerc who had inquired about the position.

We will try to find a substitute janitor for the State Grange building rental that coincides with National session as neither Anne nor Beth will be available.

Chris Heath will have the policy manual at our next meeting.

Background check documentation has still not been located.

Next meeting will be Saturday, October 21, at 10:00 am at the State Grange building.

Motion to adjourn made by Chris Heath and seconded by Tricia Taylor. It was a vote in the affirmative. Meeting closed at 11:32 pm.

It was a vote in the affirmative. The duties will be redefined as part of the State Session procedural manual.

Master's Report: Tricia Taylor attended and worked at the Big E, where she received more materials for the Affordable Connectivity Program. Each Grange will receive materials at State Session. We do not know if there's a way to track how effective our marketing of the program has been. She assisted the traveling gavel in its travels. She has a letter of resignation from State Flora Kerriann Heath. The Flora accoutrements will be dropped off today. Mark Collins was appointed to work on finalizing the State Session procedural manual. State Session invitations were sent to the State Governor, Mayor of Concord, Greater Chamber of Commerce President and the Commissioner of Agriculture. The Chamber of Commerce President isn't able to attend but the Commissioner will attend on Friday. A motion was made by Christopher Heath and seconded by Beth Merrill to accept the Master's report. It was a vote in the affirmative.

I have commitment of attendance of 19 Granges for State Session. A motion was made by Christopher Heath and seconded by Bob Haefner to approve the Standing Rules of the 150<sup>th</sup> Annual Session with one amendment. It was a vote in the affirmative. A

motion was made by Christopher Heath and seconded by Mark Collins to accept the Secretary's report. It was a vote in the affirmative.

Unfinished Business: E-postcards are ready to be included in Grange packets at State Session. Blow-Me-Down Grange still has not been approved for incorporation. The check for the sale of Arlington Grange Hall has been received. The bonding notification will go out this week. Mary will follow up with Granges who did not submit deputy reports to give us a better idea of financial standings. Chris reported that T-Mobile would charge a business rate if we got a 5G tower for the State Grange building unless an individual opens the account. A motion was made by Christopher Heath and seconded by Bob Haefner that we authorize Mary West to open a T-mobile account to get a 5G internet hotspot for the State Grange building. It was a vote in the affirmative. Captain Tewksbury of the Hooksett Fire Department has informed us that we need to install an Addressable Potter fire alarm system by 2026. Anne Boisvert will endeavor to find the Code that requires this change so we can justify the expense. Mark Collins will ask his Town Fire Marshall as well. If we will need to incur this additional cost, and if the requirement is related to us renting the building, we should reconsider renting and/or rental fees. Mary West's feedback on Northern NH Pomona is that the Pomona hadn't been collecting dues so at least Stratford and Mohawk Granges didn't have any current Pomona members.

**Budget Review:** Dan Bascom reviewed the budget. A motion was made by Christopher Heath and seconded by Beth Merrill that we reduce the webmaster fee to \$300.00. A motion was made by Mark Collins and seconded by Bob Haefner that we amend that amount to \$500. The vote on the amendment was in the affirmative.
