JOURNAL OF PROCEEDINGS OF THE NEW HAMPSHIRE STATE GRANGE OF THE ORDER OF THE PATRONS OF HUSBANDRY

The Margate Resort, Laconia, NH

After a festive Thursday evening including the annual meeting of the New Hampshire Grange Foundation, song quiz bingo hosted by State Lecturer Matt Clark and an ice cream social, the first day of the 151st Annual session of the New Hampshire State Grange was opened in the Sixth Degree at 8:00 am, on Friday, October 25, with Worthy Master Tricia Taylor and the officers of the New Hampshire State Grange.

Steward Pro Tem Christopher Heath announced Walter Hartley, Assistant Steward of the National Grange and Master of the Rhode Island State Grange as our honored guest. The Assistant Stewards escorted Brother Hartley to the Master's station. Brother Hartley thanked Sister Tricia for the invite. He is looking forward to the weekend and will be joined by his wife and daughter late this evening. The Assistants then escorted Brother Hartley back to his seat.

Steward Pro Tem Christopher Heath announced Andrew Hosmer, Mayor of the City of Laconia, as an honored guest. The Assistant Stewards escorted Mayor Hosmer to the Master's Station. Laconia is a true community of caring people, and Mr. Hosmer feels privileged to welcome us to this city of which they are very proud. He admires the values and mission of the Grange and encouraged us to reach out if there's anything the city can do for us. The Assistants escorted Mayor Hosmer back to his seat.

Roll call of officers found Steward Norman Brandt absent. Christopher Heath filled in as Steward. Roll call of Granges found a quorum present.

Introduction of Master's Address Committee: Leroy Watson, Pat Bailey and Steve Durand Introduction of Resolutions Committee: Tara Sad, Jim Tetreault, Jozi Best, and B. Richard Bailey

The resolutions submitted at Session were read in full:

Resolution #12 – Submitted by Claremont Grange #9; Subject: Protecting owners and animals in animal cruelty allegation cases

Resolution #13 – Submitted by Hudson Grange #11; Subject: Youth age at the National level

The Standing Rules for the 151st Annual Session were read. A motion was made by Christopher Heath and seconded by Gloria Davis to approve the rules. It was a vote in the affirmative.

Norman Brandt shared the report of the Agriculture Committee via video recording. *The report was accepted and ordered printed in the Journal*.

Diane Collins, Chair of the Trustees of Trust Funds, was escorted to the Master's station to give her annual report. Flyers and a few applications for trust funds are available in the back of the hall. *The report was accepted and ordered printed in the Journal*.

Beth Merrill presented the report of the NH Trustees of the New England Grange Building. Tokens of thanks were given out to Beth's supporters. *The report was accepted and ordered printed in the Journal.*

Gerald J. Leclerc, Session Coordinator, presented his report. A survey will be sent to each Grange regarding the annual session. Responses will be reviewed by a study committee. *The report was accepted and ordered printed in the Journal*. Members applauded Brother Leclerc's work on the Leader's Conference last January.

After a short recess, Christopher Heath presented his last report as Webmaster. It included a video demonstration on how to check nhgrange.org email addresses. Currently these emails exist only for State Officers and Directors. The suggestion was made that each Grange be given a nhgrange.org email address. *The report was accepted and ordered printed in the Journal*.

Bob Haefner gave a recap of last night's Grange Foundation meeting as delegate attendance was limited. Motion made by Chris Heath of Centennial Grange and seconded by Ormond Hall of Eastern NH Pomona Grange to reaffirm Jim Tetreault and Jozi Best as Foundation Directors. The goal is to have 50% of members be Grange members. Motion made by Brian Twiss of Watatic Grange and seconded by Chris Heath of Centennial Grange to approve Leroy Watson as Foundation Director, replacing Gail McWilliam Jellie. Motion made by Anne Boisvert of Suncook Valley Pomona Grange and seconded by Brian Twiss of Watatic Grange to approve the proposed slate of Foundation officers: President Jim Tetreault, Vice President John Porter, Secretary Tara Sad, and Treasurer Andrew Savage. All votes were in the affirmative.

Brother Haefner then gave his report as Legislative Director. *The report was accepted and ordered printed in the Journal.*

Worthy Overseer Arthur Merrill drew attention to the officer pins worn by most State Officers this morning, which were found at the State Grange building. Lester Gibbs will be bringing the pins to National Session for their perusal. Gloria Davis advised that those who have not yet paid for their banquet tickets need to do so today. Jozi Best advised that despite Legislative Director Bob Haefner's health this past year, he made himself available for legislative questions. Lady Assistant Steward Sarah Leclerc announced that if attendees would like to play a State Officer for Saturday morning's opening, they should see her to sign up prior to the sixth degree. Kimber Bascom shared that there are lovely items available for silent auction in the display room. Members should bid high and bid often! A broken necklace has been found and is now available to be claimed at the State Master's station.

Sarah Leclerc escorted herself to the State Master's station to give her report as State Lady Assistant Steward. *The report was accepted and ordered printed in the Journal*.

Crystal Seward presented her report as State Pomona. *The report was accepted and ordered printed in the Journal.*

Tricia Taylor drew attention to Beth Merrill's efforts in the Light Up the Village event in Hooksett, showcasing the State Grange Building to local residents. She asked that volunteers who would be willing to share the workload for that event see either Tricia or Beth. This year we will step up our game with professional Christmas lighting for the building, paid for by a grant. A brief recess was then declared.

At 11 am, the gates were closed for the annual Memorial Service, under the direction of State Chaplain Kathy Yardley. *The program was ordered printed in the Journal*. The Memorial flower arrangement will be brought to Camilie Twiss's final resting place.

The afternoon session was called to order at 1:32 pm by Blaze MacMullen, who introduced State Master Tricia Taylor to give the Master's address. *The report was accepted and ordered printed in the Journal.*

Christopher Heath was escorted to the Master's Station to share the video report of Joann Brandt, Junior Director. *The report was accepted and ordered printed in the Journal*.

Matthew Clark approached the Master's station to give the State Lecturer's annual report. Make note that State Grange Bowling will take place on *Saturday*, March 22, at Lakeside Lanes, in Manchester. The Assistants distributed Granger of the Year award nomination forms. Brother Clark encouraged everyone to think of a Granger to nominate. *The report was accepted and ordered printed in the Journal*.

Mary West requested that any sixth-degree candidates submit their paperwork as soon as possible. Sarah Leclerc announced that the offices of Gatekeeper, Pomona and the Executive Committee are left to fill for tomorrow's opening.

Throughout the day, gold stars were awarded to Rockingham Grange, Sarah Leclerc, Blaze MacMullen, Anne Boisvert, and Sherrill Bokousky.

With no further business to conduct, Worthy Master Tricia Taylor raised the Grange to the sixth degree and declared the Grange at ease at 3:12 pm, until 7:30 pm.

After fifth degree obligation, the Friday evening session opened at 7:30pm with a procession by the officers of the New Hampshire State Grange. Roll call of officers found Steward Norman Brandt absent. Christopher Heath filled in as Steward. State Secretary Mary West announced that Roberta Twiss of Watatic Grange #36 was seeking admission to the Court of Flora.

Roll call of officers found officer Steward Norman Brandt absent. Christopher Heath filled in for Steward. Roll call of Granges found a quorum present. The minutes of yesterday's session were read, approved with corrections, and ordered printed in the Journal.

Temporary Steward Lynn Clark announced Walter Hartley, Assistant Steward of the National Grange, his wife Danielle Hartley, Ceres of the Rhode Island State Grange, and Nettie Hartley, Lecturer of the Rhode Island State Grange and Past National Junior Ambassador as our honored guests.

The Standing Rules of the 151st Session were read for reference only.

After a brief recess to swap temporary officers for elected officers, Daniel Bascom presented the State Treasurer's report. *The report was accepted and ordered printed in the Journal*.

Mary West presented the State Secretary's report. *The report was accepted and ordered printed in the Journal.*

Arthur Merrill approached the Master's station and issued a challenge for members to create an acronym for "The report was accepted and ordered printed in the Journal." He then presented the report of the State Grange Executive Committee. *The report was accepted and ordered printed in the Journal.*

Kathy Yardley and Joyce Martin, Family and Community Committee Directors, approached the Master's station to give their annual report. Family and Community Day will be Saturday, May 17, 2025. They presented awards for needlework, woodworking, and community service notebooks and reports. Next year's baking contest will be baked mini cheesecakes. There are Christmas craft kits available in the hospitality room. Finished crafts will be donated to the Big E. *The report was accepted and ordered printed in the Journal*.

Leroy Watson facilitated the review of the proposed Bylaw revisions through Article Four. A motion was made by Arthur Merrill of Antrim Grange and seconded by Gloria Davis of Antrim Grange to approve the revisions presented thus far. It was a vote in the affirmative.

Sarah Leclerc facilitated the review of the proposed Bylaw revisions from Article Five through Article Seven. After much discussion, a motion was made by Arthur Merrill of Antrim Grange and seconded by Brian Twiss of Watatic Grange to approve changes to Articles Five through Seven as presented. It was a vote in the affirmative.

Gerald Leclerc facilitated the review of the proposed Bylaw revisions from Article Eight through Article Ten. After much discussion, a motion was made by Brian Twiss of Watatic Grange and seconded by Arthur Merrill to accept the changes in Article Eight through Ten as read. It was a vote in the affirmative.

After a recess for lunch, the session reconvened at 1:32 pm. Arthur Merrill, Chairman of the State Executive Committee, approached the Master's station to present the 2024-2025 Income

and Expense Budgets. The Worthy Treasurer proposed a new position of Assistant Secretary/Treasurer. A motion was made by Christopher Heath of Centennial Grange and seconded by Brian Twiss of Watatic Grange to add the new position of Assistant Secretary/Treasurer with a stipend of \$500, changing the website expense to \$400 and increasing the State Grange building donations by \$50, so the budget would remain balanced. It was a vote in the affirmative. A motion was made by Christopher Heath of Centennial Grange and seconded by Kathy Yardley of Walpole Grange to approve the Expense Budget as amended. It was a vote in the affirmative. A motion was made by Christopher Heath of Centennial Grange and seconded by Seth Clark of Arlington Grange to accept the Expense Budget as amended. It was a vote in the affirmative. The income and expense reports were accepted and ordered printed in the journal.

State Ceres Gloria Davis announced that the evening banquet will take place upstairs. State Pomona Crystal Seward shared greetings from Ida Hutchins who misses us and wishes us well.

Matthew Clark facilitated the review of the proposed Bylaw revisions from Article Eleven through Article Twelve. A motion was made by Emilie Leclerc of Hudson Grange and seconded by Arthur Merrill of Antrim Grange to accept this portion of the Bylaws. It was a vote in the affirmative.

Rick Bailey facilitated the review of the proposed Bylaw revisions for Article Fourteen. A motion was made by Brian Twiss of Watatic Grange and seconded by Andrew Savage of Wingold Grange to approve Article Fourteen as presented. It was a vote in the affirmative.

Secretary Mary West asked that delegates see her to collect the program packets for their respective Granges.

After a brief recess, Arthur Merrill facilitated the review of the proposed Bylaw revisions for Articles Fifteen through Article Seventeen. A motion was made by Kathy Yardley of Walpole Grange and seconded by Trevor Clark of Arlington Grange that we accept the changes for Articles Fifteen, Sixteen and Seventeen. It was a vote in the affirmative. Both Arthur Merrill and Tricia Taylor thanked the Bylaws Committee for all their hard work. Tricia then dismissed the committee. The new Bylaws were declared in effect at 3:29 pm.

Tara Sad, Chair of the Resolutions Committee was escorted to the Master's station to present her report.

Resolution #1 - Submitted by Claremont Grange #9

Subject: Establishing credentials for individuals with communication disabilities and educating First Responders to identify them in emergency situations

The committee recommendation was to pass the resolution with an amendment to remove the second resolved. A motion was made by Kathy Yardley of Walpole Grange and seconded by Alice Tuck of Rochester Grange that we accept the resolution as amended by the Resolutions Committee. Don Ross of East Rockingham Pomona moved the question, seconded by Gary Ward of Blow-Me-Down Grange. It was a vote in the affirmative. The original motion was also voted in the affirmative.

Resolution #2 – Submitted by the State Executive Committee (edited from a submission of Sunrise Pomona #9, MA)

Subject: Location of National Grange session

A motion was made by Emilie Leclerc of Hudson Grange and seconded by Andrew Savage of Wingold Grange that we allow this resolution submitted by the State Grange Executive Committee to be on the floor for discussion. It was a vote in the affirmative. A motion was made by Arthur Merrill of Antrim Grange and seconded by Brian Twiss of Watatic Grange that we amend the first resolved to read "the NH State Grange strongly urges the National Grange to only hold National Sessions that support maximum member participation among all segments of our diverse fraternity and minimize financial burdens on delegates and members, preferably within the United States." Jozi Best of Claremont Grange moved the question, seconded by Donald Ross of East Rockingham Pomona. It was a vote in the affirmative. Motion made by Arthur Merrill of Antrim Grange and seconded by Emilie Leclerc of Hudson Grange to accept the resolution as amended. It was a vote in the affirmative.

Resolution #3 – Submitted by Walpole Grange #125

Subject: *Opposition to mandatory adoption of electric powered farm machinery* The resolution was defeated.

Resolution #4 – Submitted by Walpole Grange #125

Subject: National Grange partnership with seed companies and horticultural groups to increase the availability of heirloom seed varieties to farmers and gardeners

The resolution was defeated.

Resolution #5 – Submitted by Walpole Grange #125

Subject: Installing air conditioning in all NH public schools, K-12

A motion was made by Brian Twiss of Watatic Grange and seconded by Emilie Leclerc of Hudson Grange to amend the resolution to twenty years rather than ten. The motion was defeated. Donald Ross of East Rockingham Pomona moved the question, seconded by Kevin Belval of Chichester Grange. It was a vote in the affirmative. The resolution was defeated.

After a five-minute breather, Sister Tara Sad continued.

Resolution #6 – Submitted by Walpole Grange #125

Subject: *Equal prices for all* The resolution was defeated.

Resolution #7 – Submitted by Walpole Grange #125

Subject: Teaching cursive writing in schools

Motion made by Christopher Heath of Centennial Grange and seconded by Ormond Hall of Eastern NH Pomona to amend the resolved, changing "mandating" to "encouraging." After learning that cursive writing is already mandated in NH law, both the motion and the second were withdrawn. The resolution was defeated.

Resolution #8 – Submitted by Walpole Grange #125

AGRICULTURE REPORT

Worthy State Master, Brothers, Sisters and delegates alike,

Thank you again for another year as State Agriculture Committee chair. I would like to start where I ended last year. Shortly after I reported, we heard from Shawn Jasper the State Commissioner of Agriculture. I personally have taken offense to his take on why agriculture in New Hampshire is failing... Though I'm sure that money does have some effect on the downfall of agriculture in New Hampshire, I do not feel that it is as much of the problem that he led on that it was. I have worked with and for farmers for decades now. It has always been a low-income job. The rewards are more internal than monetary, if it is done right. Payment is paid to the soul of the person doing the job. Many of the struggles come with rewards as much as suffering. Some farmers have to work a second job just to pay their taxes. The ones that stop farming tend to stop, not because of not becoming a millionaire, but because the support that used to come from the townspeople, the department of Agriculture, and the Extension service has started disappearing.

In the past, most people in town understood how food is produced and knew that if they didn't grow it themselves someone would provide it to them for a reasonable price. If someone planted an apple grove, they would use what they needed and sell the surplus to neighbors that would preserve it or enjoy it. Nowadays people can get it from a chain store and do not need to put in the work to keep their own foods. If they go to a farm, it is for entertainment over necessity, they don't see the farmer as someone that they want to work with, but someone that facilitated a fun activity for a while. Having not had to try to produce their own food, they cannot respect that the farmer had to spend hours cutting disease and despair out of their trees, or crops or livestock. They do not respect that with every failed yield the farmer had to struggle to correct a problem

just to make a pretty crop for a consumer to buy. Or for every pretty one that the farmer has on the stand it might represent five that got damaged that the farmer may eat or compost knowing that nobody will appreciate the work it took to grow all six, just the one.

In the past if you had a problem, call the county Extension service agent, they would come out and help. If they were at ends, they would try to have someone from the State Department of Agriculture come and find out the problem. But this year my committee had tasked me to have a program on basic animal care. Having been to programs put on by the extension service like this I reached out to the UNH extension service to see who would be good and available for such a program, only to hear, we are trying to hire someone that can do these programs but currently you would have to rely on Dr. Crawford or Dr. Harvey to put on such a program. Having been to programs put on by Dr. Crawford and hearing him tell me, well those mistakes were put in by one of my employees, the fact that he either did not proof the program he was putting on, or did not notice the errors in his presentation was impressive on me in not a good way. Dr. Harvey may be a great option, but I know from experience that there are some holes in his knowledge and for this particular topic I understand he does have some conflicting information from what is current practice. Hopefully I will find someone.

This past year in May, Gloria Davis, Joann Brandt and I attended the NH Old House and Barn Expo held at Saint Anselm College. Being the first year that NH State Grange had held a booth we did not know what to expect. I saw many people I knew, probably more I didn't know. If we were to continue doing a booth at this event every other year, I would suggest it be membership and Grange Historian with the book of Old NH Grange Halls. Many that stopped in spoke about old Grange Halls they had been in and the history of Granges in different towns more than making history in present day Granges. Do not get me wrong. If we are not attending events we might as well be considered dead, as un-spotted from the world made us an afterthought in our communities.

Following Old House and Barn Expo was Farm, Forest and Garden Expo at the Deerfield Fairgrounds. Once again, we put up a booth and seemed to draw much attention. Our theme this year was NH Grange in our community. Gloria was able to get someone to build many town buildings out of cardboard, paint and decorate them. We set up a small village on two tables and decorated it with NH state items. I was happy to hear the NH Fish and Game was not aware that the NH State saltwater game fish was the striped bass, and the freshwater was the brook trout until they visited the NH State Grange booth, so proclaimed during the awards ceremony. Making a great plug for Grange during that event, even though we did not win a free booth for next year. But the biggest win was meeting four people that seemed very interested in the Grange, one of which I understand has even gone as far as begging Rochester Grange to allow her to come and possibly join. We also had a family in New Durham that was interested in joining and I had given them information for Chichester Grange and Rochester Grange. And one that was interested in a Grange in Concord, to whom I gave Deb Patten's name and number. It gives me great hope we may start growing again. I understand that email communication nowadays can be ambiguous and not as formal as past communications, but as Lois had said I wasn't sure if I was should open or respond to an email stating "I'm interested in your group", This email almost getting discarded as junk may turn out to be silver or gold for Rochester, just

like their latest new member. Once again, I still feel this is a worthwhile event for the Grange to show themselves.

I have been on occasion having emails sent out to people by the Grange grapevine. Thank you, West household. I have not heard much from people about those, but I was happy to hear that one person was very interested when I mentioned beech leaf disease, making it worthwhile in my book. I have also heard from people that seem to enjoy the articles I have submitted to the Granite State Granger. Thank you to the Hudson Grange for giving me the opportunity to continue writing for you all.

Earlier I had mentioned the lack of support that the New Hampshire farmers have run into. One of many case points available that I would like to share with you this year is The Live and Let Live Farm in Chichester. The NH State Jr Grange did a tour a few years ago of this shelter, to everyone's enjoyment. The Live and Let Live Farm has been in operation since 1996, in Chichester. They are a no kill shelter and all animals surrendered to them are to be re-homed as pets, not for food. Due to this they have operated under a Pet Vendors license under control of the NH Department of Agriculture. Over the past few years, they have been having problems with one of the NH Department of Agriculture inspectors. They have put as a personal beef with them, no pun intended, they requested a different inspector from Shawn Jasper, hoping for a fairer and more understanding person. Their request fell upon deaf ears and no relief was granted. After telling the State that they did not have room for more animals, that the State had confiscated, everything came to a head. In July of this year the State of NH pulled their Pet Vendors License and started procedures to shut down the rescue. Trying to get them to fill out a Livestock Vendors License and report all Livestock Vendors they use to put rescues into the food chain, mainly horses.

For those people that do not know, USA has not had a USDA horse processing plant since 2007, so how the State thinks they are sending horses into the food chain I would love to know where that comes from. As Live and Let Live Farm does not put animals directly into the food chain they feel they do not fall under the rules of the State Livestock License, and as of August of this year they have been able to re-open under judge order while it works through the NH Court System. I, for one, have always heard good things about the Live and Let Live Farm in Chichester, and have been hearing more and more stories such as the one, I have just recited, from other farms and how the State Department of Agriculture has become under the new leadership from the Commissioner more into an anti-farming organization, over a help.

A second example not related to the event happening at the Live and Let Live farm is very visual at fairs. Once again, this year the NH State Vet Dr. Crawford had released a letter to all fairs that it is the strong recommendation of his office that poultry not to be shown at NH fairs again because of Avian Influenza. For those that do not know, Avian Influenza has been a leading cause of egg prices and poultry meat prices going up for several years now. Since 2021, at least 280 million birds have died due to Avian Influenza, 59 million from domestic populations via backyard birds or large factory poultry farms. Since 2021, he has made this recommendation under the ruse of a public health concern. If you have not heard, in March of 2024, Avian Influenza has jumped to dairy cows and now has gone thru 14 States, California, Colorado, Idaho, Iowa, Kansas, Michigan, Minnesota, New Mexico, North Carolina, Ohio, Oklahoma,

South Dakota, Texas, and Wyoming and 300 herds, causing the USDA to do a no transport order for lactating dairy cows between state lines, in hopes to stop it from spreading. Even though the virus has infected a total of 20 people, 11 by dairy cattle, 1 unknown manner of infection and 8 from poultry, did the State vet recommend not having dairy cow shows at the fairs? No, instead he, under the direction of the Commissioner of Agriculture, instead wrote an article in the New Hampshire Weekly Market Bulletin "New Hampshire's Agricultural Newsletter" asking people to contact their representatives to get the USDA to overturn their no transport order as it was causing undue harm to New Hampshire farms and fairs. New Hampshire has had three cases of infected poultry on farms since 2022, one in Belknap County, one in Merrimack County, and one in Rockingham County. Massachusetts has had five since 2022, Barnstable, Berkshire, Bristol, Essex, and Middlesex Counties, and Maine has had 20 cases since 2022, 7 out of 16 counties. To enter a bird into a show at the fair it must be from a tested and clean flock for both Avian Influenza and Salmonella, the bird superintendent normally visually checks all birds before they are removed from the car to be sure there is no sign of disease. Only then can they be loaded into cages at the fair. A copy of your farm's inspection is also held in the office of the superintendent and is provided to the state if an inspector walks through. To enter a bovine at the fair, if the animal is from the state the fair is in, exhibited at they are to be rabies vaccinated. The superintendent will normally inspect the animal for external signs of disease, but that's it.

When it comes to inspection of poultry in the state of New Hampshire, blood is taken from each bird by a wing puncture, a technique that is talked about a little at all veterinary schools, but those that go into Avian Veterinary only pass over it as a very risky technique that can increase the loss of the bird due to infection. The current technique is using an oral puncture. Many Avian Vets I have spoken with were appalled that any State would be using the outdated technique. The test has a 93 percent effective rating, meaning for every 100 birds tested you can expect 7 false hits. When I had 200 birds tested, three years ago, I had two birds that came back as positive, causing the State Vet's office to give me the alternative of putting a quarantine on the farm for two months while they re-test every bird, or surrender my birds for necropsy done by University of New Hampshire. When they put the birds alive in a non-ventilated cardboard box, and brought them to the lab at UNH where they would euthanize and test for both Avian Influenza and Salmonella, each time the birds came back as not infected with either disease, but as I was told by the State Vet's office once we get a possible positive it takes three negatives to cancel out the possible positive. Some states understanding this flaw in the testing do a percentage of the flock and do an antigen test seeing if the bird's immune system reacts to the virus. This test has an 87 percent effective rating but at the same time it is done right at the farm in front of the farmer and any birds that test positive they take an oral swab to send out for testing right there and then. All parties know what their chances are and can see and feel a positive instantly. If it wasn't that the State and Federal government pays for a set number of tests to be run for each state, I doubt that the New Hampshire Department of Agriculture would do this program as much as they do.

To finish me off for chicken talk, I believe the New Hampshire Poultry Club has closed down after many of their members moved out of New Hampshire to continue breeding and showing poultry elsewhere. A Minnesota poultry processing plant has abruptly shut down leaving many poultry farms in surrounding states to have poultry that they cannot sell as they are contracted poultry to that processing plant. With no money coming in many of these farmers are at a loss of

hundreds of thousands of dollars. The Federal government is finally starting to vaccinate poultry for Avian Influenza. It is a double shot with the second one given days after the first.

On the rest of the agriculture front this year, without a late frost we had a good peach and apple season. Grapes also did well. With the borderline drought conditions and humidity, fungus went wild and ground crops suffered. Overall, it was a good crop year for New Hampshire.

At this time, I am going to say thank you to everyone that has tolerated me for another year. Time will tell how many more years you will have to tolerate me. Thank you again Worthy Master (president) Trisha Taylor and members of my committee. Sorry I couldn't do more this year.

Charles McDaniel served as Chaplain from 1891-1893.

Nahum J. Bachelder was more of an overachiever. He served on the Executive Committee from 1895-1899; Lecturer from 1899-1903; and Priest Archon/Master from 1905-1911.

Esther Patee served as Ceres from 1911-1915.

Fred Rogers (not the television host) served as Gatekeeper from 1919-1921.

N. Grace Sawyer served as Ceres from 1923-1927.

James Farmer served as Lecturer from 1927-1947.

Helen Eastman served as Ceres from 1951-1953.

Asa Morgan served as Gatekeeper from 1961-1963.

John Saturley served as Priest Archon from 1969-1971.

B. Franklin Hayes served as Secretary from 1979-1983.

Daniel Bascom served as Gatekeeper from 1999-2003 and Priest Archon from 2007-2013.

John West served as Chaplain from 2005 until his death in 2008.

Beth Merrill served as Lady Assistant Steward from 2007-2013.

James Tetreault served as Lecturer from 2013-2015.

Last but not least, Leroy Watson joined the National Executive Committee in 2014 and served until 2024.

I'm pleased to announce that Brother B. Richard Bailey will be taking over the role of Historian. Lester Gibbs will be our new museum curator at the State Grange building.

MASTER'S ADDRESS

It is my honor to stand here to give my second Master's Address. Although the year has seemed relatively quiet, there has been quite a bit going on.

As I am sure most of you have heard, Deputy State Master Ida Hutchins has been unable to continue as a Deputy, Secretary of Pemigewassett Valley Pomona, and Secretary of Baker's River Grange. While Baker's River had enough members to remain open there were not enough willing to put in the time and effort to keep it going. The members who were helping Ida did not come from Rumney with the exception of one. The others came from Haverhill, Thornton, and Bristol. Reluctantly the vote was taken to close Baker's River Grange.

Pemigewassett Valley Pomona was destined for a similar fate but Wicwas Lake has risen to the challenge and meetings are being held to elect new officers, determine when meetings will be held and update their By-Laws. Pemi's new home will be at Wicwas Lake Grange Hall.

At one point we were excited to learn that a group of people in Sandwich were very interested in starting a Grange there. The Worthy Treasurer was asked to be the liaison as he is a Mason and many of the prospective Grangers were as well. Unfortunately, it was discovered that they weren't really interested in becoming a Grange as it was more about not having to pay property taxes.

Many of our Granges are struggling to get a quorum together. Some are concerned with having enough members as people unfortunately pass away. I understand that another state is considering a resolution to reduce the number of members needed for a Grange to function to eight. I'm not sure what this would mean for number necessary for a quorum. If this resolution makes it to National, I am sure there will be quite a discussion. These Granges will not be in their Pomona and for the Deputy State Masters the Granges will not be part of their Instruction and Inspection lists. If you see something exciting, please, let us know! If you are disappointed, please, let us know! We need to celebrate good Grange work and help those who are struggling. Help me let them know they are not alone and not forgotten. I will give a list of these Granges to the Membership Committee in hopes they will reach out and do their best to help the process of gaining new members.

How many of you are aware of what all Granges will need to do in the year 2025 and every five years from now on? The Executive Committee isn't allowed to answer this one. It's the reincorporation year! It happens every five years. The Worthy Treasurer has worked hard get the Granges who had let it slide back on the list. This year the NH State Grange was invited to have a table at the NH Preservation Alliance's Old House and Barn Expo. The Membership and Agriculture Committees did an excellent job representing us. I know this because several people from Danbury and surrounding areas told me so. I would like to see our participation in this event continue. Our presence at this event and at the Farm and Forest do get our organization into the public eye.

I have enjoyed traveling to Granges this year, as well as to National and Regional events, such as the Leader's Conference put on by National, the Northeast Youth Rally, and, of course our own Family Weekend, Youth Rallies and the Lecturer's Day in April. I encourage all of you to attend these various events. Youth and Junior Days are not just for the Youth and Juniors. Everyone is invited. Children learn by example and what better example than to show them that adults can enjoy these days as well.

Thank you for giving me the chance to serve these two years as your State Master. It is an honor and a privilege to serve in this way.

MASTER'S ANNUAL ADDRESS COMMITTEE

Worthy National Representative, Worthy Master, Worthy State Officers, Worthy Delegates, Brothers and Sisters:

Your 2024 State Master's Annual Address Committee is honored to present this report regarding the Annual Address that was delivered by our Worthy State Master, Tricia Taylor.

We commend the recognition by Sister Taylor of the life and service to our Order in New Hampshire by Sister Ida Hutchins.

We were pleased to note in Sister Taylor's remarks that the criteria she uses to make the difficult decision to close Granges who struggle to get a quorum together for their meetings depends on the overall community involvement of those Granges and not just on the number of active members in that Grange. We support this decision. Granges that demonstrate a commitment to community involvement are more likely to attract and retain new members, despite temporary low membership or attendance numbers and deserve the chance to revitalize themselves, with the support of our State Grange.

Anticipating that there will be resolutions at the upcoming session of the National Grange in Bettendorf, Iowa, to reduce the minimum number of grange members needed to maintain an active Grange charter from 13 to 8, we urge our State Master to carefully weigh the arguments for and against this proposal before deciding how to cast her vote.

We are pleased that Sister Taylor will assign two local Grange visitation assignments in 2025 to all sitting State Officers so that these Granges will have a chance to interact with a "pink sash", other than the Deputy State Master assigned to their Grange. The responsibilities of an elected State Officer must extend beyond their duties and assignments during the State Grange session, to help build enthusiasm and fellowship among our grassroots membership in communities across New Hampshire.

We are glad that Sister Taylor included in her address information about the important administrative responsibility of every local Grange to file their reincorporation documents with the NH Secretary of State in 2025. To help all of us reach her goal of achieving 100% compliance with the requirements for reincorporation for all New Hampshire Granges, we recommend three courses of action by the State Grange in 2025.

First, all Deputies and State Officers be asked to make inquiry and remind every local Grange they visit in 2025 about the requirement to file for reincorporation of their Grange with the NH Secretary of State. Second, every issue of the Granite State Granger contain a stand-alone, filler reminder banner, somewhere in the paper asking, "HAS YOUR GRANGE FILED ITS REINCORPORATION PAPERS WITH THE NH SECRETARY OF STATE?" Third, place a link in a prominent place on the front page of the New Hampshire State Grange website that goes directly to any officially published information, documents and instructions from the Office of the Secretary of State regarding the procedure to file reincorporation papers with that office.

The challenge by Sister Taylor for all Granges to update their by-laws and submit a copy of those by-laws to the NH State Grange is a goal that every local Grange in our state can proudly attain! To remind our local Granges of this goal, beyond the encouragement of our Deputies and State Grange Officers during their visits in 2025, we recommend that every issue of the Granite State Granger contain a stand-alone, filler reminder banner, somewhere in the paper asking, "HAS YOUR GRANGE UPDATED ITS BY-LAWS AND SUBMITTED A COPY TO THE STATE GRANGE SECRETARY?"

We were inspired by Sister Taylor's challenge to us to assure that every new Grange member in New Hampshire has an opportunity to witness the Degrees of our Order to give them a better understanding of the culture, mission, and history of our organization.

We were also excited by the attention Sister Taylor paid in her address to important participatory events for Granges and Grange members, such as the Old House and Barn Expo, The National Grange Leaders Conference, the Northeast Youth Rally, and our Family Weekend, to name just a few. Sister Taylor wisely reminded us that "participation draws attention" from both members and non-members regarding what our Order has to offer to everyone, if we are just willing to get out there and have fun!

In conclusion, your 2024 State Master's Annual Address Committee wants to thank Sister Tricia Taylor for sharing her time, talents, wisdom and enthusiasm for the New Hampshire State Grange with all of us as our Worthy State Master these past two years.

NH TRUSTEES OF THE NEW ENGLAND GRANGE BUILDING

Worthy Master, National Representatives, State Officers, Delegates, and Patrons:

I am pleased to bring you this report of the NH Trustees of the New England Grange Building.

There were three meetings held this year. For the first time since the pandemic, the Northeast Region was able to gather together for its traditional Leaders' Conference, thus the annual January meeting of the New England Grange Building trustees was held in Concord, with all three of the NH trustees in attendance. Discussion at this meeting included a report of the success and challenges of providing a vaccination clinic at the 2023 fair, and a proposal to consider creating one or more youth trustee positions intending to spark interest in the Building by the younger generation, essential to the survival of this unique Grange resource. I was both surprised and dismayed at the reluctance and actual push-back of some of the trustees to move forward with the proposal, but was eventually successful in getting a favorable vote to continue with the project. I was assigned the task of reporting back at the next meeting with a procedure for selection of up to three Youth Trustees.

A second meeting was held in the Massachusetts Building on the grounds at the Big E in April, again with all three NH trustees in attendance. And again, there was more push-back when discussing the Youth Trustee proposal, this time from the Youth Director of one of the states. The project was put on hold until January, once it was realized this would require a by-law change, which can only be done at the annual meeting. Also at this meeting was discussion about the success of the vaccination program that was done during the 2023 fair in concurrence with the National Grange and it was decided to pursue the prospect of doing it again for the 2024 fair.

The traditional work/cleaning meeting was held on site at the building in June, for which Tricia and I travelled once again to West Springfield.

Arthur and I accompanied Family and Community Directors, Kathy Yardley and Joyce Martin, on Labor Day when they made the trip to the Building to deliver the needlework contest entries and the accumulation of handcrafted goods donated by many NH Grange crafters. During the visit, Kathy and Joyce assisted the Craft Sales Manager, Dawn Percoski, and her crew of volunteers in pricing the mountain of donated items. Arthur and I also helped with this when we finished doing a deep clean of the NH room.

Brother Bob Trombi accompanied Arthur and I to the fair to volunteer at the Grange Building for two days and then Arthur and I returned on Grange Day for the specific purpose of hosting visitors in the NH room upstairs. It's the only time that the upstairs is open to the public – IF there are volunteers on hand for that to happen. It was delightful to meet and chat with visitors who expressed appreciation for this chance to see the second level of the building normally closed off to the public. Volunteers attending on Grange Day may join other Grangers and ride on the trolley in the daily parade, but we opted out of that ride this year.

The Vermont State Grange donated the quilt for the annual charity raffle, which raised \$6,003.00 for The Josh Palotta Fund, Inc., in support of veterans and service members. They offer a variety

of services including meals, dogs for support, holistic health, a suicide prevention lifeline, etc. I submitted an article for the Granite State Granger letting readers know that, for the first time this year, anyone can support the fundraiser without requirement of attending the fair. Several NH members responded by sending me their donation, which I was happy to take to the fair and submit on their behalf, giving them a chance to win while supporting a good cause. It will be NH's turn to provide this quilt next year, and thanks to the efforts and leadership of Jane Heath, said quilt is currently being finished off for us by a professional long arm quilter. All that is needed before the 2025 fair is to decide what NH charity will benefit from this fundraiser.

The fair this year was blessed with favorable weather most all of its seventeen days, resulting in a record-breaking total attendance of 1,633,935 visitors and several days had record-breaking attendance figures for that particular day of the fair. We had fewer craft items this year, but with the record attendance and more equitable pricing on the donated goods we sell, the Building's revenues were up this year with crafts taking in \$17,047.74 while the general store earned \$14,301.40. Scrubbies, dish cloths, hanging towels, baby items, and Christmas ornaments continue to be big sellers. Hats, scarves, and mittens are also good sellers, as are pet items such as catnip fish, tennis balls on a rope and other such treats. Large size quilts and afghans are selling well, with customers showing a willingness to pay the big price for them. I, myself, finished two afghans, both given to me in an incomplete condition for different circumstances, one of which had been started by Sister Happy Pelton, mother of Kim Bascom, years ago. It is a good feeling to get both projects out of the house, knowing that they are now whole and complete and being welcomed to their forever home.

We DO so much appreciate all your handmade donations and hope that you are able to continue your generous gifts of time and craftsmanship. Grange meetings are a good venue to get your members together to work on fun, simple projects. If your group is not handy, nor interested in making things, but can contribute financially you might consider purchasing gift cards to Michaels, Joanns, or Hobby Lobby, so that materials can be purchased by those who are crafty but unable to donate more than their time. I will be happy to accept the cards and pass them on to Dawn, who will know the folks who can best use them to keep on creating for our cause. Proceeds from these sales go to maintenance and improvements to the building.

I hope each member can find a way to support this unique part of our Grange heritage in the coming year. There are plenty of small ways everyone can contribute to help in a big way to preserve the legacy of the Grange at the Eastern States Exposition. And perhaps 2025 will be the year that YOU venture your way south to experience for yourself all that the Big "E and specifically, the New England Grange Building, has to offer. See you there!

RESOLUTIONS COMMITTEE

Worthy Master, National Representative, and Brother and Sister Patrons all,

It is with pleasure that I present the 2024 Resolutions Committee report on behalf of the Committee. I want to thank the members – Sister Jozi Best and Brothers Bob Haefner and Jim Tetreault – for agreeing to participate on the committee, and for doing such good and thoughtful work on the resolutions.

This was a great year for resolutions submissions! Thank you all very much for your hard work writing them. Special kudos go out to the members of Walpole Grange #125 who submitted **eight** resolutions! They spent time at a monthly meeting coming up with ideas, and, with Leroy Watson's excellent guidance, they crafted well-written and well-thought-out resolutions. Congratulations!

The committee met via Zoom on Tuesday, October 15, to discuss these resolutions, suggest amendments, and to vote on whether or not to recommend them for passage by the delegates. These are the committee's recommendations:

Resolution #1: Establishing credentials for individuals with communication disabilities and educating First Responders to identify them in emergency situations.

Approved by Antrim Grange #98

RESOLVED that the New Hampshire State Grange legislative committee adds this to state grange policy where it supports legislation in the NH State Legislature that allows individuals with communication disabilities (ie: Deaf, hard of hearing, autistic, auditory processing disorder, language disorder, and voice disorder) to be identified with their medical condition noted on their license and they can have an optional decal sticker to be placed on the top right of the license plates of their vehicle(s); Be it further

RESOLVED that the New Hampshire State Grange legislative committee supports legislation in the NH State Legislature to fund training and education about communication disabilities for all first responders: Be it further

Resolved, that, if this resolution is passed, the NH State Grange will send this resolution to the National Grange to consider this idea nationally and community it to the other State Granges.

The committee felt that this was a very good idea, and it would be a great benefit both to those drivers with communication disabilities and to the state's first responders. However, we thought that second Resolved section that supports legislation to fund training and education should be removed.

After discussion, the vote of **Recommend with amendment** was passed unanimously.

Resolution #2: Location of National Grange Session

Submitted by the State Executive Committee (edited from a submission of Sunrise Pomona #9, MA)

Therefore, Be It Resolved, that Article 4.9.5 of the National Grange Digest be amended by removing the period at the end of the first sentence and adding 'in a location within the borders of the United States that is affordable and accessible to members' ensuring that future National Grange Sessions are held in a manner that supports maximum members participation and minimize financial burdens on delegates and members.

The committee had discussion about whether it was necessary to limit the location of the National Grange Sessions to within the borders of the United States, but ultimately decided that the National Grange should do everything possible to make the National Grange Sessions accessible and affordable for all members.

The committee voted unanimously to **Recommend** this resolution as submitted.

The following 8 resolutions were all submitted by the Walpole Grange #125

Resolution #3: Opposition to Mandatory Adoption of Electric Powered Farm Machinery

Resolved, that the New Hampshire State Grange and the National Grange oppose any state or national laws or regulations that attempt to impose mandatory adoption of electricity powered farm machinery to replace farm machinery that operates on fossil fuels, and be it further

Resolved, that the New Hampshire and National Granges continue to support further research into efficiency, alternative fuels and appropriate technologies that will reduce the carbon footprint from the operation of farm machinery.

After discussion, the committee voted unanimously to **Not Recommend** this resolution. We think this needs more work. We agreed that we did not want to see mandatory adoption of electric farm equipment, but we think this is premature at this time.

Resolution #4: National Grange Partnership with Seed Companies and Horticultural Groups to Increase the Availability of Heirloom Seed Varieties to Farmers and Gardeners

Resolved, that the National Grange undertake a signature national program and work to raise money to develop partnerships with seed companies, State Land Grant Experiment Stations, and horticultural organizations to preserve and reintroduce heirloom varieties of row crops, tree/bush crops and other horticultural products to the USA market for farmers, horticulturalists and gardeners, and, be it further,

Resolved, that the National Grange support the establishment of the USDA Office of Preservation Gardens to seek out and reintroduce heirloom varieties of diverse row crops and tree/bush crops to American farmers, horticulturalists and gardeners.

In a quick Google search of 'heirloom seeds', the names of no fewer than 21 well-established heirloom seed companies came up. National Organic Farmers Association (NOFA) has for years been dealing with organic and heirloom fruits and vegetables. The effort to save heirloom seed varieties already exists and is successful

For this reason, the committee voted unanimously to **Not Recommend** this resolution.

Resolution #5: Installing Air Conditioning in All New Hampshire Public Schools, K-12 Resolved, that the New Hampshire State Grange encourage the New Hampshire state government and New Hampshire's local school districts to all begin working to develop a plan to install appropriate air conditioning equipment in all New Hampshire public schools over the next ten years.

Despite knowing that the average cost to install air conditioning in a school building was \$1.9 million in 2009, and realizing the fact that most school districts cannot afford this capital expenditure, we felt that the issue of air conditioning warrants study, which is what this Resolution seeks. However, we voted to change the study period from 10 to 20 years. The committee voted unanimously to **Recommend with amendment** this resolution.

Resolution #6: Equal Prices for All

Resolved that the New Hampshire State Grange and the National Grange support legislation at the state and federal level outlawing the practice of offering lower prices to retail customers who sign up for technology that tracks their individual shopping habits, especially in grocery stores, so that all customers receive the lowest prices possible, in order to control food and consumer staples price inflation.

During the committee's discussion, we recognized that this resolution was in support of outlawing retail practices. The Grange shouldn't be asking government to do that. The Grange consistently supports technology, and this resolution is anti-technology. Because of this, the committee unanimously voted to **Not Recommend** this resolution.

Resolution #7: Teaching Cursive Writing in Schools

Resolved, that the New Hampshire State Grange and the National Grange support mandating that all school curriculums in New Hampshire and the United States be required to include instruction of cursive script writing.

The committee discussed this resolution at length. The main problem we had was that it was making the teaching of cursive mandatory, despite the costs and the wishes of the school district. Rather than this rigid wording, we suggest that the Resolved section be amended to read 'Resolved, that the New Hampshire State Grange and the National Grange encourage school curriculums to offer cursive writing.

The committee unanimously Recommends this resolution with amendment.

Resolution #8: Retroactive Recognition of Disability by the Social Security Administration Resolved, that the New Hampshire State Grange and the National Grange support requiring all Social Security disability benefit recipients to receive retroactive payments from the date that their valid evidence of disability was submitted to the Social Security Administration.

After discussion, the committee unanimously **Recommends** this Resolution.

Resolution #9: Student Dress Codes Promote Decorum in Schools

Resolved, that the New Hampshire State Grange support requiring all New Hampshire school districts to enforce modest and uniform dress codes, appropriate for all students of all ages, during times of regular instruction, in order to reduce distractions of inappropriate clothing worn by students.

After much discussion, the committee recommends amending the Resolved to read 'Resolved, that the New Hampshire State Grange and the National Grange support schools having a dress code'.

The vote was 3 in favor of **Recommending with amendment** this Resolution, with one abstention.

Resolution #10: Taxpayer Preference for Public Funding for Public Schools in New Hampshire Resolved, that the New Hampshire State Grange support state legislation to require all local property tax bills to be printed with a checkoff box that clearly indicates that the individual taxpayers may direct, by checking the box, that their portion of the statewide property tax assessment must be used only for funding traditional local schools and public school districts in New Hampshire.

This, as one can imagine, was debated at length. The resulting vote was 3 in favor of **Recommending** this Resolution, with one member voting against. ('but not a strong no')

Following the deadline, the following resolution was submitted. Despite this, our committee decided to vote on it prior to the session.

Mental Health Therapy for First Responders

Approved by Antrim Grange #98

Therefore, be it resolved, that the New Hampshire State Grange encourage all Law Enforcement Officers, First Responders, and Emergency Dispatchers be provided with regular Mental Health checks, as well as Mental health awareness and suicide prevention training.

Three of the four committee members responded, reflecting a quorum of the committee, and voted to **Recommend** this resolution.

In summary, it was a pleasure to read and debate these resolutions, and we want to congratulate everyone who submitted them to us for consideration. Thank you.

I think there are invasive creatures that interfere with the data as it goes from local to State so that if I deep dive, the numbers never quite seem to match. Those same creatures may or may not be stealing communications, so that my follow-up questions go unanswered, payments aren't received and expensive mailings vanish. Stay tuned for a children's book about this phenomenon, or perhaps a custom stamp depicting these creatures, so you can keep an eye out.

However, I persevered! There are now 41 Granges that need quarterly packets, as Baker's River and Pine Grove Granges closed this year. Blazing Star and Wicwas Lake are still neck and neck for most members at 59 and 57 respectively. I filled orders for 28 membership awards, including 3 silver certificates, 4 golden sheaf, and 5 diamond certificates. (All achievements are impressive, but not all of them have fancy names.)

I think I've been slightly less high maintenance this year, but still need to voice some gratitude. My family puts up with the life and house disruption that comes with this job. My sister does lots of post office runs and the computer formatting I don't have patience for. She also tediously printed all the draft bylaws on Mom's color printer, which does *not* print double-sided, when I couldn't bear to drop \$1200 at Staples. Dan Bascom still makes sure I don't miss anything time-sensitive. And a special thank you to Watatic secretary Roberta Twiss. She's working hard to understand all the ins and outs of the office. As a notorious question-asker myself, I have a soft spot for others who aren't afraid to ask!

Last year I strongly encouraged you to reach out to the Grange friends you don't see regularly. I know in my Grange the number on the quarterly report doesn't match the attendance sheet. Let's make sure they know they're still part of the Grange family. At the credentials table you'll find notecards kindly donated by Hannah West. Please take one or more and send some Grange love!

SESSION COORDINATORS REPORT

Worthy Master, Worthy National Assistant Steward Hartley, State Officers, Delegates, Brothers and Sisters,

I would like to welcome you all back to the Lakes Region and The Margate on Winnipesaukee. As Session Coordinator I hope your stay here will be a pleasant and memorable one. Please take advantage of all the area has to offer during our downtime. Please visit the display room, spend some time looking at entries created by the many talented members, and maybe spend a little money at the silent auction tables as well. Be sure to stop by the Hospitality Room and enjoy some social time with fellow members.

2017 was the last time State Session was held here, Chris Heath was Master and National Master, Betsy Huber was our National Representative. The sixth degree was conferred on Theresa Avery, Esther Herrick, Debra Standley and 11 candidates.

During my report last year, I encouraged all in attendance to complete an evaluation form. I am pleased to report that I received 47 evaluations, the most I have ever received. Many of the responses were positive and expected. Most were in favor of the continuation of pre-registration format and the registration process at the credentials table. Received mixed responses regarding reports, the banquet and costs. One question was asking where to hold the 2024 Annual State Grange Session. The choices were West Lebanon or the Portsmouth area. By two votes the survey said West Lebanon. So why are we in the Lakes Region?

Well, it's a long story. Once the results of the votes from the evaluations were determined, I contacted the Fireside Inn & Suites in W. Lebanon only to find out that they were not available for either of the weekends that fall within the time frame governed by the By-laws. I looked for other facilities in the area and found nothing that would be able to accommodate us.

Having no luck in W. Lebanon, I began my search for a location in the Portsmouth area. Again, each facility I contacted couldn't accommodate us for the entire length of the session. I went back to the Holiday Inn Downtown Concord, but the room wasn't available either of the Fridays.

I made visits and phone calls to several facilities in Concord, Manchester and Nashua and was not able to secure a location.

In early April I made a call to the Margate on Winnipesaukee and was pleased to find that they could accommodate us for the session. I communicated with the Executive Committee, and they approved the contract which was signed and deposit was made. Now was time for planning the session. A walk through of the facility for the ones with room set up and food planning responsibilities was held.

I asked the hotel representative if there was any negotiation of the room rates and she informed me that we were being offered the winter rate and not the fall foliage rate. This troubled me knowing that many of our members would choose not to attend some or any of the session, due to the cost.

This year being an election year, and the presentation and vote on the proposed By-law changes it was felt that something needed to be done to encourage the members to attend. Again, I contacted the Executive Committee with this concern and asked for a meeting. The committee met to discuss what we could offer the members. After some suggestions and much discussion, it was voted favorably to pay \$75 per night per room for the 2024 session only. When you check out you will only be charged the discounted rate plus the taxes. If you are staying here at the Margate and I haven't spoken to you yet, please come and see me so that I can make sure you are on the Grange rooming list.

I am pleased to report that the contract has been signed and deposit made for the 2025 Annual State Grange Session. Mark your calendar for Thursday, October 16 to Saturday October 18, 2025. The Fireside Inn & Suites in W Lebanon will be our host. Rates and other information will be published in an issue of the Granite State Granger and will be sent to each Grange Secretary early in 2025.

In a typical year coordinating the Annual State Session is the only event I'm responsible for. However, last November, the State Master contacted me while she was at National session informing me that New Hampshire would be hosting the 2024 Northeast Region Leaders Conference. She asked if I would be willing to take care of this. My response was, as we say in NH "I'd be delighted".

Without any hesitation I called the Holiday Inn, Downtown Concord and was able to contract with them for January 12~14, 2024. Due to the short timeline for the event, registration forms, a tentative program and other information needed to be created and sent to each state in the region. I'm really amazed at how smoothly everything went. Those in attendance seemed to enjoy their stay and were very complimentary to their New Hampshire hosts. I, for one, was very happy to return home but would do it again if needed.

Some of you may have noticed that there is no evaluation form in your packets. I have spoken to the State Master and have requested a special committee be formed to look at our current format for the annual session. The committee will be charged with making suggestions and recommendations for sessions going forward and report back at the 2025 session. If you would

be interested in serving on this committee, please let me or the State Master know. A committee will be formed from the list.

Within the next month, each Grange will receive a questionnaire pertaining to State Session. It is my hope that each Grange participates. This will be strictly anonymous and will be explained in the letter that will be sent. STATE GRANGE BUILDING MANAGER

This has not been the most eventful year ever for the State Grange Building. There were hopes that a groundskeeper would be on duty in the spring and summer... but then he was in a bike accident, so weeding and seeding was cancelled. Beth Merrill and Kathy Yardley came a couple of times with Kathy's weed-whacker to keep things from becoming a complete jungle. We'll try to do better next year.

Improvements to the building didn't include anything fancy (like the new furnace and air conditioning system that I told you about last year) but we did have a new outside outlet installed recently. I think the electrician did a great job and the work looks quite professional, but if anyone were to ask if I'd recommend him to others, I might have to warn them about his scheduling skills. After two attempts to contact him, I got a return email and arranged a day for him to come and put the outlet in. He hadn't given me a specific time window, but I had told him that I could be there anytime between 9am and 2pm while my kids were at school. I arrived at the building that day with a few bags of paperwork that I was supposed to go through at pretty close to 9am (many of you may know that I am not the most punctual person ever) and I listened to a podcast and I went through a whole bag of paperwork and I played a few games on my phone and eventually it was about 2:15 so I went home again. I e-mailed him to say that I hadn't seen him that day so I supposed we would need to reschedule. He said he'd completely forgotten, and we agreed on a new day for him to come. This time he told me he'd be there at 9am. I arrived at about ten past nine and didn't see any other cars, so I unlocked the building and

waited. At 10am I sent him an email asking if he was still coming. He wrote back to say that he was running late. He arrived around 10:30, observed that the building was made of brick and cement blocks and said "oh, I don't have the tools for that with me" but we looked around and I showed him where everything was and he made a plan for where the outlet would go. We scheduled another day for him to come with the right tools for the mission. That time he arrived only an hour after the agreed upon time and actually sent me a message to say he was running late, so I figure he's making progress. Once he was there, everything went quickly and smoothly and the new outlet was all set for use. It will be helpful to the groundskeeper to have an outside outlet but the main reason it was moved to the top of the list is due to Christmas lights. We have been participating in the Light Up the Village event in Hooksett for a couple of years now and having an outside outlet is very important if the alternative is to run an extension cord out a window or door when it is very cold outside. The heating system was not installed to heat the neighborhood. Someone professional is doing our lights this year so you'll have to drive by and see them.

Other than the new outlet, the building was inspected last winter. At first the inspector said we would need to install a full fire alarm system as an upgrade to the eight smoke detectors he insisted we put in a couple of years ago. I got a quote on that which was alarmingly high (get it?) and would require a hefty yearly fee, but luckily Mark Collins has been on the planning board in his town and knows a thing or two about regulations. The inspector backed down quickly after I told him the Executive Committee needed to see the code he was referring to which required us to install the system. He said "Oh...uh... it was just a suggestion." The fire extinguishers were also checked. The guy who scheduled the appointment with me to do that didn't show up at the time I thought we had agreed upon, so I figured there had been miscommunication, and I came again on the alternate time and day he had offered. After an hour I called the company and once I had explained the scenario, the person on the other end of the phone said "Oh, I bet I know who that was." I was then contacted the following Monday by the guy who had checked the extinguishers the past two years. Apparently, he had been transferred to another area, but had been called back to cover since the original guy that stood me up twice had put in for 40 hours of work the previous week but the company GPS in his truck showed he had only left his house in the truck for about three hours. He did not work there long.

We made a valiant attempt to fix the internet issues at the building by getting a T-Mobile Hot Spot. We cancelled the old internet service which was bundled with the phone. We saved ourselves a whopping \$5 a month on the phone bill. The internet does work better than it did, I believe, but not always. The general consensus is that the internet there may just be cursed.

Luckily, I like driving, have a very flexible schedule, and usually don't plan anything more than a few minutes in advance, so I was generally amused by the wild goose chases that landed me at the State Grange Building repeatedly to meet (or not meet) various people. It all eventually

worked out. Beth Merrill continues to be the custodian, cleaning the building and checking on paper supplies and such. We still rent to the church on a regular basis, some Nepali groups on an irregular basis, and once in a while someone else (such as Norman Brandt's bird club). Various State Grange events were held at the building and the Crafty Ladies continue to meet there from Thursday through Saturday on a semi-monthly schedule.

Upcoming projects include hopefully finally doing something about the floor, hopefully finally having a groundskeeper, and hopefully painting the building, particularly the back where new boards were added when they installed the new chimney a few years ago. We'll see how it goes.

TREASURER REPORT

2024 Kim and I started the year by checking off a big item on our bucket list, our 111-day world cruise. We left Ft. Lauderdale on Jan. 4th and returned on April 25th. Visiting 21 countries and 40 ports of call. Went thru the Panama Canal, up west coast of Central America, LA to Hawaii, Figi, New Zealand, Australia, Africa, Canary Islands, Morocco, Spain, Italy, Turkey, Greece, France, Portugal and Bermuda. When we reached Australia, our trip got changed. We were supposed to go thru Suez Canal, bBut due to the war the cruise line took a safer route. We lost eight ports of call but were well compensated for it. Americans were very well received at each port. My most favorite port was Pompei.

Back to reality, we arrived in Ft Lauderdale on Thursday April 25th. Closed our Florida home and we were on the road early Sunday morning, arriving in Maine on Monday April 29th. Just in time for Rochester Grange, Oddfellow, Masonic and executive meetings. I continue to serve as deputy in the north country. Expenses were out of control. The executive committee took a hard look at the budget and instituted many changes. The stipend to Treasurer and Secretary were reduced greatly (both were accepted by then Secretary Jerry Leclerc and me). I would like to share with you four of our major accounts.

These 2024 totals do not include any amounts withdrawn from the accounts over the last ten years. "I - no we" owe a big thanks to the executive committee for their due diligence in managing our accounts and invested funds.

So, with that in mind I have suggested some changes in the budget due to inflation and such. An increase in two of the officer's stipends. These will be presented in the budget on Saturday. 2024 has been very good for us, our investments have increased nicely. Any Grange having escrow accounts please see me later as I have printouts on each account.

I also serve as Treasurer of the Trust Funds. This is a very underused fund. We only had one applicant last year and none the year before. I am very surprised that during and since Covid we have had so few applicants. These funds are there to assist our NH brothers and sisters in need. In the past, funds have been used for medical bills, heating assistance, home repairs, etc. Your information is kept in strict confidence. Please help get the information out to those who might need it.

On a different note, NH State Grange, by vote of the Executive Committee, sent a \$1,000 donation to the North Carolina Disaster Relief fund to help NC Grangers recover from Hurricane Helene.

The Educational Loan Account is another underused fund. There is money there to help Grangers and family members with their education -not just with loans but with scholarships as well. See anyone on the Grange Services committee for information.

I have completed all the 990N e-postcards. You will find them in your packets.

Bonding continues to be a problem as many Granges paid late with one still not paid for last year and this year is now due. The State Secretary and I both have a list of what each Grange should pay based on last year's deputy reports. Please take note as all bonding fees have increased. The minimum payment is now \$53.00.

In 2025, the incorporation fee (\$25.00) is due to the NH Corporate Division. This is due every five years. Notices are sent out by the corporate division to the secretary listed five years ago. If your secretary has changed since, then you may not receive one. Paying this keeps each Grange listed as a non-profit with the State of New Hampshire. If you ever try to change a bank account, most banks now require this before issuing an account. I will try to keep tabs on their website to make sure each Grange is up to date. All Granges are presently currant except one. Both the bonding and incorporation are required by our by-laws.

This past week I dropped off the tax info to our accountant. It has taken me about one full week to compile all the information. The information for the Journal of Proceedings is ready for the Secretary as soon as the budget is passed. Another item checked off my list.

I would also like to pass on kudos to Pat Bailey and Patrice Lawlor for their excellent work with the GSG. Thank you for keeping within the budget. Finally, I would like to thank Anne Boisvert for all her help as assistant Treasurer during our world cruise. She handled the few glitches we had very efficiently and quickly. Thanks, Anne. To Mary it is such a pleasure working with you, thank you for all you do. Kim thanks for holding my hand throughout. Retirement is so much better with you.

WEBMASTER REPORT

Worthy Master, National Representative, State Officers, delegates, Pink Sash family members, brother and sister patrons all,

Another year in the Grange has ended and as the new starts our organization is moving forward. This past year has had the same challenges that I have faced in the past but the future's looking brighter. I apologize that I still have not finished the Grange pages that I promised last year. Maybe with the upcoming changes to roles in the Grange I will have more time to get it completed and added to the website. One of the issues that I would like to go over and explain to those of you who have @nhgrange.org email accounts. Each officer and committee director has an email address for the @nhgrange.org which is forwarded to their personal email address. This works great for getting important emails but doesn't remove the emails from the @nhgrange.org email account. For officers and directors that don't get a lot of email, this is no problem but for officers that get many communications from their counterparts, the mailbox can fill up quickly. How many of you have received an email saying that you are reaching your quota? How many of you know what this is and how to fix it? The standard size limit of the mailbox for all users is set to 250MB by default. When the quota gets close, the system emails the user. Unfortunately, when the mailbox reaches its quota, the user must clear out some of the messages to lower the storage being used. In order to complete this step you must log into the webmail interface and clean out the mailbox. Here is how the email user can log into the system and clear it out.

- 1. Open a browser and navigate to https://web218.dnchosting.com:2096/logout/?locale=en
- 2. At the login screen enter your email address @nhgrange.org and the default password ConfidentPatrons1!

- 3. Next you will arrive at a landing page where you have control over your email account.
- 4. Here you can change your password, set up auto responses, filter emails and many other things.
- 5. To access your email platform, click on the "Blue" open button near the top of the page.
- 6. Here you have the full function of the web client and can read, move, delete and compose and send emails.
- 7. To logout out of the mailbox, click on the logout button in the lower left corner.

As your webmaster for the past year, I have tried my best to keep the website up to date and relevant for what has been happening throughout the year. I want to thank each and every person who has provided positive comments that have been passed along and sent in corrections for the website. I have done what I can to make sure that the information provided was posted.
